PRESIDENT'S MESSAGE

A number of issues will become prominent in the near future requiring participation and response from the Chicago Chapter, AIA. They are:

1. Architectural and Transportation Barriers Compliance Board (Minimum Guidelines and Requirements for Accessible Design: Final Rule). The Handicapped subcommittee is now being reformed by Joseph Fitzgerald and should be prepared by the end of April to review the accessibility guidelines document and the ANSI Standards. This subcommittee is a part of the Mayor's Commission on Building Code Amendments, which served so well to review the State of Illinois Accessibility Standards. CCAIA members serving on this committee were Robert Kill, Robert Wesley, Norman DeHaan and John Anderson.

You may recall Gertrude Kerbis' report in the March 1980 Focus which indicated the concern of the CCAIA regarding the State of Illinois Accessibility Standards, and the fine work the committee did to bring revisions to this standard. In addition to reviewing the Transportation Board Guidelines to interface with the State Standards, the ANSI standards will be reviewed to see if it could be modified into code language. We look forward to the imput this committee can bring to the CCAIA and Illinois Council.

2. Large Component Meeting. A large component meeting was held on Monday, March 23 with representatives from Minneapolis, St. Louis, Boston, Philadelphia, Columbus, New York City, Los Angeles and Chicago meeting with AIA Executive Vice President, David O. Meeker. The following agenda items were discussed during the five and one-half hour meeting: national and component coordination, membership brochures for large components, dues and national voting. Discussion on the A-1 Resolution was held with only the large component representatives present; ways in which to respond to the Resolution at the

component level, and subsequently at the convention, were considered.

3. AIA Convention. The National AIA Convention in Minneapolis has been planned to help architects "get a line on energy and design". Professional development seminars based on the convention theme are offered to accomplish the goal of giving every AIA member an opportunity to develop expertise necessary to meet the challenges of energy-conscious design.

The A-l Resolution will be discussed further at the convention, promising to be controversial as components deliver their responses. To respond to an issue as large as the A-l Resolution, and bringing it to the convention is essential to the direction the AIA will take in the '80's.

The CCAIA is entitled to 67 delegates to the National Convention. We urge you to attend and represent the Chapter as a delegate. Please telephone Vicki Behm at the Chapter office to express your desire to serve as a 1981 delegate.

CHAPTER TO MOVE TO LANDMARK BLDG.

The Chicago Chapter, ATA office is moving to the third floor (suites 341, 346 and 356) of the Monadnock Building by mid-June. The reasons for the move are economic; rent at 310 S. Michigan has gone from \$5.50 to at least \$12.00 a square foot. Our new rent, plus construction costs will reflect a savings.

Although the new space is smaller than our current office, we will still have a conference room, access to a mid-size auditorium and continue to sell documents.

The AIA Journal will be sharing office space with the Chapter. Jim Anderson will head area advertising sales for the Journal. Although Jim will be traveling much of the time, he looks forward to meeting many of our members.

The owners of the Monadnock Building are very sympathetic to the integrity of this landmark structure, as well as our needs. The 12' high corridor wall of our office will be restored by the owner (chipped glass, oak, marble). The ArchiCenter, located on the first and second floors directly below us, has opened an expanded bookstore.

During the rennovation and move period we have asked the committee chairmen to host their meetings in other offices. We appreciate your cooperation and hope the inconvenience to you is minimal.





ON ITS WAY

The Mayor's Advisory Commission on Building Code Amendments has approved the final draft of the revisions to the Building Code concerning remodeling and additions to existing buildings. The Appeals Board procedure was also approved. The proposed amendments were sent to the Corporation Council for their review and to put into legal language. This review is predicted to be completed in about sixty days after which it will be forwarded to the Mayor. The Commission is optimistic that it will be approved intact. Members of the AIA Housing Committee were instrumental in helping to draft these revisions which are considered to be the most progressive rehabilitation standards of any major city. A copy of the proposed amendments is available at the Chapter Office for review. The Dana House, designed by Frank Lloyd Wright in 1902 and 1905 and located in Springfield, Illinois is for sale by the owner, Mr. Payne Thomas. It is the only Wright structure from his Prairie period totally intact: windows, furniture, lighting, lighting fixtures and architectural elements. Vicki Behm wrote a letter to the owner strongly supporting his decision to insure that the house remain in its original state. Richard Cook wrote a similar letter to Governor Thompson.
