Mark your calendar for an evening of fellowship on October 12. The first of the season's general membership meetings will be held at North Point, a loft conversion at 727 N. Hudson. One entire floor of the building is planned for providing space and services to design professionals.

A catered reception at 5:30 will precede a meeting highlighted by a program planned and coordinated by Ken Johnson, Vicki Behm, Eva Maddox and members of the Interiors Committee. "Interior Design as a Force in Successful Renovation: The Profitable Role of the Architect as Entrepreneur" will feature Norman DeHaan, AIA, David E. O'Connell, CPA and realtor, and Ken Folgers, AIA as speakers, all of whom are involved on the equity side of conversion and rehab projects. They will share information on what to do when a client approaches you about becoming financially involved in a project.

Every member is urged to attend this meeting, to see old friends, hear the program, and, also, to welcome the potential members who are being invited to this meeting. Under the leadership of Irving Moses, AIA, the Membership Committee has begun a campaign to reach all non-members within the Chapter boundaries. 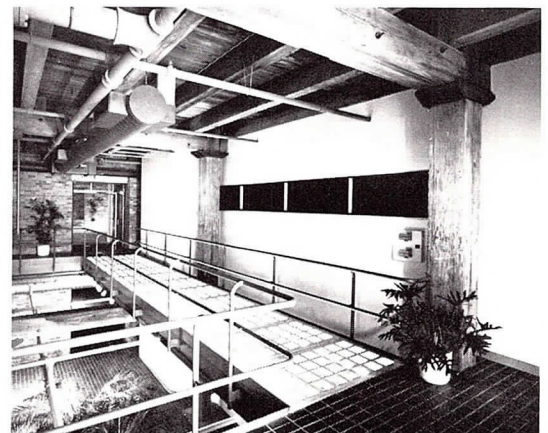

DISTINGUISHED BUILDING ENTRIES REFLECT "FIRST CITY OF ARCHITECTURE"

Approximately 300 Chicago Chapter members, guests and members of the public viewed the presentation of certificates to the 1982 Distinguished Building Awards winners. After an introduction of the program by President Donald Hackl, FAIA, George Shipporeit, AIA, chairman of the 1982 program, announced the architect and project as each entry was projected on the 40' plus Columbus Drive Auditorium screen. The slides of the 1982 entries were testimony to the excellent quality of this year's entry projects. "The standards of the entries were very high," commented the evening's guest speaker, Evans Woollen, AIA, 1982 Distinguished Building Awards jury chairman, who also expressed regret that more of the projects could not have received awards.

Cynthia Weese, AIA, Design Committee Chairman, described each of the winning projects and read the jury comments as slides of the winners were presented. President Hackl presented the certificates to those representing the architect, contractor, and owner.

Following the awarding of the certificates, the Chicago Chapter Distinguished Service Awards were presented. Stanley Tigerman, FAIA, who had nominated Fazlur Khan, made the presentation of the 1982 Service Award to Khan's widow, Liselotte, and to his daughter, Yasmin. Margaret McCurry, AIA, nominator of Carter H. Manny, Jr., FAIA, presented the second Service Award certificate to Mr. Manny.

Mr. Evans remarked on the frustrations and agonies of an awards jury; also the joy of viewing the quality of projects entered in the Chicago program. The 1982 jury found Chicago architecture reflects an "embracing of paradoxes...concern with resolution of opposites." Evans, who referred to himself as the "country cousin looking at the big city," commented that "Chicago designers are thinking of their buildings in an evolutionary process with a stronger emphasis on context, an abandonment of perfection. There is a feeling of diversity within a central unity; a sense that Chicago architects are talking to each other in a productive way." He exhorted Chicago designers to nurture this attitude. Mr. Evans closed his short commentary with, "Chicago is the first city of architecture."

The cost is expected to be \$10. According to the Department, applications for ordering the certificate have been mailed to all registered architects.

REHABILITATION CODE WORKSHOP

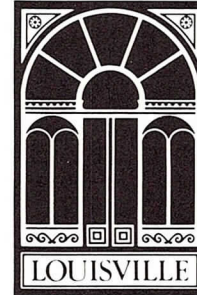
Chicago's new rehabilitation code will be the subject of a workshop to be held on October 9. Co-sponsored by the Community Investment Corporation and Metropolitan Housing and Planning Council, the purpose of the workshop will be to explain the benefits of the new code to property owners engaged in rehabilitation.

Speakers will be George Weinhold, supervising architect at the Department of Inspectional Services; John McCaffrey, Assistant Corporation Counsel, Nick Fera, Deputy Commissioner of DIS, and Don Klein, Chairman of the new Building Board of Appeals.

The workshop is intended to help property owners understand the new provisions which simplify and reduce the costs of rehabilitation. The Chicago Chapter, AIA Housing Committee laid the ground work for development of the new code and was involved in a significant way in helping to write it.

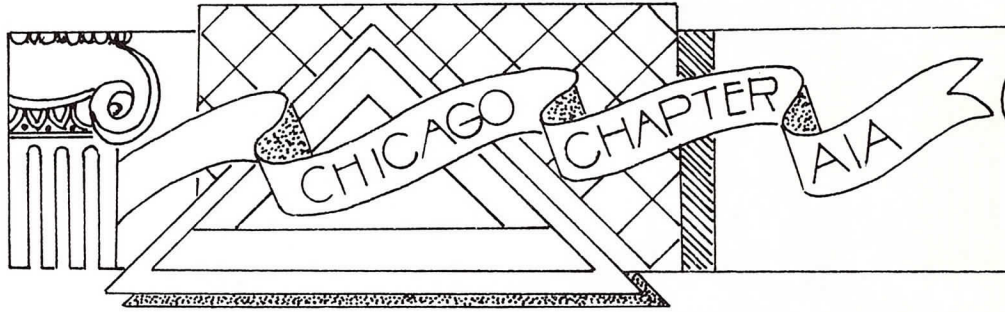

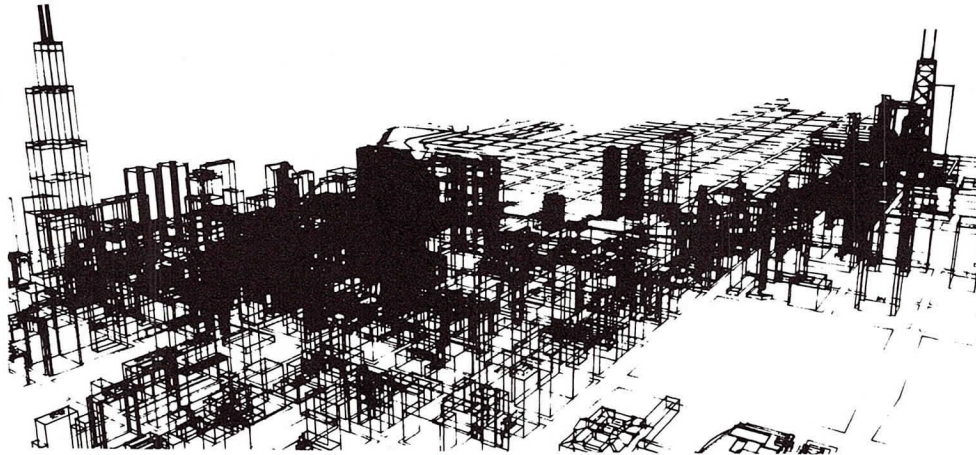

INTERIORS SEMINAR FOCUSES ON FIRE SAFETY

Is the future of fire-safe interiors solely in the designer's and architect's hands or is it shared by the specifier/manufacturer as well?

This question will be studied from various professional viewpoints on Saturday, October 30, at a seminar on "Flammability and Fire Safety in Interior Design," at Northern Illinois University. The seminar, sponsored by the Professional Development Committee of the Illinois Chapter of the ASID and Department of Art and College of Continuing Education at NIU, will be held in the uni-

versity's Visual Arts Building from 9 AM to 5:15 PM.

Seminar speakers will represent legal and governmental viewpoints, manufacturing aspects, the academic and research fields, and the consultants point of view on fire protection systems and building codes.

FINANCIAL SURVEY AVAILABLE

The 1982 PSMJ/PSMA Financial Statistics Survey will be available beginning October 1. This biennial financial "bible" of the design profession was prepared by Chicago management consultant Birnberg & Associates for PSMJ. Publisher Michael Hough states,
