

CELEBRATING CHICAGO'S ARCHITECTURAL SPECTRUM

On the evening of September 28, the main floor of the Art Institute's Columbus Drive Auditorium was nearly filled to its' capacity as 400 plus members and guests witnessed the presentation of the 1983 Chicago Chapter Awards. Twenty-three awards were given in four categories. In addition to the Distinguished Building Awards, in its 30th year of recognizing significant achievement in the planning, design, and execution of building projects, and the Distinguished Service Awards, the 1983 program was expanded to honor two outstanding young architects and exceptional work by architecture students attending schools in the Chicago region. 150 little-known architecturally and/or historically significant buildings in the Chicago area were also recognized.

As the audience entered the auditorium, slides of the 150 relatively obscure buildings were given prominence in a multi-media presentation. President Bill Brubaker welcomed everyone and introduced Cynthia Weese, 1983 Awards Program Chairman, who explained the program structure. Ruth Olin, University of Illinois, Champaign; Peter Madimenos, University of Illinois, Chicago; Mark Peters, Wayne Jenson, Jeffrey Reinke, Kevin Kemp, and Peter Van Vechten, all from the University of Wisconsin, Milwaukee, winners in the Student Award competition, were presented with the Chapter certificate by Carter Manny, Director of the Graham Foundation, which gave the gift of \$5000 to be distributed evenly among the winning schools. "There is an obligation to the student architect,

as well as practicing architect," commented Peter Landon, Chairman of the Student Awards.

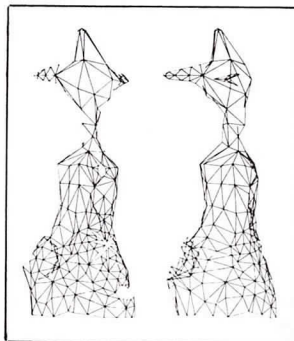
For excellence in ability and exceptional contribution, the Young Architect Award was presented to Nicholas Weingarten, AIA and Ralph Johnson, AIA. Richard Solomon, AIA, Chairman of the Young Architect Awards commended the Chapter's first recipients of the award for their "accomplishments as well as promise." In the Distinguished Service Award category, George Danforth, FAIA, was recognized for his "wise counsel and spirited teaching;" the Women's Architectural League for their "dedication to greater understanding and invaluable contribution to the architectural profession." President Brubaker presented the Distinguished Service Award to Mr. Danforth and, for the WAL, to Mary Burch, first WAL president and Carol Brejcha, 1983 president. Philip Purcell, attorney at Kirkland Ellis, cited for three decades of guidance and assistance in legal aspects to members of the profession; and Stanley Tigerman, FAIA, applauded for his "energy, commitment, and en-

couragement to young architects," were also awarded the Distinguished Service Certificate.

Before the winning DBA projects were recognized, each entry in the program was introduced in a slide presentation, with commentary by Richard Whitaker, AIA, who remarked that the program is "a model for design competitions across the country." Cynthia Weese, AIA, presented certificates to the architects, owners, and contractors of the winning buildings.

Prior to the ceremonies, there was a preview of the Awards Program exhibit in the Department of Architecture of The Art Institute. Curated by Pauline Saliga, the installation provided an entire spectrum of the '83 program through drawings, diaries, models, a continuous slide show, and animated computer graphic film (the latter created and developed by Nick Weingarten). Ms. Saliga and John Zukowsky, curator of the department, were commended during the ceremonies for their "care in conceptualization and mounting of the ex-

1st V.P./PRESIDENT ELECT

NORMAN DEHAAN, AIA, FASID, president of Norman DeHaan Associates and DeHaan Inc., has served as director on the Chicago Chapter Board for the past three years. He is a member of the National AIA Interiors Committee and the Mayor's Review Committee on Accessibility Standards and Codes. DeHaan, who studied under Mies Van der Rohe at IIT, has lectured widely in the U. S. and abroad and was the first national president of the American Society of Interior Designers. DeHaan has acted as architectural advisor to the president of the Republic of Korea, served as housing director of the United Nations Korean Reconstruction Agency, as a delegate to the World Congress of International Federation of Interior Designers and Architects, and as project director for the Department of State Industrial Design Assistance Program. He has served on panels for the National Endowment for the Arts, the National Fire Prevention and Control Administration, and the Smithsonian Institute.

VICE PRESIDENT - 2 YEARS

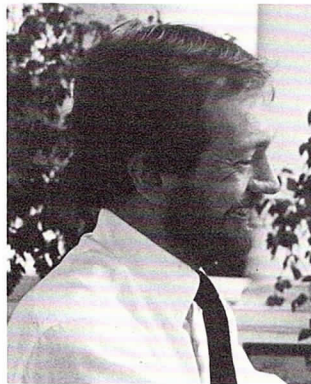
CYNTHIA WEESE, AIA, who has also served as director since 1981, is a principal at Weese Hickey Weese. This past year Ms. Weese has acted as chairman of the Design Committee, and under her direction and inspiration as chairman of the 1983 Awards Program, the annual Distinguished Building Awards was expanded to include four categories plus recognition of 150 historically significant and architecturally

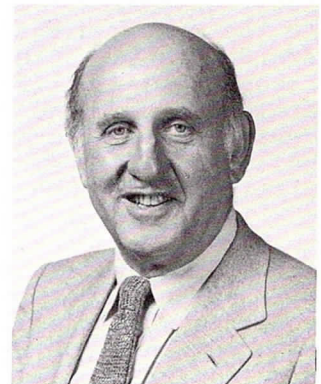

important buildings in the Chicago area. The firm of Weese Hickey Weese was awarded both an Interior Architecture and Distinguished Building Award in 1981, and in 1978 Ms. Weese received the Distinguished Service Award for the traveling exhibit, "Chicago Women Architects." She received her architectural degree from Washington University, St. Louis.

SECRETARY - 2 YEARS

SUSAN GREENWALD, AIA architect and specifications consultant, with offices in the Fine Arts Building, served as secretary of the Board this past year. She is a member of the CCAIA membership committee and is editor of the 1983 Chicago Awards Program catalog. Ms. Greenwald, a certified construction specifier, is a member of the Construc-

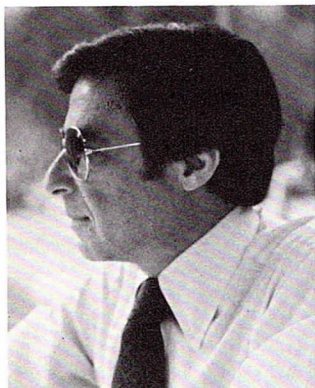

DIRECTOR - 3 YEARS

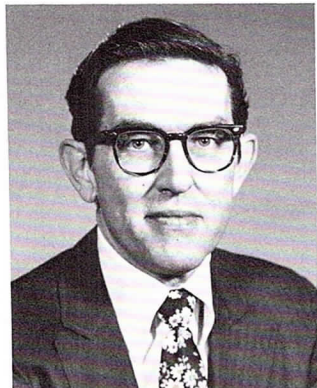

ASSOCIATE DIRECTOR - 1 YEAR

THOMAS FABIAN, associate member of the Chapter since August of this year, is a 1983 graduate of architecture from the University of Illinois, Champaign, and is currently pursuing a C.P.M. from the Institute of Real Estate Management. From 1982 to '83 Fabian represented the Tri-States Region on the ASC/AIA Board, and has served as Student Director on the Boards of the Illinois

Council, AIA and the Indiana Society of Architects. He was a member of the national ASC/AIA Long Range Planning, Budget, and Nominating Committees. He has, also, been a member of the national AIA Architects in Industry Committee. Currently, Fabian is serving on the national AIA Honor Awards Jury.

Robertson, who is with Nagle, Hartray and Associates, has served as chairman of the Inter-Professional Energy Committee, and taught an energy course for the Museum of Science and Industry. This past year he has taught courses at Argonne National Laboratory and in various cities in the mid-west as an instructor for the national AIA Energy in Architecture Workshops. INDEMNIFICATION CLAUSE

The Chicago Chapter Board of Directors has proposed that a clause concerning indemnification of officers and directors be inserted into the Chapter bylaws. The bylaws require that the members receive a 30-day notice of proposed amendments. The Indemnification of Officers and Directors clause will be presented and voted on at the November 29, 1983 meeting of the CCAIA Board of Directors.

The clause is to be included under Article III, Officers and Their Duties, Section 7. A copy of the proposed Indemnification may be requested through the Chapter office.

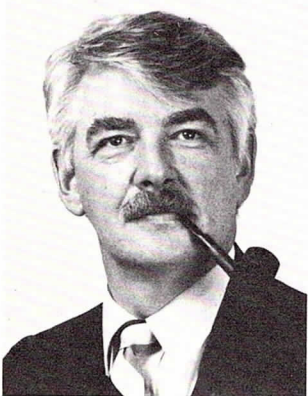
ANNUAL DINNER KALEIDOSCOPE OF ACTIVITY

What are the prevailing design trends; how are they affecting the planning and development of our cities? DANCE TO COMMEMORATE ARCHITECTURE

On April 4, the CCAIA will host a gala at The Art Institute which will feature the world premiere of a dance tribute to Chicago, to be choreographed by Lar Lubovitch. "Big Shoulders," inspired by the Carl Sandburg Poem, focuses on Chicago as a city of working people and as a center for some of the world's greatest architecture.

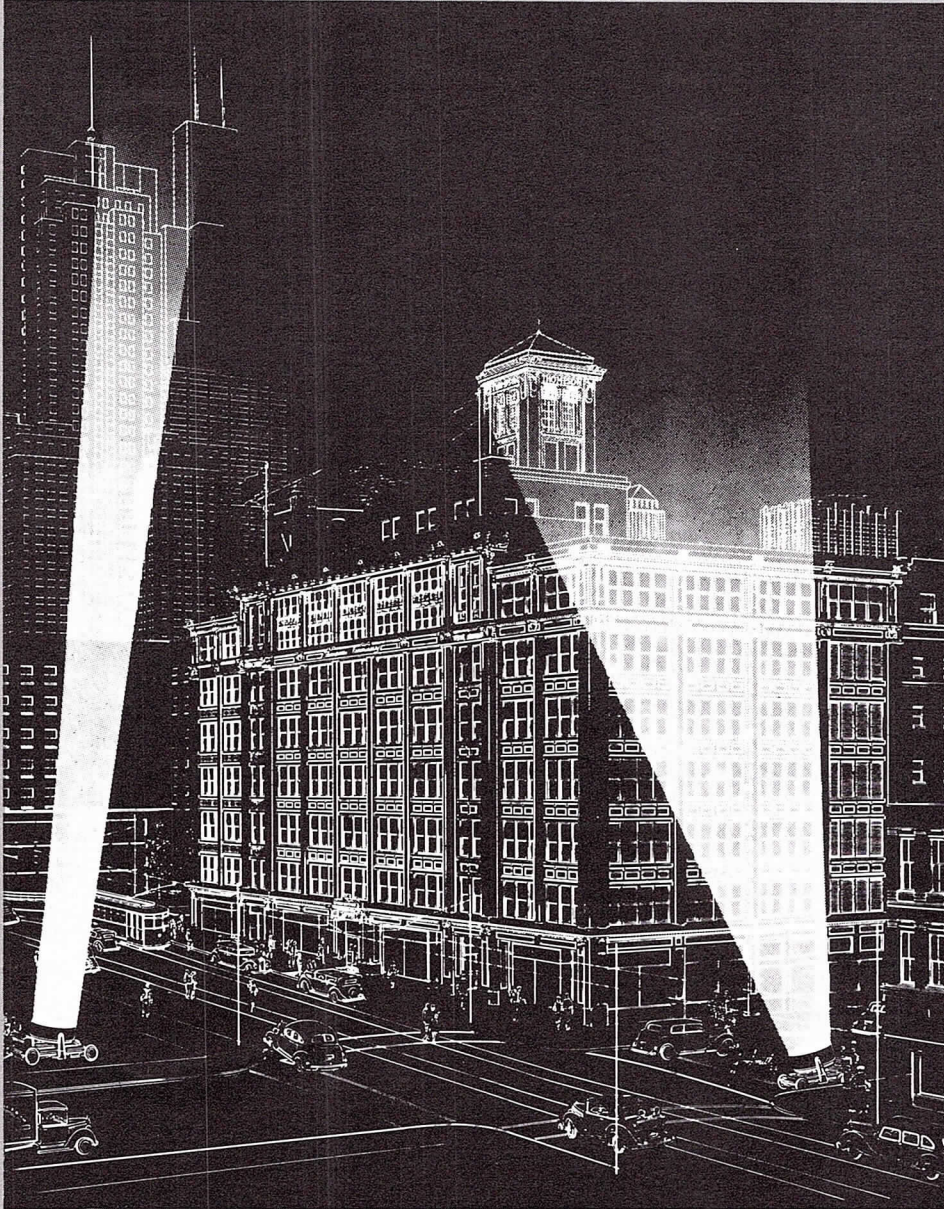
