

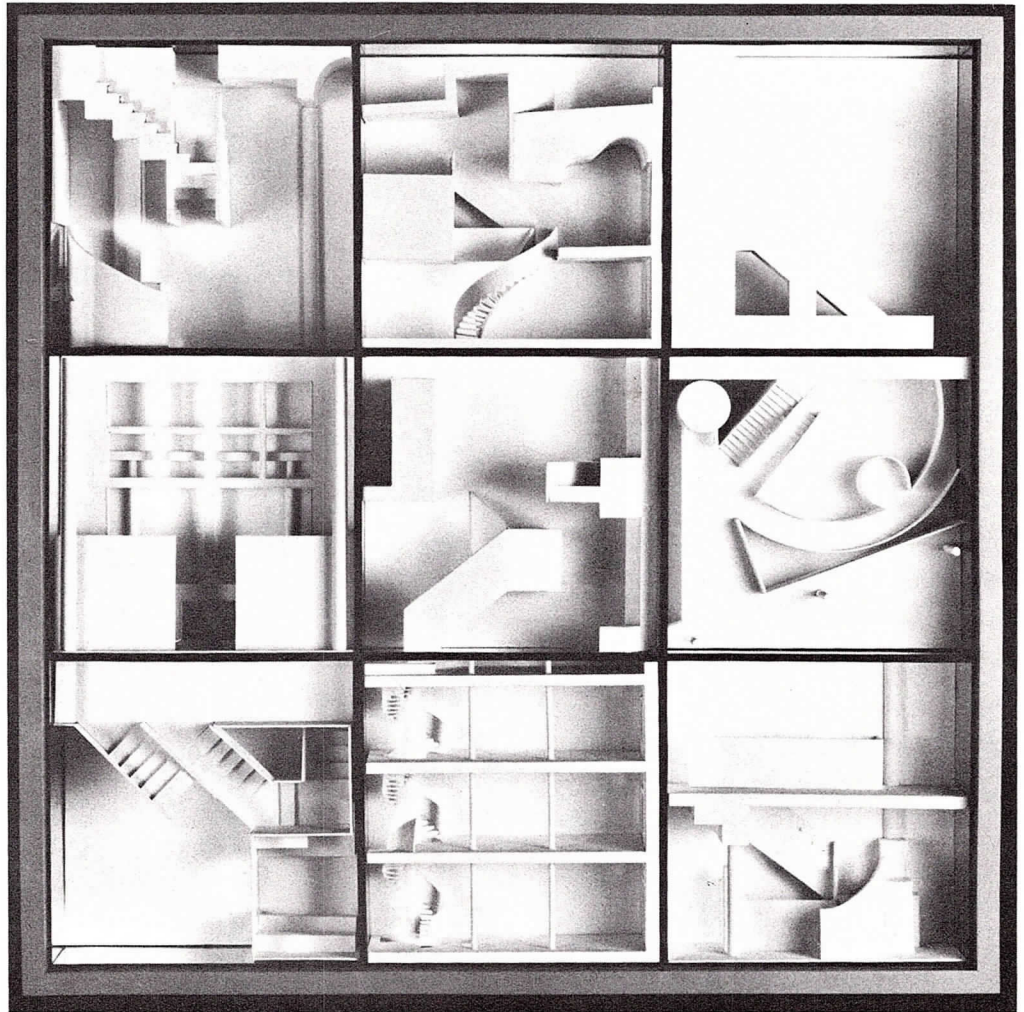
## WA Celebrates 10 Years With Exhibit

The growth and accomplishments of women in the architectural profession, both as individuals and as a group, are evident in the exhibition, "Chicago Women in Architecture: Progress & Evolution, 1974-1984," opening October 17 at the Chicago Historical Society. Celebrating the 10th anniversary of Chicago Women in Architecture (CWA), the focal point of the exhibition consists of 30 wall-mounted shadow boxes filled with drawings, models, photographs, and found objects that create a montage of the contributor's work over the past 10 years.

Organized by Sabra Clark, Assistant Curator, Architectural Collections at the Chicago Historical Society, the exhibition reflects popular tastes and styles as well as a wide range of drawing techniques, from romantic watercolors to computer-generated graphics. A photo wall provides the historical context for the contemporary work on display in the shadow boxes. Sophia Hayden's design for the Women's Building at the 1893 Columbian Exposition to the present built work of CWA members may be seen.

Chicago Women in Architecture is a professional organization established in 1974 to advance the status of women in the architectural profession. They have agreed to donate a selection of their work to the Architectural Collections at the Chicago Historical Society, establishing a permanent archive and supplementing the Society's holdings of contemporary work.

"Chicago Women in Architecture" will run through March 1985 at the CHS. It will then

go on tour in Illinois for at least 18 months under the auspices of the Illinois Arts Council's traveling exhibit program. A catalogue for the exhibition will be included in the November/December issue of Inland Architect magazine.

On Saturday, October 27, from 10:30 a.m. to 4:30 p.m., a symposium will be held fea-

aturing five women in the field of architecture: two architects, a critic, an educator, and a historian. Each will discuss, from her own perspective, the contributions and advancement made by women. A general panel discussion will follow.

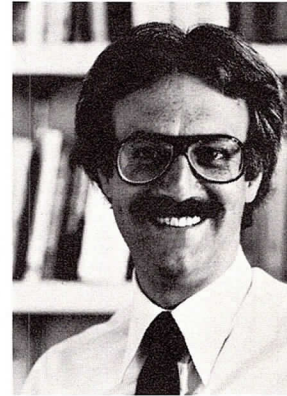
Ms. Fallon has been active on the CCAIA World's Fair Planning, Computer, and Research Committees, and organized and coordinated the midwestern conference, "Designi-

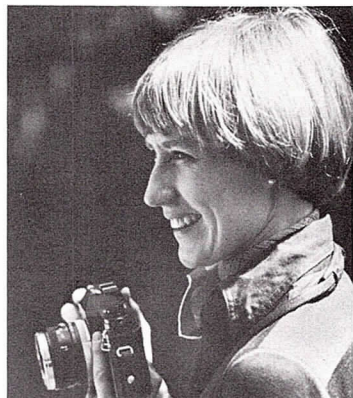

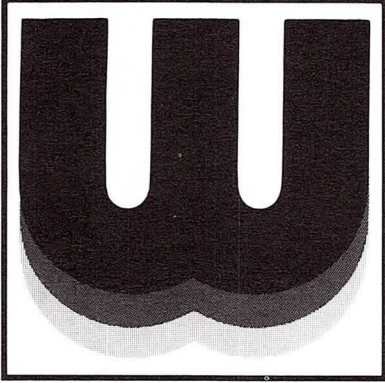

## Rome Prize Fellowship to Naughton

Chicago resident and CCAIA member John Naughton has been awarded a 1984-85 Advanced Fellowship in Architecture. Sponsored jointly by the American Academy in Rome and the Graham Foundation for Advanced Studies in the Fine Arts, the fellowship provides for six months of independent study at the Academy in Rome.

Naughton, who has been a Chapter member since 1979, interrupted 12 years of professional practice with Chicago

Associates, Planners and Architects, and A. Epstein and Sons, to return to academic study. After receiving his Master of Architecture from the University of Illinois, Chicago in 1981, he was a visiting critic in design at Yale University and a teaching fellow at the Institute for Architecture and Urban Studies.

The Six-Month Advanced Fellowship in the Design Arts, awarded in architecture, landscape architecture, urban design & planning, interiors, graphics. Seven years of professional experience is required. The One-Year Fellowship is granted in architecture, landscape architecture, painting, sculpture, history of art. There is also a Special Fellowship in the History of Art.

## Piece of the Action for Woman-owned Firm

Carrie Jeffers, vice president of Chicago Women in Architecture, reports that the State of Illinois has recently passed the Minority and Women Business Enterprise Act. Under this act, a goal is set to contract 5% of all the goods and services purchased by the State with Women Business Enterprises (WBE) and 5% with Minority Business Enterprises.

In order to take advantage of the act, women-owned firms must make their existence and status known. The state currently has no official record of women-owned architectural firms; therefore, the CDB has requested that women-owned firms identify themselves. Any firm not currently pre-quali-

fied with the CDB is urged to do so promptly in order to be considered for architectural contracts to be awarded in 1985. Any WBE firm now pre-qualified should make its status known to the CDB. Contact Esther Opermeyer at the Capital Development Board, 312-793-6034, and ask for the professional services form.

Chicago Women in Architecture attempts to maintain a list of women-owned firms in the Chicago area; however, they have no knowledge of such firms in Illinois outside Chicago. You can help the CWA contact these firms about the act by writing the CWA, 531 Jackson, Suite 346, Chicago 60654.

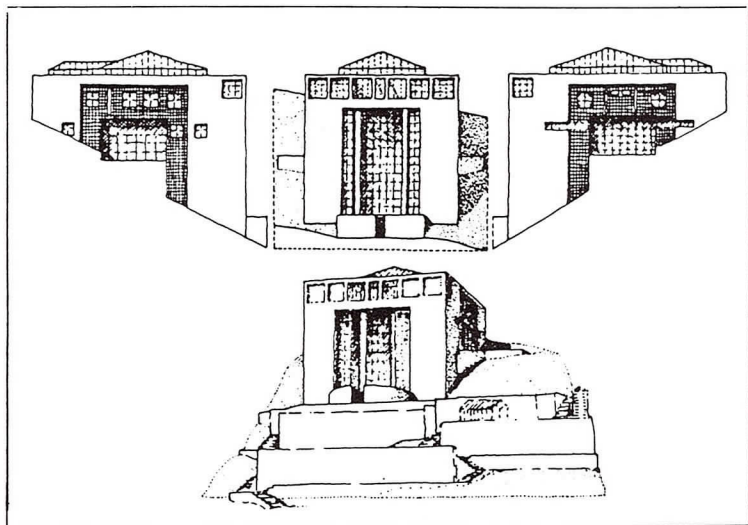

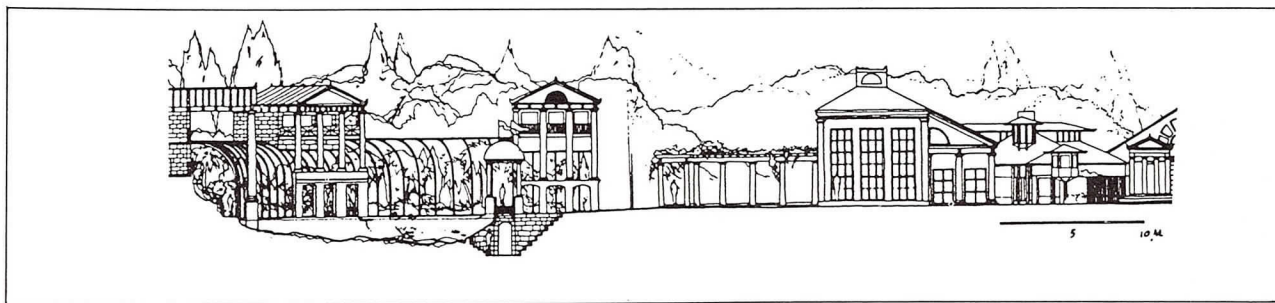



### AC Recommendations Examined

The Construction Industry Affairs Committee of Chicago (CIAC) will present a seminar to introduce architects to the AC recommendations for construction industry cooperation. This program will be held at the M & M Club of the Merchandise Mart, 2:30-5:30 p.m., on Tuesday, October 16. It is co-sponsored by CCAIA, I and CECI.

The CIAC, founded in 1967, is charged with fostering better relations between owners, architects, and contractors. It is composed of representatives of the Builders' Association of Chicago (representing general contractors), the Mechanical Contractors Association, the American Subcontractors Association, the Consulting Engineers Council of Illinois, the Construction Specifications Institute, and the Chicago AIA. Through the process of developing and promoting recommendations for contractual obligations, CIAC endeavors to provide solutions to potential conflicts, before they arise. The CIAC recommendations are consensus agreements between all of the member organizations. They provide owners with methods of contracting and construction administration which allow all parties equitable protection. In addition, they provide pre-negotiation solutions to some of the thorniest construction issues.

The CIAC has published 23 recommendations to date, broad-covering the areas of bidding, contract documents, construction operations and payment procedures. The seminar will provide an overview of all of the recommendations, as well as a detailed analysis

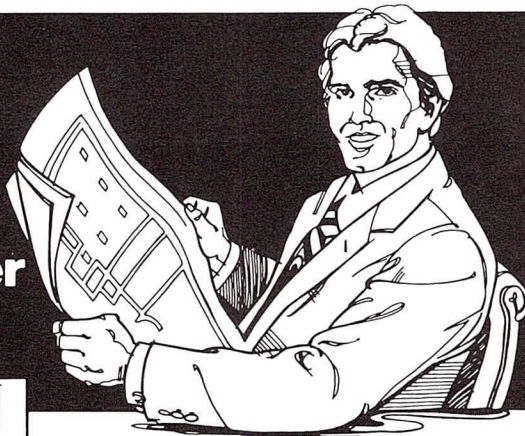

of 10 of the most substantive recommendations.

Most of the recommendations also include an implementation guide, relating the recommendations to the content a language of the AIA General Conditions, A201. Each of the general areas will be presented in a small group, round table format, with a speaker from the construction industry joining a speaker from the design professions to provide a balanced view of the issue. There will be small group discussion sessions, as well as a large group question and answer session.

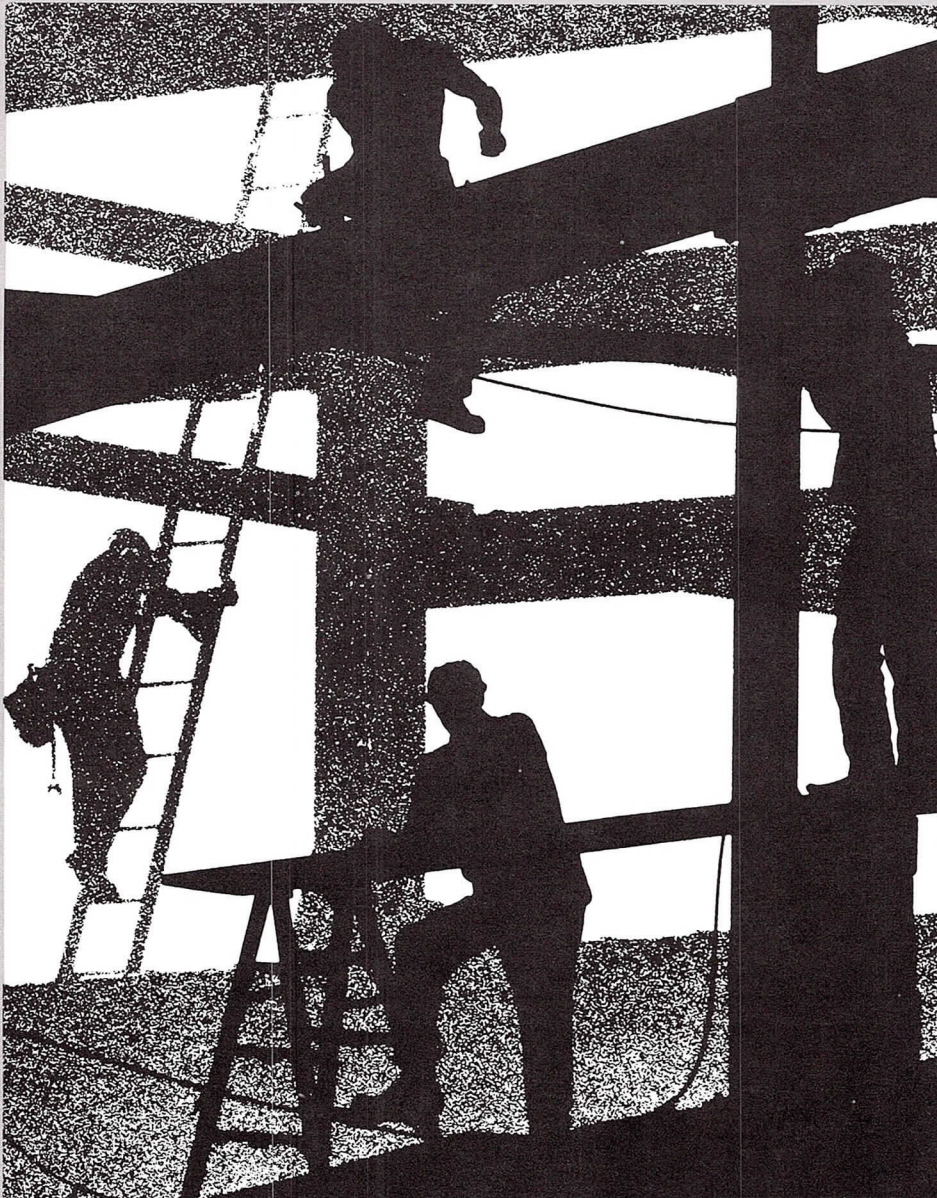
