High School Career Day Sat., March 28

"Should my son/daughter become an architect?"; "What architecture school should my child attend?" are questions frequently heard in the CCAIA office. In response to these questions, the Chapter is sponsoring a Career Day in Architecture on Saturday, March 28, 1987.

The program will begin at 9:30 a.m. and last until 2 p.m in the School of the Art Institute of Chicago auditorium, Jackson Boulevard and Columbus Drive. Kicking off the program will be two short, PBS award winning films, "An architect Never Sleeps," by Mark Richard Keane and "Chicago: a City of Architecture" by Keane and Linda Lee Nelson, AIA.

After the films, a panel of architects will tell why they chose the profession of architecture or interior architecture, the type of degree path they followed, and their current work. Panelists are: Jack Bowman, AIA, Vice President for Design, Lohan Associates; Cynthia Weese, AIA, Principal, Weese Hickey Weese; Robert L. Wesley, AIA, Principal, Skidmore, Owings & Merrill; Marya Lilien; Don Kalec, AIA, Restoration Architect, Frank Lloyd Wright Home and Studio: Lee S. Weintraub, AIA, Jack Train Associates, Chairman, Student Affairs Committee. Linda Lee Nelson, Area Head, Interior Architecture Department, School of the Art Institute, will introduce the panel and act as moderator.

There will also be a presentation on licensing, and types of programs available. Representatives from local colleges and universities will be on hand to meet with students and discuss their specific programs.

The program will end with a multi-media presentation by John Kurtich, AIA and May Hanfield, "Architecture in the Fourth Dimension."

High school and college students interested in careers in architecture and interior architecture and their teachers, counselors and parents are welcome. Admission is free.

Outdoor Sculpture Maintenance and Restoration

Sponsored by Architects in Government, Industry, Education. Timothy J. Lennon, Conservator of Paintings for the Art Institute of Chicago, will discuss the conservation concerns of Chicago outdoor sculpture.

Using the B.F. Ferguson collection as a reference, Mr. Lennon will illustrate through a slide presentation the issues involved in the maintenance of outdoor monuments. Maintenance involves two issues: the sculpture or monument itself and the pedestal, base, niche or whatever supports the monument. Other aspects to be covered include: the annual inspection program; the makeup of the review team; outside consultants; budget and cost concerns

Reintegrating Terra Cotta into Architectural Mainstream

On March 12, in the Chapter Board Room, at both 8 a.m. and noon, Nancy Berryman, president of Berryman Enterprises, will speak on architectural terra cotta as a viable contemporary building material appropriate for both masonry and metal frame buildings. Ms. Berryman will present the view that while there is a renewed interest in ornamentation, making terra cotta a natural choice for such expression, there is a place in contemporary design for terra cotta, and it should be reintegrated into the architectural mainstream rather than



Introduction to CADD Series

Sponsored by Computer Committee. Beginning Tuesday evening, April 7, those enrolled in the Computer Committee's six-part, hands-on "Introduction to CADD" series will get the feel of actually working on a CADD system, while learning what sorts of projects can benefit from CADD.

A general overview of CADD capabilities will be provided while students perform class exercises on AutoCAD workstations. All exercises will relate to "real life" situations, and participants will be able to apply what they have learned to whatever system they may eventually use in their firms.

Topics will include the basic organization of graphics files (drawings), layering methods and conventions, symbol libraries, scanning existing drawings for inclusion in the graphic database, and the use of 3-D in the design process. Students will be paired at workstations for all class exercises.

The six sessions will be held at 6:30 to 9 p.m. April 7, 14, 21, 18, May 5, and May 12 at Illinois Technical College, 506 S. Wabash and in the CCAIA Board Room.

IIT/Kent **Construction Law** Seminar

On April 23 and 24, the IIT Chicago Kent Construction Law Institute will present its Fifth Annual Construction Law Seminar that over the years has been rated by over half of the attendees as "outstanding."

Again, this year's format will concentrate on making construction law disputes understandable by using the foremost experts in the field and by presenting the material in uniquely interesting and refreshing format.

Twenty of the foremost contractors, architects, engineers, and the lawyers who represent them, will play act events which occur in the industry and which create the greatest number of disputes. After the construction professionals demonstrate how the disputes arise, the lawyers will discuss what the legal ramifications of the disputes are and how they can be resolved. Specific attention will be paid to contract documents, including the recently revised AIA standard forms, and in describing appropriate field procedures which will minimize the chances of a dispute arising.

The Construction Law Institute's director is Steven G. M. Stein, of Lurie Sklar & Simon, Ltd., who teaches Construction Law at Chicago-Kent College of Law. For more information. please call Stein at 641-5252.

First Vice President/President Elect Frank Heitzman, AIA

Heitzman, a partner in Heitzman & Thorpe Architects and instructor in the Department of Architecture at Triton College, has been very visible the past several years on a variety of Chapter and State committees and special task forces.

He has been chairman of the Chapter's Quality Assurance Task Force and an active participant on the Accessibility Task Force for eight years, serving as chairman since 1986. As Chapter delegate to the Illinois Council he has contributed hundreds of hours of service to the ICAIA through the Long Range Plan Committee, State Building Code Advisory Committee, and as State Legislative Liaison and co-chair of the Illinois State Conference. He was a program evaluator for two years on AIA *Technology* magazine's "Affordable CADD Shootout" and served on the AIA National Codes and Standards Committee.

Heitzman has co-authored *Chicago's* Landmark Structures, an Inventory for the Landmarks Preservation Council and Service, the City of Chicago Rehabilitation Code (1979), and MegaCADD – A New Way of Thinking for Architectural Technology.

Service to the community in a professional capacity includes the Mayor's Advisory Committee on Building Code Amendments, Rehabilitation Code Subcommittee Chairman, and Accessibility Code Co-chair. He has served on the Energy Advisory Committee for the North Eastern Illinois Planning Commission, first vice president of the Oak Park Preservation Association, and member of the Rehabilitation Code Committee for the Metropolitan Housing & Planning Council. Heitzman has also been active on the Oak Park Landmarks Commission serving as Chairman of the Ordinance Drafting Committee.

He was president of the Illinois Association of Historic Preservation Commissions, 1984-1986, and in 1986 he received the Landmarks Preservation Council of Illinois Distinguished Service Award.

Heitzman received his Master of Architecture from the University of Illinois at Champaign-Urbana.

Vice President Margaret McCurry, AIA

McCurry has been a director on the Chapter Board for three years. Chapter activities also include participation on the Design Committee for the past several years, and, as a member of the Chapter office space design team, presenting us with beautiful new quarters.

McCurry is a partner in the firm Tigerman Fugman McCurry whose projects have won several Chapter design awards. In 1984 the firm was presented with a National AIA Honor Award for the Tigerman/McCurry residence in Michigan, which earlier was awarded a Distinguished Building Award by the Chicago Chapter.

Her work has been exhibited at the Art Institute of Chicago and has appeared in numerous major national design publications including *The New York Times*, *Architectural Record*, *Progressive Architecture*, and *House & Garden*. She has served on several design juries including the National Endowment for the Arts Design Grants Jury.

In 1986 McCurry was named to receive the Loeb Fellowship in Advanced Environmental Studies from Harvard University Graduate School of Design.

Commission on Chicago Historical and Architectural Landmarks, is chairman of the CCAIA Historical Resources Committee, and a Director on the Board of the Landmarks Preservation Council.

He is an appointed member of the National AIA Historic Resources Committee and a member of the Friends of Terra Cotta National Board. He is an invited participant on the Secretary of the Interior's symposium on Standards for Rehabilitation of Historic Structures.

Hunderman is a consultant at Wiss, Janney, Elstner Associates. Formerly a Principal of Hasbrouck Hunderman Architects he was the restoration architect on the Rookery Building, the Dana/Thomas House in Springfield, and the Cape Hatteras Lighthouse in North Carolina.

Hunderman has lectured on technical and aesthetic problems of architectural preservation and is the author of several papers on terra cotta and plaster conservation. He received his Master of Architecture degree from the University of Michigan.

Director - 3 Years Anders Nereim, AIA

A partner in the firm Stuart Cohen and Anders Nereim, Architects, Nereim is also Assistant Professor of Architecture at the University of Illinois-Chicago. He received his Bachelor of Architecture from UIC with honors and highest distinction in design.

His work has been exhibited in galleries and museums internationally and his paintings and drawings are in the collections of the Art Institute of Chicago, the Deutsches ArchiteKturmuseum, and the Chemical Bank. His firm was presented with a 1984 CCAIA Distinguished Building Award. He has written for *Progressive Architecture*, *Inland Architecture*, *Skyline*, and the *Journal of Architectural Education*.

Nereim has been a Visiting Professor at the Universities of Pennsylvania, Wisconsin at Milwaukee and Illinois at Champaign-Urbana, and has been a visiting critic or lecturer at a variety of schools, including Harvard, Notre Dame, and Catholic University. In 1982 he participated in the symposium "Romantic Rationalism" at Rice University, along with Rudolpho Machado and Ralph Lerner.

He is a member of the National AIA Committee on Design, and was a charter member of the Chicago Architectural Club.

Treasurer Sherwin Braun, AIA

Braun, partner in the firm, Braun Skiba, Ltd., is completing a two-year term on the Chapter Board of Directors as a delegate to the Illinois Council.

Maddox is principal of the firm Eva Maddox Associates, founded in 1975. She is a member of the CCAIA Interiors Committee and is completing a one-year term on the Board of Directors as Associate Director.

She is a member of the Architectural Society of the Art Institute of Chicago, the Chicago Architecture Foundation, the Chicago Association of Commerce and Industry, and the Chicago Women's Forum. Maddox was the recipient of the YWCA 1983 Outstanding Achievement Award and has exhibited in the Chicago Historical Society's Women in Architecture and the Museum of Science and Industry's 1985 Interior Architecture Awards shows.

She has lectured and taught at a number of local schools of design including that of the Art Institute.

Illinois Council Delegates Kristine Fallon, AIA

Fallon, who received her Master of Architecture from Virginia Polytechnic Institute and State University, has served on the Chapter Board of Directors as vice president since 1985, and is widely recognized in the computer field.

She is President of Computer Technology Management Inc., a consulting service of the A. Epstein Companies, whom she joined in 1984 as Director of Computer Graphics. Prior to her association with A. Epstein, Fallon was Manager of the Chicago Computer Group at Skidmore, Owings & Merrill. While at SOM she provided assistance on 40 projects in the use of such computer techniques as design analysis, three-dimensional modeling and presentation, working drawing production, and software customization for quantitative studies.

She has made presentations to A/E/C Systems '86, the Automated Design/Drafting Users Association 1986 Fall Conference, the Third Annual International Forum on Micro-Based CADD, and the 1985 AIA National Convention. She has been interviewed by *Inland Architect* magazine and has co-authored several articles.

As a member of the CCAIA, she has served as Chairman of the Computer Committee and planned and coordinated the Designing for the Electronic Office Conferences. She has served Chicago Women in Architecture as both vice president and president and is currently International Chairman of Automated Design/Drafting Users Association (Auto-trol Users Group).

Lee Weintraub, AIA

Weintraub began his affiliation with the Chapter as a Student Affiliate Member in 1983, moved into Associate membership three years later, has now obtained his license to practice architecture, and recently became a full AIA member.

He is presently chairing the Student Affairs Committee which has been under his direction since 1985. In 1983 he was Chairman of the Chicago Awards — the annual student competition held in conjunction with the Distinguished Building Awards.

A project architect at Jack Train Associates Weintraub received his Bachelor Architecture from the University of Illinois at Chicago.

Robert Clough, AIA

An associate in the firm, Loebl Schlossman and Hackl, Clough is Director of Finance and Administration. He is currently serving a two-year term as CCAIA delegate to the Illinois Council and beginning with January of this year he assumed the ICAIA Board position of treasurer. Also at the State level he coordinated the 1986 Illinois Council Annual Conference.

Most recently at Nagle Hartray, he was an associate at the firm, working as designer and project architect.

Decker, who received his Master of Architecture from the University of Illinois-Chicago, has taught design at UIC, IIT and the University of Wisconsin at Milwaukee. He has served on competition juries for the Columbus and Wichita Chapters, in addition to being Chairman of the CCAIA 1984 and 1985 Chicago Awards, and he has been published in Inland Architect and the Chicago Architectural Journal.

His work has been exhibited at UIC, Barat College, Grinnell College, University of Virginia, and most recently in the "Five Young Chicago Architects" Exhibition at the Merchandise Mart. Chapter Offers Roche Traveling Scholarship

Three Awards to be Presented

Each spring the Chicago Chapter, AIA Foundation presents three \$500 scholarships for architectural study in the U.S. or abroad.

Funded by a trust set up in 1926 by Martin Roche, the scholarships are awarded to: a graduate of the architecture program of either the Illinois Institute of Technology or the University of Illinois at Chicago; an undergraduate enrolled in the architecture degree program at the University of Illinois at Chicago; and an undergraduate enrolled in the architecture degree program at the Illinois Institute of Technology.

Recipients of the 1987 Roche Scholarship must commence study on or before September 1, 1987, and the duration of the trip must be a minimum of three weeks. Upon completion of the trip, and within three months of return, recipients must submit a typewritten report to the Chicago Chapter Foundation. This report will consist of a synopsis of the areas visited and the recipients' impressions of the architecture. In addition, recipients are expected to make brief presentations at one of the regularly scheduled Chicago Chapter Board meetings.

'86 Winner Reflects on Journey

With the funds provided me by the Martin Roche Travel Scholarship, last summer I undertook a three-week study tour of Northern Italy. The focus of my travels and studies was to explore in detail the Early Christian monuments of Ravenna.

After the proclamation of Christianity as the official religion of the Roman Empire by Constantine in 313, numerous new churches were built commemorating the life of Jesus Christ. While these churches exhibited a great degree of variety in construction methods and subtle plan variations, they all conformed to a basic type which became known as the basilica. Ravenna contains a number of fine

Other cities visited during my travels included: Venice, Verona, Asolo, San Gimignano, Siena, Florence, and Milan. Before returning home, I spent several relaxing days in the mountainous beauty of Italy's Lake Region. For any young architect, the ability to travel and experience first hand other cultures and their architecture is among the greatest of all opportunities, and I would like to thank the Chicago Chapter of the American Institute of Architects once again for providing me with this enriching experience.

Illinois Council Report

1987 Board Installed

1987 marks the 10th anniversary of the reorganization of the Illinois Council, which resulted in the ICAIA moving to Springfield from Chicago and focusing on government affairs. The Board meets bi-monthly and includes representatives from each of the seven chapters in the state. The Chicago Chapter is represented with five delegates: Sherwin Braun, Robert Clough, Frank Heitzman, Brian Robertson, and Jim Stefanski. The other chapters each have one representative.

The new Board had their first 1987 meeting on January 16 with the following new officers: President, Dennis Calvert, from the Southern Chapter; President-Elect, Don Walton, from the Central Chapter; Secretary, Less Larson, from Northeast Illinois Chapter; and Treasurer, Robert Clough, from the Chicago Chapter.

1987 Legislative Agenda Set

The Legislative Agenda for 1987 was established at the January Council meeting. Two prominent issues for the current legislative session will be a proposal to amend the Workers Compensation Act and a movement to institute a state professional services tax.

The ICAIA will be working in coordination with the Illinois Society of Professional Engineers to amend the Workers Compensation Act following a model change enacted in Florida last year. The amendment would provide construction design professionals with immunity from liability for injuries to workers resulting from an employer's failure to comply with safety standards. It is hoped that this amendment will be introduced this session.

Governor Thompson is seeking to resolve spending pressures at the State level through the institution of a tax reform which most likely will result in the service sector bearing an increased share of the tax burden to avoid placing a greater burden on the State's smoke stack industries.

One suggested vehicle for accomplishing this objective is a professional service tax. ICAIA will be monitoring developments on this issue closely, and will join with other service and professional organizations to fight such a tax should it be included in the tax package.


Proposals to amend the Environmental

Barriers Act are being formulated to eliminate areas of concern, such as the requirement of redundant certification by the architect.

The State Procurement Act is expected to be introduced again this session. The act includes a section dealing with the

procurement of architectural services which can be cited as a model for use by municipalities and other organizations.

Other proposed legislation which will be monitored includes a proposal by the landscape architects to register their profession and a proposal by the

Preservation Watch

The CCAIA Landmarks Task Force continues to look into landmark designation issues and the procedures of the Commission on Chicago Historical and Architectural Landmarks (CCHAL).

Restore McCarthy Bldg. on Present Site — CCAIA

A development proposal for Block 37 has been of major concern during recent weeks. Development guidelines included in the original proposal specified restoration of the historic McCarthy Building (a National Register property and Chicago Landmark constructed in 1872) on its present site. At the December meeting of the CCHAL, the Department of Planning and the developers presented a proposal to move the McCarthy Building facades to the northeast corner of the

same block to make way for a new development.

At the January 15 CCHAL hearing, numerous groups and individuals testified on behalf of preservation of the McCarthy Building. Ed Uhlir, Chicago Chapter, AIA President, testifying on behalf of the CCAIA Board of Directors, commented that "the CCAIA strongly recommends that the redevelopment guidelines be respected, and that the McCarthy Building be restored as an independent structure on its present site."

Chapter Very Visible at Recent Hearings

On January 28, a hearing was held on an easement agreement proposed by the Department of Planning and the developers. Testimony was given by John Syvertsen on behalf of the CCAIA Board of Directors, and by the Landmarks Preservation Council of Illinois (LPCI),

In 1985, the CCHAL and LPCI prepared a series of amendments to the Chicago Landmark Ordinance. These amendments were endorsed by a coalition of civic groups, neighborhood organizations, the Mayor, and the Chairman of the City Council Committee on Historical Landmark Preservation. A hearing to review the proposed amendments was recently held before the City Council on January 23, 1987. I testified on behalf of the CCAIA Board of Directors supporting acceptance of the amendments as drafted with some minor suggestions for improvements. Another meeting before the City Council Committee took place on February 5.




