

### Art Institute to Present Major **Architecture Exhibit**

Chicago Architecture: Ten Visions, opening on November 26 in the Art Institute's Regenstein Hall, will feature one of the most innovative exhibit installations in the museum's history. Within a master plan designed by Stanley Tigerman, FAIA, ten architects are each curating and designing a mini-exhibition of approximately 21 by 21 feet square. Visitors will pass through the spaces in a linear sequence to an interactive area where they can pick up telephones to listen to the architects' commentaries and record comments of their own.

Each architect was asked to define an issue important for the future of Chicago and create a "spatial commentary" on that theme. The issues they chose include affordable housing, regional planning, the impact of the information age on the city, and the shifting definitions of real and virtual space.

### "Rolling Clock" to be **Implemented for the ARE**

The National Council of Architectural Registration Boards (NCARB) has officially created a "rolling clock" standard

for the Architectural Registration Examination (ARE). Effective January 1, 2006, candidates for the ARE must pass the nine-division exam within five years.

Three transitional rules will apply. Applicants who have passed all divisions of the ARE by January 1, 2006. regardless of the time taken, will have passed the ARE. Applicants who have passed one or more but not all divisions of the exam by January 1, 2006 will have five years to pass all remaining divisions. Applicants who have passed no divisions by the January date shall be governed by the new five-year requirement. The five-year period begins on the date when the first passed division is administered. ### Chapter's Environment PIA Signs Agreement with City Department

The highlight of the Green Holiday Get-Together on December 14 will be the signing of a Memorandum of Understanding (MOU) by the AIA Chicago Environment PIA and the City of Chicago Department of the Environment. This will be the third MOU for the two entities. It mirrors an agreement at the national level between the AIA Committee on the Environment (COTE) and the U.S. Environmental Protection Agency, but is the only one in the country that exists between a local AIA chapter and a city agency.

The first memorandum was signed in September 1999 and results have included the creation of the Chicago Center for Green Technology as well as educational programs such as the Urban Agriculture Charette and the Chicago Green exhibit at the Chicago Architecture Foundation.

### Book on North Shore Houses Co-authored by Local Architect

Acanthus Press has published *North Shore Chicago: Houses of the Lakefront Suburbs 1890-1940* by Stuart Cohen, FAIA and architectural historian Susan Benjamin. It is the first detailed history of the residential

architecture of the North Shore, and is illustrated with over 350 duotone photographs and floor plans, many published for the first time. More than 40 houses are examined in detail, with a greater number illustrated in the portfolio section at the back of the book. An appendix provides biographies of 42 architects and their firms.

Another new publication from Acanthus is *Chicago Apartments: A Century of Lakefront Luxury* by Neil Harris of the University of Chicago. It profiles almost 100 buildings and includes work by recent practitioners such as Lucien Lagrange, AIA and Solomon Cordwell Buenz as well as dramatic interiors by firms such as Booth Hansen, Krueck & Sexton, and Tigerman McCurry.

Much of the publication is devoted to reinforcing security in public spaces, such as federal buildings and parks, and it includes an overview of FEMA's newly published Risk Management Series, which provides building design guidance for mitigating potential terrorist attacks.



### **Emerging Professionals:** Bridging the Gap Between School and Practice

**Case Studies: What Firms Do for Their Emerging Professionals** 

he journey from architecture graduate to licensed architect is full of challenges. Emerging professionals (formerly called interns) will be most successful if they find a firm that is supportive of their specific goals and needs. Here are views of what

some local firms are doing to help their employees navigate the path to licensure.

### **Cannon Design**

The 28-person Chicago office of Cannon Design, a national firm with more than 600 people, offers a variety of programs to help emerging professionals become licensed architects. Beginning with a thorough orientation for new employees, Cannon allows interns to choose their mentors, offers internal education, maintains a study guide library, pays for exams and pays for the time to take the exams.

"Young people have questions and are sometimes reluctant to ask someone higher up, so they miss out on getting informed answers," says Richard Carlson, AIA, principal of the Chicago office. "In fact it is to our benefit to give interns the advantage of the knowledge of senior people."

Cannon is experimenting with an intensified mentoring program. Chicago is one of two pilot locations for the special Fellowship Program, in which emerging professionals partner with an architect in a specific field of practice to deepen their understanding of the market. Carlson says, "Many young architects want to have a broad base of experience and after 10 years or so specialize in a certain area. We have people with three or four years of experience who are focused on the healthcare market and want to intensify their training."

Carlson notes that many of the offices' emerging professionals have opted to gain LEED certification. You do not have to be a licensed architect in order to take the LEED tests, and the timed



exams are similar to the Architectural Registration Exams, so they provide experience with the testing process.

Once emerging professionals pass all phases of the licensing exam, they are given an immediate salary increase that does not diminish the amount of their raise at their annual review.

### RTKL

RTKL's intern development program is being enhanced with a new companywide mentor program undergoing a pilot test in Chicago. Keith Campbell, AIA, vice president, says that an internal survey revealed that employees desired more structured opportunities for career path development, knowledge transfer, progress evaluation and other systems that could be addressed, in part, with a formalized mentor program.

For four months, the 35-person Chicago office, which includes eight emerging professionals, is testing professional and personal interest forms, evaluation forms, time requirements and other issues with the mentor program. Company-wide roll out of the program

will begin in January 2005. Company officials use the interest forms to help determine which volunteer mentors would be an appropriate match for each protégé, who then has the opportunity to accept or reject the suggested mentor.

The mentor program is open to all members of RTKL and Campbell says that more than 50 percent of the emerging professionals in the Chicago office have entered it.

Other elements of RTKL's intern development program include a companyfunded study guide library, payment of all architectural registration exams that are passed, a formal construction documents class that is popular with new interns, and informal clubs for activities such as drawing.

One of the most unusual programs is a design competition intended to give young staff members experience in a setting with client input. Each of RTKL's eight international offices is sending a two-designer team to company headquarters in Baltimore to participate in a two-day competition for a proposed residence hall at the Maryland Institute College of Art. The Chicago office opted to send two interns who will present their design to a jury that includes members from the potential client.


Campbell says that in addition to creating schematic designs for a project and having client-level interaction, the participants meet other emerging professionals, see the headquarters and develop a better understanding of the firm.

### **Holabird & Root**

Holabird & Root has an informal but intensely focused approach to emerging professional development, according to principal Greg Cook, AIA, who has the responsibility of training recent graduates. "The IDP program is good because school does not prepare you for professional service; it is learned 100 percent at the firm," says Cook. He prefers to hire young people and train them to meet company standards rather than retrain existing professionals. Holabird & Root has 71 employees, 37 of whom are educated in architecture. Of those 37, 12 are in the IDP program.

Two recently licensed architects head an informal IDP study group that is oriented to help deal with the stress of the exam as much as the education, according to Cook. Anyone who has recently passed a section of the licensing exam has to meet with those who are about to take that section and relate the attitude and direction of the test. The firm has compiled a library of the expensive study guides from architects who have been licensed and no longer need them. "The group is set up in a manner similar to the



joint study groups at law firms that help people pass the bar exam," Cook says.

Also, licensed architects are assigned to give internal seminars that provide education regarding specific areas of the IDP program and architectural registration exam. (See the June issue of *Focus* for the article that Cook developed from his construction management seminar.)

During annual salary and performance reviews, Cook determines what specific areas of practice emerging professionals need to fulfill their IDP requirements. Future assignments are then adjusted to assure the hours of experience are fulfilled. Cook says that inevitably, The Truman State University Fine and Performing Arts Center by Holabird & Root

construction management and cost estimating are the areas where emerging professionals need more hours.

"Construction management is not a school field trip; they are the owner's representative," Cook says. "I won't let them go on a site until they know to speak with a contractor, because if you say the wrong thing, you can adversely impact the project."

### PROJECTS


The Regenstein Center for African Apes at the Lincoln Park Zoo, designed by **Lohan Caprile Goettsch Architects**, opened to the public on July 1. 


