## President's Message:

## AIA COLORADO NAMES JOHN B. ROGERS, FAIA ARCHITECT OF THE YEAR

John B. Rogers, FAIA, one of the founding principals of RNL Facilities Corporation was named the Architect of the Year by the AIA Colorado. John's long, distinguished career began 45 years ago, when he had his own practice in Cherry Creek. Several years later, he joined with Jerry Nagel, and in 1966 the two teamed with Vic Langhart to form Rogers, Nagel, Langhart, now RNL Facilities Corporation.

A sampling of some of their projects include: extensive work for Mountain Bell, now US West; the Colorado State Judicial Heritage Center; the Career Education Center; the Solar Energy Research Institute; an addition to the US Mint; an addition and interiors for the ROCKY MOUNTAIN NEWS; interiors for Concourse "A" at Stapleton International Airport; the World Headquarters for the Manville Corporation; Ball Aerospace Manufacturing Center; and most recently, the First Christian Church in Longmont, Colorado.

After forty-five years of being project principal, as well as participation on numerous AIA local and national committees, John Rogers was very pleased to receive this award. Keeping the secret was not easy, but John's three sons joined the celebration at the 1991 Colorado Design Awards presentation. They are truly proud of their dad.

## ADA: A Resource Guide:

This collection of introductory information helps you form a strong foundation upon which to build your ADA education. Included in the manual are sections on the law, ADA employment policies, information on additional resources and educational opportunities, as well as a section to organize your ADA information from other sources. You'll find such information as copies of the 1990 ADA law, Title III regulations and guidelines, a list of compliance dates, highlights of ADA Title II (state and local government) and Title III (public accommodation), disability terminology, tips on interviewing disabled employees, and ways to manage the liability risks of complying with the ADA. The manual also provides 1990 IRS information and forms on tax credits for removal of barriers and contact information for key government agencies that provide ADA information.

## ADA Compliance Guidebook:

A checklist for your building: The AIA Special Edition for the ADA Compliance Guidebook was developed by The Building Owners and Managers Association (BOMA) International to assist building owners, managers, and their architects to comply with the American with Disabilities Act, Title III regulations and to address accessibility to buildings. The checklist references specific sections of the ADA guidelines, names the area to study, discusses the requirements, and provides an area to sketch or make notes. It also includes an overview of the ADA and discusses special points of interest in the ADA to architects including alterations to historic properties, disproportionate costs, barrier removal, good faith efforts, and tax deductions.

## MAILING LIST POLICY

At the December AIA Colorado Board Meeting, the following policy was established for sale of mailing lists:

The cost of AIA Colorado mailing labels (approx. 1100) will be \$50 for members, and \$150 for non-members. At least one week's advance notice is required so that the staff can work them into the computer schedule. Pick-up is required or postage will be added to the cost of mailing. A signed statement that the mailing list will only be used once is required, as well as a copy of what will be mailed.



For AIA Colorado chapter's use (Denver, South, West and North), the cost for the state mailing labels will be \$10 (to cover the cost of the labels). Requests for individual chapter mailing lists for that chapter is free upon request. The request needs to come from the chapter president if possible. Again, one week advance notice is required.

## PELLECCHIA OLSON ARCHITECTS EXHIBITION OPENS JANUARY 27

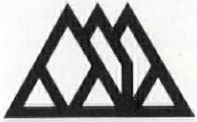
