GAC meets monthly to discuss what's happening with the Colorado Legislature, State Board of Examiners of Architects and sometimes legal and ethical issues of importance to the profession. During the legislative session (January through May), volunteers of the legislative sub-committee meet at 7:30 a.m. each Friday morning to keep on top of the proposed legislation spilling out of the House and Senate.

1993 Design Conference: We need a chair, a program chair and volunteers for all of the subcommittees. FELLOWS TASK FORCE REPORT

The Fellows Task Force, appointed in 1992 by President Kaki Zeeb, has met on four occasions in 1992. The Task Force goal is to increase the interest in the AIA College of Fellows in the coming year.

Colorado has not received any new Fellows for six years, and there have been only a few nominations.

The goal for the Task Force is to create a continuing program to identify candidates for Fellowship so that architects who wish to be candidates can prepare appropriate materials. The Chapter nominating process can then be more consistent, effective and successful.

On June 12th, the Fellows Task Force met and reviewed material submitted from nine candidates for 1993, and have recommended to the Chapters that five of these candidates' achievements appear to be strong enough for consideration for 1993. The Task Force felt that with further projects and a directed effort, the other candidates who submitted material would also be qualified.

In addition, the Task Force wishes to encourage architects in Colorado who believe they are ready for consideration to become candidates, and encourages the Chapters to build a backlog of eligible candidates for future years.

Colorado South Chapter

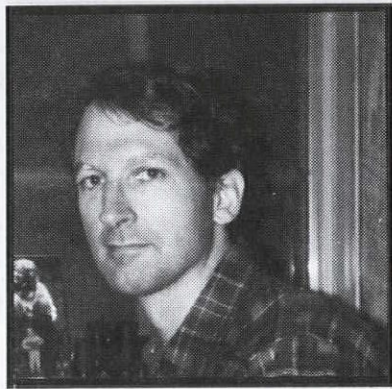

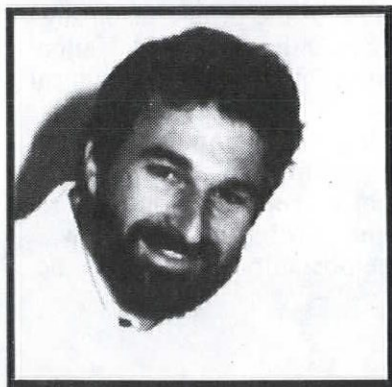

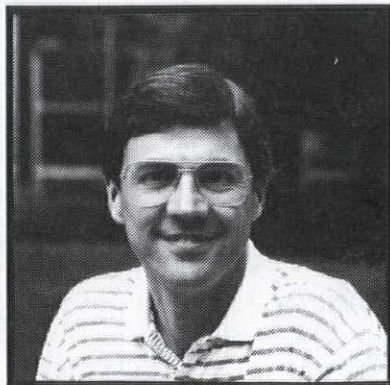
wildlife related issues. He holds a M.S. in environmental interpretation from the College of Forestry and Natural Resources, Colorado State University.

in Engineering and a M.S. in Civil Engineering from Stanford University.



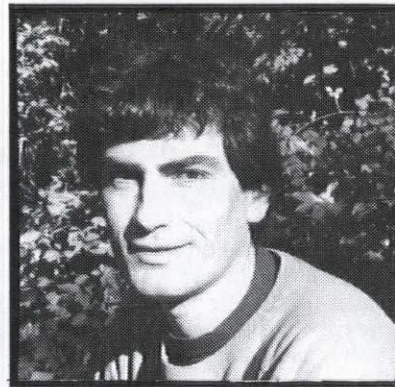
"Environmental Quality Management in Design"

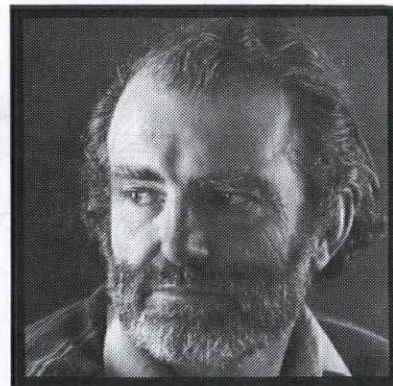

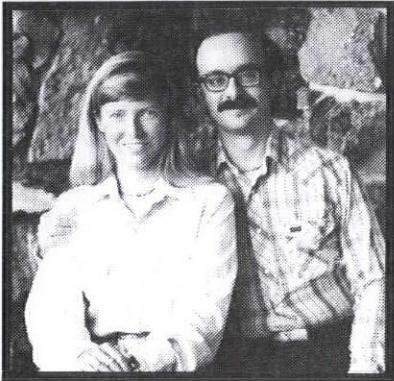
"Organic Form"

"Earthships"

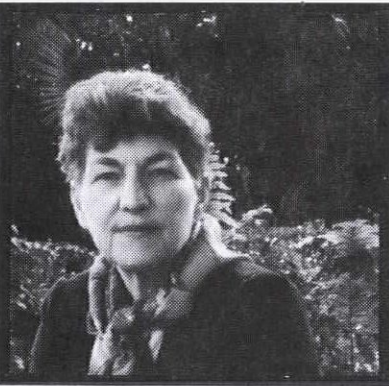

He holds a Bachelor of Architecture Degree from the University of Cincinnati and is licensed to practice architecture in New Mexico and Colorado.

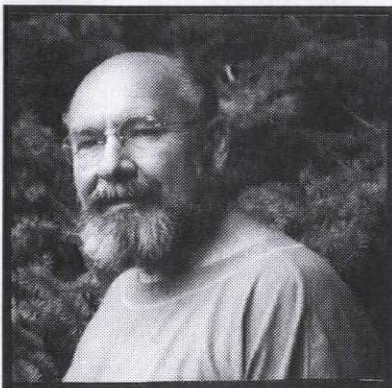
and global security. RMI's 40 plus staff explore the links between energy, water, agriculture, security and development.

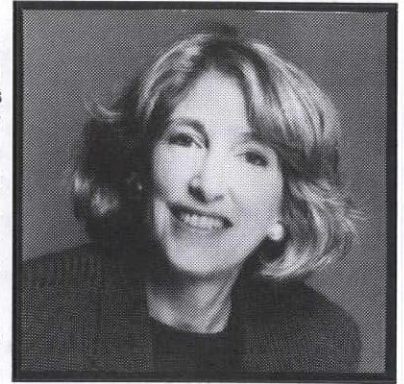
sionals and the public on sustainable design strategies for the preservation and productive use of the earth's resources.



"21st Century: A Golden Age for Architects"

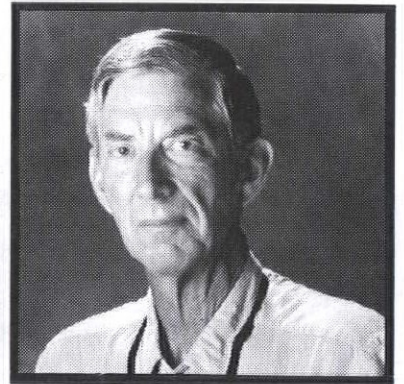

"Where Are We Going?"

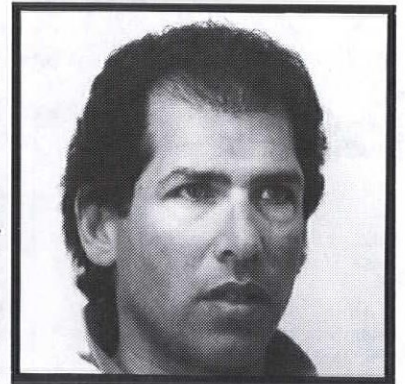

NEW AGENDA FOR AIA/C TASK FORCE ON THE AMERICANS WITH DISABILITIES ACT OF 1990

The Task Force was restructured last month to focus our efforts for the balance of the year on five goals approved by the Board of Directors.

- 1. Fund Raiser/Conference**
This group is planning a major event, which is likely to be a Fall conference held in metro Denver to help establish a bridge between design professionals and the disability community. Event income will help fund Carriage House accessibility alterations. Chairmen: Peter Orleans, and Roy Perlmutter, AIA).
- 2. State/Local ADA-Certified Codes**
Owen Leslie, AIA, Fred Harris, AIA and Roy Perlmutter, AIA, are researching the existing State handicapped access law and developments in ICBO's UBC to find an expedient way to promote ADA-certified local codes in Colorado, thus minimizing the conflict between ADA and local codes.
- 3. Readily Achievable White Paper**
Part of our group is working on a document which is intended to deal with the thorny question: how far can an architect's responsibility go in preparing his client for the Readily Achievable decisions? Chairman: Kris Kostolansky.
- 4. Disability Community Contacts**
Tia Jenkins, AIA, is researching Colorado accessibility consulting counterparts of AIA National's accessibility resource list.
- 5. Carriage House Accessibility**
John Canady, P.E., Steven Walsh, AIA, and D. A. Bertram, AIA, Esq. are completing an ADA Barrier Survey of the Carriage House property for the AIA/C Board of Directors.

If you are an AIA member and are able to volunteer a small amount of your time between monthly meetings to assist in advancing one of the above efforts, please join us! We meet typically on the last Wednesday of each month from 3-5 PM in the Carriage House.

1992 AIA Colorado Centennial Design Awards

CALL FOR ENTRIES

To encourage excellence in architecture, AIA Colorado seeks to honor works of distinction by its members and to bring to public attention the outstanding architectural services provided by its members and to their commitment to the preservation of the environment. All entries shall be completed works of architecture, either a building, or a complex of buildings and related spaces, designed by members of AIA Colorado and executed in any location throughout the world. With the exception of previous award winners, any previous entry of this program may be resubmitted. Projects which have won awards in other programs are eligible for entry.

Each entry in the Design Award program, regardless of size or classification, will be judged individually on the basis of total design merit. The type and number of awards given will be decided upon by the jury. Slides of the award winning projects and presentation of the award certificates will be part of the Award Ceremonies at the AIA Colorado Centennial Design Conference on October 10, 1992 at the Snowmass Conference Center. In recognition of this year's conference theme, "Man in Harmony with Nature," a special awards category will be introduced to acknowledge architecture that demonstrates a sympathetic co-existence between building, site and the environment as a whole. This year's jurors will be W. Cecil Steward, FAIA, Dean, University of Nebraska; Roger Baalman, AIA, Director of Facility Planning, University of Wyoming; and Kendrick Kellogg, Architect. This year's design award chairman is Todd W. Crowe, AIA, Crowe Architects, AIA.

All entries must be submitted in the binder which will be supplied to each entrant on receipt of the entry form and fee. Additional details and entry information will be mailed with the binders. The Submittal Binders are due on August 30, 1992.

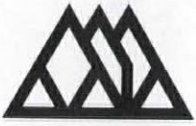
