Integration of IDP into the University of Colorado

On October 14, at the College of Environmental Design in Boulder there was a discussion on the importance to the students of the Intern Development Program ("IDP"). John Maas, who is on the Board of Examiners of Architects, spoke to the students about education, interning, licensing and careers. Needless to say, the students were interested and yet astonished by the time and effort required to someday call themselves "architects." The truth is that regulations are becoming very strict, and trying to figure out how to go about becoming licensed has thoroughly confused many of those pursuing architecture as a career. Through a series of explanations about the examination, graduate school, Colorado state regulations and where our school stands as a accredited program, the students learned a lot about where they stand in the process of licensing. Keith Hayes, Intern AIA and Steven Walsh, AIA, the present and past IDP State coordinators explained how IDP works. This was probably the most beneficial information because it gave the students direction in how next to pursue their career.

For those not familiar with IDP, it is interesting to note that it is still not required in the state of Colorado. In most states however, about 75% of them, it is necessary to use this program in order to record work experience before taking the examination. It is estimated that in the near future of about two years it will be required of all states to use IDP. The College of Environmental Design in Boulder has a unique situation in that it is a pre-professional program linked to the University of Colorado-Denver, which is up for accreditation this year. This means that students from Boulder have to be accepted to graduate school with advanced standing in order to use their earned value units. For many, this is unsettling because they are not assured that the units that they earn will be credited towards the examination.

The experience that IDP contributes to the student is very beneficial. The program provides interns with a comprehensive view to the field of architecture. Through participation, experience is acquired and recorded, and the chance to meet more people in the field is increased. Also, those students that join IDP have a ten percent better chance of passing the examination than those that do not participate in the program.

The response to the program at the lecture was very good because students really had no previous exposure as to how to attain licensing. In fact, most students thought that you did not need to be licensed in order to practice architecture - surprise, surprise! The goal is to encourage the students to start IDP as soon as possible after their third year of college. After all, it is our future, and IDP has good things to offer.

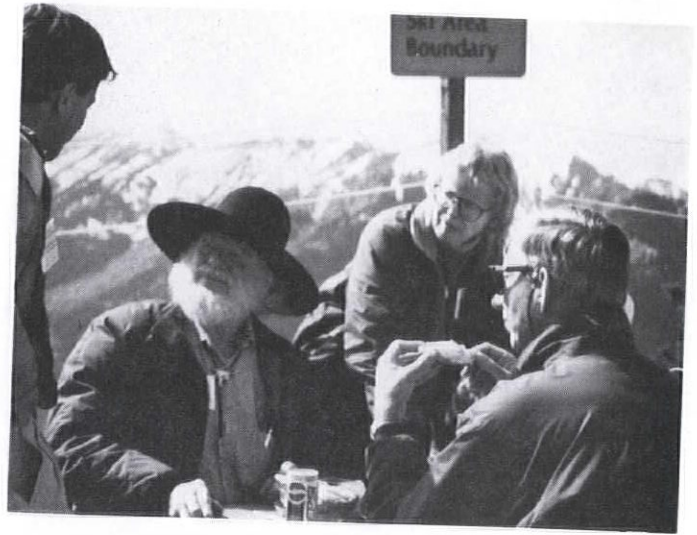

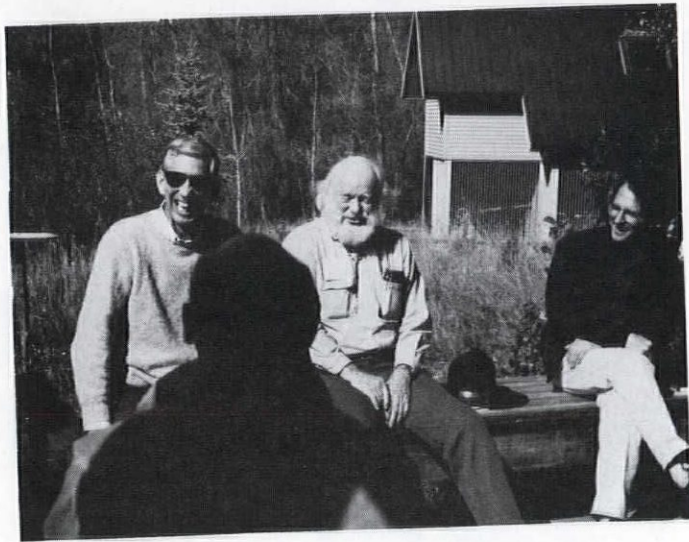

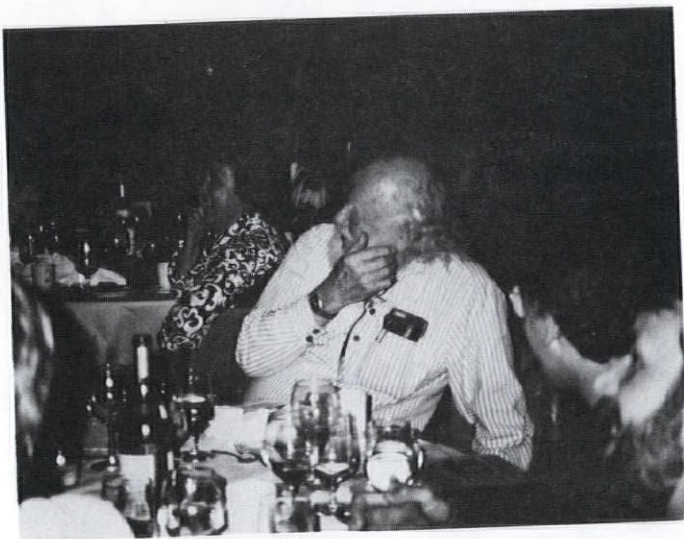

WE, AS COLORADO ARCHITECTS, CAN CONTRIBUTE NATIONALLY AND MAKE A DIFFERENCE

Jim Cox, AIA, 1992 Design Conference Chairman

The Design Conference this year "Man in Harmony with Nature," celebrating 100 years of AIA in Colorado, was a success. My hat goes off to Sam Caudill, FAIA who, as program chairman, adeptly selected our speakers. Sam was also the catalyst for the wonderful slide presentation we saw on the Anasazi Indians. National AIA, represented by our president W. Cecil Steward, FAIA and president-elect Susan A. Maxman, FAIA were so impressed with our program that portions of it will be used at next year's national convention in Chicago. Yes, as Colorado architects, we can contribute nationally and make a difference.

But more than that, Sam provided AIA Colorado with a conference theme, "Man in Harmony with Nature," that we can build upon and use in future years. This year we centered around the mountains. Colorado is unique. We have so many ecosystems. Our problem is how to meet the needs of a fast-growing population without damaging a beautiful but increasingly fragile land. Do we want to repeat what has happened in California? Or do we want to address how man can live in harmony with nature? This is not just a Colorado problem, but a world-wide problem that, because of our variety of ecosystems, we can help the world address. We have lessons to learn from the Anasazi. Let history not repeat itself and have us disappear as the Anasazi did.

Future programs, using the same theme "Man in Harmony with Nature," could focus on urban areas, rural areas, the prairies, the plains, the plateaus, the mountains, the front range, the limited supply of our natural resources, etc. We could send mailers to all major universities, AIA components, major corporate businesses and governmental agencies who have a vested interest in our environment. Continuing the high caliber of this year's conference by dealing with the urban environment, and a mailing to the entities mentioned above, could significantly increase our attendance (more income for AIA Colorado) and demonstrate that we, as architects are concerned with our environment. I enjoy working together with my colleagues, and we must provide a vehicle so that we can continue

to do this. But, we must stop looking inward and reach out to include the other design disciplines -- engineers, sociologists, psychologists, government officials and the public -- to include the people who are or who may some day be our client.

We also need to look at the criteria we use for the AIA Colorado Design Awards. Admittedly, I may be overly sensitive on this issue because of two recent experiences. In the past three years, I have been asked to look at two architectural projects that received AIA Honor Awards. They are beautiful projects, but for the client they don't work. One leaks excessively. The other one cannot afford the heating bill and they are seriously considering tearing down the facility - even though it is an honor award building. In visiting with both clients they expressed concern that if the buildings they have are the best the architectural profession can provide, why should they talk to an architect again? They indicated to me they are considering retaining an engineer to correct their present problems. THESE ARE HONOR AWARD WINNING BUILDINGS AND THEY ARE RELUCTANT TO TALK TO AN ARCHITECT AGAIN! One is a financial institution and the other is a church. Can you imagine the discussion about architects at the bank's board meeting among leaders of the community? Or among the 600 members of the church congregation?

I do know that many of us who have received honor awards have happy and satisfied clients. But I still find there is a credibility issue among the general public when it comes to our honor awards. Some people I have talked to say that it borders on incest.

We need to open up our design conference and our awards to show the public that we not only care about aesthetics, but we also care that the buildings we design are technically sound and functional for their intended use.

Opening up our conference and our awards jury to the general public would go a long way to making us more responsive to the public. Why not have half of our jury made up of non-architect type people? Why not ask the client/user to submit their impressions of the building that is being considered for an award? Why not require a waiting period of three years before you can submit for an award, and let the time to receive an award be limitless? After all if a building is technically and functionally sound for ten years shouldn't that speak higher than if it hasn't had but a few years under its belt to see if it can successfully stand the test of time? Are we so caught up "fashion" that three years outdates a building that is to be around 50 years or more? We need to develop a sustainable architecture if we, as architects, are to be stewards of our land and have the trust and respect of our clients - if we don't, another profession will fill that void. As caretakers of the environment, design professionals can no longer ignore the impact of our interventions. Sam gave us the vehicle to establish our credibility. Now I say, let us get on with it!
