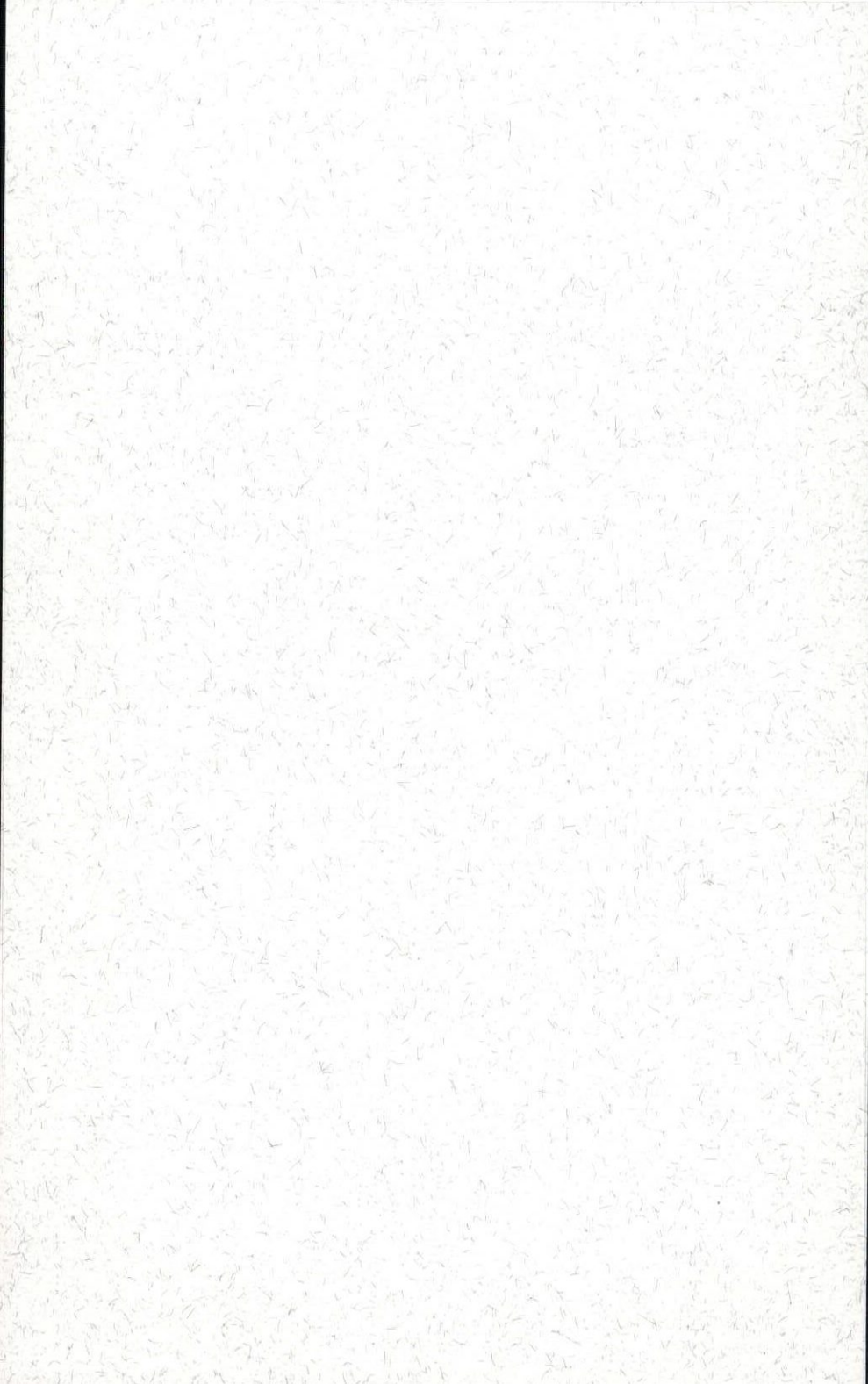

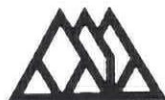

## AIA COLORADO BOARD OF DIRECTORS

The Board of Directors is the governing body of AIA Colorado and develops all immediate and long term positions and policies for the state. An important note to members is that there is a permanent item on the Board's Agenda entitled "Membership Input." This item is reserved for any member to address the Board on a subject of concern. Call the AIA Colorado office by the 10th of each month to schedule a time for you to offer your input to the Board. AIA Colorado board meetings are open to all members and are held on the 3rd Friday of each month at 2:00 p.m.

# COMMITTEES & TASK FORCES

## Government Affairs

**Chair: Thomas McKenzie, AIA**

This committee meets at the Carriage House on the second Friday of each month at 2:00 p.m. to discuss matters relating to the State Board of Examiners of Architects and legislation at the federal and state levels. During the 120 day Colorado legislative session, the Legislative Sub-Committee meets at 7:30 a.m. each Friday morning to screen and discuss potential legislation which could impact the profession of architecture. Jerry Johnson (a lobbyist with Colorado Legislative Services) assists AIA Colorado in this monitoring process. The 1993 session of the Colorado Legislature will run from Wednesday, January 13th through May 12, 1993.

## 1993 Design Conference Committee

**Chair: Ron Mason, AIA**

This committee is responsible for the planning and execution of the annual AIA Colorado Design Conference. Its chair is appointed by the President-Elect of the year prior to the year of the conference. (We must always plan far in advance for this one). The 1993 Design Conference will be held on December 3 and 4, 1993 at the Broadmoor Hotel in Colorado Springs. The 1992 Centennial Design Conference, inspired by the theme "Architecture/Environment: Man in Harmony with Nature" and the beauty of the Snowmass /Aspen area, was thought-provoking and an overwhelming success according to the members and exhibitors who attended. The 1993 Design Conference committee is working on a theme and will begin inviting speakers to carry out that theme. Participation from members is welcome and necessary for the conference's success.



## **1993 Design Awards Sub-Committee**

The Awards Committee develops guidelines for the design awards program, recommends the jury to the Board of Directors, designs the entry form for the awards program and coordinates the entire process from announcing the award winners to presenting slides of the winning entries at the annual Design Awards Dinner. This committee (appointed by the Design Conference Chairman) welcomes input as to potential jurors or improvements in the program format.

## **Finance Committee**

**Chair: Chick Lee, AIA**

This Committee is responsible for the financial well-being of AIA Colorado. The committee develops long-range financial goals plus makes recommendations to the Board regarding budgets and other areas of financial planning. Membership dues, annual Design Conference, and document sales generate the revenue necessary for the operating budget of AIA Colorado.

## **Nominating Committee**

**Chair: John B Rogers, FAIA (1993 President-Elect)**

This committee is composed of at least five (5) AIA Colorado architects, selected on the basis of one representative from each AIA Colorado chapter (appointed at the June Board Meeting by the Board of Directors) and chaired by the current President-Elect. The Nominating Committee recommends at least two (2) nominees to run for each officer's position on the AIA Colorado Board of Directors by August 15th of each year.

## **Long-Range Planning Committee**

The purpose of this committee is to look into the future and envision the course that AIA Colorado should take in terms of generating income, providing state-of-the-art services to its membership and streamlining office structure.

## **Educational Fund of AIA Colorado**

**Kenneth R. Fuller, FAIA**

The Educational Fund awards scholarships and grants to architectural students, faculty members, architects and AIA components each spring. Application deadline for these scholarships is, historically, in March of each year. Approximately \$25,000 is distributed annually by the Fund.

## **Qualifications-Based Selection ("QBS")**

Chair: Karl Berg, AIA

Qualifications-based selection is a process for the selection of design professionals by Public Owners. It is a negotiated procurement process for selection based on qualifications and competence in relation to the work to be performed. AIA Colorado along with Colorado Engineers Council of Colorado ("CECC") and Professional Engineers Council ("PEC") have formed a coalition to achieve quality and cost effectiveness in public projects.

## Task Forces

AIA Colorado utilizes task forces to address specific short-term issues of concern to our membership. Short descriptions of the current task forces follow:

### ADA Task Force

**Chair: Roy Perlmutter, AIA**

This was a Task Force formed in anticipation of and to analyze the ramifications of the 1992 Americans With Disabilities Act. One of the main purposes of this Task Force was to complete an ADA survey of the Carriage House and its access from the street. Colorado Resources: Disabilities and Facility Access is a resource developed by the ADA Task Force and it is available at the Carriage House. The price is \$5.00 for members, plus tax, shipping and handling (\$10.00 for non-members).

### Carriage House Task Force

**Chairman: Dan Havekost, FAIA**

This Task Force was formed to study and make recommendations to the Board on the maintenance and improvement necessary for the Carriage House — the property owned by and housing the offices of AIA Colorado. Maintenance and improvements include: painting, carpeting, and ADA compliance. Some of the challenges faced by the Task Force: obtaining funds; finding suppliers willing to donate materials and labor; and ADA compliance.

### Education Task Force

**Chair: Chick Lee, AIA**

The charge of this task force was to determine a way for the 4-year School of Environmental Design in Boulder and the Graduate School of Architecture and Planning in Denver to either communicate better or perhaps rejoin the two schools. The schools rejoined as the College of Architecture and Planning. The Task Force which is more than two years old is now monitoring the progress of the newly joined schools.

## **Fellows Task Force**

**Chair: John B Rogers, FAIA**

This Task Force is devoted to developing a system and promoting the status of Fellowship for AIA members. Fellowship is the highest honor the AIA can bestow on any member. It is conferred on members with at least 10 years continuous membership who have made significant contributions to the profession. Fellows are entitled to use the designation "FAIA" following their names.

## **SERVICES**

### **Newsletter ("AIA Colorado Field Report")**

**Editor: Linda T. Smith, CAA**

The Field Report is published as a monthly newsletter by AIA Colorado. The Field Report gives members an update on actions taken by the board, notice of events of interest to members (like the Design Conference), announces call for entries (like the Annual AIA Colorado Design Awards), lists resume "short" forms of those seeking employment, publishes committee reports, and reports from the chapters across the state.

### **AIA Document and Publication Sales**

AIA Colorado is a full-service distributor of AIA contract documents and forms. Each member receives a 20% discount on all AIA copyright-protected contract documents and a member price on many books published by AIA. Order forms faxed or mailed to AIA Colorado, accompanied by a check or VISA/MC number, are usually processed on the day of receipt. Or, you may pick up your document orders at the Carriage House.



## **Client Referral File**

Each AIA Member is encouraged to fill out the Client Referral Form mailed out each calendar year with the dues renewals. This form is used for the Architect Referral Service offered to the general public. Many potential clients call us for assistance in selecting an architect or finding a speaker or expert witness and your Client Referral Form is used exclusively for these purposes.

## **Job Referral Service ("Job Board")**

The Job Board is a service provided to members, the architectural community and architectural job-seekers everywhere. Job openings are listed for \$20 per week per listing on the Job Board which is updated every Tuesday afternoon. Posted in a box outside the Carriage House, the Job Board is available twenty-four hours a day, seven days a week (about 100 copies are picked up each week). Job seekers can also subscribe to the Job Board by sending self-addressed stamped #10 envelopes to AIA Colorado (approximately 100 Job Boards are mailed out each week).

## **Design Conference and Exhibition**

The 1993 Design Conference will be held December 3 and 4, 1993, at the Broadmoor Hotel in Colorado Springs. Two days of professional development programs, business meetings, social events, major displays of new products and services, and plenty of peer interaction. Mark your calendar now so you won't miss it!

## **Design Awards Program**

The Awards Program seeks to honor works of distinction by our Members and to bring to public attention the outstanding architectural services provided by the members of AIA Colorado. Design Awards winners are announced at the Design Conference during a special awards dinner.

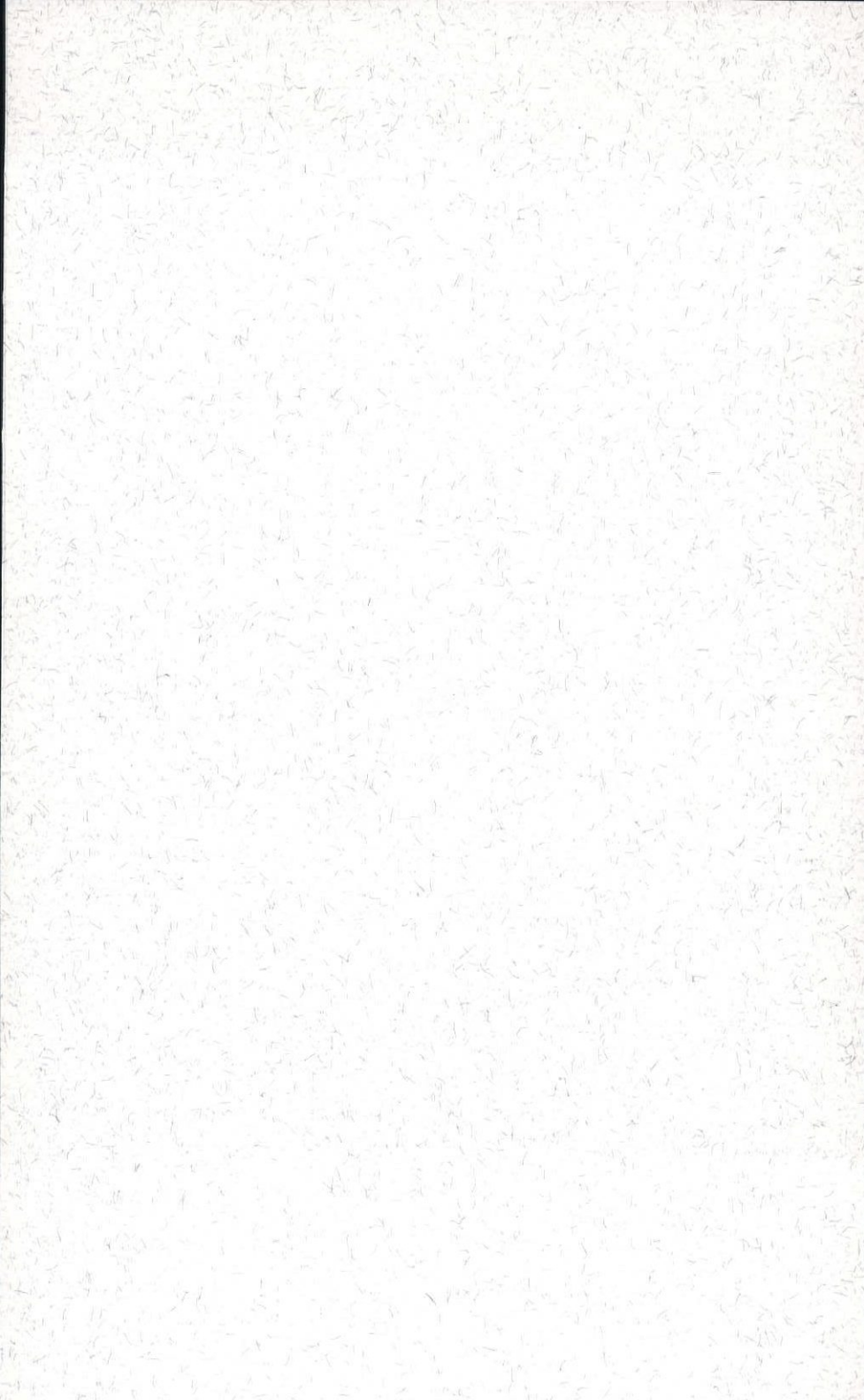
