## THE COLORADO CHAPTER OF THE AMERICAN INSTITUTE OF ARCHITECTS AND THE UNIVERSITY OF COLORADO INVITE PROJECT SUBMISSIONS

"We must take bold and unequivocal action: we must make the rescue of the environment the central organizing principle for civilization ... we are now engaged in an epic battle to right the balance of our earth, the tide of this battle will turn only when the majority of people become sufficiently aroused by a shared sense of urgent danger to join an all-out effort. It is time to come to terms with exactly how this can be accomplished." Vice President Al Gore.

The Colorado Chapter of the American Institute of Architects (AIA Colorado) and the New College of Architecture and Planning of the University of Colorado (CU) are seeking research and design submissions for "A Call for Creative and Visionary Projects" which illustrate attitudes and practices that embrace the concept of sustainability, both ecologically and socially, in architecture. This event will be held in conjunction with the AIA Colorado Design Conference theme of **Awakening Responsibility** at the Broadmoor Hotel in Colorado Springs, Colorado on December 3-4, 1993.

The **Call for Creative and Visionary Projects** is open to anyone. Architects, landscape architects, planners, engineers, designers, humanists, social scientists, and students are encouraged to submit projects. Projects must be client-based unbuilt, or current incomplete construction work, or theoretical.

Individuals and groups are invited to propose ideas for sustainability that effect positive change in the built environment; are appropriate within physical and socio-economic contexts; are feasible technically; and offer improvements to local or global sustainability for either or both the social and the natural environments.

An exhibition of all design work submitted to this program will be presented as part of a reception at the AIA Colorado Design Conference on December 3, 1993. Research and design submissions will be judged independently. Total amount of awards available is \$25,000. Registration is \$50.00 (\$25.00 for students) and the deadline for all research and design submissions is September 24, 1993.

## AIA REPORT EXPLORES DESIGN, ENVIRONMENTAL CONCEPTS

Opportunities to connect design excellence with environmental goals and to build a collective vision for sustaining the world's future are explored in a new report published by AIA. **DESIGN AND THE ENVIRONMENT** is the third in a series of the AIA's 20/20 Vision for America publications to help communities visualize their futures. The new 69-page report is a sister publication of **DESIGNING YOUR TOWN**, which discusses planning for change in small towns, and **LEARNING FROM L.A.**, examining the problems of growth by larger cities.

Developed by the AIA Regional and Urban Design Committee, the new publication resulted from two panel discussions in 1992 exploring the role of design in accommodating

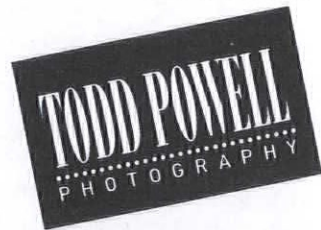

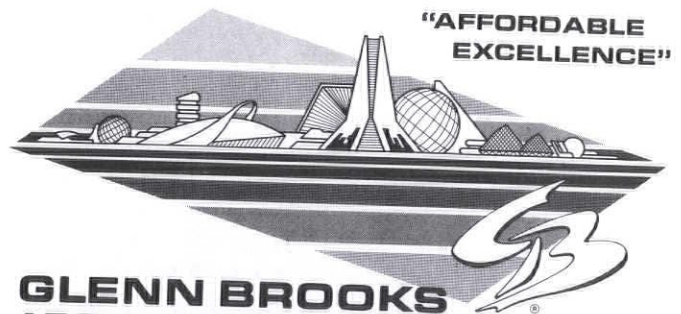

BRS decided to express social responsibility with deep respect for the environment as well as the interests of the client and the surrounding community. Because most of its clients are public entities with large constituencies, BRS has developed a technique for including a broad cross section of people into the design process. The company emphasizes a building's "user" as it considers all parts of a design. In fact, the firm shies away from large office buildings because it is difficult to interact with the people who will live and work in them.

BRS employees volunteer time and expertise to a variety of community activities, such as designing a "safehouse" for battered women; assisting non-profits in writing grants, developing fund-raising tools for various projects and involving the entire staff in building a hiking trail on Jefferson County Open Space land.

BRS partner Roz Schneider sums up the company's philanthropic ideology by saying, "Those who can, must." (This excerpt was printed from the July 1993 edition of Colorado Business.)

## IDP HONORS GIVEN

Sponsored by the AIA and the National Council of Architectural Registration Boards (NCARB), the Intern Development Program (IDP) offers comprehensive mentorship and training programs involving architectural firms, students, educators, practitioners, and professional organizations. The program aims to develop competent architects nationwide. The four award winners were selected by the IDP Coordinating Committee for their "exemplary support to interns, for providing well-rounded training opportunities, for fostering mentorship and participating as advisors, and for encouraging supplementary educational activities."

The 1993 IDP Outstanding Firm Awards went to:

**Conrad & Okuma**, Oxnard, CA, a six-person firm with two interns, has developed its own system of record keeping and review forms that reference IDP training areas and the 14 areas of California architectural practice. Interns participate directly in all phases of the firm's projects, even the financial aspects, as well as in the continued review and critique of their work.

**CUH2A**, Princeton, NJ, a 250-person firm with 40 architects and approximately 10 interns, recognizes "the quality and intensity" that young architects bring to the firm by hiring two graduates each year. The firm provides training opportunities such as seminars and outside activities. One partner is assigned to supervise the interns, oversee their files, and "ensure happiness in the firm."

**Eric Swenson Associates (ESA)**, Nashville, a 135-person firm with 33 architects, encourages its 20 interns to participate in a full range of professional and continuing education activities. All phases of the design process—project management, meetings with consultants, communications with clients, and construction site visits—are open to interns.

**Department of Campus Planning, Engineering, and Construction, Western Michigan University (WMU)**, Kalamazoo, a 16-person office with 1 intern, provides hands-on experience in all aspects of architectural practice—programming, design, management, contracts, documentation, and construction. WMU funds intern participation in management and product information seminars, AIA conventions, and design seminars.
