## AIA COLORADO's and AIA DENVER's JOINT OFFICE RELOCATION TASK FORCE ISSUES A REQUEST FOR QUALIFICATIONS

The Joint Office Relocation Task Force is a joint effort of AIA Colorado and AIA Denver to develop a combined office for both organizations. This is an action that has been supported by both Boards as a means of saving costs and effectuating better communications.

To this end, the Joint Office Relocation Task Force is seeking letters of interest from architects who wish to be considered for the project. A quality-based selection process will be undertaken to select a qualified firm for the design of approximately 2,000 sq. ft. of space. Services provided will include space planning, interior design, furniture selection, construction documents, and construction administration.

Compensation shall be the following:

1. Test fit of program in alternative locations to be paid by landlord at rate of 10 cents per sq. ft.
2. Compensation for design service shall be the payment of one member's AIA local and state membership dues for two years.
3. Free attendance for two at AIA Denver annual meeting and AIA Colorado Design Conference to receive recognition for work provided.
4. Reimbursables to be paid directly to architect for printing and other out-of-pocket expenses.

Selection will be based upon relevant experience, design quality, and staff assignments. Interested architects are asked to submit a qualification package of 10 pages or less along with a letter of interest to:

## THE ELECTION BEGINS

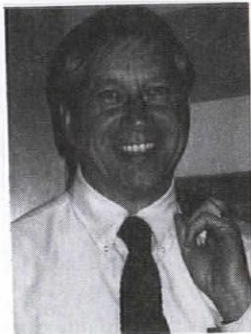
Here are your candidates for the 1994 AIA Colorado Board of Directors:

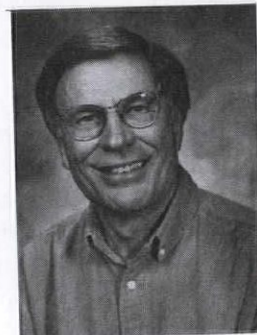

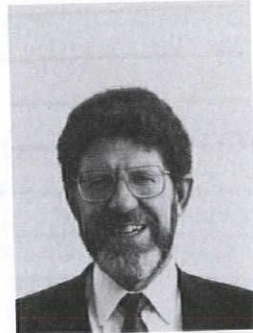


### SECRETARY - 2 Candidates

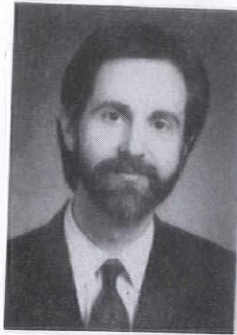

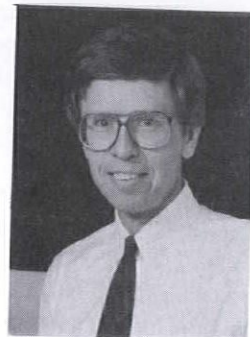
I appreciate the opportunity to be considered for this position and I can certainly promise that it will have my full attention and enthusiasm.

Over the past twenty-eight years that I have been involved in architecture, I have witnessed many changes and challenges to our profession. Some of these changes

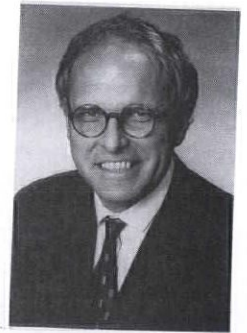

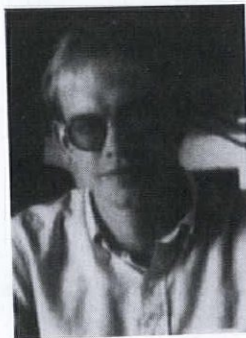

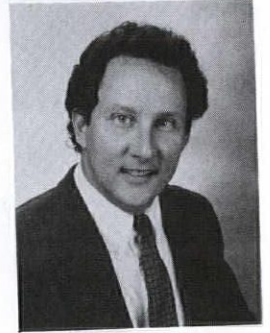

As a result, a five-year term of accreditation has been granted the professional architectural program entitled: Master of Architecture, degree + 3 (1/2) years by NAAB. The school is scheduled for its next accreditation visit in the academic year 1997/1998.

Accreditation is subject to the usual conditions described in NAAB's Conditions and Procedures and the submission of an annual report which addresses the deficiencies, concerns and recommendations contained in the Visiting Team Report.

NAAB encourages public dissemination of information about each school contained in both the school's Architectural Program Report and the visiting team report. If the visiting team report is made public, then it is to be published in its entirety. (A copy of this report is available from AIA Colorado.)

*A variegated aural environment, the city is full of sounds of every kind. Traffic, interference, signals, people noises, music, and other artificial sound is accompanied by natural noises like the rustling or howling of winds blowing through trees or between buildings. Quasi-natural water sounds are important too... Sometimes light is experienced almost awrally and, unconsciously, we distinguish between sounds by processing them with left and right hemispheres of the brain.*

*Though dominant, sight does not hold exclusive sway, for the sense of hearing too exerts great influence over human behavior. Yet the overwhelming tendency in shaping the city, in drawing its divisions and creating environmental functions, has been to rely on visual effects.... The theme of the competition was proposed to stimulate thinking on new potential that could be opened up by looking at the composition of the city from the standpoint of sound, to see what kind of roles sound could play in defining the spatial and functional articulation of the city....*

*Mellifluous sounds can... be used to obstruct the release or intrusion of sounds considered precious or pernicious. Sprawling cities are spatially articulated using a wide variety of devices.... Sound corridors could become important devices to define the city. Moreover, visual rendering of such systems could introduce new vibrancy into urban spaces.... The conceivable range of definition could extend from something like a silent corridor encompassing city-wide perspectives to anything up to a total sound environment dominating an entire region. It could just as easily mean creating distinct aural qualities for the different urban areas and combining them into a grand configuration of city sound corridor.*
