PRESIDENT'S MESSAGE

1993 has been a better year for architecture in Colorado and in most other parts of the United States and AIA membership has been increasing as well. We now have 1,075 members in Colorado. The results of a survey recently taken by AIA and another one taken by the Professional Marketing Services Journal ("PMSJ") seem to indicate that, except for the "hard-hit Pacific region," revenues are increasing for most firms. Jim Cramer, Hon. AIA and AIA National's vice president/CEO said "Given the important role of architects in the early process of building, this bodes well for the near future of the construction industry in some regions of the country." (AIA Colorado will be happy to give copies of one or both of these survey results).

My thanks to all of the many people who gave their time and commitment to the 1993 AIA Colorado Design Conference. The conference was a great success with 500 people registered and Ron Mason, AIA (the 1993 Design Conference Chairman) should be very pleased at that. The support of the New College of Architecture and Planning at both University of Colorado campuses and the Producer's Council of Colorado was very much appreciated. Due to the efforts of Dean Dwayne Nuzum, AIA, the faculty and students, we had many student entries to the Call for Creative and Visionary Projects and many students signed up to attend the conference itself. The Producer's Council generously picked up lodging costs for C.U. students.

Also, many firms made it possible for their employees to participate in this year's Design Conference by paying their registration fees. AIA Colorado thanks these firms for this support of their employees and of the conference itself. I look forward to returning to the Broadmoor on December 9 and 10, 1994 for next year's Design Conference.

Thank you for letting me serve as your President in 1993. My hat goes off to John Rogers, FAIA, the 1994 AIA Colorado President, and to all those who will serve on a board of directors or a committee in 1994.

Colorado West Chapter

The West Chapter has had an excellent year with over ten percent growth in membership to over 175 members. Or geographical area is very large, from the Continental Divide west to the Utah border and from the New Mexico line north to Wyoming.

YOUNG ARCHITECT'S FORUM UPDATE

On Saturday, October 16th, the Young Architect's Form of Denver hosted its first annual CMU charette on the 16th Street Mall in downtown Denver. This design-build event was a three and one-half hour back-breaking competition that concluded with the evaluation of the constructions by our distinguished judges. Special thanks go out to Valley Block of Loveland, Colorado for the generous donation of the CMUs used.

There were five teams of five to eight members each. The competition progressed through several identifiable stages; experimentation and exploration of the material's properties, along with possible patterns and combinations; formulation of a scheme (this stage consumed a vast majority of some teams' efforts); execution of a chosen scheme (can also be construed as the 'let's do something!' solution); and refinement (complete dismantling to reposition the bottom block).

Kelly Vigil of the Brick Institute of America, Robert Lengold, a kinetic artist, and Jeff Newsteader, a masonry instructor served as the judges. They chose the team of Chris Stumm; Julia Johnston, Associate AIA; Ewk Kuon; Christie Kim, Student Affiliate; and Linda Purcell as the First Place Team. The first place team was awarded the \$100 grand prize. An all-student team from CU Denver received the \$50 second prize. This event was exciting and challenging to the imagination. Plenty of precariously balanced CMUs and liberal audience participation from passersby provided for a unique and varied learning experience seldom found anywhere but in the Young Architect's Forum!

1994 VISION FOR AIA COLORADO

(from a speech delivered at the Design Conference Dinner on December 4, 1993 at The Broadmoor)

Thank you Curt. Yours and Ron Mason's conference has been a great way to complete 1993 on a high note of design. I believe <u>AIA</u> can continue its current successful programs and can assist its members in improving the results of their practice and in strengthening their impact on their communities.

Therefore, I would like to focus 1994 on "THE ARCHITECT," and ensure that AIA Colorado, in cooperation with all four local Chapters, assists in identifying and implementing the opportunities for all of us to increase our visibility in our communities, to increase the effectiveness of our practice, and to enjoy the fruits of these improvements.

I attended the AIA National Board meeting in Aspen in October and, as a result of a direct appeal to Bill Chapin, FAIA (1994 AIA National President), AIA Colorado has obtained 1,200 AIA pins and 200 Associate pins at a very reduced cost. Each Design Conference registrant has received his or her pin with the compliments of AIA Colorado, along with a mandate to use it to their own advantage and to the advantage of the profession.

Personally, I have found that not a week goes by but that someone, some place, asks about my pin, and of course I take that opportunity to identify myself as an architect, and to promote architecture. Together, if each of us has one conversation with one new person, once a week in 1994, a total of 55,900 new people will know an architect and have an opportunity to increase their appreciation of architecture. At the same time, each architect will have made 52 new friends.

In order to improve the effectiveness of AIA (in addition to the current services which are available at the Chapter, State and National levels in 1994), AIA will assist in increasing our impact, involvement and usefulness in our communities by increasing our visibility. We can add to each Architect's effectiveness in the business relationships in his or her practice by utilizing our current opportunity to provide business seminars through the College of Business at the University of Colorado at Denver. AIA Colorado's first experimental business seminar, held in October, was a great success. Michael Barber, AIA is the Task Force Leader and he is planning at least four more seminars for 1994.

In addition, since AIA represents the profession in Colorado, it is appropriate to enlist all Colorado Architects in this endeavor, and to encourage their membership and participation in their local Chapters. We will make it clear that AIA membership is necessary to maximize successful architectural practice at all levels.

VIEW

Architectural design ideas are equivalent to intellectual property and should be presented as such. Software design, for example, lasts six to twelve months, while architecturally designed buildings outlast their designers.

VALUE

We should recognize the value of our design capabilities and be compensated accordingly, not as labor, but as an intellectual investment.

Therefore, I would like to propose a 10% growth for AIA Architects next year, which would include:

- 1. 107 new AIA members in Colorado.
- A growth of the AIA Architects' visibility by increasing their participation in various community activities by 10%.
- A 10% growth in practice management skills and in our clients' understanding of the value of design.
- 4. A 10% growth in recognition of AIA Architects' contributions to our communities and the built environment, through recognition of the Architect when projects are published, in lieu of "artist rendering."
- Finally, a 10% growth in the participation of AIA members in AIA activities in their Chapters.

The October issue of Memo (AIA National's Newsletter) contained the following paragraph which should be of great interest to you.

WE ARE NUMBER ONE

"In a survey conducted in the North Carolina Counties of Wake, Durham, and Johnston, some 500 people told WPTR-AM radio that Architects, out of all professionals, demonstrate the highest level of integrity and are the most trusted to 'act responsibly in the public's best interest.'

Of 35 professions, Architects were first, followed, in rank order, by certified public accountants, engineers, teachers, clergy, doctors and nurses. The police ranked 12th and the news media ranked 18th. Lawyers placed 35th, narrowly edging out politicians and used car sales people for last place."

As architects, we should use our energies to build on this platform of positive public perception, while other professions are still trying to improve their public image.

Thank you for your attention and participation. Let's take stock at next year's conference (scheduled for the Broadmoor on December 9 and 10, 1994) and see how much we have improved our visibility, resulting in increased stature and income.

1993 AIA COLORADO DESIGN AWARD WINNERS

The Colorado Chapter of the American Institute of Architects presented its 1993 Design Awards to close the annual Design Conference at the Broadmoor. It is important to note that the success of any construction project depends upon the coordinated efforts of many teams of professionals. AIA Colorado recognizes the contribution of architectural firms on the following projects and has presented to them Design Awards. AIA Colorado thanks all those who submitted their projects for consideration. Participating on the Design Awards Jury were Christopher Carvell, AIA, Dwayne Nuzum, AIA, James Stewart Polshek, AIA of New York and Douglas Darden.

Bristol Hall at Colorado Mountain College in Steamboat Springs is a multi-purpose center consolidating administrative, recreational and instructional facilities. Anderson Mason Dale of Denver, Colorado designed the project.

The Executive Marketing Demonstration Center for Storage Technology Corporation in Louisville, Colorado has been created in the center of an existing computer factory. Its purpose is to be able to accommodate two separate groups at the same time who arrive for day-long strategic planning sessions or production demonstrations. Hoover Berg Desmond of Denver, Colorado were the architects for this project.

Harvard Gulch Recreation Center has been expanded for the Department of Parks and recreation of the City and County of Denver. Michael Brendle Architects, P.C., of Denver, Colorado designed this project.

Riverwalk Performing Arts Center in Breckenridge, Colorado was commissioned by the town of Breckenridge to create a public amphitheater, library and office building for support staff. Anderson Mason Dale was the architectural firm for this project.

The Ross Cherry Creek Branch Library was remodeled and expanded for the City and County of Denver to blend into the unique urban fabric of the area. The architectural firm for this project was Michael Brendle Architects, P.C.

Curt Fentress, AIA presented three more awards at Saturday night's dinner. Richard L. Crowther, FAIA was named AIA Colorado's 1993 Architect of the Year. Harry Teague Architects received the honor of AIA Colorado's 1993 Firm of the Year. The Aspen Community Plan put together by the citizens in Pitkin County was noted for its Contribution to the Built Environment.
