DENVER FIRM WINS TOP HONORS FOR INTERN DEVELOPMENT PROGRAM

The Denver architectural firm of Klipp Colussy Jenks DuBois Architects, P.C., was recently selected as one of four recipients of the 1994 Intern Development Program (IDP) Outstanding Firm Award. The American Institute of Architects (AIA) made their announcement at the annual IDP Coordinators Conference, in Washington D.C., January 28-30. Firms are selected from nominations received throughout the United States. And, the awards will be presented at the Practice Management Breakfast during the 1994 AIA National Convention and Design Exposition in Los Angeles, California on May 13-16.

This firm was selected because of their overall enthusiasm and proactive efforts at creating a learning atmoshpere for interns," stated IDP Coordinating Committee member and American Institute of Architectural Students (AIAS) Vice President, Christie Malecki.


Klipp Colussy Jenks DuBois has initiated mentor programs within their own firm, along with making their architects available to interns working in other firms as well.



from the

Capitol

We continue to monitor the meetings of the Board of Examiners of Architects which now meets every two months. To better understand the State Legislature's thinking on the professional licensing process we are closely monitoring the Sunset review process for the Engineer's licensing law. (Architect's Licensing Law will come up for sunset review in 1997).

The GAC continues to

work on revisions to the Jefferson County School District contract. Progress has been made.

The Asbestos Abatement Task Force is awaiting the scheduling of a meeting between the Colorado Department of Health and members of the task force to review proposed changes to the permit process. The Legislative Sub-Committee of the GAC is meeting every Friday morning at 7:30 a.m. to review pending legislation in the House and Senate of the Colorado Legislature. We are currently monitoring three bills in the Senate and four House bills.

AIA Colorado, AGC and ACEC joined together in opposition to proposed Senate Bill 74 which would have *changed* the date a

mechanics' lien could be attached to property until *after* construction began. Thanks to the members who telephoned their State Senators to let them know their opposition to this bill. Thanks also go to D.A. Bertram, AIA, Esq. and our lobbyist, Jerry Johnson, for their support.

Colorado West Chapter

The Colorado West Board met in Glenwood Springs on February 5th for its monthly meeting. In addition to the Board there were five past presidents who were present to discuss the direction our chapter should take in the next few years. Our chapter has been growing steadily and has become more active each year. Our seminars, 10 x 10 presentations, newsletter, and awards program all have been quite successful and we take pride in continuing them this year.

However, we face some problems which seem even more apparent as the chapter grows. For example, the Aspen-Glenwood-Grand Junction-Steamboat-Vail loop seems to be achieving a greater coherence, while we offer little to the membership in Telluride, Durango, Montrose and remote areas. Also, despite two well-organized chapter meetings last year, attendance was very low which signaled to us that we were not clear about what motivates and interests our members.

In addition, as we strive to provide more it has become apparent that our programs need to become more institutionalized in order to make better use of our manpower, create more familiarity with our members, and allow greater access to sponsorship. To deal with these issues our first focus this year will be to define our chapter's vision and understand our members better. One step we are already taking is the formation of a Past Presidents Advisory Council to tap into the collective knowledge and energy of this important group of members. Michael Hazard, AIA is leading this group, I will report on more specifics of our soul searching as we develop this focus throughout the year. We look forward also to ideas and suggestions from our members and the other Colorado chapters.

QBS PROVES SUCCESSFUL

QBS Colorado is receiving more requests from municipalities, other public agencies, as well as architectural and engineering firms, in establishing procedures for the selection of design professionals.

- Arapahoe County presentation to the engineering staff. Later this was followed up by a meeting with the purchasing department. QBS was well received by both and a disk with the forms was sent.
- City of Louisville discussion of QBS with the Parks department staff and the Assistant City Engineer. They took the request for price from their RFP. We have been asked to make a QBS presentation to the District Parks Directors meeting in South Dakota in May.
- University of Colorado at Colorado Springs phone calls and FAX contacts. Campus Child Care Center removed price from their RFP as a result of the QBS Colorado efforts.
- HUD Office of Public Housing telephone discussion with head of public housing and head of the engineering department of public housing. Engineering department is in favor of QBS and is suggesting its use to all agencies. Local law may override the federal law according to the HUD procedures.
- Roaring Forks School District workbook was sent to the head of the district at his request. The District wants to "do things right".
- Poudre School District R-1 meeting held at request of Director of Organizational Development & Construction. They needed help in selecting qualified local architects.

QBS COLORADO RECEIVES GRANT

The last \$4,000 of the \$10,000 available funding from national AIA, NSPE/PEPP, and ACEC was awarded in January to QBS Colorado. This money was granted to organizations who proved they were making QBS work. Under current committee rules, we will not receive any more money to fund QBS Colorado. All participating organizations in Colorado are reviewing their budgets for next year taking this into account.

QBS MEETS IN TUCSON

QBS Colorado Coordinator, Ila Bishop, met with other QBS Facilitators at the NSPE/PEPP meeting in Tucson on January 8, 1994. Representatives from sixteen states discussed the most successful methods of improving the quality of public projects through the use of qualifications based selection.

As is being done in other states, we in Colorado need to get our professional engineers and architects to contact Colorado Municipal League, American Public Works Assn., Associated General Contractors, Colorado Bar Assn., Denver Bar Assn., etc. to get endorsements, to get QBS scheduled on agendas, and to place articles on QBS in newsletters. Let us know if you have contacts in any of these or similar groups. WE NEED YOUR HELP! We have to let these people know that QBS will benefit THEM.

Also, we need your help in getting information to QBS Colorado *before* an RFP is released. When you know a project is being considered, assist us by getting a contact person's name to us and we'll try to work with the public agency ahead of time. That way no one is embarrassed. However, if you receive, an RFP, let us know.

AMERICAN BAR ASSOCIATION ENDORSES QBS

After thorough study, ABA endorsed the QBS process. The QBS Process is contained in the ABA Model Procurement Code for State and Local Governments. The code was a joint effort by the ABA Section of Public Contract Law and the Section of Urban, State and Local Government Law. On February 13, 1979, the ABA House of Delegates unanimously approved the Model Procurement Code.

Article 5 includes provisions governing the award of contracts for architect, engineer, and land surveying services. Municipalities and other government agencies are encouraged to use the Model Code as the basis for their own ordinances or regulations.

NEGOTIATING IS FAIR

Perhaps the biggest obstacle to the use of QBS by municipalities is the problem of negotiating the fee. How does the government agency know if it has negotiated a fair fee?

Most selection panels are comfortable determining the most qualified professional for the particular project. However, they don't have as much experience or knowledge of the market place as the consultants.

There are several ways to help government agencies with this problem. Rather than look at the fee for the entire project, the QBS process allows for developing a scope with a fee for each major component. Perhaps the design professional could furnish the client with published cost information for similar projects. If you have other suggestions, please call IIa Bishop 303-757-3838 with your thoughts.

I was part of the fourteen person contingent sent from Colorado to not only represent you, but also to listen and learn about the issues and challenges we face as practicing architects. I also had the opportunity to get to know our AIA Colorado and chapter leaders. Their enthusiasm for fellowship and teamwork is contagious!

One of the issues we worked on was the potential legislative erosion of the 20 year old Brooks Act which requires that architects be selected for federally funded projects based on their qualifications; only after selected are the fee's negotiated. This encourages the best use of taxpayer dollars and allows architects to be compensated on the fair value of their work, instead of the lowest fee.

This is important because we also learned that we are our own worst enemy, that we must work together to raise the public's awareness of our value and importance to society. To that end the AIA is initiating awareness programs to be executed at the chapter level. AIA Colorado president John Rogers has been championing this mission very effectively; wear your AIA pin, tell people about architecture, get on community boards and committees, and take the time to educate your clients about the value you bring to their projects.

Walking through the Octagon in Washington DC, I was reminded of those architects who got together way back in 1857 to form the AIA. This group of architects recognized that there was strength in numbers and their voice would only be heard if they were unified. Today we need to remind and educate nonmember architects as to the role *our* AIA plays in keeping our profession secure and a vital part of society.

During Grassroots, hundreds of architects took these messages to their representatives on "The Hill." I had the opportunity to meet with Representative Patricia Shroeder and the assistants of David Skaggs and Ben Knighthorse Campbell. I was amazed at how truly open our government is, and how interested they were in what we had to say.

We also learned about an exciting new tool, AIA Online. I predict this electronic communications tool will revolutionize the way our chapters provide service. Board and committee meeting minutes, schedules of events, late bulletins, and E-mail will allow instantaneous contact between each individual member. Groups of architects, clients, and governmental agencies will be able to "chat" on-line in real time or over a period of time via "bulletin boards." All members will be able to "listen" and join in. The positive impact on the environment due to fewer car trips and less paper, and the savings in travel time alone will more than justify the effort of learning to use this new tool. Being able to electronically search through the mountains of information we receive daily means you will be able to efficiently access all the information only you need. Space does not permit going into the marketing benefits of this tool; that is a future article in itself! During an open house at AIA headquarters, Thomas Beck and I had the opportunity to personally urge AIA president Chester Widom to consider making this tool a free and unlimited benefit (to AIA members); due to a very vocal sentiment expressed at Grassroots, they are seriously considering it.

If I sound excited, I am. I cannot stress the importance of being involved if you want to get the most value from your membership in the AIA. Opportunities are unlimited at AIA in areas of your interest. AIA COLORADO EXHIBIT AT THE DENVER ART MUSEUM

On February 22, 1994, an exhibit highlighting sustainable architectural design was at the Denver Art Museum. Fourteen works, created in response to the "Call for Creative and Visionary Projects" competition, were on display through Wednesday, March 2, 1994.

Architects and design students from across the country were invited to submit sustainable design projects which recognized our dependence on the environment as a functioning natural system by creating physical products that sustain both environmental and human needs. The award winning design submissions illustrate attitudes and practices that embrace the concept of sustainability, both ecologically and socially, in architecture. Ron Mason, an architect with the firm of Anderson Mason Dale in Denver, conceived of and coordinated this competition with the help of a dedicated committee. They felt that "Architects should have the opportunity to take a visionary approach to this challenge because the realities of the practice of architecture does not always afford this opportunity. Here is an opportunity to let loose and be inventive."

"More than ever before, our survival depends on sustaining a healthy global environment. Humans have always altered the environment. Sometimes this was constructive but often it was exploitative and left natural recovery to chance. When our numbers were small, natural systems eventually compensated, but today the number of people on our planet has stretched natural systems beyond the point of natural recovery. Today, we must apply our creative talents in a constructive manner...Our ability as humans to visualize a better environment and work toward it — by design — is a key to sustaining a balance between our activities and the natural environment." (excerpt from AIA's 1993 Design and the Environment)

Sim VanDerRyn and Peter Calthorpe warn in their book <u>Sustainable Communities</u>, "Lacking any tangible vision of what the future might be like, the future comes and goes by default. As the biblical quote says, 'without vision, the people perish.""
