## ARCHITECTURE: A CHANGING PROFESSION

The cover story for the February issue of *Progressive Architecture* entitled "Can This Profession Be Saved?" was very thought-provoking. Where is the profession of architecture headed? The article's author, Thomas Fisher, has suggested that the "old ways of doing things no longer work" in our chosen profession and that "[if] the profession is moving in a single direction...with enough effort, we will be able to define forms of practice in the future as clearly as we have in the past." He also mentioned many of the factors affecting our field, including the electronic age (computers, faxes and modems) which has "permanently eliminated certain types of jobs...[and] the barriers of time and distance that once protected firms from competition."

I believe that no one else is better prepared and trained than architects to deal with disparate information, both requirements and restraints, and to synthesize all the needs and constraints into an aesthetic, functional physical facility, from a single residence to a city and regional plan. By increasing our own expectations of ourselves and our appreciation of the need for responsibility and, yes, "risk," architects can provide the leadership necessary to conceive of a total integrated project and manage its execution.

The traditional architectural schools' dictum has been that, "You are only a real architect when you hang out your shingle and design a house." I believe there is a need for architects in every walk of life. The schools need to broaden the architecture student's foundation to extend beyond design and expand the student's understanding of the lifetime use of facilities.

Consider all the physical facilities in our built environment, and their value. Besides construction, there is the utilization, the maintenance and the overall useful purpose of a facility that needs to be managed and maintained by architects. The opportunity for a facility's flexibility and service can be immeasurably increased and improved by the use of an architect's skills.

Consider the lost opportunity for the efficient use of a building when there is little or no understanding of the original vision of its designer in the way the facility is used.

Consider the great advantage to society and the public when architects are utilized in directing and defining the problems, scope, alternatives and final direction for projects.

Consider joining a committee in your community. No matter which committee you are a part of, in my experience, you are the only architect there. When an issue comes up that is within your area of expertise, you are the expert and the committee will turn to you. You get the floor and generally the committee will take your suggestion because you are the expert.

Increasing architects' visibility and public service will cause a change in the perception and understanding required to enlarge the field of endeavor for architects. Architects can then fully use their abilities, imagination, vision and organizational skills to advance both the public and private agendas for the built environment.

Thomas Fisher sums up what is happening within our profession by stating that "Changes are occurring in the structure of architectural firms and the scope of their

services, in the goals of architectural graduates and the careers they are pursuing, and in the nature of architectural education and the responsibilities of the schools." The profession of architecture is in transition. I invite you to participate in the December 9th and 10th Annual Conference to be held at the Broadmoor Hotel in Colorado Springs. Many of the issues mentioned above will be explored. This year, the annual conference theme will be "Visibility and the Changing Profession."

### AIA Colorado West Chapter

At AIA Colorado West's last board meeting we tried to devise a strategy for including areas in our chapter which up to now have not seen much local AIA activity. ### AIA COLORADO/GSA REINVENTION TASK FORCE

The Region 8 General Services Administration Design and Construction Branch at the Denver Federal Center invited AIA Colorado to establish a task force to assist them in developing policies to improve their AE Selection process. Region 8 has been designated a "Reinvention Laboratory" in conjunction with Vice President Gore's reinvention of government.

The task force met with Jerry Lowe of GSA Design and Construction branch on February 3rd. Jerry identified GSA's six-point target agenda toward improving the Architect-Engineer selection process. In the subsequent weeks, the task force prepared a point-by-point response to the agenda, which was presented to the Board on February 18th and then sent on to GSA.

Emphasis was placed upon ways to reduce the length of time presently required to conduct audits and negotiate fees after the initial AE selection is made. Format of statements of qualification, make-up of the GSA screening and elevation boards and contracting authority were also addressed. We have also offered to address other topics with GSA relating to project management procedures and requirements. Follow up meetings will be scheduled after GSA reviews our initial comments and recommendations.

## WMR NATIONAL BOARD DIRECTOR'S REPORT

March 16-20, 1994 will be the first National Board I will be attending as Junior Director of the American Institute of Architects representing the Western Mountain Region (WMR). WMR is a large region consisting of six states: Arizona, Colorado, Nevada, New Mexico, Utah and Wyoming. The Senior Director is Phil Gerou, FAIA from Evergreen, Colorado and he is serving his final year on the National Board.

I attended Board orientation last December along with the twelve "Rookies." This starts our three-year term. We are called the Class of '96. Each year there is a turnover of one-third of the Board. The Board consists of 46 members as follows:

I want to make this time that I am spending on your behalf meaningful for both of us. Time is limited and issues are plentiful. From time to time I will be noting some things of importance on what the National Board is working on, but this time, I want to share what orientation was all about and a couple of other details.

### Library and Archives

Newly renovated in 1993, the expanded library offers 30,000 volumes, 450 journals and reports accessible via modem (AIA Online) or CD-rom. Members may also borrow all books and materials via U.S. Mail. AIA will pay the cost of shipping items to you. You simply pay the return shipping cost. Otherwise the service is free.

### Professional Interest Areas (PIAs)

There are 23 PIAs to become involved in such as Buildings Codes and Standards, Design, Education, Housing, Small Projects, etc. You are given the opportunity to participate in one PIA for free on your membership renewal each year, or you may call the Institute to join a PIA anytime.

The Board interviewed the new Executive Vice President/Chief Executive Officer (EVP/CEO) Terry McDermott in December. McDermott will replace James Cramer who will be leaving the Institute at the end of June.

Grassroots '94, the annual leadership conference, was excel-

lent. The AIA Continuing Education Program will have a pilot program at the 1994 National Convention. All members may accrue learning units toward their membership requirement. The life-long learning committee is recommending a two-year record-keeping period to begin January 1995. Members will have until 1997 to earn the requisite number of CES credits. The exact number of credits required will be proposed in September.

The 1994 National Convention schedule and registration should be in your possession by now. Early bird registration is due by April 15 and will include a free copy of *Los Angeles: An Architectural Guide*. There is also a "1+1" program in place where the registration for the second person signing up from your office is 50% off when both register at the same time. **JUST DO IT!!**
