TAKE ADVANTAGE OF AIA COLORADO'S REFERRAL SERVICE - IT WORKS!

As a member of AIA Colorado, each year you receive a Client Referral Form that we ask you to fill out and return to us. If you haven't returned your form yet, fill it out and send it back to us. Our Client Referral System is working for you. Because we get calls for specific areas, referrals are sorted by Chapter. Inquiries come in from throughout the state. When we receive a referral request, we send the caller five referrals that match the criteria they have asked for, narrowing down their architect search. It is then up to the client to contact the architect referrals we have provided. To give you an idea of how many requests we get, from January 1 through April 30 of this year we received 87 calls. Most were residential, however calls for specializations such as ADA compliance, health care facilities, movie theaters, churches, golf courses and speakers are also received. The Referral Service is an important member benefit that AIA Colorado provides. Be sure to take advantage of it by returning your form. New forms will be sent in December for 1995. New home of AIA Colorado/Denver

Vacant for many years, the Off Market Limited Liability Co. bought the building in 1991 and converted the upstairs into lofts. The main level is planned for retail space and, of course, us. The design includes a gallery for exhibits, photographs and displays, a conference room to seat 20 people, a resource area for small meetings and/or research gathering, a central receptionist station, and work area for the staff. CAD NEWS for ARCHITECTS

Software Changes

If you currently use Autodesk design software, you may be interested in one of the updates released in the past few weeks. The updates are: AutoCAD c3 for DOS and Windows; c4 for Windows (fixes three primary bugs that c3 did not take care of). If you have AutoCAD Release 12c2 or any version of Release 12 Windows, you may receive your patch directly from CAD-1. In June, Autodesk also announced a new policy for dual use of the DOS and Windows platforms of AutoCAD. Registered users who previously completed a platform change from DOS to Windows, or vice versa, are entitled to the dual platform license at no extra charge until 1/31/95. For guidelines on receiving any of these updates or for information on the dual platform license, call Carol at 303/427-2231.

What about 13?

Autodesk has not released official word about AutoCAD Release 13, the newest version of the world's most-used CAD software. Its ship date, however, is rumored to be in the fourth quarter of 1994. CAD-1 is planning for informational seminars which will be finalized as soon as the Release 13 ship date is announced. If you and your associates are interested in attending preview seminars, please notify us to place you on the Release 13 fax list. Our seminar will center around a demonstration of the new AutoCAD's feature.
