WARNING

Amendment 12 is this year's attempt by Doug Bruce to reshape the Colorado Constitution to fit his perception of "good" government. If approved, it would change provisions in both the Constitution and the Colorado Revised Statutes. The Government Affairs Committee of AIA Colorado is opposed to its passage because it has the potential of significantly extending the time required for any local governmental decision to become "final." Whether it's a rezoning case or a request to issue bonds, under Amendment 12, any person has 90 days to object to the decision by requesting petitions to challenge the decision. Nine months are then allowed to gather signatures, and the question will be placed on the following November ballot. Following the election, the dissatisfied party may also choose to contest the results of the election in District Court. At a minimum, any legislative decision will have to be put on hold for 90 days to see if objections occur. Worst case, a decision could be tied up with petitions, an election and possibly even a court case for two or more years. How many of our clients will be willing or able to wait that long for their government approvals?

The other provisions of Amendment 12, while having a less direct impact on architects, are still significant. They deal primarily with the mechanics of the initiative process, allow recall elections for judges, extend limitations on the compensation packages for government employees, and impose significant limits on the ability of government entities to analyze and comment on potential initiated petitions. While these are closer to the heart of Doug Bruce's arguments, they would place significant burdens on our elected representatives:

- Should a judge be subject to recall by the voters for an unpopular decision?
- Should signatures on a petition be accepted at face value, or should they be subject to the current level of scrutiny by the Secretary of State?
- Should government employees be prohibited from speaking out on issues that affect them directly, even when they're not working?
- Shouldn't a school district be able to explain why they're asking the voters to increase their level of bonded indebtedness?

Amendment 12 has the potential for significantly complicating an already complicated process. The AIA Colorado Board of Directors and the Government Affairs Committee urges you to fully explore its ramifications, and to vote against it in November.

President's Message by John B Rogers, FAIA

As we begin the final quarter of 1994, the following should be of interest to our members:

1. Thus far, the membership efforts (1,104 members currently) of the Chapters have produced 67 new members (including reinstating members and transfers in from other chapters) since the first of the year (our goal is 109), however, we have lost 61 members who have not paid their dues for this year. A further investigation indicates that about two-thirds of these former AIA members have moved out of Colorado. Since Colorado Architect's offices are busy and have been hiring new people who have come to Colorado, it would be a good idea to put new employees in contact with their AIA Chapters in order that they have an opportunity to participate in the Chapter activities and to meet their peers.
2. AIA Colorado's Education Task Force, chaired by **Chick Lee**, AIA, has been actively pursuing involvement, input, and recognition of the practicing community by the College of Architecture & Planning at the University of Colorado. When Dwayne Nuzum, the Dean at the beginning of 1994, transferred to the Commission on Higher Education, the AIA Colorado Board recommended to Chancellor John Buechner, that a practicing architect be selected as an Interim Dean pending the organization of a Dean Search Committee, and finding a permanent Dean. We were not successful in this recommendation and Bruce Bergland, an existing administrative person at UCD, was appointed.

Since that time, the Educational Task Force has been actively seeking participation on the Dean Search Committee through meetings with President Albino, Chancellor John Buechner, and Vice Chancellor for Academic Affairs, Georgia Lesh-Laurie. Further, we have recommended and received cooperation from the College in providing architects to serve on a 12-person advisory committee, to work with the faculty to develop a written statement of the vision for the College of Architecture & Planning, by the 1st of December, 1994. We believe this to be particularly important to have completed prior to the Dean Search Committee considering candidates for a new Dean.

The members of this Advisory Committee are: **Thomas Beck**, AIA, North Chapter, **Michael Barber**, AIA, Denver Chapter, **Roger K. Crosby**, AIA, Denver Chapter, **Dennis Humphries**, AIA, Denver Chapter, **Elizabeth Wright Ingraham**, AIA, South Chapter, **Chick Lee**, AIA, Denver Chapter, **Clifford S. Nakata**, AIA, South Chapter, and **Wendy A. Thoresen**, AIA, North Chapter.

The other four members will be comprised of two practicing landscape architects and two practicing planners.

AIA Colorado has submitted names and background information of nine practicing architects, to Georgia Lesh-Laurie, the Vice Chancellor for Academic Affairs, from which she has agreed to select two for the Dean Search Committee, representing the practicing community.

3. The consolidation of the offices and staff of AIA Colorado and AIA Denver will be physically completed at the end of September, and they will all be working together from our new offices located at 1526 15th Street beginning October 1st. During the balance of

this year, the integration and coordination of the staff's activities and services in support of all four Chapters will be accomplished. Your cooperation during this time will be appreciated by the staff and by the officers of the Chapters.

4. Our Government Affairs Committee, under the chairmanship of **Tom McKenzie**, AIA, has been successful in challenging the Center for Stabilization at CSU, which has been competing with practicing architects for planning projects. This effort, precipitated by AIA Colorado, has resulted in a cooperative and supportive arrangement between CSU and practicing architects in two areas: a) CSU is anxious to find architectural firms that will take some of their interns for a limited period, and b) CSU is willing to bring their funding and expertise to a project jointly with an architect in private practice.

This committee has taken exception to the Colorado State Board of Examiners of Architects' proposal to liberalize their rules on derivatives of the word, "architect" as used in firm names and in the telephone book.

5. AIA Colorado's Fellows Task Force, chaired by **John Anderson**, FAIA, has been successful in assisting Chapters in their nomination of Fellowship candidates, and have assisted the nominees with their submittals. This year, Colorado expects to have eight candidates for Fellowship, who are: Colorado South Chapter - **Clifford Nakata**, AIA and **Elizabeth Wright Ingraham**, AIA; Colorado North Chapter - **Marvin Sparn**, AIA and **Al Zeigel**, AIA; and Denver Chapter - **Gary**

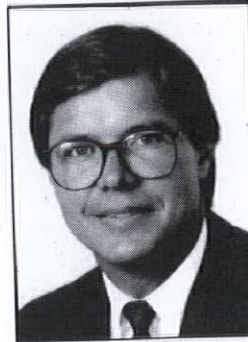

As Colorado South Chapter Past President, I pushed for improved public awareness of our profession. To that end, we established a local design awards and



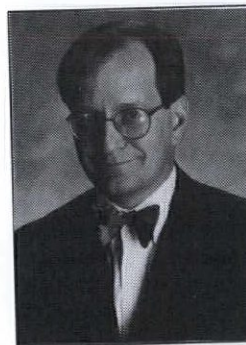

6. Vice President Al Gore's call for reinventing government began with the General Services Administration in Denver, and AIA responded with a special task force to negotiate the streamlining and increased effectiveness of architects' contracting with the GSA. John Hellgren, AIA and Jeffrey Olson, AIA led this task force until this summer, when GSA lost their advocate, Gary Lowe, and no further meetings have been held pending his replacement.
7. A Non-Dues Revenue Task Force, chaired by Marvin Sparr, AIA, has been reviewing non-dues policies and procedures of all components within the state. They have also reviewed means and methods to improve the procedures and to create a more professional and coordinated system. They have recommended a unified program encompassing the five entities of AIA Colorado be implemented. The program should be developed, structured and put into action beginning in 1995 to produce revenue for 1996. The AIA Colorado Board of Directors is taking this recommendation under advisement.
8. Our Annual Conference will be held at the Broadmoor on December 9th and 10th, and has been developed and organized by Dayl Larson, FAIA, carrying out the theme, "Visibility in the Changing Profession." It will be preceded by a business seminar sponsored jointly by AIA Colorado and the Graduate School of Business Administration of the University of Colorado at Denver, on December 8th. This day-long seminar was pioneered last year by Michael Barber, AIA, and his task force, when AIA Colorado and the College of Business conducted a seminar on Finance in October of 1993. The details of this seminar opportunity are enclosed and, since I have been involved with these Professors at the College of Business, I heartily recommend this seminar to you. 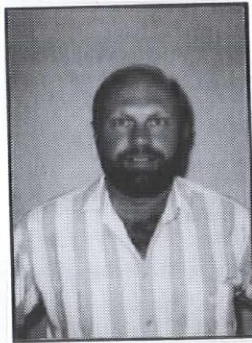

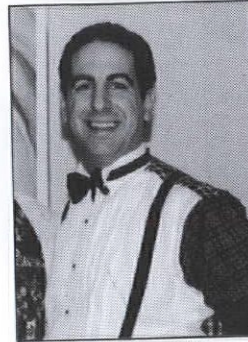

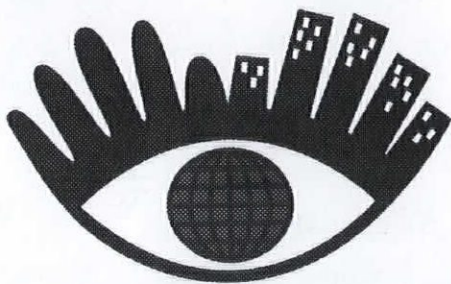

Most successful working relationships are simply a matter of luck; however, by implementing the partnering process, the odds of achieving a fruitful and productive contract relationship can be drastically improved. **Louis R. Bainbridge**, National Director in charge of FMI's partnering services, oversees all research and development, partnering implementation, and client satisfaction. Currently, FMI has more than 425 partnering processes underway across the country.

Lighting for People, not Footcandles (Level 2, 2 LU)
This presentation will go beyond basic lighting design and investigate the human factor of lighting. Main Speakers

Thomas Fisher is the Editorial Director of *Progressive Architecture* magazine and *Building Renovation* magazine. Prior to joining P/A in 1982, Tom worked in architectural offices in Hartford, Connecticut, and Cleveland, Ohio, and served as the Historical Architect for the State of Connecticut. He has a BA in Architecture from Cornell University and a Masters Degree in Interdisciplinary Studies, with a focus on intellectual history, from Case Western Reserve University.

The Once and Future Profession (Level 2, 2LU) The information revolution is having as dramatic an effect on architecture and the other professions as the industrial revolution had on manual laborers. As a result, many of the assumptions we have about how to practice architecture and how to make buildings are changing. Ironically, some of the effects of these changes have been to bring the profession back to its origins. The once and future profession, in other words, may not be all that far apart.

What is the Value of the Architect? (Level 2, 2LU) We talk about the benefits of good design, but as a profession we have done little to quantify those benefits or convince potential clients of our value. Accordingly, architects are too often seen as a mandated expense rather than as a profession that is adding value and saving clients money and headaches. How might this situation be turned around? How can the institutions of the profession - the AIA, the magazines, the schools - help in this cause?

Charles B. Thomsen, FAIA, is President and CEO of 3D/International in Houston, Texas. Mr. Thomsen has led a number of organizations from a two-person, start-up company to a 1,200 person, publicly-traded, international design and construction company. He has written books on contracting methods, project delivery strategies, and the management of design and construction organizations. Mr. Thomsen lectures annually at Harvard University and Texas A&M, and frequently speaks at professional associations, seminars and conventions.

Project Delivery Strategies (Level 2, 2LU) Mr. Thomsen will present a wide range of Project Delivery Strategies that are growing internationally along with current trends in the industry.

Case Studies of Project Delivery Strategies (Level 2, 2LU) Several case studies involving different Project Delivery Strategies will be presented.

Congressman Dick Swett represents the 2nd Congressional District of New Hampshire and is the only Architect in Congress. He was first elected to Congress in 1990 being the first Democrat elected in 78 years. When re-elected in 1992, he was the first Democrat to win re-election in 120 years, winning 63% of the vote. He is a graduate of Yale University with a BA in Architecture. Congressman Swett is assigned to the Committee on Transportation and Public Works and the Committee on Science, Space and Technology. In 1994 he is focusing his efforts on cutting government costs, balancing the federal budget, stimulating our national economy, promoting energy conservation, alternate and renewable energy and advancing congressional reform. Congressman Swett is truly a visible leader helping to change laws for the good of architecture.

A Third Way of Building Communities on a Strong Foundation (Level 2, 2LU) Congressman Swett will draw upon ideas from Jefferson, Madison, Hegel, and Garrison Keller to describe how our society, like our buildings, must be constructed on solid underlying structures. Strong communities can be built if we do not focus on the politics of polarization but on a third way - one which combines a fundamental commitment to values like tolerance and diversity as well as moral truth and virtue.

Architecture in Public Service (Level 2, 2LU) Congressman Swett will discuss the necessity for architects to become involved in public service and various opportunities for doing so.

Dave R. Braden, FAIA is a Texas Architect, whose sense of humor and civic involvement has caused him to be dubbed the civically serious humorist of Dallas. His sense of political wit and topical humor keeps him at the rostrum of everything from political rallies to grass fires. Dave Braden is currently Chairman of the Dallas Fort Worth International Airport Board and Director of the State Fair of Texas. He was the former President and Principal Architect of Dahl Braden PTM, Inc. in Dallas. He holds a Bachelor of Architecture from the University of Texas at Austin.

The State of the Nation - According to Braden (Level 2, 2LU) Be ready for dinner entertainment you will never forget. Mr. Braden will present his own humorous anecdotes on what is happening politically and regionally.

Architects Taking Charge (Level 2, 2LU) David Braden will have an interactive conversation with participants on how to become visible in your community and take charge of things that are bothering you.
