

President's Message

GRASSROOTS 95 was better than ever. We had many opportunities to express our individual needs and those of our Chapter and Region. Until last year, I am told, GRASSROOTS was mainly a time to listen to what National wanted to say. This short note is to tell you what it felt like.

Our Western Mountain Region (Colorado, Utah, Wyoming, New Mexico and Arizona) gathered on three occasions to debate and prepare positions on the most important aspects of Performance Criteria for the Institute (National AIA). While gathered we learned a lot about each other and acted on Regional business.

The most important question was what does the Region do? Pat Rehse, AIA and John Anderson, FAIA, our directors and others, told us about the education funds, their representing us at the AIA board, and mostly about the need to communicate with some 2,500 members over our 6 states. The six presidents met separately to discuss the benefits of continuing the "President's Commission" (a long standing committee of WMR). We decided to allow the Commission to continue, but be inactive. It was also concluded that the states could play a bigger role in WMR. How is to be explored.

One of the most important points I came away with was one of the ten performance Criteria. It was "Programming to enhance public understanding of architecture and the value of architectural services."

I returned from Washington, D.C. convinced that AIA and its architect members do want to make this a viable profession, and want to learn how to do it.

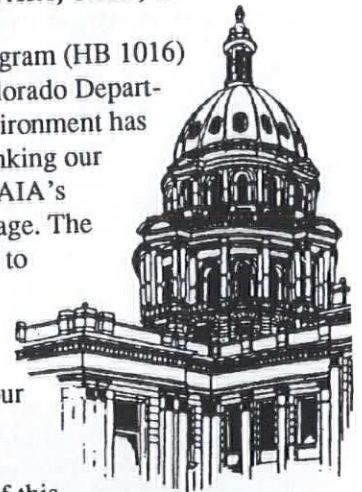
State Committee Reports Government Affairs Committee

The Asbestos Certification Program (HB 1016) passed in this State and the Colorado Department of Public Health and Environment has sent AIA Colorado a letter thanking our lobbyist Jerry Johnson for the AIA's efforts in helping with its passage. The Minuteman Program was used to garner support and contacts with our legislators to help pass this bill, which almost went down to defeat prior to our involvement. The Minuteman Program really works and we encourage the strengthening of this program with new member involvement. D. A. Bertram, AIA, and Jane Adams, AIA, who worked very hard on this issue, attended the Bill Signing on Friday, March 17.

The Legislative Affairs Subcommittee is currently monitoring 18 House and Senate bills and have been instrumental in either defeating in committee or helping with the passage of

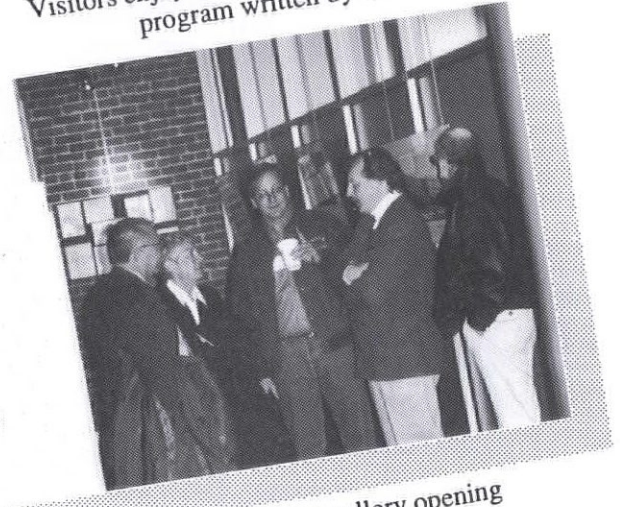

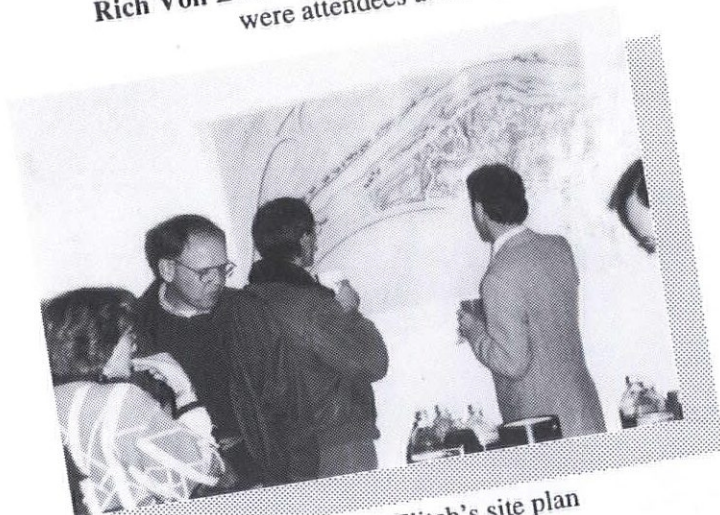

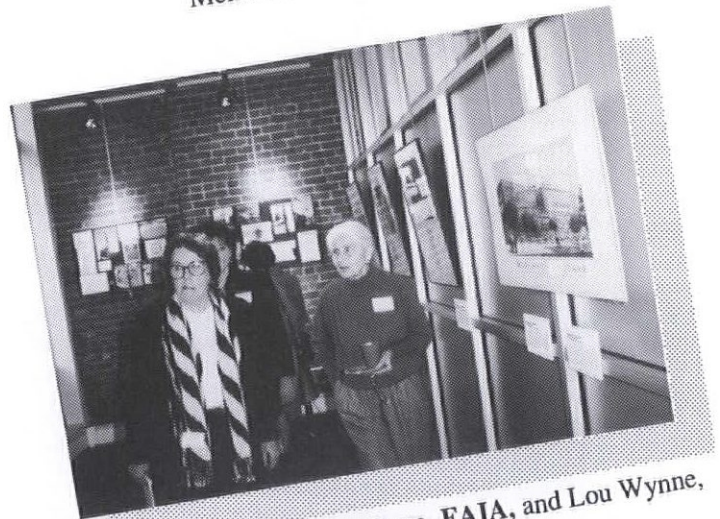

Critical Contracts

Donald A. Bertram is a practicing attorney and a licensed architect with the firm of Bertram & Associates located in Denver, Colorado. Mr. Bertram is experienced in all aspects of design, construction and business law.

Architects, such as yourself, are very excited when you win a commission, it is exciting to have a new opportunity to do what you love. The realities of actually performing the work and getting the project built sometimes elude you in the midst of your enthusiasm. The contracts that you sign after winning a battle for the project are more than critical. Contracts mean the difference between really winning or losing; being successful or failing; making money or being at the short end of the stick.

For the last eighteen (18) years, I have served on the AIA Colorado's Government Affairs Committee, I have been the Coordinator for the State of Colorado since the inception of the Documents Coordinator Program on the national level. This, along with my twenty (20) years as a practicing attorney and the thirty-five (35) plus years in the construction industry has given me an in-depth knowledge of how Architectural contracts have developed. There are three (3) basic delivery systems:

- Traditional - Design/Bid/Build,
- Design/Build, and
- Construction Management

All three involve varying levels of **risk and exposure**. Over the next few months, I will discuss different issues pertaining to delivery systems and contracts. Each delivery system and corresponding contract has its own areas of consideration and risk, thus each needs to be addressed separately. For this first discussion, I will discuss the Design/Build delivery system and how they can be dealt with in a contract.

Design/Build, sometimes disguised as a "Purchase Lease-Back," has received a fair amount of notoriety in the past and seems to have regained interest in the 90's. Some people hate it and others love it, few are neutral on the subject. Owners/Users love it because they want to limit their financial exposure and consider it easier to do because it is "one-stop shopping." Developers/Builders embrace it because they have control of the money, the Architect (Design) and control of the project.

Some Architects have learned to thrive with the Design/Build delivery system. But most Architects loathe it for a number of good reasons. The Architect is one step removed from the Owner since the contract is with the Developer/Builder. The traditional triumphant balance between the Owner, Architect and the Contractor is lost creating a situation where the Architect has lost control, which can occasionally lead to frustrating "compromises" where the Architect is pressured to incorporate items which may not be in the best interest of the Owner, but is directed to do so by the Developer/Builder.

The Design/Build delivery system can be very effective and provide a viable mechanism to accomplish the Owner's goal. It is a viable Delivery System if the Owner/User is highly sophisticated and has the capacity to create a detailed and accurate program to give to the Developer/Builder.

Problems arise when a project is driven by finances alone rather than relationships and good communication both in word and deed. ("Word," by the way, also includes the contract.) Architects have become extremely competitive and create their own "price wars." Developers/Builders take advantage of the situation driving the Architect's fees down. Every dime saved by the Developer/Builder goes directly into his/her pocket, and you know how ruthless they can be.

Every contract should provide for the proper allocation of risk, and the risk should be commensurate with the financial gain. In truth, the amount of risk is tremendous, and it is very difficult for the Architect to receive proper compensation. Unfortunately, this is the nature of the business of Architecture. But, you can do your best to mitigate the effects by writing a tight, specific contract, defining the Scope of Work, performance expectations of all parties, and additional services. Disclaimers and indemnity clauses can be helpful to limit liability, but the lawsuits to enforce them may be costly, aggravating, and time consuming. Know the services for which you have contracted and only do those services that you contracted for. Consulting an experienced attorney with a background in the design and construction industry can be a resource for solving issues before you are in a problematic situation.

Nationwide Restaurant Chain to Improve Accessibility under Justice Department Settlement

Nearly 100 Lone Star Steakhouse and Saloon restaurants that were not built or remodeled within specific guidelines are being made more accessible to persons with disabilities, under a formal agreement reached on 2/28/95 with the Justice Department. The Lone Star chain has restaurants in 29 states, including four in Colorado. In site visits and in review of the architectural plans, the Justice Department determined that the chain lacked sufficient accessible parking, failed to offer sufficient accessible seating, built inaccessible bathrooms, and installed inadequate ramps.

Under the agreement, Lone Star will make all of its restaurants fully accessible within 45 days and comply with the Standards in the future. Lone Star will also donate \$25,000 to four non-profit disability groups selected by Lone Star, including the National Council on Independent Living, Self Help for Hard of Hearing People, the American Council of the Blind, and the Learning Disabilities Association. And finally, Lone Star will allow site visits by the Justice Department and provide a detailed report outlining its compliance efforts.

four bills to date (see breakout).

Our biggest issue currently, outside of the legislative activities, is the continuing concern with the CSU Center for Stabilization. It appeared, after complaints were filed last year, that the Center was going to yield to AIA's concerns about unfair competition. Now it seems that they have returned to their practices. It does not seem right that the Center, unlike ourselves, benefits from a large network of sales representatives in the form of extension agents throughout the state. Then we as taxpayers are subsidizing the work so that they can severely undercut our fees and *under bid* work throughout the state. After some heavy discussion, the Committee feels we must make an all-out effort on several fronts to attack this problem. A Task Force on this subject will be gathering definitive information. We will then address the AIA Colorado Board of Directors at their next meeting to seek approval to aggressively seek resolution to this problem. A member of the Colorado Engineers Council was in attendance at this month's meeting because they too are the recipient of this competition.

We have now received a copy of the Landscape Architects proposed licensing law and will be reviewing this during the next month for discussion at our April Committee meeting. The Landscape Architects will be seeking Sunrise Legislation during the 1996 Legislative Session. AIA has been asked to support their quest for licensing. We must first see how this new law meshes with our existing law before we can render a decision.

Larry Friedberg, AIA, of State Building Services, attended our meeting. Stan Andrews, AIA, is leading a Task force on coordination between the State and AIA in helping to establish better communication and work toward common goals with new legislation that may be proposed in the 1996 Legislature. This is a result of the defeat of HB 1089 which was defeated in committee in January.

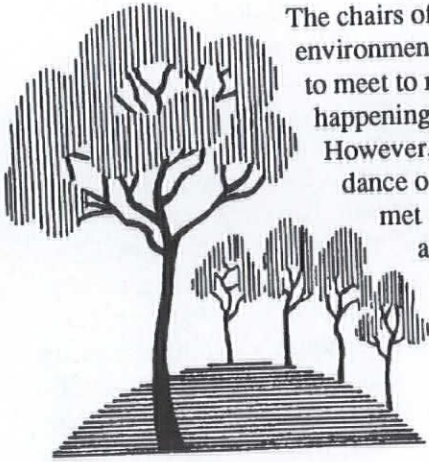

The chairs of each of the local environmental committees continue to meet to review the work that is happening in each of the chapters. However, due to an over-abundance of activities, we have not met this year. There is a lot of activity going on, especially in the Denver Chapter.

Each of the four chapters within Colorado will be

participating in the upcoming Environmentally Sustainable Architecture Workshops to take place in each region. These workshops should be significant for the more remote chapters which have a difficult time keeping programs together. Architects, builders, government officials, and others will be participating in the programs.

The Denver Chapter Committee on the Environment, along with the local chapter of Architects, Designers, and Planners for Social Responsibility (ADPSR) are wrapping up the second edition of the Sustainable Design Resource Guide. They should be proud that the publication is no longer in the red, but is now running on a profit basis! I hope everyone on the Colorado Board will support this effort and purchase a copy next month. It is available on disk or in printed form. The Denver Chapter is also working with the University of Colorado in Boulder and Denver to develop a course on Sustainable Design and a breakfast lecture series is being coordinated with the education committee for 1995. Speakers include Bill Wenk, Steve Ternoey, AIA, and Committee members.

The South Chapter has been discussing having a workshop on sustainable design in addition to the series currently being planned.

The North Chapter has been working to tie into the activities of Denver Chapter, and will additionally continue to coordinate with CU Boulder's Environmental Design Program.

The West Chapter now has a chair for the environmental committee. There are a few planned activities coming up which include a lecture by Sir Norman Foster about current work and Charles Buki from AIA National speaking on Urban Design. The chapter newsletter is going to be used in a limited degree to promote issues.

Intern Development Program Report

I have received 36 calls requesting information for the period 12/13/94 - 2/15/95. On February 8, I was asked to discuss IDP at Anderson Mason Dale Architects in Denver (5 interns and 3 architects were present). In December, I nominated Brenner Harr P.C. Architects in Glenwood Springs for the 1995 IDP Firm of the Year Award. On January 27, I attended the State Board of Examiners Rule Making Hearing to monitor changes in the Board's rules pertaining to DPE/IDP.

The beginning of the year seemed particularly hectic with respect to the number of phone calls requesting information. According to my logs, I have averaged 12 calls per month over two years, the average for this period. I am receiving more calls from interns who attended school from out-of-state and who are seeking information about IDP in Colorado. Many callers request information about job opportunities in the Denver area.

I will be making an IDP presentation at Barker Rinker Seacat in the coming weeks and will also be planning presentations at the Boulder and Denver campuses of CU. Past presentations at the University seem to be having an effect. Many callers refer to a previous presentation, and I seem to be getting fewer calls from students/interns from CU. I continue to believe that both schools could do a better job informing students about career options and counseling.

In the coming weeks, I should know the results of the 1995 IDP Firm of the Year Award judging. I had been in contact with Brenner Harr over the course of the past year so that the firm could prepare for the nomination. I have several firms in mind for this year, and will be contacting them in the coming months. Please contact me now if you have a firm you believe is deserving of this kind of recognition.

IDP and the State Board of Examiners continues to be a frustrating mix...the Attorneys General assigned to the Board do not understand the architects. In this instance where I was trying to offer suggestions attempting to clarify the licensing process for Interns, the solution was to provide duplicate paperwork with amended information. The architectural registration process is already complicated enough, rife with acronyms, without another piece of paper to read.

Architects & Photography A Call For Entries for a Jurored Exhibition at the Joint AIA Offices

The inaugural gala opening of the joint offices of the AIA Denver and AIA Colorado on Friday, March 3, was well received by the visiting public and professionals. 2. Submissions are open to all members of AIA Colorado (AIA, Associate AIA, Student Affiliates), Friends of Architecture, students from the College of Architecture & Planning, Denver and Boulder campuses. No entry fee. No limit to number, and size of entries. Be thoughtful in what is submitted.
3. Works will be jurored anonymously to maintain impartiality of review process. Attach to the back of each photograph in an envelope a card with the artist's name, title and date of work, telephone number, and media or process if relevant. Works must be submitted *ready to be hung* with all necessary hardware and directions as to image orientation attached.
4. Entries are due at the joint offices of the American Institute of Architects Colorado and Denver Chapters on Friday, May 12 by 5:00 PM. Works not accepted for exhibit can be picked up on or after Monday, May 22. AIA is not responsible for the return of images, unless already post-marked and addressed packaging is included with entries. All works exhibited in show will be available to be picked up after August 25.

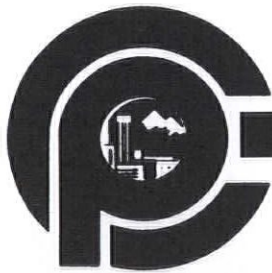
