## President's Message AIA Organization Restructuring Proposal

Your AIA Colorado Board of Directors has been evaluating the concept of reorganizing AIA Denver and AIA Colorado. The reason for change is so that we may better serve our members.

The reorganization idea was precipitated by the resignation of Betsy Boudreau, AIA Denver Executive Director, in January of this year. With this resignation came the idea of evaluating AIA Denver and AIA Colorado to determine if the current staffing adequately fills the needs of a growing and active membership.

In April of this year, the annual retreat was held to prepare a strategy for this issue. Twenty six board members from around the state participated. The retreat conclusion was that the organization should be led by a highly visible person that is either an architect or strong advocate of the profession. The support staff should be structured to provide direct assistance to all state chapters.

The retreat results identified the need for change, but did not address how this change should be implemented and what the organizational and financial ramifications will be. Therefore, the five AIA presidents were asked to form a task force and prepare a recommendation for the AIA Colorado Board of Directors.

The plan was developed and presented to each of the four chapters: AIA Denver, AIA Colorado North, AIA Colorado South and AIA Colorado West. With a few modifications, requested by the AIA Colorado South Board of Directors, the general plan was approved by each Board.

On July 21, 1995, the AIA Colorado Board of Directors approved the reorganization plan and identified steps that need to be taken for implementation. Although all of the details have not been finalized, the Board worked through August, 1995 to develop a job description for each of the positions, and start to advertise for candidates.

### The Organizational Structure Summary:

An AIA Colorado Executive Director (an architect being preferred) would be hired to lead AIA throughout the state in public relations, marketing of architects and fundraising. A strong national AIA connection and political knowledge is also desired. This person will be well paid and expected to make a big difference in how architects are valued by all Coloradans.

Two additional "Directors" will be hired primarily to work directly with the boards and membership of our three chapters. One would serve the Denver Chapter and one the North, South and West Chapters. These two positions are very much the same in salary and responsibility. The number of members is about the same for each director. The director for North, South and West will travel to each chapter to provide direct assistance.

The costs for salary and benefits when the full staff is complete as proposed would be about \$36,000 above the current costs. This is the most difficult issue we have to resolve. There are several possibilities, from extending the time of hiring to making the increased cost a part of a fundraising program.

The AIA Colorado board, including all presidents, approved the reorganization plan with these important provisions:

1. A definite financial plan must be provided and approved.
2. The State Executive Director should be an architect, if possible.
3. The task force can proceed to write job descriptions, advertise for the positions and compile a list of candidates.
4. The AIA Colorado Board will review the data at the August 18, 1995 Board Meeting.
5. Funds will not be spent except for advertisement until board approval of the financial plan.

I feel that AIA Colorado is clearly on the right track here. We cannot know all the ramifications of this new organization or exactly how it will be paid for. But, if our professional organization could promote us every day and continue to do so from Board to Board, year after year, our practice will be stronger as a result.

### *Victor Hornbein, FAIA emeritus*

The Denver community recently mourned the loss of one of its finest architects, **Victor Hornbein, FAIA emeritus**. Hornbein, who was honored by the Modern Architecture Preservation League in June, is best known for his design of the conservatory at the Denver Botanic Gardens. Other Hornbein projects included the Frederick R. Ross Branch Library, Aurora's City Center at 16th and Elmira Streets, Kent Denver Denver School, Cory Elementary School, Graland Country Day School, and the John F. Kennedy Child Development Center at the CU Health Sciences Center. Hornbein attended the atelier program of the Beaux-Arts Academy of Design in Denver. ## Design-Build in the Public Sector from the QBS Colorado Update

The Council on the Federal Procurement of Architectural and Engineering Services (COFPAES), representing the seven principal design and professional associations, believes that the selection of design professionals based on their qualifications provide the public with the best value for the design of the public facilities. In recent years, various agencies have begun to use design-build as an alternative project delivery process providing that it protects the interests of the government agency, design professional, contractor, and the public.

COFPAES believes that any acceptable alternative project delivery process should contain certain basic elements:

- A registered design professional (either in-house or retained) should represent the government throughout the entire project. The design professional, if retained from the private sector, should be selected based on their qualifications and experience according to the requirements of the Brooks Act as amended.
- The design professional should prepare the project scope, description, function, standards, design criteria, analyses, reports and cost estimates for the proposed project. A sufficient level of detail should be produced to provide an adequate description of the project scope and level of quality expected by the government agency.
- The design-build team must include registered design professionals who are selected based on their qualifications and expertise.
- The selection of a design-build team should include two steps. Step one, evaluation of the teams, would be based on the qualifications and experience of the competing teams. Step two would include a detailed evaluation of the proposals from the short-listed teams. The selection of the top design-build team would be based on pre-determined criteria established for the specific project, such as technical expertise, past performance, management capabilities, design quality, approach, schedule, and cost.

## Smart Growth and Development Awards

The Governor's First Annual Smart Growth and Development Awards competition in June drew over 200 entries from neighborhoods and communities, municipalities and counties, and regional partnerships between the public/private sector.

It was a good effort with some understandable first-year problems. Although the call was for "visions and plans," specific projects sneaked in, just to confuse the judges. Even more confusing was the disparity of information accepted from entrants and the broad nature of the criteria.

Nevertheless, this quick exercise highlights the state's new emphasis on vision and planning efforts which have no doubt increased, thanks to the Governor's Smart Growth initiative administered by the Department of Local Affairs.

McStain has been building homes in Boulder County and throughout the metro area since that time. The company has been ranked as one of the top ten volume Colorado home builders for the last five years.

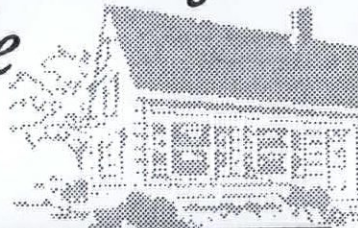
