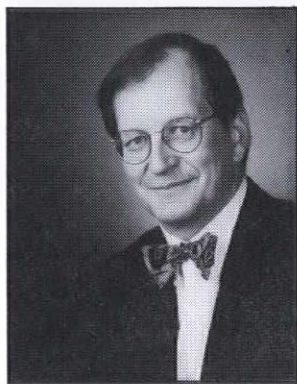

1996 AIA COLORADO AGENDA: "LEADERSHIP ARCHITECTS '96" by Dennis Humphries, AIA

The theme for the past two years of AIA Colorado has focused on the "Visibility of the Profession" under the guidance of 1994 president John Rogers, FAIA and the "Value of the Architect" under the direction of 1995 President Alan Zeigel, AIA. Building upon this notion of the role and importance of the architect, the 1996 theme for AIA Colorado will focus on "Leadership" and the responsibility of the profession to our local communities.

It has often been said the best way to predict the future is to create it. Our communities are growing increasingly diverse by race, age, religion, and socio-economic status. The architect has the opportunity to foster the growth of our state by identifying the common needs of these diverse agendas. 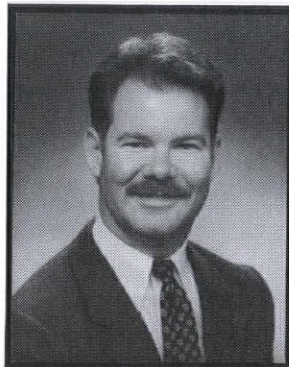
EXECUTIVE VICE PRESIDENT'S REPORT

For those of you who have not heard about my selection as your new Executive Vice President, I would like to take this opportunity to introduce myself. You may consider the background I bring to the staff of AIA Colorado unusual, in that I have association management experience as well as experience and education in the field of architecture and construction. This allows me to maintain my Associate membership with the Institute, affording me a view from "both sides of the fence." I attended the Southern California Institute of Architecture (SciARC), and also received a Bachelor of Science degree in Construction Management from California State University, Fresno. I've held professional architectural positions in both corporate and private practice settings and for the past four years it has been my pleasure to serve as staff to the AIA California Council, the largest state component of the AIA. My primary roles at the AIACC included promoting the profession by lobbying the state legislature and regulatory bodies on many issues affecting the practice of architecture. I also provided a liaison between the AIA and allied organizations and staffed a number of statewide committees (everything from building codes and standards to continuing education). I've served on a local AIA chapter Board of Directors as the elected Associate Director, and held a two-year term as the State IDP Coordinator.

During her tenure with AIA Colorado, she brought the chapter to a point of financial stability, increased membership, and efficiently organized and relocated the office. Linda has left me a very strong base to build upon, and for that I thank her.

IN MEMORIAM

Carl Gaede, AIA, a prominent Colorado Springs architect and member of the Colorado South Chapter, died on Thursday, December 7 of heart failure. Gaede was known nationally for his design of exquisite churches, universities and commercial buildings. He and his partner, Gary Larson, AIA, designed the Focus on the Family buildings and the Garden of the Gods Visitor Center in Colorado Springs. His work can also be found in California where he designed buildings for Focus on the Family in Arcadia and Pomona, and the Church of the Nazarene of Pasadena, which received an AIA National Honor Award. The church, which holds 2,500 people, set the pace nationally for contemporary church design. Gaede is survived by his wife Dawn and two children, Katrina and Peter of Colorado Springs.

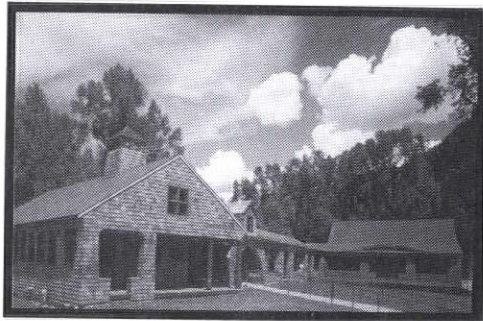

AIA COLORADO'S 1995 DESIGN AWARDS SHOWCASES OUTSTANDING ARCHITECTURE

At AIA Colorado's 1995 Design Conference on December 9, five Design Awards were announced for recognition in design excellence. Sixty-eight entries were judged by prominent architects from Connecticut. The jury was encouraged to take into account how well each project reflected and encouraged the use of resources, energy, technology and aesthetics. **Fred Koetter, FAIA**, Dean of the Yale School of Architecture was the Jury Chair. **Mark Simon, AIA** of Centerbrook Architects in Essex, Connecticut and **Tom Fisher, Editorial Director of Progressive Architecture** from Stamford, Connecticut also served as judges. **David Decker, AIA**, from Denver, served as the Design Awards Chair.

This year's winners reflect outstanding achievements in architecture, interiors, and urban design.

Lipkin Warner Design Partnership, of Aspen, for the **Aspen Music School/Aspen Country Day School Administration and School Building**. The existing school was

a nice collection of buildings dating back to the 19th century. Lipkin Warner invented the building plan circumscribing the classrooms and offices with porches and as many windows as they could. The porches now attract the students and the large central space behind the arches provide a new focus to the river which the other buildings had blocked off.



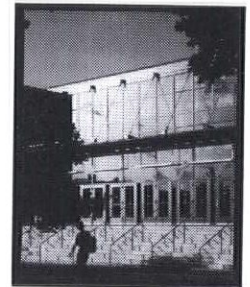
Offices of Humphries Poli Architects

Humphries Poli, Architects, PC, of Denver, for the **Offices of Humphries Poli Architects**. The storefront's transparency allows for the tools and process of making architecture become a neighborhood fixture, enticing pedestrians to stop and see models, drawings, machines and people. The interior

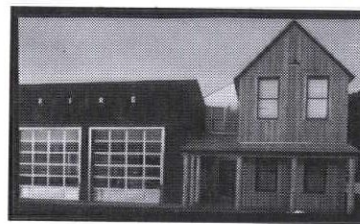
organization is straightforward. Walls were kept to a minimum in number and height, defining public, private and service spaces. A translucent, pine corrugated fiberglass "snow fence" provides a zone of visual privacy from the street while maintaining penetration of the southern light. This wall is backlit at night, bringing a warm animation and new meaning to a recently abandoned auto glass service garage.

Robert Kronewitter, FAIA, CICP, Campus Architect of the **Auraria Campus, Denver**, for the **Auraria Campus Design; Transformation Years 1982-1991**.

The goal of this project was to create a plan and design guidelines for the expansion of a new 180-acre campus in the Denver Business District. The campus is the home of three schools of higher education. There was frequently little support or financing for quality planning and design. Over 75 architects, landscape architects, planners, and specialty designers nationwide contributed to the effort. They donated time, provided inspiration, and offered design direction to make this project a success.

Rural Fire Station, Carbondale

Black Shack Studio Architects, of Aspen, for the **Rural Fire Station in Carbondale, Colorado**. This project was the design of a two-bay fire protection substation in a remote ranching area. Primarily

volunteer, this station will serve as a meeting house for area residents and was actually built by the firemen from the Main Station in Carbondale. The upstairs is a one-bedroom apartment for the local fire chief. The primary concept was to employ bold massing in order to distinguish component functions. Simple vernacular forms and materials were used in order to suggest permanence.

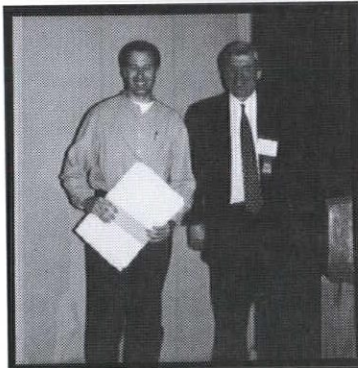
1995 AIA COLORADO DESIGN CONFERENCE: A PLACE TO NETWORK, MEET, AND LEARN

Curt Dale, AIA, receives his firm's (Anderson Mason Dale) award for the Georgia Barr Cabin

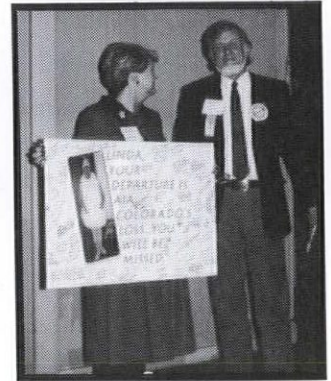

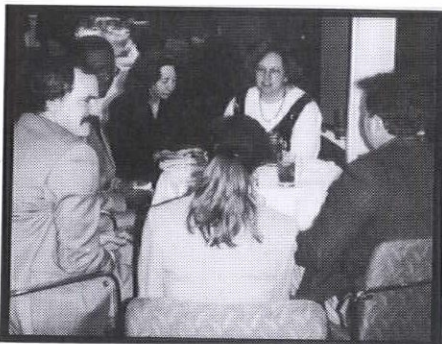

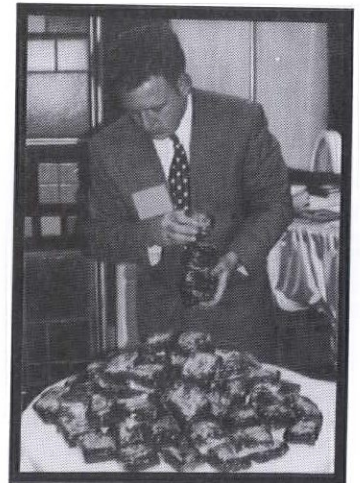

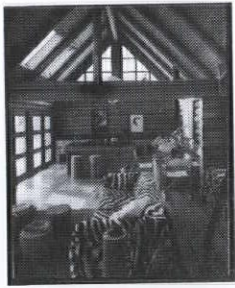

Georgia Bar Cabin

Anderson Mason Dale, PC, Denver, for the **Georgia Bar Log Cabin**. This retreat incorporated two rugged yet elegant log structures - main cabin and guest cabin - on the rocky and sandy bank of the Arkansas River. The cabin embraces the spectacle of the nearby 14,000 foot Collegiate Mountain Range. It is affectionately known as the Georgia Bar, after the famous gold mining claim

on which it is located. The design reflects the interaction with nature and the Western landscape.

ARCHITECT, FIRM, AND OTHERS HONORED AT 1995 DESIGN CONFERENCE

ARCHITECT OF THE YEAR: FREDRIC "FRITZ" BENEDICT

Fredric "Fritz" Benedict, FAIA emeritus of Aspen was named AIA Colorado's 14th Architect of the Year posthumously. He began his architectural career in 1945 after World War II. From his early days as an apprentice with Frank Lloyd Wright, he learned a great respect for nature and organic architecture. One of the earliest proponents of passive solar architecture and energy conservation, Benedict built Aspen's first passive solar home on Red Mountain in 1945. He also built an underground house on Hallam Lake in Aspen in 1949 for author John P. Marquand. His own house received a honor award from the Colorado Society of AIA in 1961 for its solar greenhouse/living room - the first of its kind in Colorado.

Benedict pioneered the science of year-round mountain resort planning and design in Aspen/Snowmass, Vail and Breckenridge. Beginning with an evaluation of how facilities and ski slopes would interface with topography, soils, vegetation and wildlife and the natural forces of wind, moisture and sun, his plans featured a careful concentration of density to preserve open space together with the separation of automobiles and pedestrians.

Benedict gave freely of his time and resources. Serving as a patron of the arts and architecture, and as a planner, he was instrumental in the early development of the Aspen Institute for Humanistic studies and the Aspen Music Festival and school,

for which he served as Chairman for seven years. Appointed by the Governor to the Colorado Historical Preservation Committee, Benedict led the crusade in 1976 to preserve the historic Wheeler Opera House in Aspen. As Founder and President of the 10th Mountain Hut and Trail Association, he fulfilled a dream of connecting a hut system for cross-country skiers from Aspen to Vail.

Mr. Benedict died in July, 1995. AIA Colorado is proud to honor him.

FIRM OF THE YEAR: COTTLE GRAYBEAL YAW ARCHITECTS

Cottle Graybeal Yaw Architects of Aspen was the recipient of AIA Colorado's fifth **Firm of the Year** award. This honor is awarded to the firm that "best represents the practice of architecture." This fall the six-state Western Mountain Region of AIA also selected the Aspen-based firm as the recipient of the 1995 Regional Architectural Firm Award.

Cottle Graybeal Yaw Architects promotes professional development by maintaining a stimulating, intellectual environment. They believe in a strong knowledge base as the foundation of innovation, and innovation to be the heart of successful, memorable and unique projects. Participation is encouraged at all levels to stimulate both client and employee.

As part of their community leadership, Cottle Graybeal Yaw sponsored local AIA events, such as the Jersey Devil's speaker, James Wines lecture, and 10 X 10 presentations. Involvement within the profession and the AIA is emphasized and supported by the firm. Four employees currently serve on the AIA Colorado West Chapter Board and members of the firm have served on the Board of Directors for AIA Colorado. Valuing good ideas over authorship, employees are encouraged to participate in the design process and attend client meetings. Mandatory site visits for the entire project team and weekly presentations of all office projects and new technologies are given to keep the entire staff well informed. The firm provides educational funding, lucrative employee benefit packages and has sponsored college and high school internships.

Founded 25 years ago, Cottle Graybeal Yaw Architects has developed a unique expertise in the specialized field of resort architecture and design. They operate on two distinct scales - design for destination resort villages and single family custom residences - and believe they mutually benefit one another. In addition to the four to six custom residences they accept per year, some of Cottle Graybeal Yaw's current projects include 4 buildings in the new River Run Village at Keystone; a \$100 million mixed-use project in South Lake Tahoe; and a new ski village in Muju, Korea. AIA Colorado is proud to add Cottle Graybeal Yaw Architects to its list of distinguished awardees.

25 YEAR AWARD: ZECKENDORF PLAZA AND THE HYPERBOLIC PARABOLOID

For the second time, a Twenty-Five Year Award was presented to the **Zeckendorf Plaza and the Hyperbolic Paraboloid** designed by the team of I. M. Pei and Henry Cobb. The "test of time" is used to single out completed projects to receive this award. The criteria is that the project must have been completed 25 to 30 years ago and still be a part of Colorado's landscape.

The Zeckendorf Plaza Development, consisting of the landscaped people-place skating rink and the Hyperbolic Paraboloid is more than worthy of this honor. The downtown block known as Court House Square got its name from the Arapahoe County Court that had stood there from 1865 until it was demolished in 1933, after the City and County Building was occupied.

William Zeckendorf, a real estate developer, hired a talented but unknown architecture instructor from Harvard in 1948. Together they began making superb spaces, beginning in Denver with The Mile High Center and Court House Square. Zeckendorf and Pei succeeded in giving uptown Denver a landmark symbol, as well as a new tree-shaped people-place which it had lacked since the court house square became a parking lot.

In 1969, The American Institute of Architects gave its National First Honor Award to the May D & F Store, the Hyperbolic Paraboloid Pavilion and the skating rink, then called Zeckendorf Plaza. The jury's comment in 1969 was "a simple and large building mass accomplished by the rich sculptural form of an appendage surrounded by outdoor features for the enjoyment of the public in a crowded downtown area."

Lou Wynne of Colorado Springs was named this year's recipient of the Contribution to the Built Environment. Recognition for this award is awarded for outstanding accomplishments of a non-architect in Colorado for demonstrating exemplary achievements in contributing to the quality of the built environment.
