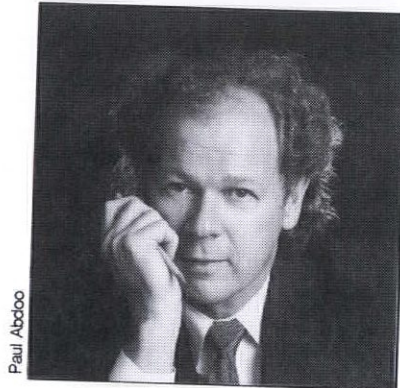

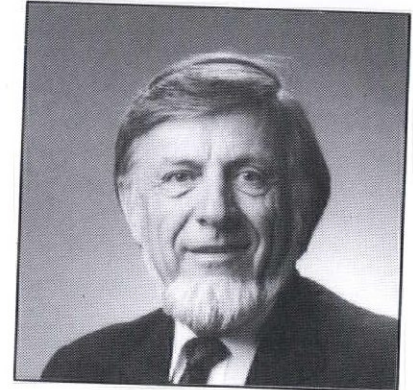

1996 FELLOWS NAMED

Curtis W. Fentress, FAIA, and Marvin Sparn, FAIA, to receive Top Honors at Convention

Curtis Worth Fentress, FAIA, of Denver, a member of the AIA Denver Chapter, and Marvin J. Sparn, FAIA, of Boulder, president of AIA Colorado North Chapter, were selected, along with 89 architects throughout the nation, to be inducted into the AIA College of Fellows. With the exception of the Gold Medal, fellowship is the highest honor the AIA can bestow on a member. There are less than 2,000 FAIA members recognized out of a membership of over 58,000. It is conferred on members with at least 10 years of continuous membership who have made significant contributions to the aesthetic, scientific, and practical efficiency of the profession; to the standards of architectural education, training, and practice; to the building industry through leadership of the AIA and other related professional organizations; to the advancement of the living standards of people through their improved environment; and to society through significant public service. The new Fellows will be invested in the College of Fellows at the 1996 AIA National Convention in Minneapolis on May 11th.

Curt Fentress

Selected for his promotion of the aesthetic, scientific and practical efficiency of the profession, Curt Fentress' designs are easily recognizable, from the tented roof of the Passenger Terminal Complex of Denver International Airport; to the Colorado Convention Center, 1999 Broadway; and the Jefferson County Government Center.

A graduate of the School of Design at North Carolina State University where he finished at the top of his class, Fentress worked for the New York firms of I. M. Pei and Partners, and Kohn Pederson Fox, before forming C. W. Fentress and Associates (now C. W. Fentress J. H. Bradburn and Associates, P.C.) with James Henry Bradburn in 1980. C. W. Fentress J. H. Bradburn & Associates is a firm that practices both nationally and internationally, and they have won over 105 design awards. Curt is a member of the Denver Chamber of Commerce, Denver Partnership, Historic Denver, National Trust for Historic Preservation, the Urban Land Institute, the Urban Design Forum of Denver, the Royal Institute of British Architects (RIBA), and AIA National's Design Committee. Curt served as the President of AIA Colorado in 1993, and says, "It is my belief that creative thinking breeds design excellence. Through this concentration comes original and relevant contextualized architecture that is at its heart "humanized." "

Marvin Sparn

Boulder architect Marvin Sparn was selected for his promotion of the building industry and the profession of architecture. His role in the founding of AIA Colorado's model Government Affairs Committee has spawned similar movements nationally, creating a bond between the profession and the Colorado Legislature. His focus on such issues as Architect/Engineer Qualification Based Selection, contract language liability for architects with regard to asbestos abatement, and school district contracts has had a solid impact.

A Sole Proprietor of his own firm, Marvin J. Sparn Architect, since 1977, Sparn is a graduate of C. U. Boulder. Marvin was the recipient of the 1995 AIA Colorado Education Fund Alan Fisher Scholarship for Foreign Study, and has won many community awards including an Appreciation of Service Plaque from the Boulder YMCA; a Monday Morning Rose from the Boulder Daily Camera in 1991 for his Community Service to Seniors; and the Steve Dach Memorial Award for Design Excellence in Colorado Masonry for Leanin Tree, Inc. in Boulder, from the Rocky Mountain Masonry Institute in 1992. Currently the president of AIA Colorado North (a position that he has previously served), Marvin has been the President of AIA Colorado and the Treasurer of the AIA Western Mountain Region.

AIA Colorado salutes Curt and Marvin for their dedication to their communities, the promotion of the profession of architecture, and their commitment to the AIA at the National, State and local levels. Congratulations!

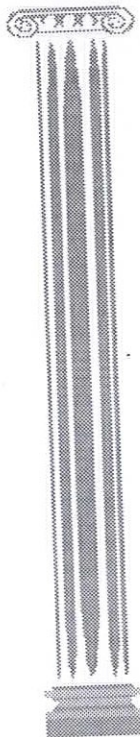

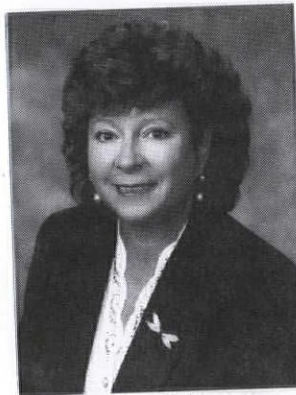

PENDING LEGISLATION: STUDENT LOAN DEFAULTS CAN COST LICENSE!

77,000 federally insured student loans in Colorado are in default, a number estimated to be less than 5% of all such student loans. No one is quite sure how many of the borrowers are among Colorado's 300,000 licensed professionals, although preliminary estimates set the future high at 8%. But those professional "deadbeats," which may even include a handful of architects, are the target of HB 1093.

WHY THE SUNRISE AND SUNSET REVIEW COMMITTEE SHOULD BE ELIMINATED

After I completed my term as chairman of the Colorado State Legislature's Joint House and Senate Sunrise and Sunset Review Committee, I was convinced that there had to be a way to maintain the review of state boards and agencies by the General Assembly, but streamline the process.

The process was extremely cumbersome. Our six-member committee met virtually the entire summer. We took recommendations from the professional staff at the Department of Regulatory Agencies (DORA). We heard testimony urging changes in licensing acts. We were lobbied by professional trade associations happy or unhappy with elements of the system that regulated them. We rewrote statutes. We divided up the workload among members of the committee assigned to carry licensing bills. *THEN WE STARTED OVER.*

Each bill had to be heard *AGAIN* by *BOTH* standing committees of the Legislature that appropriately dealt with the subject matter. Medical issues were heard by the Health Committees, for example, and the Insurance Division by the Business Committees. I believe that this is the appropriate venue for such discussions. The Health Committee deals with medical issues as a continuing matter. The Business Committee has insurance issues before it as a matter of practice.

The Sunrise/Sunset Committee, on the other hand, lacks that expertise. For example, during my tenure, nearly one-half of our reviews dealt with Agriculture issues and yet not one member of our Committee served on the House or Senate standing Agricultural Committees. Five of the six of us were from urban districts. Yet we had to carry legislation dealing with egg handlers, apple storage or farm products before the House and Senate Agriculture Committees whose members *DID* understand the subject matter. Our sponsorship of such bills was awkward at best.

HB 1159, which I am carrying with Senator Bill Schroeder (R-Morrison), would streamline the procedure. It would amend Colorado's Sunrise and Sunset Review process to keep the review but change the venue. The Joint Legislative Sunrise/Sunset Review Committee would be eliminated. Standing committees of the Legislature would conduct the hearings as they do now, but the legislative process would **START** in those committees. DORA recommendations would be forwarded to the Legislature in September instead of July.

If this legislation is enacted into law, the current "process duplicity" ends. Committees with the appropriate subject matter experience will be involved earlier and more directly in the review.

The Colorado experience on this issue is one shared by numerous other states. At its peak, 33 states had separate sunrise/sunset review committees. Now, fewer than 20 do. I fully expect Colorado to join the exodus.

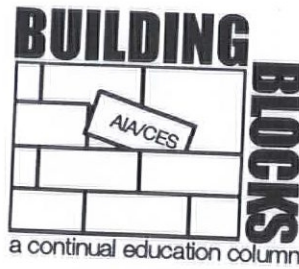

Introduced by Rep. Andy McElhany (R-Colorado Springs), the bill would prohibit licensing agencies from issuing or renewing licenses to professionals who are in default of student loans. The bill passed through the House Education Committee and is sitting in the House Appropriations Committee.

Whether it will move from the committee probably depends on the ability of the Colorado Student Loan Program and the Department of Regulatory Agencies (DORA) to agree on a fiscal note. Student loan records and professional license records would have to be merged. It might take a number of state employees to run the program. Estimates of the cost of administering the screening and notification program range from \$89,000 to \$1.2 million. These would be cash funds, so the cost of each license would increase somewhere between an estimated 30 cents and \$4.00.

DORA opposes the bill. If it should become law, professionals could recapture their suspended license by starting repayment of the loan.



Answers to CES questions you didn't know how to ask

Is It Required?

Yes. It is mandatory for architect membership in the AIA.

Why?

Lifelong professional learning is necessary for success in our businesses. The AIA/CES is designed to assist us in maintaining our competence and achieving our professional goals.

How do I get started?

You can earn credit, or learning units (LU's), in two ways:

1. Participating in programs offered by chapters, firms and other registered providers; in this case, there's no paperwork at all for you to deal with.
2. For self-directed personal learning activities, you simply complete and return a preprinted form so that the data can be entered into your individual transcript.

How much time do I have?

To have sufficient time to become acquainted with CES, you have until December 31, 1997 to earn 36 LU's. Thereafter, beginning in 1998, you will be asked to earn 36 LU's each calendar year to maintain your AIA membership.

Where can I get help?

Assistance may be obtained from the national AIA and your local chapter, or call Dori Harrell at AIA Colorado at 303/446-2266 or 800/628-5598. The National AIA has increased its staff commitment for CES and has established a hotline to provide a source of information and respond with requested materials and forms. GOVERNMENT AFFAIRS COMMITTEE TAKES ACTION

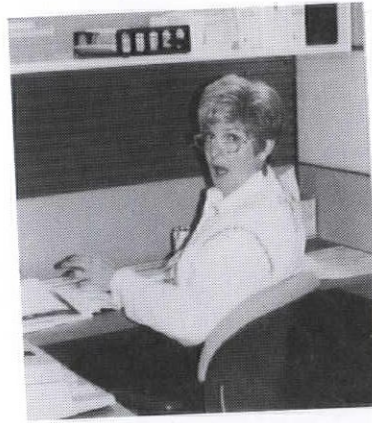

There is a statement which is attributable to one of our State Supreme Court Justices, and it goes like this: "No man, woman or child in Colorado is safe while the legislature is in session." This seems to be true in the case of this year's Colorado Legislature.

As some of you know, the AIA Colorado Government Affairs Committee (GAC) has a special Legislative Subcommittee that meets every Friday morning during the legislative session to review all the bills that have been introduced (over 600 are introduced each year) as well as amendments made in committee as the bills progress through the legislative process.

Freshman Representative Eric Prinzler of Thornton introduced House Bill 1171, titled *A Bill for an Act Concerning Privatization of the Regulation of Professions and Occupations*. In short, HB1171 would do away with the Department of Regulatory Agencies (DORA) and all licensing boards in the state in the context of allowing the private sector to monitor and administer licensing requirements. As soon as this bill was introduced, it was immediately flagged by the Legislative Subcommittee for consideration and concern. The bill was also brought to the attention of AIA Colorado by the Engineering Society, the Dental Association and other groups which the AIA, through its lobbying efforts, has gained respect and cooperation with during the 18 years of GAC activity at the Capital.

Immediately after recognizing the detrimental ramifications of this bill, the GAC polled our allies and launched its efforts to kill the bill. In attendance at the House of Representatives Business Committee meeting for the bill's first reading were our contract lobbyist Jerry Johnson, our executive vice president Joe Jackson, and GAC members Mike Wisneski, D.A. Bertram, and Jim Zavist who testified in opposition of the bill. In addition, representatives from various other licensed professional agencies testified against the bill, and following a heated discussion of the measure, it failed to pass out of committee and was "Postponed Indefinitely" (a nice way of stating *killed*). This is just one example of the dedication and quick response that the GAC provides to AIA Colorado and all architects in the state.

After earthquakes, fires and floods in California, hurricanes in Florida and Hawaii, and the tragic explosion in Oklahoma City, architects were on hand to help coordinate community relief efforts, organize structural assessment teams, and offer assistance on various projects associated with community recovery efforts. In the wake of certain disasters, architects also have teamed up with local government officials to push for new building codes and other structural safety requirements. Locally, an example of this effort followed the devastating tornado that struck Limon a number of years ago.

By having groups of architects serving in advisory roles in the aftermath of emergencies, the AIA is better able to facilitate response times when our state or other states need coordinated relief from federal agencies in Washington. Offering assistance to urban and rural communities during rebuilding and recovery efforts helps address the architectural profession's concerns with structural safety and environmental quality.


