AIA Colorado South Chapter

The reception for Colorado South Associates and Interns originally scheduled for Tuesday, July 9 at the Hillside Community Center, was rescheduled for Tuesday, August 27 at 5:30. The guest speakers were **Steve Frey, Associate AIA**, AIA Colorado Associate Director, and Margaret Gilbert, Secretary of the Colorado State Board of Examiners of Architects. It was a great opportunity to learn about the Architectural Registration Exam, the Intern Development Program, and NCARB.

The South Chapter hosted an exhibit at the *piazza!*AIA gallery in August, and had a just-for-fun outing to the Sky Sox baseball game on August 29.

Denver Chapter

For 1996, AIA Denver will celebrate outstanding design by spotlighting the growth of Denver. Citizens actively make use of the new airport, baseball stadium, convention center, central library and numerous retail marketplaces. AIA Denver sees the resurgence of downtown through renovation of older warehouse and office buildings for new lofts, restaurants and retail shops. Many historic sites have been restored and Denver visitors experience this growth and revitalization through new architecture.

For those who live here, there are also a variety of newly designed housing opportunities and recreational venues. Denver is changing dramatically with respect for the past but a definite focus on the future. AIA Denver recognizes all these contributions to the urban landscape and celebrates them with this year's theme: "**Denver...A New Spirit of Architecture.**"

Design awards for built projects will be issued in three categories: architecture, interiors and urban design. All building types will be considered, including residential, commercial, restoration, and industrial. Future projects will be eligible for separate awards in their own respective category. In addition to design awards based on projects, a separate category of awards will focus on craftsmanship and technical achievement. A People's Choice Award will be chosen via public ballot at the awards program.

AIA Denver also presents several local chapter awards for

outstanding contributions to the profession including Young Architect, Public Service, 25-Year Award, Sudler Award and Community Service Award. All exhibits will be published with accompanying photography in the AIA Denver Awards Program booklet, which will be provided to all attendees at the door. All exhibits will be on display for two weeks following the awards program in the Denver Central Library. The program includes a cash bar and viewing of all the exhibits with recognition of the award winners.

Atlanta's Lloyd Bray, AIA, partner in Scogin Elam & Bray Architects, Jury Chair and keynote speaker, will present internationally acclaimed work of his firm on Friday, September 27 from 5:00 - 6:30 PM, followed by the AIA Denver-sponsored awards program on Saturday, September 28, from 6:30 - 8:30 PM. Both events are being held in the new Central Denver Public Library. Attendees will enter through the southwest entrance near the bright orange art sculpture off 13th Avenue and Acoma Street. Ample parking is available directly across the street from the library entrance. The public is invited to attend. Tickets for non-members are \$5 for the lecture on Friday and \$25 for the Awards Program on Saturday. Tickets are available through the AIA Denver office or at the door. Call 303/446-2266.

Easy Access Housing Design Awards Program

Millions of American families include someone with a disability. Accessible or easily adapted single-family housing is a major concern for these families and for aging Americans who wish to continue living in their own homes. In response to this concern, Century 21 Real Estate Corporation and the National Easter Seal Society have created the Easy Access Design Awards program. Undertaken in cooperation with the AIA through its AIA Research division, the program seeks to recognize high quality, innovative housing designs which enhance accessibility for the elderly and/or persons with disabilities.

PARTICIPANTS

Leadership AIA will select 20 to 30 participants who have been identified as potential leaders with the interest and skills to provide leadership in service to the community and the architecture profession. Participant selection is made by the *Leadership AIA* Steering Committee based on written application and a potential interview. Participants will come from a diverse cross-section of the profession, including students, interns and licensed architects. AIA/CES Learning Units will be awarded.

THE APPLICATION/TUITION

To apply for *Leadership AIA*, complete the application on the reverse and return to AIA Colorado with a copy of your resume. The deadline for applications is September 27, 1996. Due to the limited enrollment, interviews may be scheduled the week of September 30. You will be contacted to schedule a time. All tuition fees will be refunded if you are not accepted into the program.

Tuition for the seven-session program is \$195, paid prior to the first session by the participant or the sponsoring employer. A limited number of scholarships will be granted annually to individuals who otherwise would be unable to participate. Requests for scholarship assistance must be made with the application.

Colorado's Best in Residential Architecture Award is sponsored jointly by AIA Denver and Colorado Homes & Lifestyles Magazine. This annual award program aims to bring the finest residential design work in the state to the public's eye. Residential projects of any type from multi-family lofts in Lo-Do, to mountain top retreats are eligible. The prize, beyond the recognition of your peers and a handsome certificate, is being featured in Colorado Homes & Lifestyles Magazine.

With a readership of over 121,750, Colorado Homes & Lifestyles Magazine is the most widely read design publication in the region. Photographs and editorial on the Award Winner and Merit Award Winners will be published in the March-April issue of 1997. Other projects may be selected by the Editors for publication in a later issue.



Eligibility

Project Types. All new or remodeled, single family or multi-family residences, custom projects and projects built on speculation are eligible for consideration subject to the restrictions which follow.

Previous Awards or Publications. No projects which previously received an AIA Award or which were previously featured in Colorado Homes & Lifestyles are eligible.

Location and Age of Project. Any projects constructed within the last five years and within the State of Colorado are eligible.

Architect. The project must have been executed by, or under the direct supervision of a licensed Architect, or by an Architectural firm whose principals are so qualified (AIA affiliation is not a requirement).

Submission Requirements

Please submit the following materials in a 1/2" - 1" binder with a back pocket. The binder must be no larger than 8 1/2" x 11" in size. The applicant's name should appear on the entry form only.

- 1. Call for Entry and Waiver Form.** All information must be provided as requested, however the Owner's name may be withheld if so noted.
- 2. Entry Fee.** Make your check payable to AIA Denver for \$75.00. Rejected and/or incomplete submittals will not receive a refund.
- 3. Photographs and slides.** Please note that professional quality photographs suitable for reproduction by Colorado Homes & Lifestyles Magazine are required. Applicant should select photos which best convey the design concept--including a minimum of three exterior and three interior shots. Entries are required to have a minimum of six slides for judging and awards night presentation.
- 4.** You may submit floor plans, sections, elevations and any other visual materials within the format requirements which the Applicant feels best represent their project.
- 5.** Please include a project description and narrative (not to exceed one page) which elaborates on the design goals and architectural or conceptual features of the project.
- 6.** Submissions for the COBRA Awards program not received by 5 p.m. November 14, 1996 at the Denver AIA offices (DEADLINE) will be rejected.
- 7. Return of Materials.** Although care is exercised in the handling of all submittal materials, AIA Denver and the COBRA Awards Committee cannot be responsible for the safekeeping of, or damage to, any submitted materials. Entrants are cautioned regarding the submittal or use of irreplaceable materials. Entrants must enclose a self-addressed, stamped envelope (with sufficient postage) for the return of submittal binders.

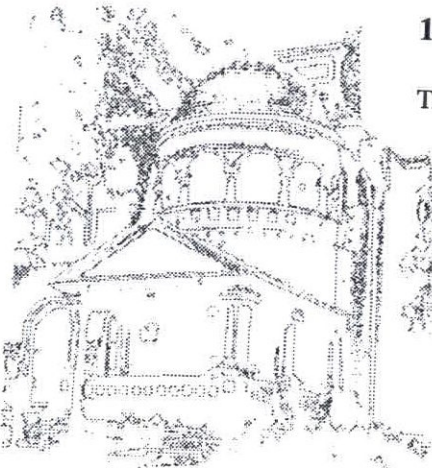

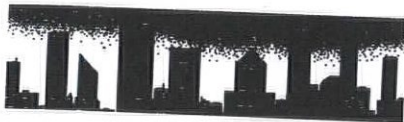

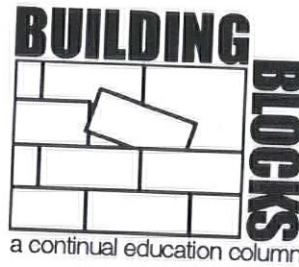
