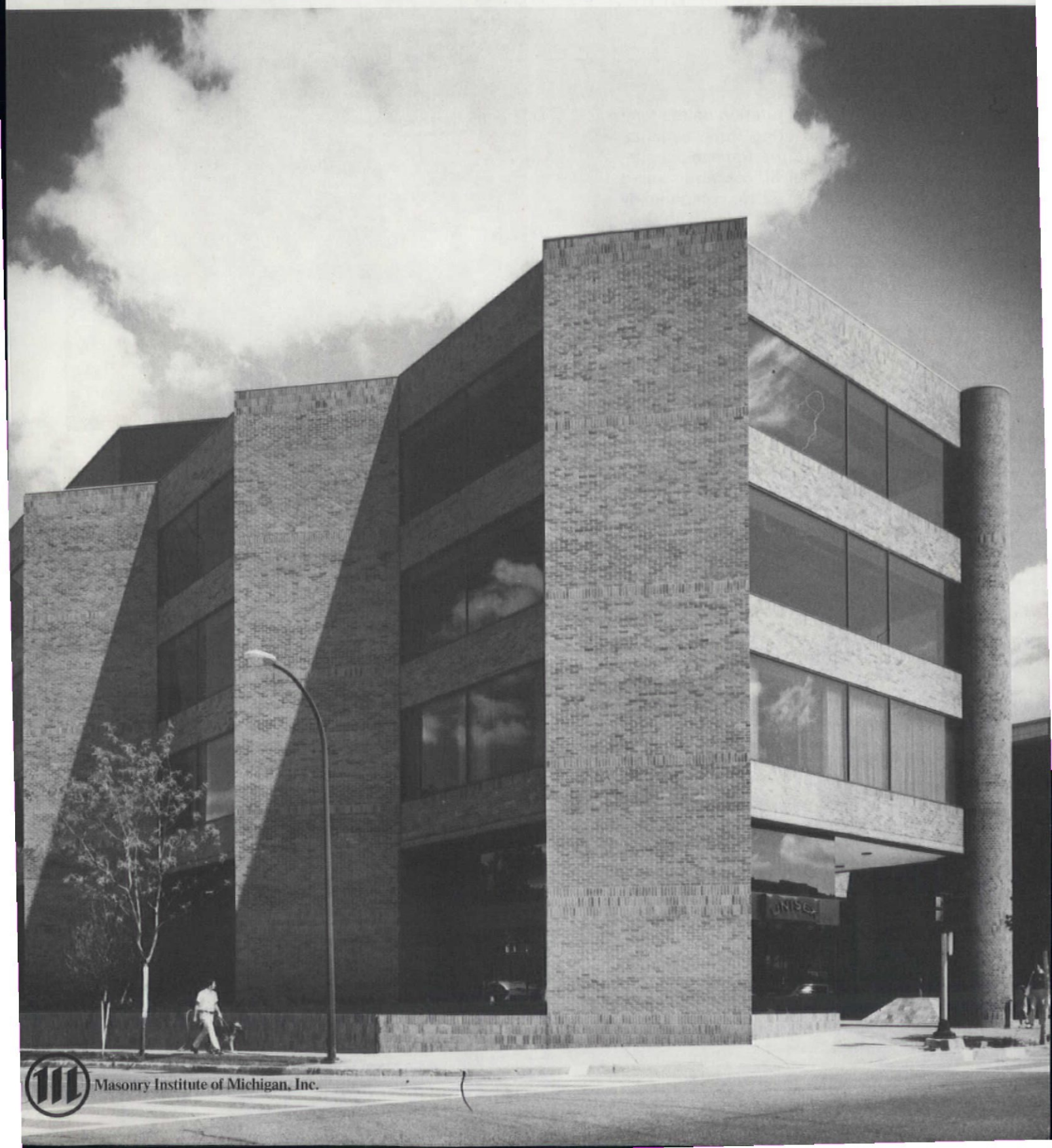

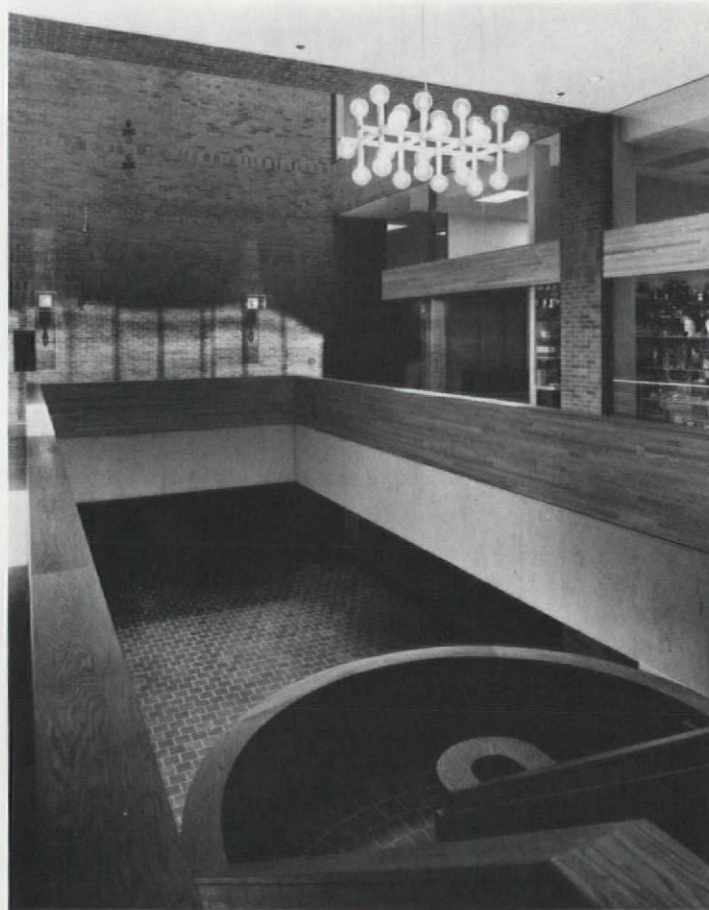
## Birmingham office building wins 1976 'M Award' for Rossetti Associates

The Great American Insurance Company Office Building, a powerful expression of the human scale of masonry, won for Rossetti Associates Architects Planners, of Detroit, an "M Award" in the second annual masonry design program sponsored by the Masonry Institute of Michigan in cooperation with the Michigan Society of Architects. (Mason contractor on the project was G. Forte Co. of St. Clair Shores.)

In all, four architects and their projects were honored by a distinguished panel of Philadelphia-area architects who judged the submissions.





## REGISTRATION REQUIREMENTS

### Educational Guidelines:

Mr. Metcalf moved that effective January 1, 1977, in accordance with the provisions of Act 240, applicants for registration as an Architect in the State of Michigan must have passed the Professional Examination and completed eight years combined education and experience. Requirements for admission to the Professional Examination may be met in two ways: 1. Applicant must hold a 5-year Bachelor of Architecture degree or a 6-year Master of Architecture degree from a National Architectural Accrediting Board's accredited School of Architecture. In addition the applicant must have completed three years practical training in the office of registered Architects who are practicing as principals, or the equivalent as outlined in the current National Council of Architectural Registration Boards' Table of Equivalents. Two years of this practical training must be obtained after the applicant has completed the education requirement. 2. Applicant must have passed the Qualifying Examination (formerly Equivalency Exam.) and completed four years of practical training in the office of registered Architects who are practicing as principals or the equivalent as outlined in the current National Council of Architectural Registration Boards' Table of Equivalents. Three years of this practical training must be obtained after the applicant has completed the education requirement. To be eligible for the Qualifying Examination, an applicant must hold a baccalaureate degree as follows: (a) Non-Accredited Bachelors or Masters degree in Architecture. (b) Bachelor of Architectural Engineering degree. (c) Pre-professional Bachelor of Science degree from Lawrence Institute of Technology, University of Detroit, or University of Michigan (4 year). (d) Any other pre-professional baccalaureate degree related to Architecture and acceptable to the Board. (e) Bachelor of Engineering degree, Engineers' Council for Professional Development accredited, Civil, Mechanical, or Electrical (4 year). (f) Foreign Architecture or Architectural Engineering degree as approved by the Board after review of transcript.

Mr. DeVries seconded the motion which passed unanimously.

### DC/AIA POSITION PAPER #1

The American Institute of Architects must continually strive to represent and unite all registered architects in the United States if it is to remain a force to be dealt with politically and professionally. Since such an effort is an

overall goal of this Membership Committee, we are trying to look beyond and with somewhat more depth, the usual task of coaxing new members to join each year. This is the first in a series of Membership Committee position papers which will address specific professional problems and solutions, as we see them, related to the impact on membership recruitment.

Surveys have indicated that many of the non-member registered architects are young.

We therefore looked to this group as a specific problem area with great potential. If we do not attract newly registered professionals early, the span of time tends to make their membership less likely at a later time as well. We have found that the cost of AIA Corporate Membership is a major deterrent for involvement in the AIA by these young registrants. Consequently, our proposal is simply a system of graduated dues for new corporate members on The Detroit Chapter and Michigan Society of Architects levels.

Such a system of graduated local and regional dues would be in keeping with the goals and practices of the National AIA. In addition to the National's graduated dues system, presently many local chapters and regional societies have graduated dues systems working well.

We propose and encourage that a new dues structure for Corporate Membership be initiated immediately, as shown below:

As shown, when an architect joins AIA under this proposal, he would pay dues of \$90 for his first year, as compared to the present \$180. Currently, these dues represent a sizeable investment for someone who may be recently married, starting a family or buying his first house on a limited budget. As his position, skills and salary increase, he would be more likely and willing to pay more, gradually over the five year projection.

The results of this proposal would be an increase in the Corporate Membership of young registrants. Certainly, there may be minor administrative adjustments needed in the DC/AIA and MSA to handle a system of graduated dues. However, such difficulties should not be the cause of preventing this system from becoming a reality.

If we can encourage more young new members, they will rapidly become aware of the benefits and satisfaction of participation in the AIA and will continue as active members. If we fail to accommodate the young member, he will learn



to cope with his profession without participation in the AIA, and may be alienated forever by the existing dues structure. Even though a young registrant cannot afford the current dues, this proposal will allow the AIA to take advantage of youthful enthusiasm to better and strengthen our organization.

#### DETROIT SCIENCE CENTER OPENS DOORS

Increased interest and an upsurge in attendance at the Detroit Science Center has resulted in the decision to open the Center on Saturdays -- making it open to the public seven days a week.

The change in schedule was announced by Dr. David Frantz, Director, who said the Science Center will be open from 10 a.m. to 5 p.m. Saturdays, beginning March 19. Located at 52 East Forest, the Detroit Science Center will remain open as in the past Monday through Friday from 9 a.m. to 5 p.m. and on Sunday from noon until 5 p.m.

With the doors open to the public on Saturdays, a greater number of Detroiters will be given the opportunity to visit the Center, he said, when the program format, like that for Sundays, will be geared to family visitors, with special films and demonstrations designed for family viewing.

Admission is free, although donations are welcome. Arrangements for group tours may be made by calling 833-1892.

#### LETTER / C.E.C.

Dear Miss Stacy:

I am writing in regard to the article titled "Report on Continuing Education" appearing in the March Issue of the MSA Newsletter.

As one of the many architects who believe in performing the best services possible for their clients, I am in favor of continuing education for architects, however; I am definitely against any laws requiring continuing education. It would be interesting to know of the architects who are working at their profession, how many are in favor of such a law. All too often a legislator will propose a law thinking it is something the general public cannot be against (whether or not, in fact the law is a good law). Often times, things seem to be good on the surface, but after having been put to actual use, prove to be otherwise.

Laws should not be passed just because no one is against them. A legislator may be for a proposed law because he wants to run up his score of passed laws and, therefore; supposedly justify his re-election. School administrators or professors could conceivably be in favor of supporting or even instigating such a law.

Speaking for myself, I know my realm of professional practice and I make certain that I am informed to the extent required by that practice.

If such a law were passed, it seems that it would be just one more step to make it more difficult for the architect with a smaller practice to stay in business. At a time when clients are scarce and business, in general, is poor, it does not make sense to even consider such a law. For those of us who still want to work for a living, I object to the actions of those who are bent on placing impediments in the way.

#### OBITUARY

Richard Raseman, former Detroit Chapter member, died November, 1976. Mr. Raseman had been Alcona County resident since 1949, and served as a member of the Alcona County School Board from 1952 to 1962. He was vice-president and executive secretary of Cranbrook Academy of Arts, Bloomfield Hills, from 1932 to 1943 and was a member of the Board of Directors of Port Huron Paper Co. from 1936 to 1971. He served as a Lt. Commander with the U.S. Naval Reserve from 1943 to 1945. He was president of the Detroit Chapter from 1937 thru 1939. He is survived by his wife and two daughters.

George Bickford Brigham, FAIA, former Detroit Chapter member died March 2, 1977. Mr. Brigham, an Ann Arbor architect for 40 years and professor emeritus from the University of Michigan was elected to Fellowship in 1970 for outstanding achievements in design, education, and research. He has done a number of fine residential projects dating back to the thirties which are distinguished examples of contemporary architecture. He was one of the early educators to break with the traditional style approach and during his long career at UM exerted a great influence on many of the architects now practicing in Mich. and throughout the country. He had for many years conducted extensive research in the area of systems building and pre-fabrication and continued this work today even though he was in his eighties.

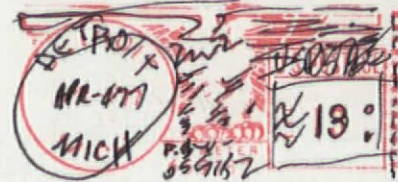
