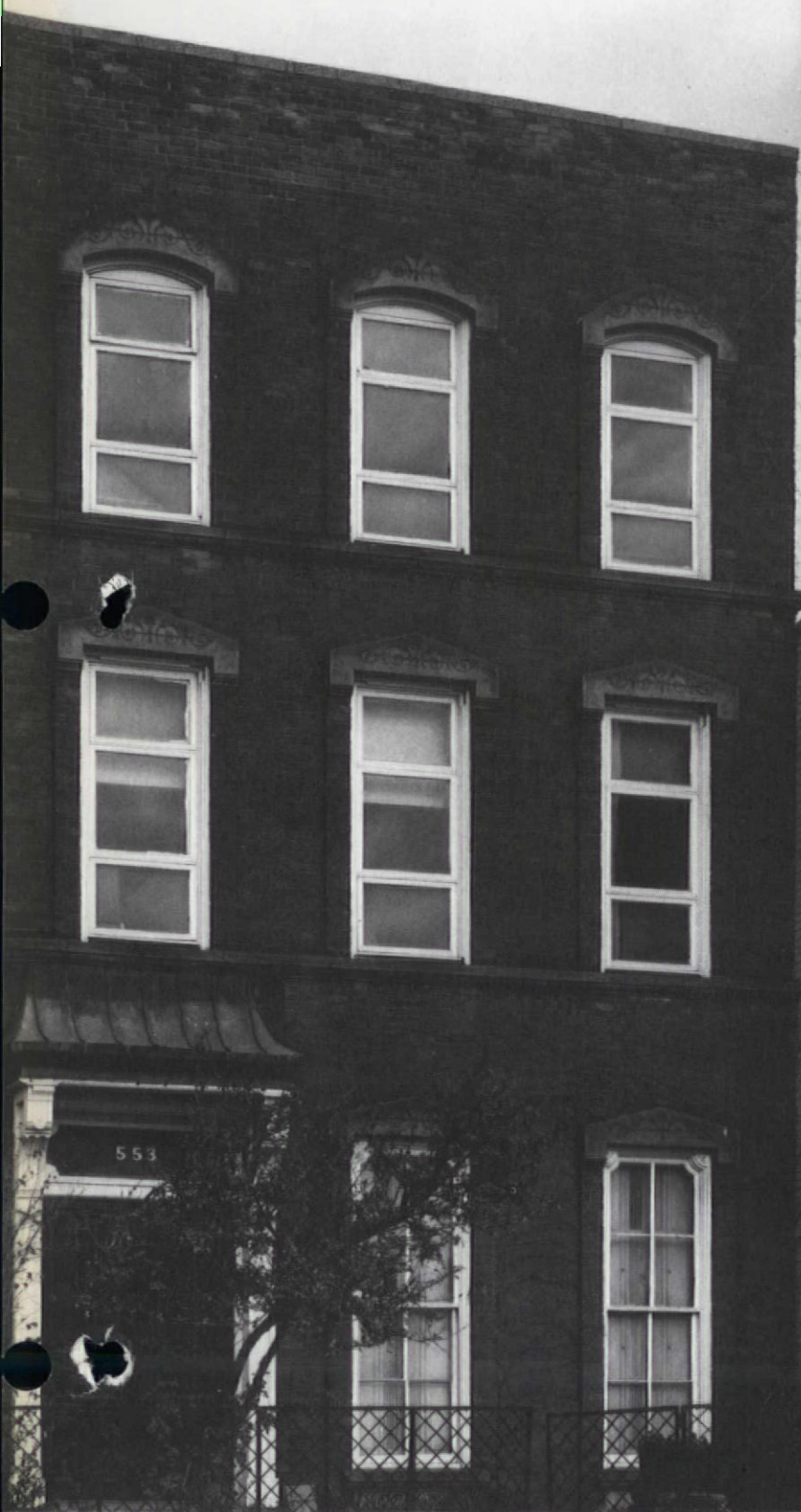


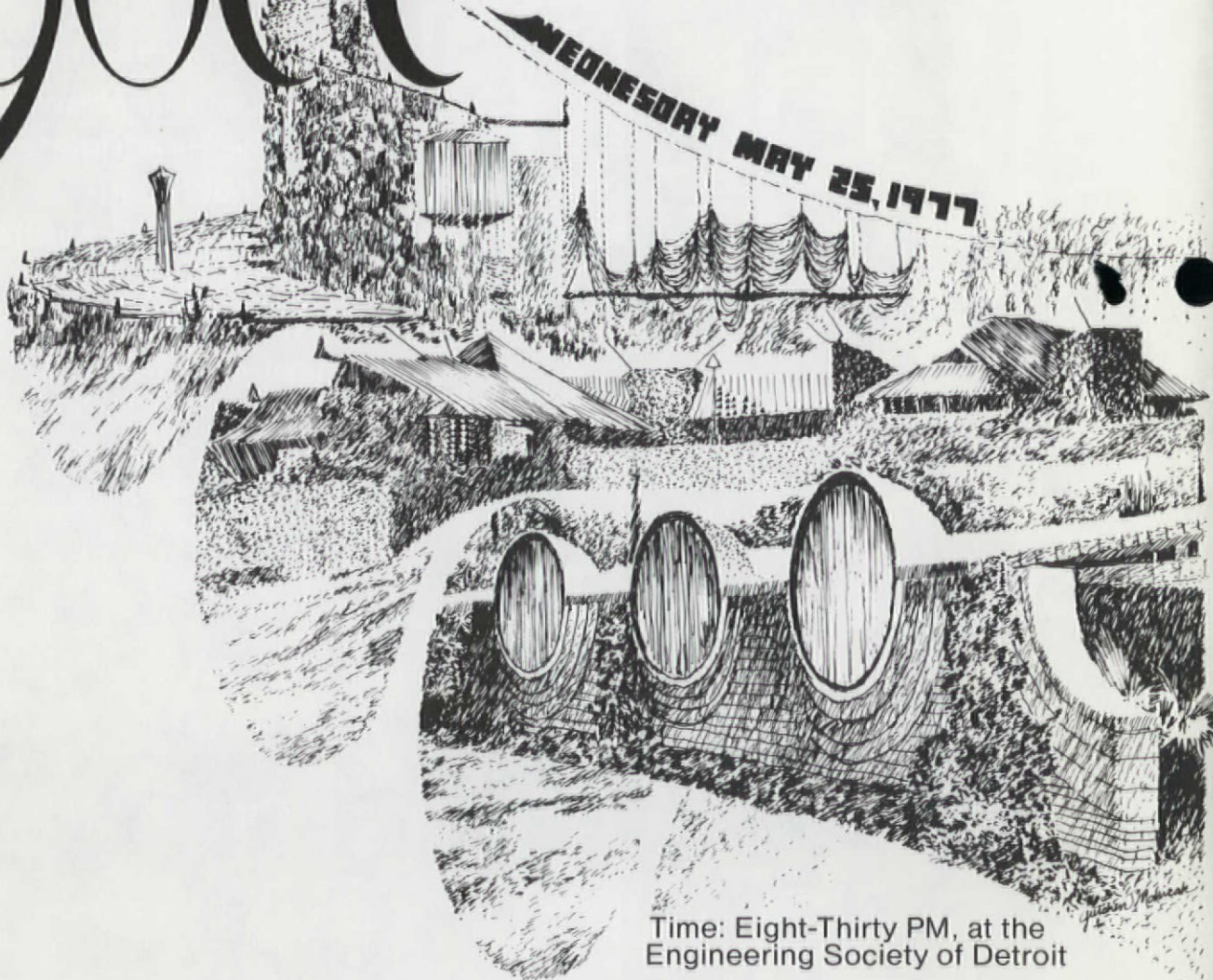

HISTORY OF BEAUBIEN HOUSE

Antoine Beaubien was descended from some of the most distinguished French families in this area of the Northwest Territories - Cuillerier de Beaubien and Trotier de Beaubien. His original grant of 337 acres extended three miles inland from the river, and from which both Beaubien and St. Antoine streets were carved. The original family home was a long, low structure, built in the prevailing French style, located on Woodbridge Street. When it was decided to extend Jefferson Eastward from the downtown area, Beaubien took up arms and fought off the surveyors. Progress could not be hindered, a fact, no doubt, of great solace to his descendants who realized a fortune from this tract of land so close to the center of the city. Beaubien generously gave land for many of the churches and institutions in the area - SS. Peter and Paul's Church, St. Mary's Church and St. Mary's Hospital. He was held in such high esteem that upon his death he was buried in a leaded coffin, next to Father Richard, in the crypt of St. Anne's Church.

The simple brick house at 553 Jefferson would have been constructed about 1850 as a compromise between the prevailing classical spirit, and the constraints of a narrow city lot. The house is remarkable for the small number of owners it has had. One family, that of John P. Antisdell, a prominent attorney, occupied the residence from 1894 to 1940.

LETTER TO THE EDITOR

AIA/DC Position Paper #1, printed in the April Newsletter, is extremely well written. The Paper aims specifically at the "young" registrant and seeks to remove the deterrent of high membership cost to this newly registered architect. However high dues are a deterrent to "older" registered architects also, who do not feel there is a value for the cost. The Paper does not clarify if the low cost dues are available only during the four years immediately after registration, or if they begin when an individual applies for AIA membership, regardless of whether he has been a practicing architect for 25 years.

Another issue, certain to be raised, is retroactivity. If, and when, this graduated rate became official, would a new member in his second year pay \$35.00 for DC/AIA dues, or would the \$70.00 he paid in his first year, under the old rate, be credited to future years?

The Paper does address the problem of a young architect, with beginning financial obligations and minimum income, and allows him to pay more as his income increases. But what about the older, experienced architect who gets laid off, or whose income decreases over time? These people need relief also or they may drop their membership.

Finally, by what procedures can a dues change be made? According to the Chapter Bylaws, Article 9, the changes must be made before the end of one fiscal year to be effective in the next.

DID YOU KNOW: AIA LIBRARY SERVICES

Susan Cosgrove, AIA's librarian, has sent along the following communication about the library's service to members.

Reference: The library is not at present equipped to undertake extensive research. We will, however, attempt to answer requests for information on architects' biographies, architectural history, AIA history, building types, etc., and we will prepare short bibliographies of our holdings on specific subjects. The library collection is strongest in contemporary American architectural books.

Accessions List: Six times a year the library prepares a list of recent acquisitions. This list is available to members for \$1.00 per year subscription fee. Checks and a mailing label from the MEMO should be sent to the library. Each chapter receives this list as enclosure in the CPL. List #72 and 73 are enclosed.

Loan Services: The library loans all circulating books in the collection to AIA members. This does not include reference books, rare books, bibliographies, or periodicals.

Books may be requested by title or by subject. In the latter case, we will usually supply a list of what is available. Books may also be chosen from the Accessions List. Up to six books may be borrowed at one time.

All loans will be for two weeks from receipt of book, with renewal privileges if no one else has requested the book.

Borrowers are responsible for loss or damage to books in their possession and pay replacement cost and charge of \$5 to cover ordering and processing if books are lost or damaged.

Audio-Visual Department: Members and chapters may also borrow audio-visual materials from the library. The collection includes a number of 16 mm films on architecture and urban planning, slide shows, and individual slides of architectural subjects. A list of available materials may be obtained from the Audio-Visual Librarian.

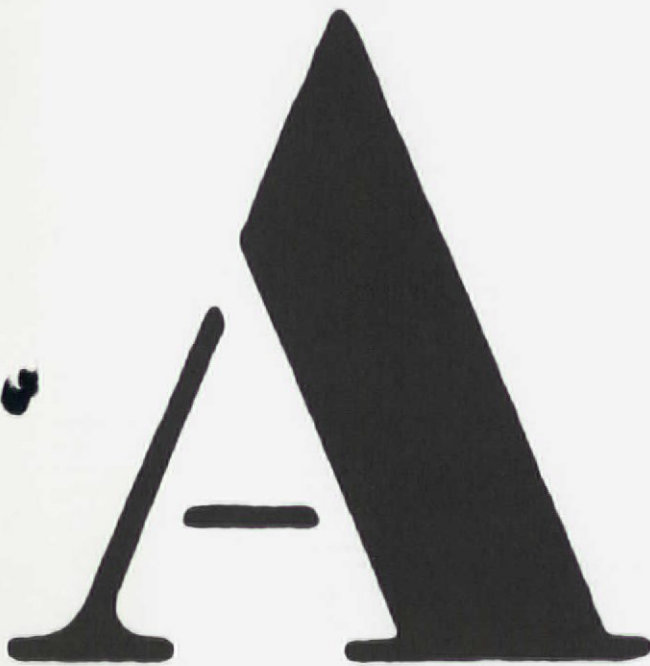
