


Masonry Institute of Michigan, Inc.



The North Hills Christian Reformed Church, a loadbearing masonry structure that utilizes warm-toned brick units on both the exterior and interior, won for Straub, Van Dine, Dziurman/Architects, of Troy, an "M Award" in the second annual masonry design program sponsored by the Masonry Institute of Michigan in cooperation with the Michigan Society of Architects. (Mason contractor on the project was Cavanaugh Construction Co. of Troy.)

In all, four architects and their projects were honored by a distinguished panel of three Philadelphia-area architects who judged the entries.

A REMINDER

ASHRAE 90/75, Michigan's first energy building standard, becomes effective June 22, 1977.

The standard is designed primarily for new buildings, but until approved as acceptable reovation standard (s) is available, ASHRAE 90/75 will apply to renovations as well.

The definition of a renovated structure and its accompanying terms of compliance have been borrowed from BOCA which employs "percent of existing value" system.

Although, the code should not present any major technical questions in the minds of the design professionals, questions are likely to arise in the standards interpretation and actual design applications.

LEGISLATIVE

Both the Michigan Senate and House offered Joint Resolutions to the Michigan Society of Architects for their efforts on behalf of the Regional/Urban Design Assistance Teams which will be held throughout the State during 1977-1978. Over 40 MSA members attended a meeting to accept a Proclaimation by Governor Milliken which was made by Lt. Governor Damman at a presentation on May 16th in Lansing.

Senator Faxon and House Representatives Cawthorne and Mowat made the joint resolution which is as follows:

Whereas, as all of Michigan observes
Design Week starting May 17, 1977, it is
indeed appropriate that we honor the Michigan
Society of Architects in recognition of its
role in making design a discipline in harmony with the values of humanity; and

Whereas, The Society has accepted the responsibility for establishing a statewide steering committee for Regional Urban Design Assistance Teams. With an emphasis on human needs, aspirations, and capabilities, the regional teams have made citizen participation a prime factor in influencing the direction of urban design to make it responsive to the general public; and

Whereas, an awakening of public concern for the greater implications of urban design as it relates to daily life is being accomplished, largely due to the admirable efforts of the Michigan Society of Architects. The Society's work has proven to be responsive to the public weal. As the many dedicated men and women in the architectural profession direct their outstanding abilities to benefiting society, it is apparent that the support of all Michigan's citizens is paramount toward the realization of this broader goal; and

Whereas, Building without thought of implications to the environment and the effect on people's lives has no part in modern society. The Michigan Society of Architects' role in helping to focus the attentions of the public and government officials on the need for responsive and harmonious design is indeed worthy of our gratitude; now, therefore, be it

Resolved by the Senate (the House of Representatives concurring), That the highest praise and tribute be hereby accorded the Michigan Society of Architects in recognition of its outstanding contributions to this State; and be it further

Resolved, That a copy of this tribute be transmitted to the Michigan Society of Architects in testimony to the high regard in which it is held by the Michigan Legislature.

Pending the order that, under rule 32, the concurrent resolution be reffered to the Committee on Senate Business.

Senator O'Brien moved that rule 32 be suspended.

The motion prevailed, a majority of the Senators serving having voted therefor.

The concurrent resolution was adopted.

HB 4103 introduced by Reps. Sietsema, Thomas H. Brown, Griffin and Trim.

Concerns the licensing of architects, professional engineers, and land surveyors registration examination. This bill states that the examination shall include questions which require the applicant to demonstrate knowledge of the design needs of a person with a physical disability and the laws of this state and the U.S. related to those needs. The questions shall be developed by each board in cooperation with the department of labor. This shall be a separate examination for the purpose of determining the qualifications of applicants for registration.

The MSA has taken the position that the above could be incorporated into the exam as it now exists rather than making it a separate examination. The Bill is currently in the Committee on State Affairs. No actions are expected immediately.

HB 4562 introduced by Reps. McCollough, Anderson, Bullard, Gingrass and Angel.

Concerns an amendment to the State Construction Code. This amendment is in regards to a cost analysis of various energy systems and will affect governmental projects over 35,000 square feet of floor area and which has a heating or cooling system for heating water. This will not take effect until December 31, 1978. This bill has been referred to the State Committee on Urban Affairs.

HB 4716 introduced by Reps. Hollister and Thomas H. Brown.

Concerns the State Board of Registration for architects, professional engineers and land surveyors. The main purpose of this bill will be to open their official records to the public. This bill has been referred to the Committee on Towns and Counties.

LICENSURE Ballenger Replaces Clark at L & R

Former Republican State Senator William Ballenger was named director of the Licensing and Regulation Department by Governor Milliken. Current Director Beverly Clark will return March 28 to her former civil service job of herings officer, but at a salary two grades higher, said Governor's aide, George Weeks. She had asked for the return before Mr. Milliken broached the subject of reorganizing the department in his State of the State Message.

Mr. Ballenger, to be paid \$34,900 a year, will also serve as a new inter-departmental coordinator for consumer affairs while reorganizing the licensing agency and expanding it into consumer issues, the governor said. He is to be a strong consumer advocate, Mr. Weeks added.

Under President Fords administration, Mr. Ballenger was a deputy assistant secretary for legislation in the Department of Health, Education, and Welfare. He took the job

after losing a 1974 Republican primary election for Comgress from the 6th District. He was elected to the state Senate in 1970 and to the House in 1968.

Mr. Weeks noted that Mr. Ballenger sponsored consumer legislation adding public members to 14 licensing boards within the state department.

STATE FIRE SAFETY BOARD

School Fire Safety Rule 72: (By authority conferred on the State Fire Safety Board by section 3c of Act No. 207 of the Public Acts of 1941, as amended, being section 29.3c of the Compiled Laws of 1948.)

Upon determination that a door 36 inches wide is not essential to the life safety of small groups, that a door 32 inches wide often limits the location of an opening and can not be justified in all locations, the State Fire Safety Board, on April 20, 1977, acted to modify previous actions regarding School Fire Safety Rule 72, as well as the promulgated rule itself as follows:

(4) A single door from a classroom to a corridor, from a classroom to the outside, or from a corridor to the outside, shall not be less than 36 inches nor more than 48 inches wide, except that a door 32 inches wide shall be permitted on a room for 6 to 20 persons and a door 30 inches wide shall be permitted on a room for not more than 5 persons.

This altered provision will be included in the next revision of the promulgated rules and pending that action, the State Fire Marshal and the City of Detroit Fire Marshal have been authorized to modify School Fire Safety Rule 72(4) accordingly.

School Fire Safety Rules 76: (By authority conferred upon the State Fire Safety Board by section 3c of Act No. 207 of the Public Acts of 1941, as amended, being section 29.3c of the Compiled Laws of 1948.)

Based upon formal requests and numerous conversations, on April 20, 1977, the State Fire Safety Board reevaluated School Fire Safety Rule 76, Latching Hardware for Single Means of Egress.

It was found that features of the requirement have not eliminated latching hardware failures, in fact, less than precision workmanship actually induces failures more frequently than with conventional latching hardware. The requirement is not supported by sufficient documentation as to the ratio of failures versus the numbers of latching hardware devices in service and further, the requirement is not consistent with recognized good practices as evidenced by standards adopted by nationally recognized authorities in the field of fire protection.

It was the determination of the Board that the continued enforcement of this rule would do manifest injustice and would be contrary to the public interest, therefore, School Fire Safety Rule 76 will be repealed by the next revision of the promulgated rules and pending that action, the State Fire Marshal and the City of Detroit Fire Marshal have been authorized to waive the enforcement of School Fire Safety Rule 76.

Flammable Liquids Storage - 154 - School Fire Safety Rules: Attention has been directed to School Fire Safety Rule 154 and the fact that the rule and other sections are silent in regard to additional hazardous substances and their storage commonly in use in schools.

Michigan Flammable Liquids Regulations and Michigan Liquefied Petroleum Gases Regulations address these matters and compliance in school facilities is required. NFPA codes also speak to such materials.

To bring the School Fire Safety Rules in line with other promulgated rules and requirements the State Fire Safety Board on April 20, 1977, acted to modify the provisions of Rule 154 as follows: (2) A storage room for major bulk storage of hazardous chemicals liquids and gases in amounts of more than I-gallon or 2-1/2 pounds individual capacity containers shall be above grade and the room shall be separated from the remainder of the school building by construction having a 1-hour fire resistance rating. At least I wall of the room shall be an outside wall of the building and natural or mechanical ventilation shall be provided to prevent the accumulation of vapors within the room. A doorway exposed to the interior of the building shall be provided with a 6inch high noncombustible liquid-tight sill or ramp. The floor shall be liquidtight and arranged to drain to a safe location. Electrical switches, outlets, wiring and fixtures shall comply with the state electrical law and rules for such location.

- (3) Oxygen, combustible gases, fuel gases, and flammable and combustible liquids shall not be stored with each other or with combustible material, except that small amounts for daily use in a shop, a laboratory and an office may be kept within those areas of use in an original container or an approved safety container of not more than legallon or 2-1/2 pounds individual capacity. Additional containers shall not be permitted in the areas.
- (4) The installation and operation of "oxygen fuel gas systems for welding and cutting" shall be permitted only in approved shops (rule 157) and shall comply with NFPA 51. The standard for fire prevention and use of cutting and welding processes shall comply with NFPA 51B and shall be the responsibility of the owner.

The altered provisions will be included in the next revision of the promulgated rules and pending that action, the State Fire Marshal and the City of Detroit Fire Marshal have been authorized to modify School Fire Safety Rule 154 accordingly.

STATE CONSTRUCTION CODE COMMISSION

Gretchen Minnharr, AIA, of Grand Rapids, has been appointed by the Governor to the Construction Code Commission. Gretchen succeeds Howard Sims, FAIA, of Detroit. Other members are Frank E. Smith of Iron Mountain, Clayton O. Diebel of Southfield, Wesley G. Jeltema of Dimondale and Louis M. Balius of Hartland are both reappointments.

The architectural design for Wayne County Community College's new Downriver Regional Center in Taylor has been chosen to receive a citation at the 1977 Exhibition of College Architecture at the annual meeting of the American Association of Community and Junior Colleges to be held in Denver, Colorado.

The announcement of the selection of the Taylor Center design for the national display was made jointly by Wayne County Community College and William Kessler and Associates, Inc. of Detroit, architects for the new facility.

The WC3 exhibit was one of 28 in the architectural display which played a principal part in the annual AACJC meeting that was held on April 17-20.

The Kessler Associates entry was cited as "exemplary" by a jury of the AACJC which selected the final exhibits. The following citation is attached to the Taylor Center design: "The design is direct and straightforward. The achieved simplicity can be observed in the selection of materials and mechanical systems which together provide the sense of scale and harmony required in a successful building complex. There is a creative discipline which seems to complement both the exterior and interior space."

Scheduled for completion in the fall of 1978, the Taylor Center has been designed as a major vocational facility. The building cost will be \$8.4 million. The site location is a 94-acre tract located on Northline Rd. between 1-75 and Telegraph Rd. which includes a seven-acre woodland and is adjacent to a city park, both of which are significant to the natural setting of the building location.

When completed, the Taylor Center will have facilities for instruction in the following vocational programs: Automotive Services, Automotive Body and Paint Repairs, Heavy Equipment and Diesel Repair, Parts Management, Secretarial Science, Medical Secretary, Machine Tool Laboratory, Metallurgy, Welding and Fabrication, Civil Technology, Nursing, Licensed Practical Nursing, Nurse Aide, Optical Technician, Commercial Art, Child Care, Advertising, Interior Design, Drafting, Physics, Chemistry, Biology, and Business.

The Taylor Center is one of two major regional instructional facilities under construction as part of WC3's Five Year Master Facilities Plan. A major center is also under construction in Downtown Detroit, and is scheduled for completion in 1979.

PROJECT RAILREST DESIGN COMPETITION

The Fiscal Court of Montgomery County, Kentucky announces an Architectural Design Competition for the adaptive re-use of the old Chesapeake and Ohio Railway Freight Depot in Mount Sterling, Kentucky, for the purposes of a performing arts center and other community functions.

The 19th century structure containing 5,700 square feet is to be redesigned to provide approximately 7,000 square feet of desired accommodation at an estimated construction cost of \$400,000.

BRAB AWARD WINNER

Ross W. Pursifull, architect and assistant manager of Daverman Associates Construction Management Division, was one of 63 men selected nationwide to be honored by the Building Research Advisory Board of the National Research Council, which is celebrating its 25th Anniversary this year.

Pursifull was one of the recipients of the BRAB's "Men of the Quarter Century" awards presented in Washington, D.C. on April 28 at a Building Futures Forum.

The Quarter Century Citation stated that Pursifull and his fellow honorees were selected from within the national building community "for their singularly significant and outstanding contributions to the development of building science and construction technology during the past 25 years and consequent improvements in the quality of American life."

Included in the group receiving the Award Citations were such nationally known figures as Buckminster Fuller, Walter Gropius, George Romney, Eero Saarinen, William Zeckendorf, Mies Van Der Rohe and Frank Lloyd Wright.

Pursifull served as Executive Chairman of the Board of Directors of the BRAB Building Research Institute during the years 1969-71. James C. Perkins, a senior in the School of Architecture at Lawrence Institute of Technology, has been named regional winner of the 1977 Reynolds Aluminum Prize for Architectural Students.

The competition, administered by the AIA, seeks the "best original architectural design in which creative use of aluminum is an important contributing factor," Jim's project was the design and development of a community art center incorporating a unique roof system of solar energy collectors and structural aluminum. As a regional winner, he has been awarded a certificate and a \$300 check by Reynolds.

Jim, 25, is the son of Mr. and Mrs. Donald Perkins of Lansing. The prize competition was established in 1961 by Reynolds Metals Company, Richmond, VA, to encourage creativity in architectural design and to stimulate interest in aluminum as a building form.

SOL KING, FAIA, OFFICIATES AT ESD CEREMONY

As Chairman of the College of Fellows, Engineering Society of Detroit, Sol King, FAIA, former Chairman of the Board of Albert Kahn Associates, Inc., officated at the recent induction of new Fellows into the ESD College of Fellows. In a ceremony held during the Society's Annual Dinner Meeting on Friday, June 3, 15 ESD members including one architect, Paul B. Brown, FAIA, were inducted into the College.

In addition to currently chairing the College of Fellows, King has served the 6,000 member Engineering Society of Detroit in numerous positions. He was the first architect to be elected President of ESD (1969-70) and the first to serve as President of the Science and Engineering Fair, sponsored by the ESD and the Detroit News. He also served as Chairman of the Membership Committee and as a member of the Objectives Planning Committee and of the Finance Committee. The ESD recently conferred its Distinguished Member Award on King in recognition of his outstanding service.

In his professional career with the Albert Kahn office, Sol King was one of the first architects to recognize the importance of an integrated architectural and engineering approach to professional practice, and was instrumental in the early development of a complete professional service by his firm. He was active in promoting responsible and ethical practice by the profession, and in supporting high standards of professional education. The Sol King Scholarship, a personal award presented annually to a selected faculty member at the University of Michigan College of Architecture, typifies his concern for quality professional training. King has received recognition for his continuing support of high professional standards through numerous honors, including the Distinguished Alumnus Award of the University of Michigan, the Gold Medal of the MSA, and election in 1966 to Fellowship in the AIA.
