#### DETROIT CHAPTER, AIA

DETROIT CHAPTER GOALS FOR 1978 TED KURZ, AIA

In a salutation to the citizens of Detroit, Antal Dorati, world famous conductor and newly appointed music director of the Detroit Symphony Orchestra, expresses thoughts on music which can be applied with equal appropriateness to the role of architecture.

The service that we makers of music are called upon to render is one of the most valuable in the world: to give pleasure and stimulation to the mind in the most sublime way, to alleviate stress, relax tight nerves, give a few hours of centered meaningful, alert repose, and through it to renew the strength we all need to face the next day. This has been the task and the role of the arts through millenniums, and their presence with us is the best proof of their worth and validity. We all have our parts assigned to us in the great process of producing and enjoying art; though they are of varying complexities, they are equally important.

### DETROIT CHAPTER, AIA (Cont.)

While a beautiful built environment remains the essence of our professional effort, there are many supporting roles which each of us must play individually and collectively in order to maintain and strengthen that effort. It is within this spirit that I wish to discuss with you the goals and emphasis of effort for our Detroit Chapter in 1978.

Joseph Hudnut, former dean of architecture at Harvard, talked of a building's outward affiliations and inward functions. This set of relationships is true also of our activities as members of the Detroit Chapter of the ALA.

Our National AIA code of ethics contains the basis for what I believe to be the most important of our outward oriented efforts - that of continually improving the public's understanding of architecture. The corallary to this understanding is a heightened professional profile.

The role of our chapter's Public Education Committee is paramount in this regard. An "Architecture to the Schools" program, similar to the very successful "Art to the Schools" program, and formed on the experience of AIA National and programs such as the Boston Chapter's would introduce the concept of the beautiful built environment to children in their early formative years and aly the groundwork for more specific presentations later on. The task of addressing high school students and civic groups requires a much strengthened speaker's bureau to augment the effort of the faithful few who have answered this call in the past.

Another facet of public architectural education is a series of courses on architectural topics at the adult education (community house) level. Subjects such as "So You'l Like to Build a House" could be presented by some of our senior, semi-retired members with skill and enthusiasm.

Our Urban Design and Historic Resources
Committees have been actively engaged in the recognition of urban design efforts of merit and opportunities for an enriched environment through the preservation of significant historic elements. A current example is the program for the Monroe Block developed with the help of Ed Francis and Tom Holleman.
These activities should be encouraged and supported in the future, and we should establish a broader context for these efforts by seeking a basic esthetic denominator for out city to which the flux of political interests can constantly refer.

In the meanwhile, the acquisition and occupancy of the Beaubien House will certainly heighten our civic profile and lend a much needed focus to our Chapter activities. We should continue to support a comprehensive approach toward the restoration of this edifice as a symbolic and practical home.

The current effort by a group of our young members in re-introducing the previously successful "Architect's Sundays" should be strongly applauded. While this function might be maintained best at a spontaneous, task force level, it requires additional yolunteer help and ideas for future Sundays,

and will benefit from the experience of some of our older members.

A new idea, also designed to strengthen our profile, is the introduction of an Exhibits task force. The idea here is to exhibit the many impressive Honor Awards photo boards in various public lobbies, shopping malls, banks, etc. Heretofore, these valuable communication tools have occupied much needed staff space. This effort is particularly suited to a small vigorous group of young members.

Finally, earlier this year your board expressed its support of a R/UDAT in Detroit as part of a state-wide R/UDAT program under the direction of the MSA. This function is scheduled for January, 1978 and should bring added recognition to our profession.

Looking inward, it has become apparent that a most important chapter function is the re-kindling of a sense of comradery with our peers which we've somehow lost through the past decade. While this is a difficult and baffling problem, I feel we should re-introduce general membership meetings on a regularly scheduled basis with drinks, dinner and speaker. It seems unnatural, somehow, not to meet with each other to discuss our common goals and problems to laugh at our frailties - more often than we do.

Our chapter programs should be social in nature, conducive to solidarity and a sense of professional worth. Their success hinges on your response.

Increased membership should continue to be a point of major emphasis during the coming year. This year's effort was well handled and very successful, but it is important to note that our Chapter roster contains 90 emeritus members, indicative of the fact that membership increases must absorb the rate of normal membership reduction. We must all personally orient and cultivate young professionals to AIA membership and to the opportunity of serving their profession.

A new "Income Other Than Dues" or Fund Raising Committee is proposed to focus attention on the Chapter's potential for fund raising and to identify and develop specific programs for this purpose. This function, together with increased membership, is a positive step toward holding dues at their present rate and allows the Chapter more options in pursuing benefits for its members. An "Art by Architects - Auction" may present the double advantage of exposure and added income for the artist and for the Chapter!

While the National AIA has developed strong liaison at the Federal Government level, and the MSA is evolving a similar relationship with the legislature in Lansing, our local Chapter has not oriented itself sufficiently to local political action. This is an area which must be strengthened if we are to influence our local built environment significantly. It is proposed that the present Professional Practice Committee be charged with the task of identifying positions on local planning and zoning boards appropriate to architectural appointments, and issues requiring planning and design input. This committee could also act as the local arm of the Minuteman and PAC programs.

### DETROIT CHAPTER, AIA (Cont.)

The Continuing Education Committee has performed admirably in establishing the basis for a comprehensive MSA continuing education program through a consortium of the University of Detroit, University of Michigan and Michigan State University. A separate, detailed report on this activity and on the ramifications of that committee's structure will be included in the next Newsletter.

Architects in Industry has been the subject of detailed attention at the National AIA level and the formation of component committees is urged. An industrial city like Detroit should have a model Architects in Industry Committee, Our built environment can benefit substantially from candid, informal dialogue with industry corporate staffs within the assumption that Macy's can tell Gimbel's, This goal will be strongly pursued during 1978.

Technical programs, as opposed to general membership programs, are expected to be developed by the various technical committees. All programs and ideas for funding within the constraints of existing resources. The complete committee structure for 1978, to-gether with an expression - of - interest form will be set forth in the December Newsletter. The success of our programs depends almost completely on the volunteer help of our Chapter members. We will need competent, imaginative chairmen to lead our committee functions, particularly in the areas of Public Architectural Education and Fund Raising. I urge that you consider carefully the goals outlined here, and I look forward to your positive response to the opportunities they present for our Chapter and our profes-

MEMBERSHIP COMMITTEE OF THE DETROIT CHAPTER POSITION PAPER #2

This paper is concerned with the method of payment of AIA dues from the individual's point of view and the Detroit Chapter's point of view. Our recommendation (exactly the same as the most recent AIA Membership Task Force recommendation) is a system of voluntary withholding of AIA dues by each firm thru payroll deductions.

Every Detroit Chapter AIA firm should be required to offer the service of regular (each month, each paycheck, etc.) withholding of individual AIA dues thru payroll deductions. This would minimize the "single shot" impact of the dues burden on the individual member. This would increase AIA membership, especially if all firms made this policy known and encouraged it strongly among their employees. Also, job changes by an individual would not adversely affect his AIA membership in any way, since this would be a portable benefit.

For the Detroit Chapter, this policy would be helpful in creating a favorable cash flow situation and minimizing bill collecting headaches. Depending on the administrative details, each firm could submit one payment per month (bi-monthly or whatever) including all the dues for that firm's AIA members. It's share of supplemental dues could possibly be worked into this plan somehow.

The administrative details of this plan should be worked out immediately by the Detroit Chapter and Michigan Society of Architects administrative staffs so that prompt action can be taken by the respective boards to put this system into effect.

Designing a hypothetical "Great Skate" skateboard park is this year's theme of the annual architectural competition for high school students sponsored by the Detroit Chapter of the American Institute of Architects, the Detroit Edison Company and the School of Architecture at Lawrence Institute of Technology. The contest is open to students attending high schools in Wayne, Oakland and Macomb Counties.

A \$1000 first place scholarship and other scholarships to architectural colleges of the student's choice will be awarded winning entries judged by a distinguished panel of architects. Entries are evaluated on the basis of presentation technique, originality of design, technical aspects, and aesthetics. Deadline for applications is October 27 and entries must be received by February 21, 1978. Winners will be honored at a special luncheon at LIT in April. For applications and additional contest information, contact the program's director, Fred John, AIA, at 444-1800.

"The tremendous popularity of the skateboarding sport has resulted in the consideration of free form parks much like the roller skate rinks of the past generation," said Tom Wikle, AIA, a coordinator of the project. "High school students are certainly aware of the excitement and current limitations of the sport, so I'm sure they'll devise eye-opening solutions that will benefit both architects and the public alike."

The competition gives high school students a problem similar to that which a working architect might face. The site of the hypothetical park this year is in Birmingham.

"Because the competition normally involves hundreds of student man-hours, the results are often spectacular," added Fred John. "As in past years, we plan that a display of winning drawings will tour the state upon completion of the contest."

Last year, over 120 students from 30 metropolitan-area high schools competed in the design contest, offering solutions to the construction of an audio-media sales center.

MEMBERSHIP COMMITTEE OF THE DETROIT CHAPTER REPORT

Directing the 1977 Membership Campaign has been an unexpected pleasure. The assistance and encouragement offered by the Chapter's Board of Directors and Headquarters' taff has made our efforts more rewarding than would have been anticipated.

Following the devastating loss in members during the 1975-1976 recession, the Committee took on a task that was the envy of no one. Nonetheless, our efforts have paid off with a substantial increase in new memberships. At this writing, we have received or processed 56 new applications including 35 Corporate, 17 Associate, 3 Professional Associate and 1 Professional Affiliate. As impressive as the numbers appear, however, we remain some 16 Corporate applications short of our goal of 51 new members (a 10% increase in corporate membership.)

All is not lost though. Our greatest triumph of the year is just emerging. Effective January I, 1978, the following changes have been enacted: 1) Associate Membership has been increased to AIA Associate Membership, making the Journal and all other national benefits available to our younger members. 2) The Detroit Chapter dues have been slashed for new Corporate Members to coincide with the sliding dues scale established by the National AIA.

First year Detroit Chapter dues for Corporate Members will be \$20.00, second year dues \$40.00, while each year thereafter will be \$70.00. As noted in a mailing also sent to you recently, the MSA dues will also match this same sliding scale if so approved at the November MSA Convention. What all this means is that full membership will be available to qualified applicants in 1978 for only \$90.00 the first year and \$155.00 the second year. 1978 should be our greatest membership year ever.

Our committee has not been resting on our successes, however. Our Position Paper #2 has not yet received acceptance. Payroll deduction of AIA dues could be our strongest tool in encouraging participation. We implore each of you to develop in your office a system of regular payroll deduction of AIA dues for those members paying their own way. Benefits are the amin target of this year's and next year's committee activities. The Detroit Chapter, AIA will benefit you!

#### EMIL LORCH PROFESSORSHIP OF ARCHITECTURE

The Emil Lorch Professorship of Architecture and Urban Planning, named for the first head of the University of Michigan's architecture program, has been established at the U of M College of Architecture and Urban Planning.

"Named" professorships at the U of M are established to honor deceased or retired faculty members who merit special distinction. Funded at a level of \$2,500 per annum from bequests to the University, the professorships also honor those who hold them.

Lorch founded U of M's program in architecture in 1906, continuing as its head until 1936 when he resigned as director of the College of Architecture. He continued teaching at U of M until his retirement in 1940. He died in 1963.

"Throughout this period of 34 years as administrator and teacher, Lorch took the leadership in the organization of the College of Architecture, contributed largely to the development of its resources and prestige,

and was untiring in his efforts to advance the interests and usefulness of the architecture profession in this state and nationally," said U of M architecture Dean Robert C. Metcalf.

Born in Detroit in 1870, Lorch attended Detroit Museum Art School, Massachusetts Institute of Technology, and earned an M.A. degree in architecture from Harvard University. Before coming to the U of M he held teaching and administrative posts at several other schools.

He was one of the founding members of the Association of Collegiate Schools of Architecture in 1912, later serving as vice president and president. From 1915-17, Lorch was instrumental in gaining passage of legislation regulating the practice of architecture in Michigan.

Active in architectural practice, Lorch designed the original U of M Architecture and Design Building on central campus, Belle Isle Bridge in Detroit, several buildings for the Detroit Edison Company, and many residential projects.

In the 1930's, he headed a project of the Historic American Buildings Survey to record Michigan's significant structures.






