Dear Editor:

Rehabilitation of older buildings received a further boost with recent passage by Congress of the Revenue Act of 1978. Provisions in the Revenue Act clarify those contained in the Tax Reform Act by 1976, which encourage reuse of certain historic buildings.

Highlights of the Revenue Act which may be of interest to you and your readers include:

. A 10 per cent tax credit is available to property owners who rehabilitate buildings which are more than 20 years old.

. Long-term lessees who rehabilitate certain historic buildings now have the same tax options as property owners; they may either amortize the costs of rehabilitation over a

five-year period or depreciate the costs of substantially rehabilitated structures at an accelerated rate.

. The 10 per cent investment tax credit and accelerated depreciation may both be elected for qualified rehabilitations of historic buildings.

We would also like to announce a series of seminars entitled "Tax Incentives for Historic Preservation" (see separate article in Bulletin) cosponsored by the American Planning Association (APA) and the Heritage Conservation and Recreation Service, U.S. Dept. of Interior. ## MSA . . . NEWS BEAT

### STATE-WIDE HIGH SCHOOL DESIGN COMPETITION GATHERS MOMENTUM; ENTRY DEADLINE DRAWS NEAR

The original deadline for registration of January 4 has been extended indefinitely for the MSA High School Design Competition. Those who have not yet registered may still do so, however the entry deadline remains set for March 28. According to Competition Committee chairman Tom Wikle, AIA Chapters have the option to sponsor their own contest locally, judge the results and send all the winners and honorable mention projects to the Detroit Chapter AIA to be eligible for the \$1,000 grand prize scholarship to be awarded April 28.

The contest is open to high school students in art, architectural and mechanical drafting classes. Sponsors are the Detroit Chapter AIA, the Detroit Edison Company and Lawrence Institute of Technology's School of Architecture.

Students are challenged to design a "Community Fitness Center" to serve a city of 100-150,000 people. The Center is to include a 50 meter swimming pool, six racquetball courts, exercise room with weightlifting and other equipment, a large meeting room for club and group activities, observation lounges and concession stands. Objective of the contest is to challenge students with a project equivalent to that of a professional architect's.

State-wide winners as well as local winners will be invited to the Annual Luncheon Award Banquet during LIT's Annual Open House for high school students and their parents April 28.

### CONTINUING EDUCATION WORKSHOP SERIES

#### FEATURES AWARD WINNING PROGRAM ON "ENERGY"

Jack Meek and Charles McKelvey of Dayton-Hudson Properties will present an award winning program on "Application of Energy Standards in Buildings" for the February 17 Continuing Education Workshop at Lawrence Institute of

Technology, 9-12 noon. The Workshop is part of a CE series sponsored by the Detroit Chapter AIA, the Producers Council of Michigan and LIT. Cost is \$6 per session.

Meek will begin the program with a presentation on application of energy standards to commercial buildings. McKelvey, an energy consultant with Dayton-Hudson, will speak on energy savings and reductions in commercial buildings. Both men received an International Award for this program from the International Council of Shopping Centers. It was the first award ever presented by the Industry for an outstanding program on energy conservation.

An Exhibition of Paintings by Gretchen Minnhaar of Grand Rapids will highlight Third Thursday festivities March 15 beginning with a Champagne Reception at 5 p.m. in the Beaubien House, 553 East Jefferson, in downtown Detroit. ## ARCHITECTURAL FIRMS RECEIVE MASONRY AWARDS

Historic relevance was a key factor in three of the four buildings selected as winners of the 1978 "M Awards" for excellence in masonry design in the fourth annual honor awards program sponsored by the Masonry Institute of Michigan in cooperation with MSA.

The awards, all of equal value, went to: Cleaners Hanger Company, Bloomfield Township, designed by Rossen/Neumann Associates, Southfield; Fire Department Headquarters, Ann Arbor, designed by Fry/Peters Associates, Ann Arbor; Livingston County Courthouse, Howell, a complete restoration of the 1889 structure by William Kessler & Associates, Inc., Detroit; and McDonald's Restaurant, 337 Maynard, Ann Arbor, designed by Hobbs + Black Associates, Inc., Ann Arbor.

The winners were selected from 37 entries submitted by Michigan architectural firms by a jury of Minneapolis architects. Cast-bronze "M Awards" were presented at an awards banquet January 20 at the Dearborn Inn.

## AIA SPONSORS ANNUAL MID-WEST HEALTH CONFERENCE

The Mid-West Health Congress will hold its 52nd Annual Meeting in Kansas City's Convention Center March 20, 21 and 22. Theme for the meeting is "Managing Change-Challenge of New Directions". The program is expected to attract approximately 8,140 registrants from various states. The affair is sponsored by the AIA Central States Region Architecture for Health Committee.

Education is the primary purpose of this meeting. Architects from the U.S. and Canada are invited to exhibit mounts and models of their projects which will be of special interest to the Mid-West Health Congress delegates, including hospital and long term care administrators, representatives of boards of trustees, planning agency officials and other institutional personnel.

Eligible projects include complete facilities or parts of facilities, including hospitals, nursing homes, long term care facilities, health centers, diagnostic and treatment centers, medical office facilities, medical laboratories, staff housing, and medical research facilities. ## PRESERVATION SEMINARS DISCUSS TAX INCENTIVES

The one-day programs will highlight the planner's role in implementing the rehabilitation provisions of the Tax Reform Act of 1976 and the Revenue Act of 1978.

The sessions are being staged in the following cities: Denver, Colorado (February 5); Charleston, South Carolina (February 19); Monterey, California (March 23); Boston, Massachusetts (April 2); and Cincinnati, Ohio (April 16). The programs are sponsored by the Office

of Archeology and Historic Preservation, U.S. Department of the Interior, and the American Planning Association.

## ARCHITECTS BOOKSTORE BOOK REVIEWS

. ARCHITECTURAL WORKING DRAWINGS by Marvin L. Thomas, AIA (17.50).

Fulfilling a long-standing need in the field, this innovative guide presents a practical, easy-to-use system for producing architectural working drawings for the construction industry. This time-tested method of standardization - both in format and technique - puts to an end the disorganized approaches to working drawings that can prove so costly in time and efficiency. Its unique system is certain to liberate valuable time and energy for the improvement of the end product - the building itself.

. URBAN DESIGN AS PUBLIC POLICY: PRACTICAL METHODS FOR IMPROVING CITIES by Jonathan Barnett (16.50).

Jonathan Barnett was one of a group of architects who joined Mayor John Lindsay's administration in New York City to try to improve the way the city is designed: that is, to devise practical methods of controlling and directing the process of urban growth and change. In this book Barnett describes the methods that he and his colleagues devised, methods that have produced results, and attracted world-wide attention. The entire book is illustrated with actual examples of the principles described, in many cases in the form of completed buildings.

. LOST NEW YORK by Nathan Silver (15.00).

Here is a unique pictorial record of the New York City that has vanished. Architect Nathan Silver began by compiling material on the city's lost buildings that deserved recognition for their quality. He ended a two-year search amazed at the great number now forgotten. The riches he has rescued from oblivion include many rare photographs printed in this book for the first time. The result is both a fresh picture of New York in its first growth and strength, and a startling reminder of how much has disappeared forever.

. ARCHITECTURE BY TEAM by William Caudill (19.95).

In this book author Caudill gives new insights into the effects of industrialization, of interdisciplinary approach, of social reforms and of users' involvement during the planning process. He offers constructive thoughts on professional affairs...programming...architectural education...job promotion...design....computers...university planning...construction management...building systems and management. The underlying theme throughout is that manufacturers, planners, and builders must work together toward a common goal.
