## FIVE MSA MEMBERS RECEIVE FELLOWSHIP

In recognition of their "notable contributions to the profession," five MSA members were recently elected to the AIA College of Fellows. They are: Gene DiLaura of William Kessler and Associates; Chuck Parise of Smith, Hinchman & Grylls Associates: Sam Popkin of Albert Kahn Associates; James E. Tomblinson of THY & Associates and Harry Vaporciyan of Giffels Associates. Investiture ceremonies will take place at the 112th Annual Convention of the AIA, June 2 in Cincinnati.

The AIA Jury of Fellows, which uded MSA member Leo G. ea, FAIA, selected a total of 92 new Fellows from across the country.

A former MSA president, Gene DiLaura has served as construction administrator for several award winning projects for the Kessler firm including the Detroit Science Center, Wayne County Community College and the restoration of the Livingston County Courthouse in Howell. Professionally, he has been instrumental in the institution of a continuing education program for the MSA and also led the successful effort to relocate the headquarters of the MSA and the Detroit Chapter to the historic Beaubien House in downtown Detroit. Di-Laura has recently accepted the chairmanship for the 65th annual MSA convention in October.

Chuck Parise has been active in architecture since 1949 when he received his degree from the University of Detroit. After becoming registered in Michigan in 1952, he worked in several ces including Eero Saarinen Associates before joining Smith, Hinchman & Grylls. A

specialist in building technology, he has participated in the development of many products and has authored several publications on the subject as well as presenting symposiums for the Building Research Institute and the American Society for Testing and Materials.

Associated with the Albert Kahn organization for almost 30 years, Sam Popkin recently rejoined the firm as director of health facilities after a six year association with another firm. Currently the president elect of the Detroit Chapter, AIA, he also serves as vice chairman of the governor-appointed State Fire Safety Board and is certified with NCARB.

Between 1970 and 1977, Jim Tomblinson has served in all of the offices on the Michigan Board of Registration for Architects. His tenure on the Board resulted in an updated registration act and updated contract douments and publications with NCARB, where Tomblinson has also served. Heavily involved in his community. Tomblinson has contributed of himself in sitting on the YMCA Board of Directors, the Executive Committee of the Tall Pine Council of the Boy Scouts of America in addition to being voted "Outstanding Contributor to the Community" by the Grand Blanc Beautification Commission in 1975

Harry Vaporciyan is a high honors graduate of the Technological University of Istanbul and a recipient of the Albert Kahn Scholarship from the University of Michigan. A former director of design for the General Building Division of Smith, Hinchman & Grylls, he was also a principal in the firm of Sigmund Blum, Vaporciyan & Mitch from 1971-75 before joining Giffels Associates. He became vice president of the firm in 1979.

Fellowship nominees must

have at least 10 years of AIA membership and have made significant contributions in such areas as architectural practice, design, construction science, education, historic preservation and public service. It is the highest honor the AIA can bestow on a member, barring the Gold Medal.

# CALL FOR 1980 MSA HONOR AWARDS

Nomination forms for the 1980 MSA Honor Awards have been sent to the membership. All entries must be executed architectural projects of MSA members completed anywhere in the United States or abroad after May 1, 1976. Regardless of size or classification, all submittals will be considered on the basis of excellence in total design. All entries must be received by the office of the Executive Director no later than July 7, 1980.

Nomination procedures for the 1980 recipients of the MSA Gold Medal, the Robert F. Hastings Award and honorary membership have been mailed out to MSA Board members and chapter presidents. Completed forms for each of the categories are due at MSA headquarters May 31.

The Gold Medal requires superlative achievement in one or more areas of professional endeavor and clearly demonstrated leadership in any phase of the profession for an extended period of time. It is the highest award the MSA may bestow on one of its members.

The Hastings Award was created by the MSA Board in 1978 as a memorial to Robert F. Hastings, FAIA, co-sponsored with Smith, Hinchman & Grylls Associates. The award recognizes significant contributions to the profession of architecture

and service to the community.

Honorary membership is awarded to a person who has rendered a distinguished service to the profession or to the arts and sciences allied with architecture.

The award recipients will be the guests of honor at the President's Reception at the 65th Annual MSA Convention, October 17 at the Hyatt Regency Hotel in Dearborn.

## DODGE INDEX **DECLINES 25** IN FEBRUARY

Compared to the same month last year, February 1980 contracts for new construction were down 25%, the F.W. Dodge Division of McGraw-Hill Information announced recently.

F.W. Dodge vice president and chief economist, George A. Christie noted, "Although economic conditions are clearly moving against the construction industry in 1980, comparison of current contracting with the early months of 1979 leaves the impression that the situation is a lot weaker than it really is. Almost all of the difference between the two periods concerns a pair of nuclear power plants with a combined value of \$4 billion that were started in February 1979. Except for these two extraordinary projects, construction contracting so far in 1980 has held virtually even with last year's dollar total.

The economist added that the makeup of 1980 building consists of more nonresidential building and less housing, however he cautioned, "Commercial and industrial building faces a double risk in the months ahead as the backlog of lending commitments

begins to run out, and as the prospect of recession finally becomes reality."

# **LEGISLATIVE UPDATE**

A total of 426 amendments to the **BOCA Mechanical Code have** taken effect, beginning April 5. Filed with the Michigan Department of Labor last October, the new amendments update Part 9

of the Code's 1978 edition. Copies of the new amendments are available from the Michigan Department of Labor, Bureau of Construction Codes, Mechanical Division, Box 30015, 7150 Harris Drive, Lansing, Michigan 48909.

# Congratulating the Construction Industry Council

In 1971, a concerned architect, Jaroszewicz. president of the Detroit Chapter AIA, urged and encouraged the creation of a forum wherein the problems that daily involved members of the design professions and construction contractors could be explored and discussed. He, and others, sought a degree of uniformity and agreement upon the content and presentation of specifications and conditions described in bidding and contract documents, especially within the general conditions.

ithin a year, the Construction distry Council was formally organized. Its purpose then was "...to enable all segments of the construction industry to better serve the public through improved communications, greater efficiency and economy in the construction process, and understanding of their mutual responsibilities and obligations." It is still what CIC is all about.

Today's problems are more complex than they were a decade ago. Owners have become far more knowledgeable about construction and have become intimately involved in the design and bidding process. The construction manager is adding his modifications to the interpretation and administration of bidding and construction documents.

Nonetheless, the CIC has thrived, is thriving and likely will continue to thrive. Its published guidelines are the results of participation by individuals who collectively have spoken from the combined experience of centuries in our business. We would be remiss to not note that 75 to 100 individuals have invested thousands of man hours as delegates to the CIC and in committees and task forces concentrating on specific problem areas.

Past CIC guidelines have helped to virtually eliminate problems with temporary light and power, cold weather protection and temporary heat. Many of the Council's recommendations concerning bidding procedures have become accepted practice, such as afternoon bid openings on Tuesday, Wednesday or Thursday.

## Hitting a Problem

Special notice should be taken of two recent Council guidelines that address a major problem shared by everyone involved in the construction process — cash flow as affected by progress payments and retentions. The 20% plus lending rate for construction material and payroll financing is pressing both the design professional and contractor to the financial wall.

## **Payment Procedures**

Of the two, the Guideline "Payment Procedures, Waivers and Stored Materials" appears to be most timely. It is based on the principle that . . . "The ability of a Contractor or Subcontractor to manage his operating capital contributes almost as much to his business success as does his ability to manage the men he employs and the material he purchases and installs for an owner."

The guideline is anchored upon the time span that the owner requires to pay approved requests. The remainder of the schedule is built around this key element. Design professionals and contractors all agree unanimously that the procedure can and should be lived with by the industry. At the same time, it provides full consideration for the Owner's processing and payment procedures. Regardless of the time the owner requires to process and pay, the schedule provides for regular payments approximately every 30 days beginning with the receipt of the first payment.

It sounds deceptively simple. It isn't. It is just plain simple. Both the CIC and PHI recommend that the billing/payment cycle can be developed early in the planning process and be described in the bidding documents. This enables all bidding contractors to estimate and plan material and equipment purchases with the minimum of cost. This information cannot help but lead to optimum competitive bidding conditions.

## Retentions

A second timely guideline is the CIC statement covering retentions. In essence, the guideline recommends the withholding of 10% of the value of the first 50% of the work, with no further retention. When the contractor has completed satisfactorily 90% of the work, one half of the 5% retained will be paid to the contractor with the remaining 2½% paid upon substantial completion.

A bill has been introduced into the Michigan House of Representatives (#5541) which would not only reduce the amount of retention for certain state work but also provide for the establishment of an escrow account into which the amounts retained would be deposited regularly, along with the amounts paid. The interest on the escrow funds would accrue to the contractor.

## Incentive to Complete

We can't think of a more effective incentive to achieve successful completion of any contract. PHI recommends that the Council supplement the Retentions guideline with an escrow account format for all work, public and private. We also think that House Bill #5541 should be moved along as quickly as possible.

There is and will be opposition to our point of view covering payment practices and retentions. However, the alternative is even higher construction costs, artificially inflated due to the exhorbitant costs of borrowing money to finance construction materials and payrolls when legitimate requests for payment are unnecessarily delayed.

It's a problem that owners, design professionals and contractors can partially resolve together—if we really want to!

## NOTICES

The MSA has received notice that there are a number of firms and individuals in Michigan who perform soil borings and make foundation recommendations but who are not registered professional engineers. Architects who use these services should be aware that they may be assuming the total liability for the recommendations and that the liability may be very large.

Many architects may not be aware that a firm or consultant may perform soil borings, make tests and put forth recommodations for foundation design without being a licensed

engineer and be perfectly within the laws of the state of Michigan. The laws merely require that such engineering work be performed under the supervision of a licensed professional. The licensed professional may be an unsuspecting architect or structural engineer who may not even realize the liability he is assuming. In fact, when an architect places his seal on plans which were developed by unlicensed individuals, he may be assuming liability for the engineering recommendations on which the foundation design is based.

For their own protection, architects should be certain that any soils engineering or other consulting work be done under the supervision of a licensed engineer.

ASTM D-3740, "The Evaluation of Agencies Engaged in the Testing and/or Inspection of Soil and Rock as used in Construction," outlines a standard method for documenting the organization, personal qualifications and quality control programs a testing laboratory uses.
