## DODGE INDEX DECLINE CONTINUES; COSTS UP

Matching February's decline, the Dodge Index of construction contract value fell another 10 percent in March, the Dodge Division of McGraw-Hill Information Systems reported, while the Cost Information Systems Division reported an 8.7 percent increase in the cost of materials over a 12-month period which ended in March.

At the end of the first quarter of 1980, the cumulative value of all construction started in 1980 was \$32.6 billion, a decline of 20 percent from the comparable 1979 period.

Dodge vice president and chief economist, George Christie noted that the construction market's reaction to anti-inflationary restraint no longer is limited to housing, "As housing starts plunged toward the one million unit rate in March, minus signs began spreading to several types of nonresidential building and public works," he reported. The housing decline has

The housing decline has pushed some material prices down, such as lumber, but this has been offset by increases in other building materials, especially those which are petrolum-based, according to Hugh Sharp, general manager of the Cost Information Systems Division. "At present, the cost of building materials is climbing at an annual rate of 9 percent," he said.

## DETROIT RECEIVING HOSPITAL RECEIVES AIA HONOR AWARD

The Detroit Receiving Hospital/Wayne State University Clinics Building is among the 13 AIA Honor Awards recipients for 1980. The awarding takes place at the AIA Convention in Cincinnati this month.

The \$125 million complex is the product of the joint venture of William Kessler and Associates, Giffels Associates and the Zeidler Partnership.

The jury for the award commented, "This is a very exciting solution to what is often a dull, massive building type. Color, sheen and lightness are used both inside and out to create many pleasant areas along the circulation of this dense, complicated facility. The materials used and the articulation of the simple, repetitive towers give the appearance of light and open space instead of the massive structure on a tight site indicated by the plan and program."

MSA headquarters, the Beaubien House, was chosen along with the Book Building, Buhl Building, Detroit Artists Market, Detroit Cornice and Slate Building, Detroit Urban League, Dumouchelle Building, Farwell Building, Guardian Building, Griswold Building, Law Center Building, Moross House, Orchestra Hall, Palms Apartments, People's State Bank, St. Johns Episcopal Church, Second Baptist Church, Stearns Building, Tobin Building, Tuller Hotel and the Wayne County Courthouse.

The Beaubien House was also the scene of a lecture and slide presentation by architectural historian, Tom Holleman, titled "Built Like A Brick ----House" on May 12. The presentation was sponsored by the Association for Preservation Technology.

Detroit Chapter Director, Charlie Merz, AIA, hosted a walking tour of Harmonie Park on May 14 and as an extra, took his group for a conversation with Jack Hilberry, AIA.

All Preservation Week activities in Detroit were coordinated by the groups Cityscape Detroit and Preservation Wayne.



IT'S TIME TO SELECT YOUR ENTRIES FOR 1980 MASONRY AWARDS PROGRAM

It's "M Awards" time again!

For the sixth consecutive year, the Masonry Institute of Michigan, in cooperation with the Michigan Society of Architects, will honor MSA members for work of distinction in masonry.

To be eligible for entry, a building project must be located in Michigan and must have been completed after May 1, 1977. It must use masonry as the primary exterior material (or you must show that masonry was important in the solution of the design problem). All entries will be judged ...by a distinguished panel of architects from another state...on the basis of excellence in design as well as the appropriate and innovative use of unit masonry construction.

Deadlines are <u>August 11</u> for entry slips and registration fees (\$30 per project) and <u>October 20</u> for completed entries. Complete details and an entry form are contained in the awards announcement which is being sent to you by mail.

The cast-bronze "M Awards" will be presented at the annual Masonry Awards Banquet, which will be held January 24, 1981, at the Northfield Hilton Hotel in Troy. In the past five years, 22 building projects and their architects have earned these prestigious awards.

The 1979 winners were:

- -- Graheck, Bell, Kline & Brown, Inc., of Traverse City and Marquette, for the Branch County Library addition and renovation in Coldwater.
- -- Harley Ellington Pierce Yee Associates, of Southfield, for the central heating and cooling plant on the University of Michigan campus in Flint.
- -- Preservation/Urban Design/Inc., of Ann Arbor, for the restoration of the masonry water tower at Kalamazoo State Hospital.
- -- Rossen/Neumann Associates, of Southfield, for the Young Israel synagogue in Southfield. For Rossen/Neumann, it was the third straight "M Award" year.

To All Chapters from John lickling, FAIA, President: The present method of selecting architects for State of Michigan projects involves an Ad Hoc Evaluation Committee for each project, the primary purpose of which is to interview prospective architectural firms. Current policy is that one member of each Ad Hoc Selection Committee be an MSA member-a different member for each project. The member will be appointed by the MSA President from a list of those interested in serving and will be required to give about three or four days' time without compensation over a period of approximately a month. There is a further proviso: the appointee must understand that

his or her firm, subsidiary firm or parent firm is not eligible for new state professional service contracts during the period of appointment to a specific Ad Hoc Evaluation Committee. If you would be interested in serving on such a committee, please write to MSA or phone 313/965-4100 confirming your availability. MSA members in government, industry and education are obviously eligible, but any MSA member who is not actively pursuing new state work may serve. This is an opportunity to participate in an A/E selection process that is a model for the country.

## LEGISLATIVE UPDATE

HB 5685 revises provisions for local exemption from the construction code and the continued enforcement of the national model. The proposed bill, introduced by Representative Forbes (D-Oak Park), revises membership on the commission and increases the size of the commission from 10 to 16. The proposed legislation has been referred to the Committee on Urban Affairs.

Two new publications are available from AIA Component Affairs. The first, "Compendium: Architect Selection Laws," compiles A/E selection Jaws of the 18 states that currently have such statutes on their books. The booklet also includes a listing of the state administrative agencies responsibile for their implementation.

The second is "Compendium: State Statutes of Limitations," and it compiles the statutes in 41 states and the District of Columbia that have been enacted to help protect design professionals from unlimited liability on completed projects.

Both publications are free to members and are available from the MSA Bookstore.

The Construction Code Conflict Study Group is studying proposed amendments to HB 5685. The group is also studying discrepancies between the State Construction Code, the Health Code and the Fire Marshall Code. 


