ENERGY IN ARCHITECTURE/ LEVEL 3a PROCESS

This two-day, 14-hour workshop leads the design professionals through the application of energy knowledge and techniques in the design process. Lectures, application sessions and sample design problems are presented in programming, schematic design, design development and energy-economic analysis, building logically one upon the other. Region-specific examples are used to demonstrate the multitude of opportunities for energy-efficiency design.

Speakers for the Kalamazoo Convention Workshop on October 14-15, 1981 are Dennis Holloway and Michael Levy, AIA. Holloway pioneered design and construction of solar buildings. His public service to the solar energy movement was honored in 1976 by the Federal Environmental Protection Agency which presented him its Environmental Quality Award in Science and Technology.

During 1968, Holloway won a State Department Fulbright Scholarship to study Housing Design and System Building in the United Kingdom and the Netherlands. Upon his return to the United States he designed large housing projects in New York City and planned for expansion of Lower Manhattan Island. From 1970-77 Holloway was an Associate Professor of Architecture at the University of Minnesota where he directed "Project Ouroboros," Minnesota's first solar house designed and constructed by 450 of his students over a three-year period.

From 1977-80 he was an Associate Professor of Environmental Design at the University of Colorado, Boulder. Holloway devotes his private architectural practice entirely to design projects utilizing solar energy and energy conservation principles. A native of Michigan, he earned his B. Arch. degree from U of M and his Masters of Architecture from Harvard, School of Design.

Michael Levy, AIA, of Ft. Wayne, Indiana, is the principle of Michael T. Levy Associates which specializes in solar architecture, recycling buildings and environmental design. He is also President of Sun Builders, Inc., designers and builders of solar and earth sheltered projects. Levy received his B. Arch. from U of Michigan.

Levy conducts national solar energy seminars sponsored by Jordon College of Michigan. He has taught at Purdue University in Ft. Wayne and was a presenter at the National Passive Solar Conference and the University of Minnesota Earth Shelter Housing Conference.

Levy, who has been involved in solar architecture, education and industrial design since 1976, with architects for the McCormick Piano and Organ Company Building, one of the most cost effective solar applications in the country.

He also designed the earthaven series of passive solar earth sheltered residences.

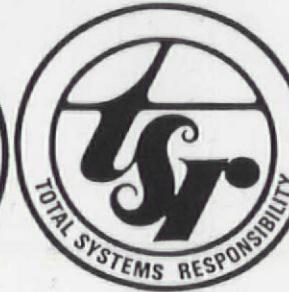



ADULT ED/LIT

The LIT School of Architecture is sponsoring a weekend Design Discovery Program designed to give adults a chance to take classes in the fields of architecture, interior architecture/design, or fine arts. The first 16-week program began September 26th. Offered during this fall term will be the architecture and fine arts programs. Interior architecture/design will be offered in addition to the other two programs in the spring term which begins February 6th. Both fall and spring sessions will meet on Saturdays only.

A wide range of lectures and museum and gallery visits, as well as a field trip to the Frank Lloyd Wright-designed "Affleck House" are planned for the participants. Classes will be taught by the LIT architecture faculty.

Participants can elect to take one, two, or all three of the courses in each program. "Basic Design" and an "Art and Architecture Seminar" will be offered in all three programs. Students may also choose a course designed specifically for their area of interest, either "Visual Communications" in architecture, "Drawing and Composition" in fine arts, or "Interior Architecture/Interior Design."

The tuition for each of the four studio classes is \$90. The cost of the art and architecture

seminar is \$30.00. Cost of supplies for the three programs will be approximately \$100.00.

The program is open to all adults who have not been previously accepted to the LIT School of Architecture and who previously have not been taking architecture courses at the College.

Candidates seeking credit toward a degree must make application to the College and be successfully admitted to the particular program. College credit toward the bachelor of science degree in architecture will be awarded upon successful completion of the courses with a grade of "C" or better.
