## A LETTER TO THE GOVERNOR

Dear Governor Milliken:

Congratulations on making an innovative and positive step in helping Michigan develop a package for economic recovery.

At our annual meeting on October 14, 1981, The Michigan Society of Architects went on record as supporting the concept of Economic Recovery as presented by you on September 17, 1981 in your special message to the Michigan Legislature on economic development.

In order to assist in supporting the concept we have joined work forces with a number of associations (spearheaded by Michigan Manufacturers Association). We also will encourage our membership to be supportive to the items that effect them by speaking in favor of the entire package.

We appreciate having Mr. Peter Walters, Deputy Director of the Department of Commerce, speak at one of the seminars at our meeting in Kalamazoo. We were disappointed, however, to find that the necessary legislation has not been introduced yet. Until we have actual legislation to work on, it is hard to rally support from our membership.

We encourage you and the Legislature to work together in an expeditious manner so that Michigan can get back on the

right economic track through effective action **now**. It is time to put aside political issues so that the realistic economic recovery package of bills can be developed and acted upon this fall. Michigan must become competitive. This can only happen if we get to work **now** — not next year.

## RESOLUTION

That the Michigan Society of Architects at their annual meeting on October 14, 1981, go on record as supporting the concept of Economic Recovery as presented by Governor William G. Milliken on September 17, 1981 in his special message to the Michigan Legislature on Economic Development.

As support of this the following action is to be taken:

1. That the President of MSA write a letter to Governor Milliken expressing our support.
2. That as legislation is developed that the individual members and member organizations be encouraged to give support to items that effect them and to so notify their local Senators and Representatives.

We further encourage the Governor and Legislature to work together in an expeditious manner so that Michigan can get back on the right economic track through effective action now. It is time to put aside political issues so that a realistic economic recovery package of bills can be developed and acted upon this fall so that Michigan can become competitive thereby promoting more jobs through new and/or expanded businesses in the State.

## MSA "PLANNING AND GOALS"

This past January, at the start of our 1981 Michigan Society of Architects programmed year, one major concern of Society President Evie Asken, A.I.A., was that of the Society's direction, its purpose, planning and goals within its organizational functions and membership.

At the Chapter level, these same questions and concerns are addressed each year by each Board Member in the hopes of providing some sort of service and purpose to and for their chapter members.

In an attempt to address these various challenges which are shared by all members of our society, President Evie Asken, A.I.A., initiated a Task Force Committee to establish an overview toward Long Range Planning of the Michigan Society and its membership.

It was determined that the best way to receive Society Membership input was to hold a retreat-like get-together. At a Michigan Society of Architect's Long Range Planning Retreat, it was hoped that any and all items of concern be reviewed, discussed, challenged, and possibly some conclusions made.

At this meeting, it was hoped that Chapter Presidents, Presidents-Elect, and other concerned and interested Chapter/Society members would meet together with various Society Board Members, past Society Presidents, students, Architects in Education and Industry and other concerned individuals. It would be in a relaxed informal setting where discussion could roam free over the state of the society, the membership, purpose, goals and the future of the society.

The results, any collective consensus and conclusions then would be presented at the Michigan Society of Architect's Annual Convention, held October 14, 15 and 16, 1981, in Kalamazoo, Michigan.

A Long Range Planning Meeting was held July 16, 1981, in a retreat-like atmosphere at Waldenwood Conference Center, near Hartland, Michigan. There were 23 members of the Michigan Society of Architects in attendance which represented seven of the nine Michigan AIA Chapters. Not represented were the Upper Peninsula and Saginaw Valley Chapters.

## MSA GOLD MEDAL

A gold medalist must stand so high above the rest of us that we find ourselves going beyond our abilities of design and find that extra amount of dedication, perseverance, goals, and leadership. To be a gold medalist, one must be so credible that the rest of us stand by and say 'a-ha, of course, ART NELSON.'"

Art is a past president of the Saginaw Valley Chapter, AIA, The Michigan Society of Architects and Keep Michigan Beautiful. He is the editor of the Saginaw Valley CSI Snake Oil Press, and the state coordinator for the national AIA/IDP.

## MSA 1981 HONORARY MEMBERS

State Senator Jack Faxon (Detroit) and Jim Mason, secretary-manager of the Plumbing and Heating Industry of Detroit, were made Honorary Members at the MSA Convention in Kalamazoo.

Ziegelman, Inc.; the Duluth Public Library in Duluth, Minnesota, by Gunnar Birkerts & Associates; Poplar Creek Music Theatre, Hoffman Estates, Illinois, by Rossen/Neumann Associates; the Oakland County Executive Office Building in Pontiac, designed by T.M.P. Associates, Inc., the William B. Hartsfield Atlanta International Airport, designed by Smith, Hinchman & Grylls Associates, Inc., with the Atlanta firms Stevens & Wilkinson and Minority Airport Architects and Planners; and ACO Incorporated headquarters and warehouse in Farmington Hills, also designed by Smith, Hinchman & Grylls.

## MSA BOARD NOTES

President Evie Asken invited representatives from all MSA Chapters to attend a special meeting of the MSA Board for the express purpose of discussion on the proposed review of the licensing of architects. This review is to be conducted by the COPAL committee appointed by Governor Milliken and is scheduled to take place sometime next year.

For this meeting Elizabeth Chalmers, Director of State Government Affairs for the AIA national staff, and Paul Welch, Executive Vice President of the California Council AIA, were invited to participate. Also in attendance were Harry Ball, PE, Executive Director of the

CEC, and Don Gordon, our lobbyist.

Welch described the procedure used by Governor Brown in California in his attempt to deregulate architects in his state. Chalmers reviewed the tactics used in other states to respond to similar approaches.

Our Political Action Committee for Design Professionals in Michigan is needed to be a key part of our program and will be aggressively headed up by Red Warner of Saginaw. You will be hearing from him in the immediate future. In this time of reapportionment of districts our PAC can be most important and indeed this is the most important time for the next 10 years in the house and the senate. PAC funds are crucial to our success in Lansing on matters relating to the profession. PAC needs you!
