YEAR-END PRESIDENT'S MESSAGE EVIE ASKEN, PRESIDENT 1981

My children had a toy called a "Slinky." It was a spring that would uncoil itself and create a motion that would cause it to open, move and perform "amazing" feats such as climbing down the stairs. It seemed to always be in control but invariably, someone would pick it up, allow it to stretch apart far beyond its tensile strength and there we would be — holding an elongated piece of wire that lost all performance, grace and motion.

In this, my year-end statement, I can't help but relate my profession, and our organization, to that coiled "Slinky." The economy has tugged many of us beyond recovery. A few weeks ago at the Convention in Kalamazoo there were many "horror" stories. We were told of Michigan firms that were literally closing their doors, packing their entire crews and heading west and south to the more prosperous areas of the country — accompanied, of course, by so many of the students who graduated last spring. Our next generation is leaving. Many rationalize these moves by comparing the times to others in history. They say, "That's life." But, I can't help but look at the unreparable spring.

I see our organization losing members. I see the MSA losing strength. I see a year approaching that is going to test the endurance of every architect in Michigan.

I see financial problems, legislative problems, organization-

al problems. I see the need for us to present the strongest, most united front ever. This is going to be difficult when the entire membership is going to be so totally involved with their own firm's direction — extra energy toward a volunteer organization normally moves to the bottom of the priority list when one is trying to survive.

I ask you, the members, to remember that our strength is through an organized effort. Let's not break away now.

Fortunately, next year's Board of Directors of the MSA will be especially strong. Few members are retiring. Their understanding of the many problems facing us as a profession is good. They have been a hard working board this year and I am certain this strong effort will continue. BUT, they are going to need the cooperation and backing of **every** member in the Society. We need to communicate, attain some goals, respond to calls, spend time working and "just plain" bolster one another.

As an organization, your leaders have expended many extra hours developing a more structured approach for the Society. We are well aware of the need to respond to the slimming effects of the economy, yet maintain the purpose of MSA by leading our profession through threats of sunset, competition based on fees and "simple survival." We have found the need to take a hard look inward, get a strong hold of the organization and get ourselves moving in a more pre-determined direction that has the needs of our members as its sole purpose. It's time to rid ourselves of the superficial tensile and solve our real problems — which, incidentally, are

the same ones we have had for 50 years.

Mike Callahan, Vice President-Elect, your incoming President for 1982, is better equipped for the office of President of the MSA than anyone who has ever approached that threshold. He has four years as Director, the long range planning session and the executive committee planning sessions as a basis of experience. He has been totally involved in all the business of the Society and we have made him aware of the workings of the office of the President. He has initiated the direction for this next year, and we of the Executive Committee and the Board of Directors have much confidence in his approach.

We may be entering one of the toughest, most challenging years, but because:

The MSA has super strength in its leadership of the Board . . .

The MSA has super strength in its newly revised structure . . .

The MSA **can** have super strength in its membership — that's up to you.

The MSA just may be the strongest spring ever . . .

Let's all work to keep the direction moving.

The seminar will be conducted by Archie Campbell, AIA, Building Official, City of Flint. Campbell is well versed in the new Code and will be

able to enlighten all of us on the important changes.

ENERGY IN DESIGN: PRACTICE

The AIA Energy in Architecture Workshop, Level 3B, Energy in Design will be held at Detroit Metro Airport, January 7 and 8, 1982. "Practice" is a two-day workshop that leads the participant through a design problem for an actual building, using information and techniques from the preceding workshops. Instructors serve as facilitators and resources, allowing for maximum direct application by the participant.

The Level 3b workshop contains six chapters: Introduction, Building Program, Climatic Analysis, Concept Analysis, Energy Analysis and Economic Analysis.

The Level 3b Workshop is designed to extend over a two-day period using the following schedule:

Introduction, 30 minutes; Building Program, 30 minutes; Climatic Analysis, 30 minutes; Concept Analysis and Development, 4 hours; Energy Analysis, 3½ hours; Economic Analysis, 2 hours; Presentation, 2 hours; and Critique, 1 hour, for a total of 14 hours.

Speakers for the Workshop are Gordon Clark, AIA, and Joseph Denk. Clark is President of an architectural firm in the Midwest specializing in energy conservation. He is a graduate of the University of Cincinnati with a BS in Architecture and

is an Assistant Professor in architecture/technology at Purdue University.

Joseph Denk, President of Denk-Kish Associates, a mechanical / electrical consulting firm. His firm specializes in building system design and system-energy source alternatives analysis.

Workbook Structure: The level 3b workbook is structured to enable designers to progress through an actual energy-conscious design problem. The individual chapters are as follows: Building Program — The chapter describes the building program for the sample design problem the workshop participant will use; Climatic Analysis — The chapter on climatic analysis includes the blank charts the workshop participant will use to perform a climatic analysis for the design problem; Concept Analysis — The chapter on concept analysis includes the monographs, forms and tables needed by the workshop participant to evaluate a number of design concept alternatives; Energy Analysis — The chapter on energy analysis includes the profiles, forms and tables that the workshop participant will need to perform an energy analysis of the design solution; Economic Analysis — The chapter on economic analysis includes the forms and tables needed by the workshop participant to analyze the life-cycle cost/benefit of the design solution.

The Energy in Design: Practice, Level 3b workshop will be held at the Hilton Airport Inn at the Detroit Metropolitan Airport, 31500 Wick Rd., Romulus, MI 48174. The date is January 7 and 8, 1982. The price per person is \$295.00. This includes coffee breaks, luncheon and workbook for

the two-day workshop.

UPDATE OF PLAN REVIEW FEES

From **CHARLES V. OPDYKE**, AIA, Chief, Plan Review Division

The Construction Code Commission on September 17, 1981 adopted a new plan review fee schedule which will become effective January 1, 1982.

The method of fee calculation has been changed from a volume basis to a cost per square foot basis coupled with the use of a multiplier factor.

These fees reflect the actual cost based on use group and construction type.

The building code review fee includes the energy code review.

The plumbing, electrical and mechanical code review fees are each 25% of the building code review fee.

The cost increase of the review fees reflect the economic conditions, but they are competitive with fees of other jurisdictions.

So Malcolm Williams walked into the office Thursday and posed a question. "How do I look to you?" he asked. He looked the way Malcolm Williams always looks — slim, sleek, rather continental. "You look fine," I said.

Williams shook his head. "The Towne Courier says I'm dead."

Williams had just heard the news himself. His daughter called and told him about his obituary in the week's Courier. He insisted that the item was incorrect. She believed him, which is rare and refreshing for an offspring.

Still, there was the item, under an imposing "Obituaries" title: "Malcolm M. Williams, an East Lansing artist, died recently."

That information is at least exaggerated, Williams insists.

Eventually things got straightened out. Somehow, a press release about Williams' art show had ended up in the wrong hands. Someone wrote "obit" on the top and a typist obligingly changed the first sentence. The rest of the story discussed Williams' art. Too often, you know, we wait until a person is dead to say nice things about him. So let's offer a brief memorial here. "Malcolm Williams is an intriguing and likable guy. He is 69, a retired architect and a genuine Renaissance man. He's on many local art groups; he's one of the good guys who works to make the Lansing area a pretty and pleasant place.

"He's a good person, and now we can pause and say nice things about him. Then we should boom ahead. Malcolm Williams says he's alive and I'm willing to take his word for it."


