An ad hoc committee from the Detroit Chapter Board has been formed to review all available data, including finances, program, schedule, and other pertinent factors, with the intention of recommending a detailed program to the Michigan Architectural Founda-

tion, the owner of the property. I am very excited about this program and I hope the Chapter can look forward to your wholehearted support for this program.

HOUSE BILL 4126

The following statement is made by William J. H. Kane, AIA, the chairman for the MSA Legislative Affairs Committee. Copies of the bill may be obtained by calling Ann Stacy (313) 965-4100.

MSA ANALYSIS OF HOUSE BILL NO. 4126

"State Construction Code Act of 1972" Bill requires a governmental agency complete a comparative cost analysis of at least two (2) energy systems; one of the systems analyzed shall be a solar energy system on any governmental building of over 35,000 square feet.

(A) "Certificate"—an official statement by the Commission.

(B) "Cost Analysis"—estimate of total cost for operation, maintenance, and construction of an energy system over the design life of the structure.

(E) "Government Agency" public agency, including the state, county, township, city or

village.

If the solar energy system is not less than another system, then the agency shall be eligible for reimbursement by the Senate for the cost of the analysis.

MSA Position:

- MSA not opposed to life cycle costing or value engineering for any structures.
- MSA concerns are with the cost of the service and the questions H.B. 4126 raises.
 - a. Who will do this type work?
 - b. Will they have to have special certification? How much will it cost?

- c. How will they be paid? (extra service)
- d. What is the cost/ benefit ratio?
- e. Will a large governmental agency be needed to monitor and issue certificate for construction?

f. What will be the filing fee and certificate cost?

 g. Possible project construction slow-up (Section 4, Page 2).

h. Poor procedures (Section 5, Page 3).

- i. What are the chances of cost reimbursement by the State for cost incurred for systems where costing is less than solar energy systems?
- 3. Under its present form, MSA cannot support H.B. 4126.






