PRESIDENT'S MESSAGE

For over a year now, a strange name or letter grouping of C...O...P...O...L has received considerable discussion during each of the MSA Board of directors' meetings. The initials stand for Commission on Professional and Occupational Licensure. A very imposing sounding commission, but what is it all about.

In accordance with Sections 215 and 216 of Public Act 299 of 1980, as amended, the Commission on Professional and Occupational Licensure is required to make recommendations on continuation or modification of state licensing for various occupations. "Sun-setting" is also a word phrase that could be used. Prior to issuing its final recommendations the commission is investigating thru questionnaires, research, and taking testimony from the public on the need to continue, or modify regulation of the licensed professions and occupations. All professions and occupations except those covered under acts of public health laws are to receive this review.

There are twenty-one professional and occupational entities to be reviewed, and the profession of architecture is one of them. So far, it is my understanding that eleven have received review, with seven recommendations concluded. Of the seven, six have been recommended for deregulation, and one survived. The remaining other half (ten) will receive their turn this coming fall to next spring. Architecture is in the second half.

The MSA Board continues to follow the progress of this commission with concern. On April 28, 1982, representatives of MSA

attended a public hearing by the Commission on Professional Community Planners and Landscape Architects. This was the first experience for anyone within the MSA to observe the commission and their procedures. Though early in the "game" for architecture, since no dialog has started yet, it was felt by the MSA executive committee that early input and influence must be made.

A statement was read to the commission for inclusion into their procedures and minutes. It is the preliminary statement to COPOL and reads as follows:

"The Michigan Society of Architects wishes to go on record as being in favor of the recommendations for continuation of state licensure of those professions which deal with all aspects of the development and improvement of the design/build environment."

"The Michigan Society of Architects does not recommend the deregulation of any of the environmental design professionals. In that development within the designed environment require most necessary interpretations of zoning, building codes, ruling, and ordinances by the design professional, protection of the health, safety and welfare of the general public must be maintained."

The dialog with COPOL has been started and will continue.

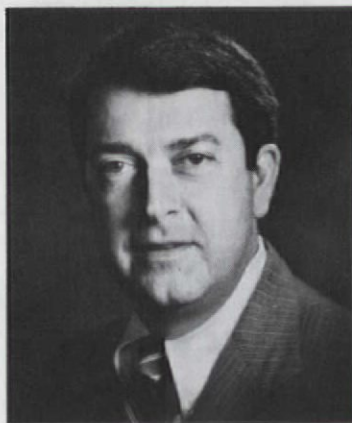

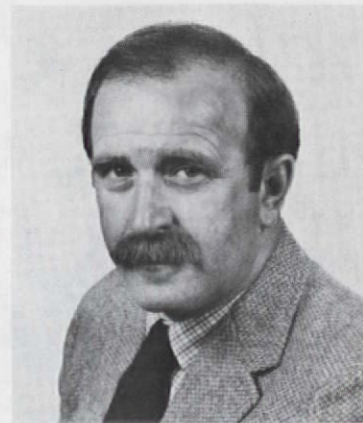

**Our Local
Construction Economy**

The construction economy in southeastern Michigan has been in a tailspin since the end of 1978 when the piping contracting industry recorded 6,287,000 hours. By the end of last December, 1981, activity had dropped to 4,115,000 hours, an overall decrease of 34½ percent!

During the first quarter of 1982, hours increased almost 12 percent over the same 1981 period. Virtually all the increase can be attributed to utility construction. The balance of the entire commercial, institutional, industrial and residential markets appear to be at a standstill. The hours recorded by plumbers during the first quarter of 1982 reflected 15½ less activity than during the same period a year ago, an indication that we are building more equipment-oriented than people-oriented structures.

While the immediate future of the southeastern Michigan construction economy is clouded, the piping industry still is optimistic. We feel that a 10 to 14 percent improvement over 1981 is not at all unrealistic, and that the second half of 1982 will witness the probable turnaround in all construction markets.

There is one particular market which we feel has not been exploited. And it is one we suggest that architects, engineers and contractors might want to enter into. . .

**Restoration, Renovation

We recently completed a two-day mechanical energy conservation seminar and enjoyed listening to a crackerjack by name of Victor Ottaviano

describe what can be done to make older, existing buildings look good and perform well.

Naturally, the PHI contractors (39 of them) were interested primarily in the plumbing and HVAC aspects of the problem. More importantly, all came out of the session with the realization that it takes the combination of building envelope and electrical knowledge, along with mechanical, to really make an older structure work well.

Since there is relatively little new activity in the design field, it might be a darned good idea if the design professionals and contractors consider selling the idea of renovation and retrofit. The market exists. But it's tough to crack. There's an old saying that nothing happens until somebody sells something. And, most owners really aren't aware of what can be done with an older structure until someone points it out to him.

Take ourselves. A few years back, in late 1977, we got the message about electrical costs. From 1972 through 1977, our average KWH usage was 110,173. We took inexpensive steps (new bulbs) to cut our lighting back and tightened controls on the air handling system timer. Last year we burned 80,960 KWH. PRESIDENT'S MESSAGE

Mike Callahan, AIA
President MSA

As announced during the Grassroots '82 presentation to the many Chapter Presidents and President-Elects in attendance, during the year 1982, the American Institute of Architects will be celebrating their 125th Anniversary of its founding. One of the 10 oldest Chapters of the Institute is the Detroit Chapter. In celebrating the Institute's 125th, Detroit's 95th, and our other Michigan Chapters' dates on down in numbered years, we must also reflect on the service to the profession that the Institute, Michigan Society, and each Chapter has given over these many years.

The theme of the Institute this year is "A Quest in Time," thereby allowing for reflections of the past, celebration of the present, and planning for the future. During this difficult year, members will be asked to evaluate their participation as an Institute member. We must analyze what we have done for the betterment of our profession, our community, our fellowman, and ourselves as architects.

The "125th Year Celebration" is upon us. Where will we all participate when asked to celebrate the presence and important place of architecture in our nation's history and future.

MSA BOARD MEETING

The first meeting of the MSA Board of Directors for 1982 was called for January 28th by President Mike Callahan.

At the invitation of Regional Director John Jickling the Board convened at the Gerald R. Ford Memorial Library on the North Campus of UM, Ann Arbor. Jickling, Lyman & Powell are the architects for the handsome new building which houses the papers of President Ford. (The Museum in Grand Rapids by DeWinter Associates houses the gifts and memorabilia from the Ford years in Washington.)

During the six-hour meeting the Board accepted the budget as proposed by Treasurer Keith Weiland. It is a very cautious budget based on a very conservative estimate of income from dues as well as other sources and with decreased expenses in all areas. Our major income producing activities, the fall Convention and the MSA Handbook have been burdened with additional net income goals to help compensate for our possible loss of members in 1982 and for our increasing day to day costs of operation.

All Chapters are encouraged to begin well planned membership drives and are asked to call on staff for assistance wherever needed.

Our legislative program is critical in the election year and for that reason Paul Bowers has accepted the chairmanship of the Political Action Committee for Design Professionals in Michigan, our fund-raising arm of the legislative affairs committee.

Bernie Mayotte will work with the State offices in the Building Division and Bill Kane with the Executive Director Ann Stacy will handle legislative and regulatory matters as they arise.

President Callahan appointed committee chairmen in addition: Dennis Haugen, MSA Fall Convention; Thomas Wheat, Mid-Summer Conference, and Art Nelson, IDP. Haugen attended the meeting to report on his progress for the October MSA Convention in Flint at the new Hyatt, October 13-15, 1982. His committee consists of Don Lee, Vice

Chairman; Dick Canfield, Graphics and PR; Jim Tomblinson, Program; Gene Terrill, Hospitality; Bob Gazall, Exhibits; Jim Wheat, Finance; Pat Haugen, WAL (Spouses); Jim Saule and Dennis Brown, Co-Chairmen Continuing Education; Students, IDP, Jeff Bennett, Past President, and Peter Danner, President Flint Chapter; ex-officio members are: Dale Grainger, MSA Director, Flint; Rae Dumke and Ann Stacy, MSA Staff; Roger Margerum, MSA Vice President.

Robert Metcalf, Dean of the College of Architecture and Urban Design, brought to the Board a proposal for a Center for Architecture and Planning Studies at the University. The goals for this proposed center are:

1. To improve the quality of architecture and planning education.

2. To bring University of Michigan resources (research, faculty, and students) to bear on contemporary architecture and planning problems in an effort to develop more effective services in the professions.

3. To advance the development of services in areas not traditionally covered by architecture and planning firms.

4. To use the name and reputation of the UM to help draw clients from other States and regions to Michigan for professional services.

5. To assist in the economic redevelopment if the State of Michigan by organizing and coordinating professional services for new industrial and commercial interests.

Chapter reports were heard. The Regional Director does not attend a national AIA Board meeting until the end of March.

OBITUARIES

WILLARD A. OBERDICK, AIA, Huron Valley Chapter member and Professor at UM College of Architecture & Urban Planning, died February 11 at UM Hospital of a heart attack. He was 59.

A specialist in the area of building technology and solar energy components, Oberdick was director of the college's Building Technology Laboratory. Recent work involved studies of energy efficiency and solar potential of buildings throughout Michigan, with particular attention to the Federal Office Building in Saginaw.

A member of the UM architecture faculty since 1948, Oberdick also did some of the earliest research in the use of thin-shell concrete in building construction, as well as research on the use of reinforced and cellular plastics, plastic sealants and structural zipper gaskets.

Born September 10, 1922, in Dunbridge, Ohio, Oberdick received the bachelor of architecture degree from UM in 1947. After graduation, he worked for several firms.

In 1977 Oberdick received an "award of merit" and was named a Fellow of the ASTM. He was recipient of awards from AIA, the Building Research Institute, and the American Society of Testing and Materials.

He is survived by his widow, Elizabeth Sheperd Oberdick, and three sons, John, Frederick and William Andrew.
