## PRESIDENT'S MESSAGE

Periodically during the Society's year, the board of directors convenes a meeting of the Michigan Architectural Foundation. Each Society board member is also a board member which makes up the Michigan Architectural Foundation. In doing so, this also expands each board member's responsibility and representation of the state's architectural community.

The Michigan Architectural Foundation was established specifically to allow for the acquisition of the Beaubien House/MSA Headquarters. Through the Foundation, the past and continuing program of contributions for the Beaubien House's purchase is administered. Also, the Foundation's board has the responsibility of overseeing the facility's rental, maintenance, repairs, alterations, and up-grading. With any old building many things have to be done to maintain and enhance the building's potential as a sound financial investment, allow for proper utilization by the MSA staff and society, and also to create the proper image for Michigan's architectural profession.

Over the past few years, various separate projects have attempted to restore or at least stop some of the building's deterioration. But much is still to be done. In the past, the MSA has had a committee to address the Beaubien House needs. A shopping list of possible efforts has been developed with some items being accomplished. This spring, the Detroit Chapter initiated a Beaubien House Committee in parallel with the MSA Committee. It appeared that a great deal

of duplication of efforts was about to begin and it was found that several individuals were on both committees.

To make the efforts of all more effective toward the single goal of the Beaubien House, and also fall under the responsibility of the Foundation, the MSA Board of Directors at the May 13, 1982 meeting recommended and approved the following:

- Recommended to the MSA Board to dissolve the Beaubien House Committee with special thanks to Chairman Tony Marino, AIA.
- Formed a Michigan Architectural Foundation-Baubien House Committee which would include the Detroit Chapter's and MSA's Beaubien House committees.
- Appointment of Charles T. McCafferty, AIA, as chairman of the MAF-Baubien House Committee.

It was also hoped that the MAF-Baubien House Committee would be a broader-based statewide committee with greater participation from outstate chapters. It is now felt that a muddled situation has been streamlined with direct linkage to the Foundation.

There are many items that need immediate attention. An overall master plan of action must be developed if grants are to be sought. Then the Beaubien House will be a representative anchor for the Michigan Society and the state architectural profession.

## NEW POLITICAL ACTION COMMITTEE FOR MSA

At the regular meeting of the Board of Directors on May 13th,

the MSA organized the new Political Action Committee for the Michigan Society of Architects.

Under the direction of Chairman Paul Bowers, FAIA, of Grand Rapids, the committee is currently raising a total of \$5,000 for use in this election year.

Members of the committee (Jim Graham, Dale Grainger, George Moutsatson, Bob Reid, Ann Stacy and Nik Schulwitz) are canvassing all the membership, chapter by chapter, to raise the total sum by contributions drawn on personal accounts made payable to the MSA/PAC.

Members may contribute in any amount, at any time, by mailing their personal check to the MSA/PAC at the Beaubien House, 553 East Jefferson, Detroit, MI 48226.

The funds collected for this calendar year will be spent in support of candidates running for office in Michigan. Funds from the MSA/PAC will not be spent on national elections. Some of the funds will support the campaign of Mike Callahan, AIA, President of the MSA. Mike is running for a seat in the Michigan Legislature from the 104th District in Traverse City. If elected he will be the only member of the House licensed under P.A. 299.

The MSA/PAC is a vital part of our legislative program, to improve the climate for doing business in Michigan. Our legislative committee needs support of PAC in order to grow and become a more effective arm of the Society. Your contribution, no matter what the amount, is important.

As part of this fund raising campaign, Bowers is also representing the national AIA/PAC fund and is asking for a percentage of your contribution pledge be made payable to the AIA/PAC.

## CHICAGO ARCHITECTURE FOUNDATION ANNOUNCES COMPETITION

The Chicago Architecture Foundation is sponsoring a competition to design an appropriate monument commemorating the sesquicentennial of the birth of William LeBaron Jenney (1832-1907), pioneer exponent of the principle of skeleton construction and 'Father of the Skyscraper'. The Foundation will spearhead an effort to secure funding for the construction and erection of the monument in the Jenney family plot in Graceland Cemetery.

This national competition is open to architectural designers, students in architecture or design, sculptors, design professionals and licensed architects. The entry fee is \$25. An information packet will be mailed upon receipt of the fee. Submission must be postmarked by August 10, 1982 and the winner will be announced September 25, 1982. First prize is \$1,000, second prize is \$650 and third prize is \$350.

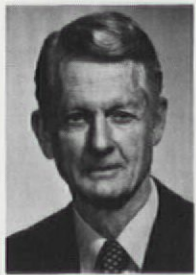

The MSA-Mechanical Airhandling Contractors 1982 Drafting Competition is being sponsored by MAC—"Mechanical Airhandling Contractors," Div. of SMACNA — Metro Detroit Chapter.

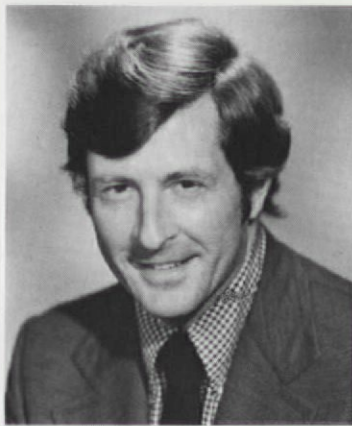

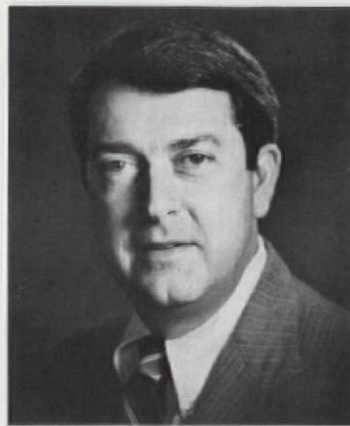

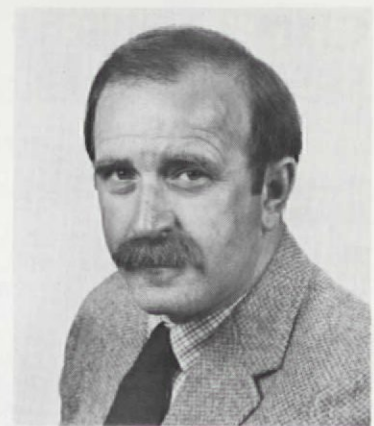
