### MSA PRESIDENT'S MESSAGE

By the time this article is presented to you, the AIA Convention will be over and the California Council/AIA will have introduced to the Convention a resolution that is of major importance to us. They describe the intention of the Proposal to accomplish the following:

- Develop a strategy for state component assistance in the event a state component is faced with a registration issue that they have inadequate resources to address.
- And further, to present the strategy for consideration by the AIA Board of Directors.
- Act as a component clearinghouse on registration matters.
- Establish a definition of practice of architecture as distinguished from the practices of related professions and practices.

It is intended that this definition would serve as a guideline for state components in defining the practice within the context of registration, in a manner which is consistent with other states.

"The American Institute of Architects, as an old and respected institution, is quick to recognize emerging issues and develop new programs and strategies in response. However, the Institute should also recognize its fundamental responsibility to the membership to defend and protect the scope and practice of architecture. While the state and local components must take the lead, the Institute, recognizing that developments in one state often times create precedents for action in other states, can develop and coordinate the resources of its 36,000 members.

This Resolution addresses a fundamental concern of our membership and therefore transcends the issues of "Big State/Little State," "Big Chapter/Little Chapter," and "Big Firm/Small Firm." This is a Resolution which reaffirms the Institute's concern for the well being of the profession and establishes registration issues as a priority of the Institute. In summary, this Resolution not only helps preserve the practice of architecture for those now practicing, but, more importantly, it preserves the integrity of the practice of architecture for future generations of Americans."

Michigan has similar problems and will give support to the concepts and actions preserving Architectural Registration.

### THE ARCHITECTURE OF ALDEN B. DOW

The MSA is pleased to announce the publication, *The Architecture of Alden B. Dow* by Sidney K. Robinson.

During the mid-seventies the MSA Board of Directors investigated the possibility of a monograph series under the chairmanship of Denis Schmiedeke and this book is the result of what started out to be a series of monologs. The book is published by Wayne State University Press with grant assistance from the Michigan Council for the Arts.

The book is the first comprehensive review of the architecture of Alden B. Dow. It examines Dow's singular approach to the design of private houses

and public buildings.

According to Robinson, "The son of the founder of the Dow Chemical Company, Dow found a receptive clientele in Midland, where over three-quarters of his work is located. He was a student of Frank Lloyd Wright, but his statements on aesthetics and the philosophy of the individual recorded in this volume show an independent and thoughtful mind."

The author, Sidney K. Robinson is associate professor of architecture at Iowa State University in Ames. His undergraduate studies were at Columbia University and he received his doctoral degree in architecture from the University of Michigan. He is registered in Michigan and a member of the AIA and Society of Architectural Historians.

The book is available from the MSA Bookstore — \$13.95 paperback.

## OBITUARIES

**AARO J. ANNALA, AIA, 64**, died unexpectedly on April 11, 1983. Aaro was a native on Finland who immigrated to the U.S. at an early age. He is a 1950 UM graduate. He joined Albert Kahn Associates in 1953 and was an associate of the firm since 1961. Prior to his death he was a senior staff architect with A/K.

Aaro served in both WWII and the Korean War. Among his decorations were the Bronze Star, Purple Heart and Cluster. He retired from the U.S. Army Reserve as a Lt. Colonel.

His affiliations included the Reserve Officers' Association, The Society of Military Engineers, the Detroit Chapter, AIA, MSA, ESD, and the Michigan Association of Professions.

He is survived by a sister, Mrs. Gertrude Annala Heikkinen, of Palmer, Michigan.

**STEPHEN S. PAGE, 64**, died unexpectedly on April 23. Steve was a native of Quincy, Mass., a UM graduate, and received a Masters degree from Cranbrook. Following Cranbrook he entered the service in 1942.

He worked with O'Dell, Hewlett & Luckenbach for 24 years and joined Giffels Associates in 1971, most recently he began his own practice serving as a consultant.

Among his works are the Meadowbrook Festival Pavilion, the Meadowbrook Theatre, Ford Auditorium and over 100 educational buildings.

According to Bob Greager, "Steve was a very concerned person about social causes. He had just volunteered his services to FOCUS-HOPE. He was helping them with architectural problems."

Steve had been a member of the Detroit Chapter, AIA, since 1951 and active on many Chapter committees.

Survivors include his wife, Betty, of Bloomfield Hills, and two sons, Clifton and Jonathan; a daughter, Peggy Batson, and his mother, Christie.

**PAUL FLEET, PE**, retired form Albert Kahn Associates, died this past April.

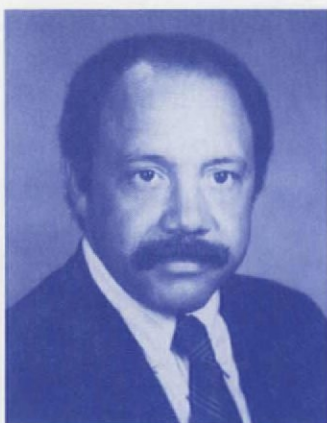

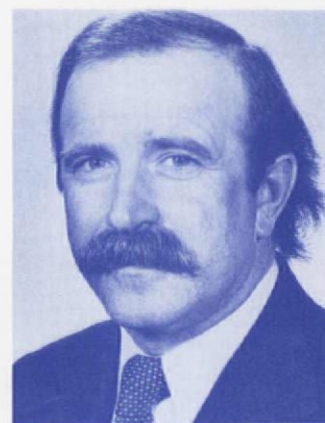
