PRESIDENT'S MESSAGE

Roger Margerum, AIA

Recently I was requested to give a state of the profession report. State of the professional society may or may not be one in the same. Those who are not in the AIA may argue the latter. There is nothing wrong with the profession that an improvement in the economy will not cure.

In fact, all indications are that the profession is ready to take its place within the newly emerging lifestyle being determined by our computer society. As John Naisbitt indicates, the industrial age is over. Society does not seem to be in a rut — just broke. And the architectural profession is poised and ready to contribute to the way things ought to be.

The AIA exercising its choice effectively by supporting designer Maya Lin and the Vietnam Memorial and fighting for the restoration of the U.S. Capitol. The AIA is developing public awareness programs for Chapters and a mass media campaign for the profession—I believe we must be certain that all programs are reflective of our region and truly create the image we need for business growth.

The AIA Intern development Program-1 believe we

must add participants in our program in Michigan but I believe strong mentorship (not just apprenticeship) must be included. Basic management, business principles and "the ropes" are not to be learned. They must be taught and groomed.

The AIA is geared toward the office practitioner—I believe it is time for us to encourage alternative career paths. We have the finest schools of Architecture in Michigan, yet we lose so much talent to other states because our firms simply cannot absorb the graduates. Architects have more to add to society than good design. The prestige and professionalism must be extended.

The Regional Director not only serves on the Institute committee assignments, but is also on the Society Board with full Executive Committee duties—I believe that the Regional Director should be freed of the Executive Committee duties and spend more time serving the member... the purpose of the position.

The Regional Director & You

Traditionally, the Regional Director meets with the Chapter Executives two times a year and communicates with the Member through the column in the Bulletin and with reports at the two membership meetings-I believe the link to the Member is weak. to strengthen it, I propose that the column be expanded to a "newspage" reporting AIA news that is pertinent to the Michigan Member; regular correspondence with the Chapater Presidents be initiated; and open "one on one" communication with the Member be encouraged.

I do not propose to charge into the Institute screaming "change," but I do pledge to you that as MSA Regional Director, I will be an active, open and sincere representative, reflective of those of us who work in Michigan at the profession called Architecture.

ALMON J. DURKEE, FAIA Candidate for **Regional Director**

Today our society is undergodramatic changes ing environmental issues, computer proliferation, uncontrollable interest rates, spiraling construc-tion costs, threatening legjslation, governmental intervention - which makes the architect's role difficult to ascertain, both for society and for the architectural profession.

In reflection, our profession was regarded as at the top of our society prior to WW II. Today, that posture has eroded! We need to bolster and organize our profession, much like other pro-

fessionals; we need to increase education and public understanding of architecture; we need to earn and collect proper fees for our services, which will result in a profitable business: and we need to involve ourselves in legislation that may inpact on our profession. This situation makes it of the utmost importance to elect the candidate with the appropriate credentials to serve during this difficult time.

My qualifications include thirty-three years of experience. Twenty-two years of that experience was in private practice, advancing from working on the boards, estimating, specifications, field supervision, to handling clients and office administration - always with an eye on the business aspect of a firm. During my later years in the private practice, I held executive positions with prominent firms in the Birmingham/Detroit area and was Exec. V.P. of the arch. firm which designed the Silver Dome at the time of entry into state service.

Following a national search in 1972, I was selected as the State Architect and Director of the Bureau of Facilities - an agency of over 500 people and a \$25 million budget. That decade of experience provides invaluable training to serve as Regional Director - testifying before legislative committees, including an effective appearance at the architectural registration hearing; daily relationships with legislators, which often involves personal and direct contact with congressmen in Washington, D. C.; administration of the building program with the JCOS; serving on numerous government committees and commissions, often as the personal representative of the governor; while concurrently administering the operation of a large and complicated Bureau.

As many of you know, I do not I

hand out jobs. Working with the professional societies (MSA, MSPE and CEC) in the late 1970's, we developed an A/E selection process for major projects which keeps the decisions for the process totally in the hands of the appointed committees. We also increased arch. fees on state work approximately 10%. I am proud to have orchestrated this successful joint effort, which hopefully protects the archtectural profession from the constant threat of all-out bidding on state work.

My experience serving for many years on committees and the Board of Directors for the Detroit Chapter of AIA, and similar activities with MSA which culminated in my Presidency in 1971, obviously is also of great value and necessary experience to bring to this position. During this tenure, great personal attention was given to the necessary and expected accountability of our professional local, state, and national associations. My interest will continue, with particular focus on the budgeting of our dues. As a father of five sons, one of which is an registered architect, I am particularly interested in the young practitioners and the awesome problems which they face today.

My experience, credibility, and hopefully my wisdom should serve me - and you - well on the National AIA Board. I believe that I am eminently qualified, with the appropriate credentials, and committed to serve Michigan with the utmost vigor during the next three years. I have the support of my wife, Norma, and my employer, the State of Michigan; and, I have the enthusiasm and desire to get deeply involved in AIA activities at the national, state, and local levels.

OBITUARIES

ALDEN DOW, who was named Michigan's architect laureat in May, died August 20th at his home in Midland. He was 79. He had designed more than 60 homes and churches in the Midland area and was responsible for the Student Center Building at WSU, Dearborn Presbyterian Church, Ann Arbor City Hall and the theatre at Interlochen. He designed the campuses of Muskegon Community College and Midland's Northwood Institute.

Mr. Dow graduated from Columbia University School of Architecture in 1931, and later studied under Frank Lloyd Wright. He opened his own office in 1935 and was MSA President in 1949-50.

Earlier this summer, the Michigan Society of Architects and Wayne State University Press published a 155-page book detailing the design style of Mr. Dow, called "The Architecture of Alden B. Dow."

Mr. Dow is survived by his wife, Vada; a son, Michael, and two daughters, Mary Mills and Barbara Carras.

LEO J. HOSMAN, 88 years old, died on July 18, 1983 in Sylvania, Ohio. Mr. Hosman was an architect with SH&G Associates for 40 years until he retired. A graduate of UM School of Architecture, Mr. Hosman served on various planning and development commissions in Washtenaw County. He also was president of the Willow Run Board of Education.

He was a member of MSA/AIA

and the Optimist Club of Flint. He is survived by a son, Richard; three daughers, Aurabel Ward, Dorothy Lindquist and Bernadette Hudson.

PRESIDENT'S MESSAGE

Roger Margerum, AIA

All reports on the outcome of the Mackinac Island event indicate that we had one of the most successful and profitable semiannual meetings in recent years. Much thanks to Dick and Judy Fry. The Grand Rapids convention and its schedule of events will have two items of ongoing interest - the Beaubien House development and the Regional Director election. To continue with MSA operations the MSA Executive Committee has accepted Rae Dumke as Acting Executive Director.

Staff leadership is in good hands with Rae Dumke and we are pleased that we may benefit from the years of her association with MSA. Vice President/President Elect Dick Slocum will chair the search and selection process to find the best qualified person to fill the position of MSA Executive Director. The Past Presidents Council has been designated to confirm the job description. We have asked the Council to suggest the advertisement vehicles for the position of Executive Director that will be placed in appropriate national publications. The final selection team shall be under the discretion of the 1984 MSA Board. We have the next six months for the search and selection process. and in the meantime we have the capable management of Acting Director Rae Dumke.

VOTING/ REGIONAL DIRECTOR

Due to several inquiries concerning the voting procedures for Regional Director at the Annual MSA Business Meeting on October 13th we are publishing Sections of the MSA Bylaws which pertain to voting and the nominatioan and election of Regional Director. This is for your information and use. Please note, as we stated before, there are no absentee ballots for this election.

ARTICLE 4,

MEETINGS OF THE SOCIETY Section 4. Voting.

a. *Eligibility*. Eligibility for voting at all meetings of the Society shall be as follows:

 All Members in good standing may vote on all matters;
All associate members in good standing may vote on all matters except dues for Members and charges of unprofessional conduct.

3. Professional affiliates, nonresident members, firm members, and honorary members shall not vote for any matter.

b. Total Votes per Chapter. The number of votes to which a chapter is entitled shall be the number of Members in good standing in said Chapter on January 1 of the year of the meeting.

c. Allocation of Votes Within a Chapter. The votes to which a Chapter is entitled shall be apportioned equally among the eligible members of said Chapter in attendance at the meeting and voting, except that no member shall cast more than 100 votes.

d. Method of Voting. Voting at all meetings of the Society shall be:

1. by voice vote;

2. by standing vote, when so requested by one member eligible to vote, or at the discretion of the chair; or

3. by secret ballot, when so requested by 10% of the members eligible to vote, or at the discretion of the chair, or when so required by these Bylaws.

e. Decisions. Each decision of a meeting of the Society shall be by a majority of the votes cast, unless a larger vote is required by these Bylaws.

ARTICLE 9. REGIONAL DIRECTOR Section 2. Nomination and Election of Regional Director

The Regional Director shall call a convocation of delegates to nominate his successor. This convocation shall be held at not less than six months prior to the expiration of the retiring Director's term of office. The delegates shall consist of the President of the Society and the presidents of all Chapters. The President of the Society shall preside at the convocation. The delegates shall nominate one or more members of the Society as Regional Director. These names shall be placed in nomination at any meeting of the Society held not less than 30 days after said convocation and not less than 45 days prior to the expiration of the retiring Director's term of office; additional nominations may be made from the floor. The gualifications and platform of each nominee shall be presented to the membership at the meeting. The members shall then elect, by secret ballot, a Regional Director. The Secretary shall send the name of the newly elected Regional Director to The Institute.

SUBJECT: Review of "One Per cent for the Arts Ordinance"

DATE: September 7, 1983

Editor's Note: We are publishing this Memorandum in its entirety because we felt the entrie membership should be advised of this type of action.

This memorandum is submitted in response to the request for the Detroit Chapter's review of the One Percent for Art Ordinance transmitted to us on August 2, 1983.

The basic position of the Detroit Chapter/AIA regarding the proposed ordinance was stated in a memorandum dated August 19, 1982. The concerns expressed then are still valid and have been repeated. Additional comments regarding the specific draft ordinances are included.

First, we must note that the intent of the ordinance to provide art as a part of all municipal construction projects is a very commendable objsctive and one to be supported in principle. Our public buildings and environments need to be enriched by the presence of art as an integral part of our daily experience.

This ordinance also follows the same intent established at the federal and at the state level with varying degrees of success. All in all it is a goal to be sought after.

There are, however, certain reservations that we must make in our consideration of this specific ordinance. These reservations are

submitted below.

1. A first concern is the fact that all public art projects will be selected by the new Public Arts Commission.

Our first concern here is that the artwork should be considered integral with the architecture and not as a separate process. The architect, in creating a work of art in his building, is in as good a position as an artist in identifying the appropriate location, scope and content of the artwork to be included in the project as any commission would be. Furthermore, a committee has no inherent qualifications to select work for a building, particularly one in which they have not been involved in the creative process itself.

2. The ordinance creates a small but potentially a potent bureaucracy which as all bureaucracies, would have to establish specific guidelines, not only for its operation, but for the selection of pieces of art. This goes cross the grain of the intuitive nature of art. Committees are not intuitive.

3. This establishment of the Selection Committee known as the Public Arts Board ignores the project architect when it indeed has been his intuitive powers that have brought the piece of architecture to reality in the first place.

4. There are other considerations within the proposed ordinances that bear a second look. In the "Draft-Public" there is apparently no connection between the funds collected and the location of works of art. There are also no other provisions for maintaining the art works after they are acquired. We assume that the statement in Sec. 2-7-134 regarding the use of this fund for salaries, expensed, etc., is a typographical error.

In the "Draft-Private" it appears that neither the Owner or his architect have any substantial voice in the selection and/or placement of the art-work. The Owner has one seat out of ten on the Board to protect his investment and to exert any control on how his money is to be spent. No provisions are made to credit the cost of portions of the building that fall into the category or works of art such as fountains, sculptures, etc., that are provided outside of the 1% assessment.

Since the City of Detroit has survived for over two hundred years without a forced program for providing works of art in public spaces, we have difficulty in seeing how the ordinance is necessary for the preservation of the peace, health, safety and welfare of the people of the City of Detroit.

Perhaps a more acceptable program could be designed around a policy adopted by the City of Detroit to fund and provide works of art for all public buildings rather than by passing a new ordinance. This could provide an example for the private sector to follow and we believe the same results could be achieved without non-enforceable laws on the books.

In summary, we believe any attempt to enforce an ordinance of this type on private projects will discourage project development within the City of Detroit. The Detroit Chapter would be pleased to offer any additional comments or services in the development of a voluntary program.



RULES FOR STORAGE AND TRANSPORTATION OF FLAMMABLE AND COMBUSTIBLE LIQUIDS

The State Fire Safety Board has promulgated new rules for the storage and transportation of flammable and combustible liquids. These rules took effect on July 13th, and rescinded the 1073 "Michigan Flammable Liquids Regulations." The rules have been divided into two packages, one relating to storage and the other to transportation.

The most noticeable change in these rules is that the rule document can no longer be used by itself but must be used in conjunction with the national standard which has been adopted by reference. For instance, in the case of the storage of flammable and combustible liquids, the rules and amendments and additions to NFPA pamphlet No. 30, 1981, "Flammable and Combustible Liquids Code." Using the rules along would be confusing and nonproductive. This action has been taken in both of these sets of rules to maintain a high degree a high degree of consistency with recognized national standards.
