There are currently over 43,000 architects in the United States who are members of the American Institute of Architects, organized on over 250 component chapters in about 50 regions. The range of resources offered to members and to the profession is awesome. A glance through the Member Resource Catalog published by the Institute describes over 100 different resources — programs, services, seminars, newsletters, directories, books and more — that AIA members call upon most frequently when they turn to the Institute for help; the catalog ought to be kept right at each member's fingertips. We all know about the AIA award-winning magazine *ARCHITECTURE* — a magazine that architects have called the most respected magazine in the field. Its outstanding news coverage of architectural events, evaluation of contemporary buildings and feature articles on topics of special interest to design professionals is now available to non-member architects and lay people interested in architecture. The December 1983 issue of *ARCHITECTURE* contains several extraordinary articles on Art Deco style; architectural

historian David Gebard writes about the parallels of aspects of present architecture with the early '30s: "... there are so many points of similarity... that we should feel slightly uneasy about our current scene" — "those clashing views of the whys and wherefores of architecture and design." And the course exponents of Art Deco "partook of both (High Art Modernists and the Traditionalists) because their interest lay essentially in design, not ideology."

The following information from the Member Resource Catalog describes two other services to which all members of the AIA may avail themselves:

AIA LIBRARY: With 20,000 volumes, a periodical list of 400 titles and impressive slide and film collections, the AIA library may be an Institute member's most complete resource. Slides, films and books are available to members on a loan basis (two weeks for slides and books, three days after confirmed delivery for films). Accessions lists (published bi-monthly and free to members) keep you up-to-date on what's available, as do 400 specially prepared bibliographies covering current books and periodical articles on architecture and related subjects. The Library also provides reference assistance — including a computerized search service — to AIA members over the phone, by mail or in person.

AIA BOOKSHELF: Whether you're looking for the broadest architectural encyclopedia or the most specialized practice guide, you'll find the title you need at the Institute's exclusive, one-stop, shop-by-mail bookstore. AIA members can order books by mail or phone from a title list that is continually growing as new tools and aids for practicing professionals are published. The
