### MSA PRESIDENT'S REPORT

Groundbreaking for the restoration of the front facade of our Beaubien House will be held on Friday, April 6th, at 5:00 p.m. I would like to take this opportunity to personally invite all of our members to join me for this long awaited event.

As you know we are looking at a major renovation for the rest of the Beaubien House, and your attendance of the groundbreaker would give you a chance to see first hand why we desperately need your understanding and support for this undertaking.

Several of our members are questioning the sanity of it all, and while it is virtually impossible to totally explain what we are looking toward, I will try to give you an overview of some of the changes that are being considered.

First, let me say that because the magnitude of this project has increased to the point that no one committee should be asked to devote the time and energy that it will take to make this project materialize, we have divided the process into four sections, with Stuart Pettitt heading up the overall coordination of the project.

I believe we now recognize the fact that it may not be possible for the MSA headquarters to occupy the entire building, nor can the membership be expected to support the entire cost of its operation. Therefore, the Planning and Design Committee is revising its thinking and is looking toward the third floor being used as rental space, with the first floor housing the MSA staff and bookstore, leaving the second floor as a gallery and board/meeting room that could be semi-self supporting, or additional rental space.

A lot of work is yet to be done. All I ask is that you, the members, give these committees a chance to fully demonstrate that this project can and will benefit all of the membership.

Dear Mrs. Dumke:

This letter is a follow up to our telephone conversation of February 16, 1984, regarding rules for health maintenance organization freestanding outpatient facilities and freestanding surgical outpatient facilities.

These two sets of rules have been developed by the Fire Marshal Division, reviewed by a Fire Marshal appointed committee, accepted by the State Fire Safety Board as appropriate for the scheduling of hearings, and sent to the Legislative Service Bureau for informal review. The Legislative Service Bureau, in their informal review, examines the document for format and grammar and assigns Michigan administrative code numbers. At such time as these rules are returned to the State Fire Safety Board office by the Legislative Service Bureau, the appropriate changes will be made and numbers added, and a public hearing on each set will be scheduled. Until the scheduling of the public hearing, we have a practice of not furnishing copies of proposed rules to interested parties due to the fact that additional questions may be raised by changes made by the Legislative Service Bureau or, hopefully, questions may be answered by changes which they make in

grammar. In any event, having two different sets of rules both marked "proposed" sent out with different texts is confusing, at best.

As is our common practice, we will provide you with a copy of the public hearing notice and draft of the rules as soon as they are returned by the Legislative Service Bureau and a hearing date is set. Public hearings probably cannot be conducted before at least May due to the time constraints established by the Michigan Register Act.

We apologize for any misunderstanding which may have taken place and appreciate the interest of your members in these rules. If we can be of further assistance to you in any way, please feel free to contact us at your convenience.

### INFRASTRUCTURE COALITION IN MICHIGAN

Governor James Blanchard has formed a Michigan Infrastructure Coalition comprised of several statewide construction associations, governmental officials and interested persons. The coalition, formed in the fall of 1983, involves 11 state department directors as well as organizations concerned with public investment in Michigan. The award is made by the Queen of England on the recommendation of the Royal Institute of British Architects. Past recipients of the award have included Sir

Golbert Scott, Sir Edwin Lutyens, Sir Nikolaus Pevsner, Frank Lloyd Wright, Buckminster Fuller, Le Corbusier, Mies van der Rohe, and Alvar Aalto.

## RETURN OF THE "NATIVE"

I put the "Native" in quotation marks because I have returned to Ferris State College in Big Rapids, Michigan, not as a real native of the place but as the "native" author and original teacher of the Architectural Technology two-year Associate Degree program here at Ferris. A poetic return or, as some have said, full circle.

In September, 1983, I resumed teaching at Ferris in the program I had started in 1954. It has grown into the Construction Department of the School of Technology. That one school of Ferris has more students than the whole college did in '54. The Construction Department under Jim Shane, AIA, has almost two dozen professional architects and engineers plus other technical staff to teach a multi-track offering in construction technology. To the original Architectural Technology curriculum the following have been added: Building Construction Technology, a hands-on curriculum in the construction of wood, steel, masonry and



crete structures — including finishes; Construction Engineering Technology, a program in heavy construction including materials testing, project layout, supervision and estimating, the use of heavy equipment; and Construction Management, the new position in the construction team. Other construction programs include Surveying & Mapping, Refrigeration, Air Conditioning & Heating. All of these have retained the good basic, practical approach which is a hallmark of all Ferris curricula.

Woodbridge N. Ferris, founder (1884) and President of Ferris Institute, Governor of the State of Michigan, U.S. Senator from Michigan, had a credo that said that education should be prac-

tical, useful and of help to people to make a better world. That philosophy has prevailed at Ferris. Hence the School of Technology has a pre-eminent place along with the School of Education & Learning Resources, the College of Optometry, the School of Allied Health and the School of General Education. Ferris offers short courses, two-year Associate Degree courses, Baccalaureate Degree courses and Master Degree courses to over 10,000 students.

Last summer at a CSI regional seminar Steve Parshall, V.P. of the CRS Group in Houston, was a principal speaker. After hearing about their expanded practice I sent him our Ferris Catalog and

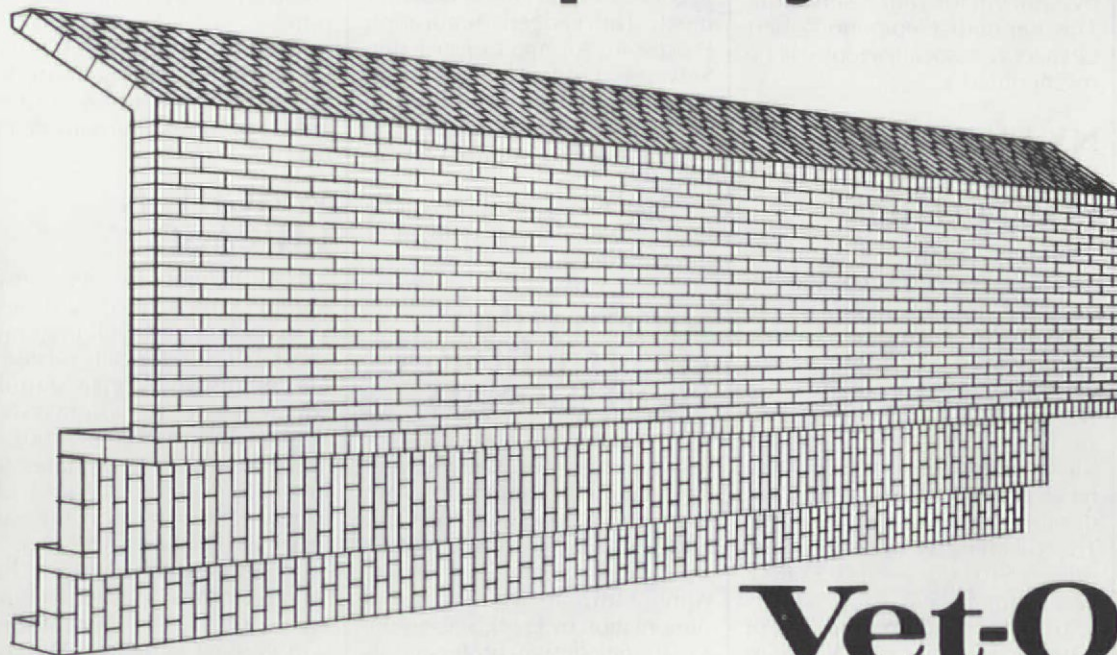
resume of courses for his critique. He noted that they head each project with a designer, a manager and a technologist. He felt that our courses with the addition of a couple of business and decision-making courses would be a most fitting training for their technologist. This spring I will send many of you that same request for your critique. We want to train the best and will be asking for your help. I'll also be asking some of you now and then to show your buildings to my "Materials" classes and to talk about your choice of building materials. I'm putting together a road show to tell all of you at chapter meetings (AIA and CSI) about our various Construction Programs at Ferris.

Well, the old teacher has made a poetic return, not to bask and reflect after thirty years of practice but to train people to make a better world. All this to be done in the best spirit of Woodbridge N. Ferris.

## OBITUARIES

SANFORD (SANDY) G. ROSSEN, 56, Detroit Chapter member since 1956, died after a brief illness on February 29, 1984.

Mr. Rossen was a graduate from the University of Michigan, School of Architecture, and practiced in Detroit area firms prior to opening his own firm in 1957. In 1969, Mr. Rossen became a partner in the firm of Rossen/Neumann Associates. Most recently he was the owner of Sanford Rossen & Associates Architects and Planners in Southfield.

Buildings by Mr. Rossen and his associates included the Ex-Cell-O Building, the American Savings Complex, the Burton Abstract Building, the Young Israel Synagogue and the outdoor concert facility for the Poplar Creek Music Festival north of Chicago.

But his favorite buildings, according to his son, Dr. James Rossen, were three homes, including the one he lived in for the last 25 years in Southfield.

### BOARD OF ARCHITECTS

The purpose of this column is to provide an overview of current activities of the State of Michigan Board of Architects. The most recent meeting on April 9th started at 10:00 and ended at 5:15. The following summarizes current activities:

- On-going review of complaints of Occupational Code Violations.
- Re-definition by Attorney General of review procedures for violations.
- Review of registration appeals.

- Re-definition of rules and regulations defining the scope of activities to eliminate unclear gray area regarding "incidental service over laps." This redefinition has been mandated by the Attorney General for both the Engineer and Architect Boards.

- Recommendations to provide continuing professional competency.

- Regulations, penalties and fees for lapsed registrations.

Two additional items of information are:

1. After July 1, 1984, only graduates with a professional degree from an accredited school will be eligible to write the registration examination. If you have any questions regarding your eligibility, contact the Department of Licensing & Regulation.

2. The following is Bureau policy regarding distribution of registration certificates to candidates. The ceremonies sponsored by professional associations are appropriate only when conducted within the following guidelines:

- The recipient must be informed that the certificate may be received by mail.
- The certificate must be handed directly to the recipient by a person directly associated with the State Licensing Board.
- Since MSA membership, or professional association membership, is not a requirement of registration, a "pitch" regarding membership must be so identified and the recipient must have the option of leaving the ceremony. This is more lenient interpretation of policy, which at one time prohibited any pitch.

As a new member, I am impressed with the dedication

sincerity and responsibility of the Board. As a freshman to the Board, I am hopeful the procedures which I find confusing can be streamlined and clarified.

### UNFINISHED BUSINESS
