### ART IN ARCHITECTURE

### GRAND VALLEY CHAPTER SPONSORED GUEST LECTURE BY MICHAEL GRAVES

The Grand Valley Chapter-AIA sponsored a guest lecture featuring postmodern architect Michael Graves on Tuesday, January 8th at the Grand Rapids Art Museum's Cook Auditorium. AIA members were invited to a champagne reception beginning at 6:00 p.m.

Graves' designs for public sculpture, libraries, and private residences have earned him international commendations. His lec-

ture, "A Case for Figurative Architecture," addressed the problems of abstraction in modern buildings and the need for a more traditional approach in architecture. Fully illustrated examples of historical and current projects will be included, featuring Graves' commissions for the Humana Building, the Portland Building, the Cincinnati Symphony Summer Pavilion and the San Juan Capistrano Public Library.

Winner of numerous design awards, he has also designed several pieces of furniture and artifacts.

### MAIN STREET CENTER SEEKS CITIES FOR NEW COMMERCIAL REVITALIZATION PROGRAM

The National Main Street Center of the National Trust is looking for eight cities to participate in a special demonstration program on commercial area revitalization. The program is designed to test the transfer of the center's successful Main Street approach for small towns and cities to commercial centers serving populations of 50,000 or more.

Participating cities will be selected from among applicants in a competitive process that begins with submission of a letter of intent by January 30th. Interested communities will select a portion of the central business district or a neighborhood commercial district as a target area and must be willing to fund three years of program cost.

Grants from the Economic Development Administration of the U.S. Department of Commerce and the National Endowment for the Arts will fund the first phase of the program. Call 202/673-4056 for more information.

*Confidential to Graduate Architects:* I believe associate membership and the Intern Development Program can enhance your overall professional development, as well as improve your chances of becoming licensed.

It takes eight years to become an architect; five or six of these years are spent in formal education and two or three obtaining the proper work experience on your own. Then, after these eight or more years have passed by, your memory and work experience are tested. Unless you remember everything you have learned and actually have had a comprehen-

sive working experience (IDP), you chances of making the casualty list are currently about 70%.

As an associate member, you meet other graduate architects with similar concerns and objectives and a network is formed. Your associate membership also provides you with almost full AIA membership privileges at substantially less rates, and gives you the opportunity to communicate and rub elbows with real, live architects.

## **OBITUARY**

James Bennett Hughes, director of the Michigan Society of Architects from 1962-65, died November 14, 1984 at Bon Secours Hospital, after a long illness. He was 69.

He worked in offices in Pennsylvania and Ohio and in the Detroit area with the offices of Albert Kahn; Saarinen, Swanson & Saarinen; Harley, Ellington & Day; Cornelius L. T. Gabler and Smith, Hinchman and Gryllis, as well as in his own offices. He was staff architect of the S. S. Kresge Company.

Mr. Hughes was a member of several Detroit area drama associations, including the Players, the Fine Arts Society of Detroit and the Grosse Pointe Theatre. He was a lay reader at Christ Church, Detroit and a longtime member of the Michigan Chapter of Recording for the Blind which produces tapes of books, texts and other documents for educational use by the blind.

He was elected to Phi Beta

Kappa at Pittsburgh's Carnegie Tech, now Carnegie-Mellon University. He was chairman of the MSA convention committee in 1956.

He is survived by his wife, Gretchen, two sons, two daughters, ten grandchildren and a brother.
