BEAUBIEN HOUSE SITE OF AUTOGRAPH PARTY

Has Balthazar Korab added another column to the alphabet table or has he expanded the lexicon of architectural forms in his book, "Archabet," just published by the Preservation Press? The Detroit News describes the book as "partly a game and partly an architectural history" in its February 17, 1985 edition.

Michigan architects and their friends will have a chance to see for themselves at a reception and autograph signing party to be held at the Beaubien House on March 21st from 5 to 7:30 p.m.

Korab is no stranger to the MSA. He has been an honorary member since 1975. He is also a Beaux Arts trained architect who worked for LeCorbusier and Eero Saarinen. He won the 1964 Medal for Architectural Photography from the AIA and was even a traveling correspondent for the Monthly Bulletin. In 1969 he went to Rome and reported "From My Sabbatical" for the April Bulletin. His photographs have also appeared numerous times in the Bulletin.

1985 has started out as a busy and productive year for Korab. In addition to his new book, he has an exhibit of his works currently

running at the Halsted Gallery in Birmingham until March 16th.

This is his eighth photographic essay. Other works include America's Forgotten Architecture; Architecture and You; the Outdoor Sculpture of Michigan series; Kalamazoo: Nineteenth Century Homes in a Midwestern Village; Roofscapes of Rome; Gamberia, a Study of Florentine Garden and the Legacy of the Raisin River.

CRIT-NOVI ROUNDTABLE

In January, the Detroit Chapter sponsored one of the most worthwhile activities in its recent history. The Public/Political Advocacy Committee held a roundtable discussion with members of the Novi City Council and Planning Board on the topic, "Can Good Design Be Legislated?" Lee Mamola moderated the panel which included John Haro, Arthur Smith and attorney John Donohue, past-president of the Michigan Society of Planning Officials, as well as Novi officials.

A mock presentation of a building proposed for the Novi City center served as a springboard for the debate about architectural and planning judgments in Novi. The main question, posed by community leaders, concerned how a young city like Novi — can protect itself against poorly designed architecture yet not discourage potential developers from future investment.

Simple answers were not forthcoming. Both the architects and Novi leaders discovered gaps in communication and understanding about the processes of design and community review. By the end of the evening it was apparent that the discussion itself was more important than any answers which might have been suggested to the dilemma of new town planning.

Architects had taken their responsibilities as public educators seriously and community leaders were willing to discuss the political problems of planning and review from an aesthetic and professional viewpoint. Opinions and comments from the small audience were unfortunately not solicited, something future roundables might consider adding.

The most disappointing aspect of the evening was that, despite announcements, only two architects were in the audience! I would guess that more than two architects live in Novi and that more than two architects in the Detroit Chapter would be critical of the decisions made by the Planning Board there.

Congratulations to Lee Mamola and Carl Roehling, who pushed this event, and to past president Dennis King, who took the theme of "Architecture and Its Public" seriously last year, for this small but seminal effort to raise public and professional consciousness in a concrete way. Let's hope this was more than a flash in the pan and that the Detroit Chapter begins to be a real force in public education and debate about architectural and planning issues in southeast Michigan.

COMMITTEE SEEKS NOMINATIONS FOR FELLOWSHIPS AND GOLD MEDAL

Detroit Chapter

The Recognitions Committee each year provides nominations for Fellowships to the Institute for Honorary Membership and for the Chapter's highest award, the Gold Medal, to the Detroit Chapter Board for their consideration and approval.

Fellowships may be bestowed upon an individual who has made notable contribution for ten years to the advancement of the profession of architecture for work in one or more areas, including design, science of construction, literature, education, service to the profession, public service, historic preservation, research, urban design, government or industry, and architectural practice.

Honorary membership is intended to recognize a person of esteemed character not eligible for corporate membership who has rendered distinguished service to the profession, the arts, or allied sciences.

The Gold Medal may be awarded annually to a member who has clearly demonstrated leadership in the profession and is intended to honor a member for a career-long dedication and not any one specific achievement. The recipient must have been a member of the Detroit Chapter in good standing for ten consecutive years.

"M" AWARDS PRESENTED

This year six building projects were selected by a St. Louis architectural jury to receive the prestigious "M" Awards.

The "M" award was established in 1974 by the Masonry Institute of Michigan, in cooperation with MSA, to recognize design excellence in buildings using hand-laid materials such as brick, concrete block, stone or glass block.

Hobbs and Black Associates, Inc., of Ann Arbor received two cast bronze plaques. One was for Hoover Universal's Plastic Machinery Division Headquarters in Manchester and the other was for the Brauer Office Building in Ann Arbor.

Harley Ellington Pierce Yee Associates of Southfield was honored for the Detroit Edison Headquarter Office Building, also located in Ann Arbor.

The Leonard Hill Car Wash won the prize for K.D.A. Architects Planners of Grand Rapids and a dormitory in Michigan's Upper Peninsula for Suomi College, Hancock, captured a trophy for TMP Associates, Inc. of Bloomfield Hills.

Architects, owners and mason contractors were all recognized at a banquet held in Troy. Jury chair, Peter Van W. Hoyt, Director of Architectural Design and Senior vice President of Hellmuth, Obata and Kassabaum, was the keynote speaker.

Based on the premise that mutual cooperation between client and architect is fundamental to a well executed design, the panel will discuss how the lack of a common goal stresses both architect and client. For example, construction is usually viewed by the client as the most important phase of a building project but often architects view it as a secondary function. Further complicating this relationship is the client's attorney who reviews the design agreements and applies legal principles to it that can increase the liability of design professionals. Often designers fail to relate their responsibilities and liabilities to the particular construction delivery mechanism being contemplated.

In addition to Redstone, the panel members are: Jim Giachino, Barton-Malow Company; Larry McLaughlin, Honigan, Miller, Schwartz & Cohn; Tom Rauch, Kemp, Klein, Endelman & Beer; Simcha Shapiro; Leo G. Shea, Louis G. Redstone Associates, and Thomas F. Sheehan.

The Detroit Chapter of the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) is seeing con-

The purpose of the Energy Awards is to share energy management expertise among building professionals.

New abbreviated rules for the local competition should make it easier for all to enter.
