PRESIDENT'S MESSAGE

We have only had two MSA Board meetings in 1985 and I am pleased to report that we have already made some real progress. A lot of planning has also been done that will show results throughout the rest of the year.

Our new student and associate directors have teamed up and they have contacted several chapters and a number of architectural schools. They are energetic and anxious to promote new members. They have produced amazing results. Since October, five of nine chapters have increased their membership. Overall associate membership is up 38%!

An open discussion brought new insights into the financial hardships of small firms created by the supplemental dues policy. Al Durkee will bring this to the attention of national AIA when he next meets in Washington.

The Membership Committee has been meeting monthly. They will have a comprehensive report and a list of recommendations ready for the convention.

The goal of the Committee on Publications is to break even financially on our AIA sponsored publications.

We have compared our state convention to the conventions of eight other states. This analysis has generated a number of recommendations that will be incorporated into the plans for future conventions.

The Bookstore Standing Committee's suggestions are being implemented with additional funding and more publicity. The autograph party for Korab's new book is but one example of the renewed effort to promote the Architects Bookstore. We also have two librarian specialists who have volunteered their consulting services. All we need now is members

to volunteer to staff this standing committee—please call the Beaubien House.

The Friends of Michigan Architecture (note the new name) has enlisted the aid of a P.R. firm to develop a questionnaire to determine its constituency. The Intern Development Program is also off and flying. A public awareness program format is in development that can be used by each state chapter.

Our government Affairs Committee report prompted the following:

1. A definitive statement against HB#4004 which would extend restricted regulations to both private and public universities.

2. Committees were formed to consider a program of continuing education and to develop a legal definition of architecture which eliminates "and incidental to."

3. The Grand Valley Chapter will report to the Board of Architects on their successful program of assisting building officials in the enforcement of permit laws.

4. Continued support, with CEC, of HB #4251 that would require that design professionals be selected by competition.

President Elect Jim Shane reports progress on the MAF By-Laws. The new MAF will allow the MSA Board to function independently of the MAF and will make the MAF directly responsible for the Friends of Architecture, Education and Scholarship, and the Beaubien House.

Legislative/COPOL

Nine new members have been appointed to the Michigan Commission on Professional and Occupational Licensure (COPOL). The appointments fill vacancies which occurred during a hiatus in Commission activities, bringing the Commission to its full 11 members; seven public members and four members who are licensed in one

of the fields regulated by the Michigan Occupational Code of 1980.

The Commission has been revitalized under 1984 amendments to their enabling legislation. A complete investigation of the operations of the Bureau of Commercial Services is underway. The Commission is to identify ways to clear the backlog of applications and complaints for 26 licensed occupations.

Walter T. Anderson, professor of electrical engineering and director of the School of Technology at MTU, Houghton, a professional member of COPOL, was elected chair of the Commission in 1983. He is currently vice-president of the MSPE.

Also remaining on the Commission as a professional member is William H. Iverson. Iverson is professor of social work and director of admissions and student services for WSU, School of Social Work.

A new professional member of the Commission is Donald A. Ratekin, a licensed land surveyor. He is a principal in the firm of Tri-County Land Surveyors and serves as Allegan County Land Surveyor.

The fourth licensee member of COPOL is Janet Murphy, a licensed cosmetologist.

Appointed as a public member was John K. Cooper, Jr., director of the Gerald R. Ford Institute for Public Service at Albion College. Also a public member is Micheal H. Duweck of Lansing.

Stephen D. Koziolk is bookkeeper for the Michigan Citizen's Lobby in Lansing and a public member of the Commission. Also serving as a public member is William Ryan, former Speaker of the Michigan House of Representatives.

Elena Sanchez of Saginaw and Special Education Teacher Emma Williams are public members and the seventh member is Larry Zimmerman, a supervisor of employee

benefits at the Steelcase Corp. of Grand Rapids.

Senate confirmation of the appointments is required.

The MSA legislative Committee will keep you advised of progress and actions of COPOL.

AIA CODE OF ETHICS

The AIA Ethics Task Force is completing its first public draft of the proposed mandatory Code of Ethics under a mandate from the 1984 AIA Convention. The proposed code will use a three tiered approach covering the canons, ethical standards and specific rules governing membership in the AIA and the profession.

The first tier, or **Canons**, will establish the ethical goals and principles under which the profession wishes to exist. The second tier provides the **Ethical Standards** and is divided into five categories:

- General Obligations
- Obligations to the Public
- Obligations to Clients
- Obligations to Colleagues
- Obligations to the Profession

The Ethical Standards focus on such issues as competency, judgment, credibility, dignity, confidentiality and conformance to the laws governing the profession. The Ethical Standards will be similar to the Canons in that they are aspirational in nature and represent what a member of the profession "should do".

The third tier, or **Rules**, states what an Architect "shall do" and will follow the same general categories and issues as the Ethical Standards. Violation of the Rules would, through due process, invoke sanctions ranging from suspension to revocation of membership.

The Ethics Task Force expects to have copies of the proposed code to the components in July, 1985.

Comments will be elicited through the components and regional meetings for further study and action by the Task Force in October, 1985. The current plan is to complete the code for action at the 1986 convention in San Antonio.

In the past, a mandatory Code of Ethics was a valued aspect of AIA membership. At the 1984 Convention, the delegates reaffirmed this principle. Despite the existence of a voluntary code, they felt that mandatory principles were necessary to assure that the profession maintains the highest of ethical standards.

In the interest of both the profession and the public, the officers and directors of the Detroit Chapter support the adoption and enforcement of a mandatory code of ethics and that these standards be clearly conveyed to the public at large.

All Detroit Chapter firms are encouraged to submit their buildings to the Architects' Sunday Committee for the 1985 program. Public support of these events has been growing for the last two years. A fourth group of architectural students and faculty are now in Poland to undertake their studies at the Polytechnical University of Warsaw. A counterpart of Polish students and faculty will be in Detroit in September.

Sixteen students and a faculty member will leave for Firenze, Italy on May 1st for a semester of study.

UNIVERSITY OF MICHIGAN — The college of architecture and urban planning has established the William Muschenheim Fellowship for Design Faculty. The fellowship was created to support and encourage architects who are at the beginning of their professional careers and show promise as designers and studio teachers.

Deans of accredited schools of architecture and others are invited to nominate candidates. The deadline is April 30, 1985.

DETROIT CHAPTER NEEDS SPEAKERS

The Detroit Chapter-AIA is flooded with requests for speakers. Spring is a busy time according to Lonnie Zimmerman who heads the Speakers Bureau. "Student Career Days are coming up and it is important that the architectural profession be represented. Women and minority architects can make an effective contribution there," he added.
