2. Education of architectural stu-



4. The development and dissemination of policies promoting the welfare of all people through the improvement of the built and new environment.


5. Fellowship activities.

# SAVE FORD AUDITORIUM

#### Leo G. Shea, FAIA DCAIA Vice President

The Detroit Chapter AIA and Cityscape Detroit, Inc. have formed The Coalition to Save Ford Auditorium with several other civic organizations and neighborhood groups. The key points that the Chapter made in its letter to the Detroit City Council at the public hearing on June 19 include:

Preservation of Hart Plaza and the Civic Center, as public land for public use, is a primary responsibility of City Government.

The City's proposed offering of this prime public land to a private developer for conversion to private ownership is outrageous.

Planning issues alone, including the impact on riverfront views, access and density that a 30 story building would bring, together with the lack of parking for such an office density, would make such a development undesirable.

Ford Auditorium's replacement cost, estimated in excess of \$50 million, calls into question why the City would propose to demolish it, to give to a bank - or a private developer.

Comerica has an unparalleled opportunity here to redirect its investment in the downtown to a location which would become the nucleus of a much-needed redevelopment effort.

Since timing was of the essence, the Executive Committee of the Chapter Board voted, on July 3, to contribute \$1,000 to the Coalition to aid in funding newspaper advertisements requesting interested persons to write the members of the City Council. The Council's address is: 1340 City County Building, Detroit, MI 48226.

Detroit Chapter members are asked to add their personal letters to Council Members, as well as to Comerica board members. The Council voted on July 18 after an additional Public Hearing on July 16 and the result was 6-3 in favor of the project.



#### MICHIGAN USE TAX

The Discovery Division will be contacting all Architectural Companies in Michigan within the next several weeks with instructions and a worksheet to perform a self audit for use tax for the years 1986 through 1989.

The Treasury Department frequently encounters a lack of awareness of the Michigan use tax. When you purchase supplies and equipments for business or personal use from a Michigan vendor, you pay sales tax. However, if you purchase supplies and equipment from a company in another state which does not collect Michigan tax, you must report it and pay Michigan use tax directly to Michigan.




