MichiganVision - A Preferred Future

Carl Roehling, AIA, Chairman

Last year's MichiganVision Conference was an unqualified success. There were 90 participants, including representatives of the Schools of Architecture, the Michigan Society of Architect's as well as Fellows of the Institute. The conference addressed issues on the nature of practice, social and environmental concerns, and changing technologies among others. The content inspired the organizers to institute this program on a yearly basis within the Michigan Society of Architects. On March 22, 1991 the second MichiganVision conference will take place at Lawrence Institute of Technology.

The purpose of the Michigan Vision is to "paint" a vision of what Michigan should be like as an environment in which to practice, live and work in the year 2001. It will set priorities for action by the architects and the citizens of this state.

Ten issues will be reviewed by ten groups. Groups will address topics ranging from the nature of practice to the achievement of design excellence. Once again, there will be representatives of the four accredited architectural schools; University of Detroit, Lawrence Technological University, University of Michigan and Andrews University. Representatives of practitioners within the state, the Fellows of the Institute, interns, as well as the Michigan Society of Architects and Michigan Architectural Foundation leadership will participate. Evie Asken, FAIA, Dick Fry, AIA, Mike Marshburn, AIA, Lorri Sipes, AIA, Gino Rossetti, FAIA and Rae Dumke, Honorary AIA are coordinating the participants and will lead the workshop. Results will be published in the spring.

"The only way to predict the future is to have the power to shape it." We will shape it in March.

Western Michigan Chapter Awards

Four building projects received awards from the Western Michigan Chapter AIA at their fifth annual Building Design Awards Presentation held in November.

Honor Awards were presented to Randy L. Case, AIA, Battle Creek, for the Grand Trunk Depot Renovation also in Battle Creek; and Allegretti Architects, St. Joseph, for the Fenville District Library. Honorable mention went to Allegretti Architects for a 12,000 sq. ft. residence in Burr Ridge, Illinois, and to Eckert/Wordell Architects, Kalamazoo, for the First of America Bank - Woodbridge Branch, in Portage, Michigan.

All sixteen projects entered by ten different firms have become part of the Chapter's travelling exhibit to be displayed throughout the eleven-county Chapter area, as part of their Public Outreach goal.

The jury consisted of a mix of Detroit area architects, and local educators, artists, and community leaders and the Awards Program/Travelling Exhibit was loosely modelled after the successful Charlotte AIA Awards Program, featured at the Grass Roots Convention in Washington.

P.S. Western Michigan Chapter is currently soliciting to help pay for a portable display system and to offset costs involved with transporting and maintaining the exhibit.

CAM EXPO '91

The Construction Association of Michigan (CAM) will host its annual construction exposition and conference next month at the Pontiac Silverdome. CAM Expo '91 will open on February 13th and will run through February 14th.

This year, CAM Expo will mark its seventh year as the Midwest's largest construction exposition and conference. Over 600 exhibit spaces will cover the Silverdome's main floor and concourse area packed with everything from hand tools to heavy equipment. Show Manager James McLaughlin predicts that more than 12,000 will attend the annual event.

"Each year the show participation and attendance keep climbing," said McLaughlin. "This year doesn't look like any exception to the pattern. With everyone tightening their belts, the show is more important than ever since exhibitors are trying to reach sincere buyers, and buyers are looking for bargains on construction products and services."

In anticipation of larger crowds, CAM Expo '91 will include two entrances to the show and advanced registration for attendees. "We decided to make some changes in our registration procedures so people can get into the show with no delays," said McLaughlin. "Attendees can get tickets before the opening, fill them out and send them to us through the mail. We'll pre-register them and send a name badge back through the mail. 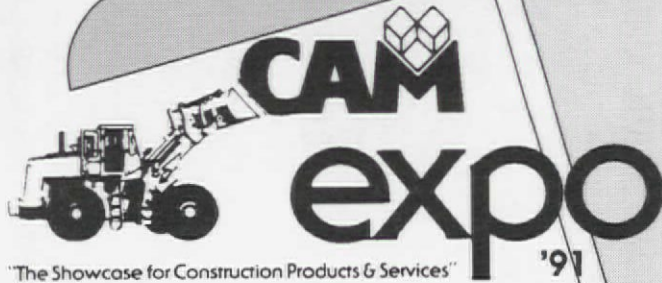
