CURRENT GOVERNMENT AFFAIRS

Legislative Affairs Task Force
SCHOOL CONSTRUCTION CODE
BILL VETOED! The AELC
(Architects/Engineers Joint
Legislative Committee) met on
September 9th at the offices of our
lobbyists, Dennis Cawthorne and
Jim Cavanagh, to review legislative
issues. We were informed that
HB4143 dealing with the school
construction code had passed both
the House and the Senate and was
on the Governor's desk for
signature.

According to Cawthorne and Cavanagh, the school board attorneys did not want the 1937 language adjusted to meet 1993 current practices. Dan Redstone, AIA, a member of the AELC Committee, had submitted revised wording earlier in the summer that was not acceptable to the submitter of the Bill. Dan Ryan of Plunkett & Cooney, Kevin Gleeson of Sullivan Ward Bone Tyler Fiott & Asher, PC, and Tom Porterfield of V.O. Schinnerer were contacted to help us veto the Bill at the last minute. Gleeson researched this issue and submitted a summary for us to use in the newsletter. Ryan submitted his findings directly to the Governor, which are too lengthy to be reproduced here.

We were fortunate to have the Bill vetoed! A summary of Gleeson's

THE SPECTER OF LIABILITY (THE NEW SCHOOL CONSTRUCTION BILL) By Kevin Gleeson

For the better part of a decade, many design professionals, and fortunately the plaintiff's practice of the American Bar Association. were unaware of the presence of a statute which required architects and engineers involved with the design or construction of a school building to remain responsible for not only code compliance, but to assure the owner would receive a building which was built in a "workmanlike manner" and guaranteed to "resist fire." Through the efforts of many individuals within the design professional community and their legislative counsel, this offending verbiage was deleted. However, we are now faced with a new school construction Bill, which as been placed on the Governor's desk for signature into law. The revised proposed statute contains similar language to that which has been deleted from the previous body of law (MCLA 338.852) but goes on to further define the obligations of the architect or engineer in connection with the work.

In its present form, the statute

appears as follows:

"The plans and specifications for a school building or remodeling project with construction costs that exceed \$15,000 shall be prepared and the construction supervised by a State licensed architect or professional engineer employed by, or under contract with, the school board.

The architect or professional engineer...who prepares the plans and specifications or who supervises the construction of any school building shall be responsible for determining the building is resistant to fire and constructed in a workmanlike manner according to the plans and specifications."

The statute, in its present proposed form, poses a significant threat to those design professionals who enter into contracts with school officials. Additionally, the ill advised and apparently uninformed decision on the part of the government to reinstitute this obligation will have a direct impact on the number and quality of design professionals willing to enter into agreements with school districts and will certainly have an impact upon their cost of doing business. Obviously, any prudent architect or engineer is not going to enter into a contract with their exposure now exponentially increased without seeking additional compensation to cover the costs of this particular risk.

This would include the added costs of premiums for insurance coverage normally not carried by design professionals, but which will be required if the architect or engineer wishes to avoid personal risk.

Since the architect or engineer "shall be responsible for determining the building is resistant to fire and constructed in a workmanlike manner," the design professional is all but compelled to provide "supervision" on the project, since they are held to the same standard for the completed product whether present on site or simply involved with the preparation of contract documents. Although the words "guarantee and warranty" do not appear within the test of this proposed law, it certainly smacks of that level of assurance. This flies in the fact of well-reasoned and ancient law within the borders of the State of Michigan which has always looked upon the architect's and engineer's design effort as being without guarantees or warranties, unless otherwise stated expressly in the contract.

In "supervising" or overseeing construction activity to determine whether it is built "in a workmanlike manner," the architect and engineer are required to provide extraordinary services, which most design firms are not qualified to achieve, or simply to not possess the manpower.

In terms of insurance coverage, the obligatory language of this statute requiring extraordinary services during not only the design, but the construction phase, imposes upon the design professional services which are not covered under the normal professional liability policy. If the design professional is to be responsible for construction, then the completed operations, other forms of the general liability and products liability coverages all may

be required to bridge the void in coverage.

This article is not intended as an exhaustive study critiqueing all of the problems which might arise if this law is enacted, but certainly a red flag must be raised at this critical moment. There are a number of individuals both in the design community and legal practice attempting to head off the Bill before it is signed into law. It is strongly recommended that all engineers and architects contact their Representatives and suggest the proposed Bill be modified to delete the proposed language.

In conclusion, the proposed legislation amending the State Construction Code to include school construction and to increase the Michigan Dept. of Labor's involvement would significantly increase the cost of construction for Michigan's school districts.

Steve Vogel, AIA, President of AIA Michigan, and Bob Beckley, AIA, Dean at The University of Michigan School of Architecture and Urban Planning, discuss the educational requirements for a licensed architect. Award-winning columnist and Honorary AIA Michigan Member John Gallagher, from the Detroit Free Press, offers his views on the state of the built environment in Michigan. Many other issues are explored, including a client's perspective of working with a licensed architect.

The spotlight is on *your* work. Dramatic visual images of projects, ranging from private residences to major universities to municipal facilities from Detroit to Marquette, are featured. Most firms who had been published in PLACE Magazine were invited to submit still photography for possible inclusion in the video.

The video was jointly funded by the the Government Affairs
Assessment monies and the Michigan Architectural Foundation for public awareness. Each AIA Michigan Chapter has received a complimentary video to promote local public awareness compliments of the MAF.

"Architectural Update" was previewed at the Annual AIA Mid-Summer Conference on Mackinac Island in August. Recipients of copies of the video include Joe Young, Jr., Chairman, State Affairs Committee, and select legislators working to further our Government Affairs program. Rep. Young's committee is currently sponsoring legislation on our behalf for licensing and enforcement. Distribution of "Architectural Update" also includes AIA

components, such as ours in Detroit, across the country, and the Government Affairs staff at AIA headquarters in Washington, DC.

The Government Affairs Committee is currently working on ways to further distribute this video. We need to acquaint, inform and educate the public, media and governmental bodies in Michigan in order to develop support for hiring licensed architects. You can help! AIAOnline AT AIA MICHIGAN
