**GOVERNMENT AFFAIRS  
REPORT**

There has been a considerable amount of activity in legislative affairs during the past 60 days. The level of activity is going to increase during the next 60 days. The issues that we are involved in and their summary status is as follows:

**4787/4788** - Unlicensed practice fund. Passed House Committee and full House October 20, 1993. We will be making a major effort to get these Bills out of Senate hearings and onto the floor. There is considerable resistance from both the executive office and the administrative office.

**5100** - Unlicensed practice/injunctive action by individual or organization. We will support it being reported out of Senate hearings and onto the floor. This Bill is acceptable to government, but it is not a substitute for 4787.

**4982** - Qualifications Based Selection has been holding due to amount of activity but will now be pushed for House hearings as soon as possible. This bill is with the House Committee on State Affairs.

**Landscape Bill** - Practice act. At the present time, it appears that this Bill is dead but will be followed in case it is

reactivated.

**405** - School Bill would transfer the regulation of school construction from the Department of Education to the Department of Labor, Bureau of Construction Codes. In its current form, the Bill repeals a 1937 law which makes architects and professional engineers responsible for school construction. The Bill is now silent on that issue, thus leaving such matters for the parties to negotiate. Our lobbyists believe school interests will make every effort to reinsert the 1937 language. The Bill has passed the Senate and is now with the House Committee on State Affairs. We have offered to work with the school people to work out this issue.

**AIBD** - No Architects required for single family residence. This Senate Bill 330 is being held up by our allies, the Homebuilders. In several ways, this Bill relates back to our activities on 4787 and 5100.

**5153 and 5154** - Interior Design practice act vs. title act. Would create a new article within the Occupational Code and allow the registration of interior designers. These Bills have stayed with the House Committee on State Affairs since their referral last Fall. There has been a great deal of activity on this issue, and it will probably come to conclusion in the next 60 days. We are working on an agreement to change the practice act to a title act in agreement with the AIA national accord to which we are bound. There are a few key issues yet to be resolved.

**State Contract** - Indemnification clauses. This effort is just beginning and will take some time before any



results are seen.

All of these Bills have an interrelationship as we work with the House, the Senate, the administrative offices, and the various groups of interest. Our lobbyist, Cawthorne/Cavanagh, has guided our efforts.

I can't stress too strongly the fact that as we push for positive action on 4787 and 5100, it has impact on several of the other issues. And, as we push for negative action on the School and Landscape Bills, it impacts QBS and Interior Design. It is an art in itself to juggle all of these various efforts.

During these efforts in Lansing, several other things are also being developed:

**Professional Practice** is being rejuvenated to develop stronger ties with building officials and code authorities. They are also being developed into our monitoring group for adherence to the various practice laws. The Construction Industry Regulations Seminar is scheduled for April 25 and 26, 1994 at Shanty Creek.

**Communications Task Force** continues to develop and implement our efforts to improve our public image and public awareness and support for our various efforts. The Task Force has produced a video and brochure for use by the public, legislators, media and membership. Their efforts have been recognized by AIA National with a 1994 State and Local Government Affairs Award for Outstanding Communications and Public Outreach Efforts.

One last item...our **Minuteman Program** was activated the week of February 14th in support of 4787 and 5100. Members in the 26th, 8th, 10th, 5th and 36th Districts were notified to

contact their Senators. IT IS ESSENTIAL THAT YOU ACTIVELY SUPPORT THIS EFFORT. We must make a good showing here.

We are not alone in this effort. The Engineers, Surveyors, and the Homebuilders activated their programs at the same time.

## **AWARDS FOR AIA MICHIGAN AT GRASSROOTS**

AIA Michigan was just named the recipient of an American Institute of Architects 1994 State and Local Government Affairs Award. The award recognized outstanding communications and public outreach efforts that championed the benefits of using architects, the value of good design, and the architects' licensing law in Michigan.

Copies of our new *Architectural Update* video and brochure were submitted to national along with the communications plan that won the award for us. The award was presented to Gene Hopkins, AIA, President, AIA Michigan, and Rae Dumke, Hon. AIA, during Government Affairs events at AIA Grassroots in January with over 500 component leaders present.

Michigan was also recognized at the local, state and foundation levels by presenting programs to Grassroots attendees on Michigan programs. Jim Shane, AIA, Michigan Architectural Foundation President presented

a program on Foundation Growth and Partnering; Graham Dickens, AIA, Vice President, AIA Michigan, presented the AIA Michigan Minuteperson Program at "Government Affairs: Fundamentals for Success," which highlighted ways to increase member involvement in government affairs programs. Another presentation was made by Hopkins, Dumke and AIA Arizona on "State and Local Components: Living in Symbiosis." In other words, how do AIA Michigan, AIA Detroit and the MAF co-exist under one roof and split the overhead. The final program was presented by Carl Roehling, AIA, President, AIA Detroit on "Taking a Stand: How to Handle Difficult Public Issues." This one dealt with how components handle issues affecting the community. Roehling used Tiger Stadium as the example and discussed the response from AIA Detroit to the City and the Stadium.

## HABITAT FOR HUMANITY

Two Michigan architects have been recognized for their time, talent and unselfish effort given to the Habitat for Humanity program in North Carolina. **John Allegretti, AIA**, AIA Southwest Michigan, and **Dennis Reckley** designed and produced working drawings for houses in Asheville. And **Mikkel R. Hansen, AIA**, coordinator of the program, can't thank them enough for their efforts. In a letter sent to the Beaubien House, Hansen enclosed a copy of AIA North Carolina's newsletter which tells the story of a \$150,000 grant to Western North Carolina's affiliate of Habitat for Humanity International to buy land for their first subdivision, Oakwood. Hansen's challenge was to quickly plan, design and build 20 houses that would fill Oakwood's beautifully-wooded, gently-sloping lots. Since getting 20 designs in shape himself didn't look probable, he called on two Michigan friends, Allegretti and Reckley, for some additional help. They, along with a dozen or so architects and landscape architects from North Carolina, devoted considerable time to the project. The first families began moving in last Fall, many of them never having lived in a house. Completion is expected this year.
