AIA MICHIGAN PRESIDENT'S REPORT

When I assumed the role of President on December 8, 1994, I gave the Board of Directors a list of goals and objectives that will be used as our report card to you, the membership, when my term expires in December 1995. Repeated below is that list:

- * Did we develop a strategy for making the relationship between AIA Michigan and the Michigan Architectural Foundation (MAF) comply with the architecture/architects model indicated in the reorganization plan?
- * Did we obtain resolution from the Chapters as to their organizational structure and did we assist to the needs of the members?
- * Did we develop a strategy for reorganization of the Board of directors that is responsive to the needs of the members?
- * Did we revise the operating procedures of the Board of Directors to focus the Board as a debating, policy making body?
- * Did we change the financial structure of the administration of this society to provide the following:
 - Programmatic budgeting and accounting
 - Audit of the organization shared with AIA Detroit/ MAF every five years
 - Business like financial reporting procedures
- * Did we develop a strategy for the disposition of Beaubien House, do we understand the financial elements of our occupancy?

- * Did we develop a strategy for moving AIA Michigan in part/or whole to Lansing?
- * Were we effective in the Government Affairs arena? Did we accomplish the goals of the Government Affairs Committee?
- * Were our conventions and events successful in providing education and fellowship to our members? Did they meet their financial goals?
- * Did we implement the task oriented responsibilities of staff? Was it effective?
- * Did we implement a measurable evaluation procedure for staff?
- * Did we communicate well with the members?
- * Did we see a net increase in the number of members?

Work on some of these items has started. For example:

- * Regional Director, Richard E. Fry, FAIA, has had a meeting with the Chapter Presidents to review the present structure.
- * The Board of Directors has discussed the Board organizational structure at the Leadership meeting held in January.
- * We have implemented programmatic budgeting for the Society; Gary Skog, Treasurer, will make recommendations for revising the financial reporting procedure to the membership.

- * A Finance Committee has been formed, led by Gene Hopkins, AIA, Past President, to make recommendations for the Board to review.

All of our efforts will be directed towards making the Society, member responsive, financially sound and open to progressive and meaningful change.

As we begin this year, I ask for your input and your participation. The Executive Committee and Board will be traveling to each Chapter over the course of the year and I hope that you are able to join us at these meetings. Chapter/ Board schedule is as follows: March 9/Mid-Michigan; April 6/Flint; May 18/Southwest; June 15/Huron Valley; July 13/Saginaw Valley; September 28/Northern & Upper Great Lakes; September 29/Upper Peninsula; & October 19/Grand Valley.

I hope to see you at various events through the year, and I look forward to the opportunity of serving you, and making a positive change in 1995.

GOVERNMENT AFFAIRS UPDATE

House Bill 5100/Public Act 400

At the end of 1994 it was reported that HB5100 was dead. This bill provides legal standing for injunctive relief against unlicensed practice. However, on December 27, 1994, a last minute tradeoff between the legislature and the governor saw this bill passed and it was signed into law as Public Act 400. Unfortunately, a last minute amendment added language that confused the applicability of this

law in resolving the issue of unlicensed practice. We are working closely with the Bureau of Professional and Occupational Regulation, who are in agreement with AIA Michigan on this matter, to resolve the issue and obtain a clear interpretation of the new law. Clearing up the ambiguities in PA400 will be a focus of the Professional Licensing Task Force. This Task Force will also, once again, begin to work on the definition of architecture, a necessary component to any legal action.

House Bill 4787 and Homebuilder's Legislation

Also reported last year was that HB4787, which would define more clearly the limitations on square footage of single family residential construction that requires an architect, did not clear the legislature. Whether or not this bill will be reintroduced is under discussion. Likewise, there is concern that the Homebuilders, who were our partners on HB4787, may consider reintroduction of SB330, which called for elimination of the need for architects for any residential construction. This will be monitored very closely.

State Contract

Dave Lawrence, AIA is chairing a committee that is meeting with the State of Michigan about the problems with the standard contract for architectural services. AIA Michigan is attempting to delete the punitive aspects of this contract and to work with the State in creating a more equitable agreement.

Interior Design Legislation

Interior Design Licensing legislation did not pass the legislature last year it is not known whether new legislation will be introduced.

Qualifications Based Selection

AIA Michigan is partnering with the consulting Engineering Council and others to promote QBS. At some point in time, legislation may be introduced to mandate QBS on state projects. We have also applied to AIA National for a grant to assist in our QBS efforts.

EB4927

AIA Michigan partnered with Oakland and Wayne County and others to kill HB4927 last session. This bill would have given contractors automatic extras for delays caused by late documentation. This bill could come back in this session.

Communications Plan

Lovio-George, Inc. has been named the new communications counsel for AIA Michigan. In conjunction with the Communications Task Force they have created a strategy called "Building Advocates instead of Adversaries". This strategy focuses on communications to members, the public, building officials and legislators. It is now being refined to coordinate closely with our legislative initiatives.

Professional Practice

The Professional Practice Task Force is working with the State Board of Architects to produce a pamphlet explaining "How to Hire an Architect" and a building officials guide.

AIA's CONTINUING EDUCATION PROGRAM

The AIA's continuing education program will enter a three-year phase in period beginning in January 1995 and concluding in December 1997. This phase in period will allow members time to become familiar with the idea of continuing education and the reporting procedures. Members will be required to accrue and report 36 Learning Units (LUs) during the phase in period, and 36 LU's each succeeding year following the phase-in (after January 1998). OBITUARIES

Dr. Earl Pellerin, FAIA, 89, died last December. He was a former Dean at LTU School of Architecture for over two decades. One quote from Karl Greimel, who succeeded him as dean. "He was a significant figure in the development of architectural education in Michigan." He maintained a private practice designing homes, municipal buildings and churches, he exemplified the school's motto emphasizing the need for practice as well as theory. He received both AIA Michigan and AIA Detroit Gold Medals, in 1971 & 1973.

Nobyn H. D'Haene, AIA, 69, died in November 1994. He was a Mid-Michigan member and former partner in the firm MBDS (Mayotte, Budzynski, D'Haene, Stuckman), Inc. Architects of Lansing. He was a veteran of WWII and Korean Conflict. Mr. D'Haene served on both the Mid-Michigan Chapter and the AIA Michigan Board.

George L. Schulz, AIA-E, 94, died in November 1994. He was a member since 1941 and retired from the Detroit Public Schools in 1966 as the head architect. More than 150 schools and additions were planned under his direction. He had a B.S. degree from UM in 1923.

David S. McGrath, AIA, 39, died in January 1995. He was a member of the Huron Valley Chapter. Mr. McGrath worked for the Michigan Masonry Association.

AIA MICHIGAN PRESIDENT'S REPORT

Graham Dickens, AIA

When I assumed the role of President on December 8, 1994, I gave the Board of Directors a list of goals and objectives that will be used as our report card to you, the membership, when my term expires in December 1995. Repeated below is that list:

- * Did we develop a strategy for making the relationship between AIA Michigan and the Michigan Architectural Foundation (MAF) comply with the architecture/architects model indicated in the reorganization plan?
- * Did we obtain resolution from the Chapters as to their organizational structure and did we assist to the needs of the members?
- * Did we develop a strategy for reorganization of the Board of directors that is responsive to the needs of the members?
- * Did we revise the operating procedures of the Board of Directors to focus the Board as a debating, policy making body?
- * Did we change the financial structure of the administration of this society to provide the following:
 - Programmatic budgeting and accounting
 - Audit of the organization shared with AIA Detroit/ MAF every five years
 - Business like financial reporting procedures
- * Did we develop a strategy for the disposition of Beaubien House, do we understand the financial elements of our occupancy?

- * Did we develop a strategy for moving AIA Michigan in part/or whole to Lansing?
- * Were we effective in the Government Affairs arena? Did we accomplish the goals of the Government Affairs Committee?
- * Were our conventions and events successful in providing education and fellowship to our members? Did they meet their financial goals?
- * Did we implement the task oriented responsibilities of staff? Was it effective?
- * Did we implement a measurable evaluation procedure for staff?
- * Did we communicate well with the members?
- * Did we see a net increase in the number of members?

Work on some of these items has started. For example:

- * Regional Director, Richard E. Fry, FAIA, has had a meeting with the Chapter Presidents to review the present structure.
- * The Board of Directors has discussed the Board organizational structure at the Leadership meeting held in January.
- * We have implemented programmatic budgeting for the Society; Gary Skog, Treasurer, will make recommendations for revising the financial reporting procedure to the membership.

- * A Finance Committee has been formed, led by Gene Hopkins, AIA, Past President, to make recommendations for the Board to review.

GOVERNMENT AFFAIRS UPDATE

Stephen Vogel, FAIA

House Bill 5100/Public Act 400

At the end of 1994 it was reported that HB5100 was dead. This bill provides legal standing for injunctive relief against unlicensed practice. However, on December 27, 1994, a last minute tradeoff between the legislature and the governor saw this bill passed and it was signed into law as Public Act 400. Unfortunately, a last minute amendment added language that confused the applicability of this

law in resolving the issue of unlicensed practice. We are working closely with the Bureau of Professional and Occupational Regulation, who are in agreement with AIA Michigan on this matter, to resolve the issue and obtain a clear interpretation of the new law. Clearing up the ambiguities in PA400 will be a focus of the Professional Licensing Task Force. This Task Force will also, once again, begin to work on the definition of architecture, a necessary component to any legal action.

House Bill 4787 and Homebuilder's Legislation

Also reported last year was that HB4787, which would define more clearly the limitations on square footage of single family residential construction that requires an architect, did not clear the legislature. Whether or not this bill will be reintroduced is under discussion. Likewise, there is concern that the Homebuilders, who were our partners on HB4787, may consider reintroduction of SB330, which called for elimination of the need for architects for any residential construction. This will be monitored very closely.

State Contract

Dave Lawrence, AIA is chairing a committee that is meeting with the State of Michigan about the problems with the standard contract for architectural services. AIA Michigan is attempting to delete the punitive aspects of this contract and to work with the State in creating a more equitable agreement.

Interior Design Legislation

Interior Design Licensing legislation did not pass the legislature last year it is not known whether new legislation will be introduced.

Qualifications Based Selection

AIA Michigan is partnering with the consulting Engineering Council and others to promote QBS. At some point in time, legislation may be introduced to mandate QBS on state projects. We have also applied to AIA National for a grant to assist in our QBS efforts.

EB4927

AIA Michigan partnered with Oakland and Wayne County and others to kill HB4927 last session. This bill would have given contractors automatic extras for delays caused by late documentation. This bill could come back in this session.

Communications Plan

Lovio-George, Inc. has been named the new communications counsel for AIA Michigan. In conjunction with the Communications Task Force they have created a strategy called "Building Advocates instead of Adversaries". This strategy focuses on communications to members, the public, building officials and legislators. It is now being refined to coordinate closely with our legislative initiatives.

Professional Practice

The Professional Practice Task Force is working with the State Board of Architects to produce a pamphlet explaining "How to Hire an Architect" and a building officials guide.
