Three Architects Named Fellows

The AIA has elected three Michigan architects to its prestigious College of Fellows: Arnold Mikon, Leslie Tincknell and Stephen Whitney.

Arnold Mikon, FAIA

Under Mikon, SH&G has grown to become the third largest A/E practice in the U.S., with offices in Detroit, Washington, D.C., and Phoenix. His comprehensive approach to service has enhanced SH&G's ability to solve society's complex technical and social issues.

Mikon brought SH&G's resources to the City of Detroit to produce a Land Use Plan to guide land and economic development well into the 21st century. He brought SH&G's integrated service approach to civil rights organization Focus: HOPE, showing how technology and design quality can inspire an urban neighborhood.

Mikon has been a member of AIA's Large Firm Roundtable for several years, and has served as a director of AIA Michigan, as treasurer, vice president and president of AIA Detroit. He is currently chairman of Detroit's Central Business District Association.

Leslie Tincknell, FAIA

Since entering the architectural profession in 1958,
Tincknell's designs have encompassed a varied scope of projects including educational, health care, recreational, housing for the elderly, governmental, commercial, adaptive reuse, and historic preservation projects. His firm has received many honors, including the 1996 AIA Design Honor Award for the Michigan Capitol restoration.

Tincknell was recently awarded the 1995 Michigan Gold Medal for "notable contributions to the AIA and outstanding achievement in the profession." He is president of the Michigan Architectural Foundation, vice-chairman of the Saginaw County American Red Cross and secretary of the Historical Society of Saginaw County. For the past two years, he has been an adjunct faculty member at Lawrence Technological University.

Stephen Whitney, FAIA

Whitney's experience in

health care architecture spans over 25 years. Among his most significant projects at AKA are the \$210 million, 1.1 million-sq.-ft. University of Michigan replacement hospital and the Providence Medical Center ambulatory diagnostic and treatment center and medical office building in Novi. Whitney is currently serving as project principal for the UofM's new East Campus primary care medical facility, and is also heading AKA projects for the Detroit Medical Center, St. John Health System, Beaumont Hospital and Sparrow Hospital and Health System in Lansing.

Whitney's involvement with AIA has been substantial over the last decade. In addition to national committee involvement, Whitney has been active on the regional and local levels, most notably serving as AIA Michigan president in 1992. His longstanding commitment to the organization and the architectural profession played a major role in AKA being named AIA Michigan's "Firm of the Year" in 1995 and AIA's national "IDP Firm of the Year" in 1994.

Simplify, And Make it Better

So far this year, I have attended many of the programs, events, board meetings, excom meetings, committee meetings, receptions and chapter meetings around the state, either in person or by speaker-phone. I hope teleconferencing will soon draw all our members even closer.

I can tell you one thing as I see programs and events across the state: AIA Michigan is doing more than ever before, and it's doing a lot of things right! You can be proud...

- ➤ of the increasingly strong voice we have in Lansing (the attendance at our recent legislative reception is evidence)
- ➤ of the higher quality of communications (by newsletter, fax and phone)
- ➤ of the increasing commitment to provide excellent continuing education opportunities for our members
- ➤ of the tremendous efforts by literally dozens of member volunteers serving on committees to keep our annual programs and events fresh and relevant, and
- ➤ of the refinement of our budgeting process to prioritize and streamline.

Still, things can and should improve. We must continually communicate our value as creators of the built environment, as problemsolvers, as visionaries, as leaders, as responsible professionals.

Our efforts in governmental affairs need to move down in the organization, to the individual member forming relationships with officials who impact our profession. We really need to expand and improve our grassroots network through improved communications to amplify our collective voice.

We need a growing number of quality continuing education offerings for our members, so that AIA architects are clearly recognized as the best architects. We need to find ways to make those programs and events more accessible to all our members, including associates and students.

There is no shortage of opportunities to enhance architects and architecture in Michigan. We are limited only by our imagination and our resources to implement ideas.

Which brings me to a specific opportunity before us now. AIA National is eliminating supplemental dues for AIA members starting in 1997. This means a \$79 per member reduction in National dues for next year, along with a welcome step toward simplification of

a complicated dues structure. We are working on ideas to simplify the dues for AIA Michigan, too. In line with National, we want to eliminate supplemental dues and simplify the structure even further. It's about time.

The AIA Michigan board will soon be looking at recommendations to redirect some of the National dues reduction dollars back to AIA Michigan. The rest would go back to the individual member in the form of lower overall dues. This way, AIA can establish sustained funding for crucial areas like government affairs and continuing education while still offering dues relief. The board has already discussed and unanimously endorsed such a concept. But the specifics have to be ironed out prior to a vote at the June board meeting, and prior to membership vote approval.

This is a rare win-win opportunity. It's a chance to provide stronger financial footing for our collective future while reducing the overall dues bill. Please take the time to talk about this idea with your chapter leadership. Give them some feedback so this important change in our dues structure can bring maximum benefit to AIA Michigan, and to you.

Injunctive Relief Put to the Test

Court Cases Uphold AIAM Stance on Licensing

Three Michigan court cases have tested our commitment to challenge those practicing architecture illegally. The cases have been settled successfully, and a fourth case is under way. With the positive resolution of these cases, we deter those who practice architecture without a license. In Charlevoix County, an individual who designed and built a 5,000+ sq. ft. residence will not design a residence over 3,500 sq. ft. without using the services of

an architect. He also agreed to no longer use the term "architect" or similar term in connection with his name.

In Kent County, a home building firm held themselves as architects and designed and built several residences over 3,500 sq. ft. A court order to cease and desist is expected to be signed by the defendant any day.

A contractor in Oakland County produced architectural drawings for an interiors project without an architect. The contractor is expected to sign a court issued consent order admitting to violations and agreeing not to produce drawings in the future.

Under way in Genesee County, a case involves a design firm providing architectural drawings and a structural engineer sealing the drawings for an office building.

AIAM President Tom Mathison, AIA, urged members to continue their support of government and public affairs activities.

"AIAM members' strong

support for our government affairs activities has enabled us to defend licensed practice of architecture," explained Tom Mathison, AIA, president. "New challenges in the form of proposed legislation which would diminish or delete the requirement for licensure on a wide range of project types, sizes and services will be vigorously resisted," he said.

Final Paper-and-Pencil A.R.E. Exam in June

Registration boards will administer the last paper-and-pencil version of the Architect Registration Examination (A.R.E.) June 17-20, 1996. Beginning February 1997, NCARB will offer the A.R.E. year-round at a network of computer-based testing centers.

NCARB will use the computerized mastery test format to deliver the multiple-choice divisions of the exam in 1997. Division A: Pre-Design; Division D/F: Structural Technology-General and Long Span; Division E: Structural Technology-Lateral Forces; Division G: Mechanical, Electrical, Plumbing and

Acoustical Systems; Division H: Materials and Methods; and Division I: Construction Documents and Services will appear in this format on the computer-administered exam.

NCARB selected this methodology because of its appropriateness for registration examinations which divide test takers into two groups — passers and failers.

In a computerized mastery test format, the A.R.E. will be a variable-length test, meaning that applicants may take tests of different lengths. The A.R.E. has been designed so that applicants take two testlets (questions grouped into small tests) that form a base test.

After the applicant completes the base test, the computer scores the applicant's performance. If the performance is clearly passing or clearly failing, then the applicant has completed the exam and no more questions will be administered.

If, on the other hand, the applicant's performance lies within a band of ability levels that is neither clearly passing nor clearly failing, then the applicant will receive another testlet. The process continues until the applicant's performance has been determined as clearly passing or failing.

20 Leading Causes of Troubled Jobs

What does cause a claim? CNA/Schinnerer commissioned an A/E Management Practice Study which looked at A/E firms, their project and firm management practices, and their claims experience over a ten-year period. Among other questions, the study asked firm leaders about the factors they thought prevented (or at least ameliorated) claims as well as those factors that, in their experience, started (or perhaps aggravated) claims. The top 20 claims starters or aggravators are printed here. (We'll print the top 20 preventers next issue.)

Top 20 Claims Starters Or Aggravators

Site responsibilities are not clear and coordinated Client differences not resolved immediately Construction schedule, budget not tied to scope Client's project representative is inexperienced Firm accepts projects with uncompensated risks Infrequent site observations

Opinions Sought on State Building Code

Ben Tiseo, AIA, was appointed to the 1996 State Building Code Review Committee and will be working on setting up the new state construction code.

The committee will review the 1996 BOCA Building Code, CABO/ANSI A117.1-1992 and the 1993 State Code (including Barrier Free Design) and come to an agreement for a new revised State Building Code (1996 BOCA with amendments).

The committee hopes to adopt the 1996 BOCA with as few amendments as possible, and to eliminate as many of the existing rules as feasible, explained Tiseo. As an example, he noted, the committee has recommended elimination of the separate (and different) BFD Parking Ratio Table in favor of the similar BOCA Table.

Public hearings are expected in the fall, with submission to the Legislative Rules Committee for adoption into law by early summer 1997.

Fire Marshal Sets Fees for Hospitals and Schools

Public Act 147 (amends Public Act 207 of 1941) enables the Fire Marshal Division to collect fees for plan review and construction inspections for hospitals and schools. In addition, hospitals will be assessed an operation and maintenance inspection fee.

The Act restores funding for the Fire Marshal Division nearly to its previous level, which will allow all programs to continue, including the State Certified Fire Inspector Training and Certification Program. The School has been scheduled for Oct. 7-Nov. 1.

Fire Safety Rules Discussed Publicly

Four sets of proposed fire safety rules will be discussed at public hearings including: Health Care Facilities Fire Safety, New and Existing Penal Institutions Fire Safety, Fire Prevention (covers public buildings) and State Owned and Leased Buildings Fire Safety.

Meetings will be held in St. Ignace on June 18; Lansing on June 21; and Southfield on June 25. For information, or to request copies of the proposed rules in advance, call 517-322-1921.

School Election Bills Pass Senate

Senate Majority Leader Dick Posthumus reports that the Senate passed a package of bills designed to tie school board elections and millage proposals to Michigan's general elections in order to boost voter participation and interest. The three tiebarred bills set up guidelines to restructure school elections and set up standards for their administration under the precepts of the Michigan Election Law.

The legislation will repeal provisions in the School Code that allow for the operation of elections to be conducted by school districts and establish that such duties be granted to local units of government. As a result, the Michigan Election Law would also be amended to create provisions under which school districts govern such elections.

The bills are now before the House Committee on Local Government for review.

Regional Director's Report from National

AIA Michigan should expect to see cost savings from single point dues system to start in 1998. A vendor for consolidating the database for single point dues was being selected in April. Plans will be unveiled in August at the CACE meeting. Testing will take place in 1997.

A round table meeting of Michigan, Indiana, Ohio and Kentucky architects and the Louisville Corp of Engineers will be set up by Stuart Binstock, national government affairs director. If you are interested or work with the Corp, fax a note to Carl Roehling at 313-983-3633.

The national program for **practice and prosperity** is designed to expand architects' role and definition. New documents, new services, new insurance and new marketing approaches would permit all architects to move into design/build, economic consulting, facility management and other services. A draft of the program should be available this month. AGC is developing a standard program management contract wherein the contractor is the leader of the process. AIA will develop a similar document. B141 will be sunset.

The AIA advertising program is generating 2,000 calls per month.

AIA National membership renewal rate is 93 percent, higher than most associations. Total membership is 53,000.

CSI has dropped their system for **specifications**. AIA is promoting MasterSpec to them and to the federal agencies.
