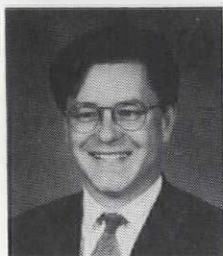

President's Report

Our new convention, unveiled in April, met with resounding success in terms of attendance and program participation. Held in Midland, the convention was organized around the work and environment of Alden Dow. More than 250 members participated in 10 programs ranging from continuing education seminars and building tours to the Honor Awards program.

This new format was organized to promote member interaction with an opportunity to easily obtain continuing education requirements in a relaxed environment. Initial member feedback has been very positive – we encourage you to make the journey to expand your knowledge next year.

Our journey to build bridges with the Homebuilders Association and the interior designers has experienced a few pot holes in the road. Sounds like a Michigan phenomenon!

Negotiations with the homebuilders on the issue of the degree and extent of architectural involvement in residential design have stalled. We were prepared to discuss potential modifications to the 3,500 square foot exemption within Article 20 when the Homebuilders Association pulled away from the negotia-

tion table. They are seeking a "repeal of the seal" which would eliminate the requirement for an architect's involvement on residential construction regardless of the size. The future of this issue is unclear and may result in a legislative battle. We will maintain contact with their organization in order to continue discussions regarding issues of common interest, e.g. self regulation, continuing education, public awareness, etc. The journey continues.....

Discussions with the interior designers have been successful to date. Initial proposed legislation was opposed by our Board of Directors. We requested language to define who they are, what services they are able to perform and strict grandfathering limitations. The interior designers agreed to our requests.

We await input from Governor Engler's office to see how the current Administration would respond to this proposal. Historically, the Administration has fought legislation that would define the existence of another profession.

Therefore, this issue is in process with an overall agreement in principle as to the desired resolution. We have stated that this is our offer and anything

less is unacceptable. It is up to the political machine to see if it has any chance this year. We know this is a journey that continues beyond our imaginations.

On a different note, to encourage interaction with members, the Executive Committee and Board will travel throughout the state with detours onto a few golf courses. If your schedule permits, please join us for these journeys on the links. We are in Flint on June 18, Kalamazoo on July 18 and, of course (no pun intended) Mackinac for our Mid-Summer Conference, August 7-10. There is always a golfing opportunity when traveling to and from the Design Retreat September 5-6.

We are seeking projects for this year's Design Retreat, as well as your participation. Last year was a sell out! If you have a terrific project to share with colleagues, please contact Bill Grindatti at 810-353-5995.

For those of you who are involved, I think you would agree this year has been challenging so far with the extremely diverse terrain. We look forward to your participation throughout the year. I welcome your comments and thoughts concerning future AIA activities. Jump on board as the journey continues.

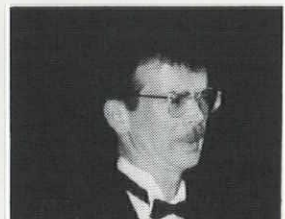

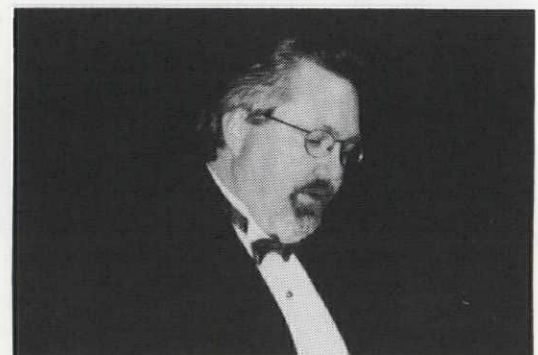

ACSA/AIA Teacher's Seminar Slated for June 21-24

Architectural movements of the last few decades have protested against our lack of connection with the world. But they remain highly conceptual and essentially language-based, and thus have failed to close the widening gap between the world and our mental constructs of it.

The 1997 ACSA/AIA Teacher's Seminar will examine the relationship between conceptual thinking and perceptual knowledge and will explore strategies for reestablishing a reciprocal relationship between subject and object, perceiver and environment, architect (or inhabitant) and building. Program sponsors encourage local practitioners to attend by offering a special rate of \$300. One-day registration is \$150.

The tuition charged for faculty members is normally \$750.

The June 21-24 seminar will challenge the traditional notion of a Cranbrook retreat - by engaging participants in the nearby urban and suburban environment, and by examining subsequent fall studio work, based on the seminar, at the 1998 ACSA Annual Meeting in Cleveland. Participants are eligible for AIA Learning Units.

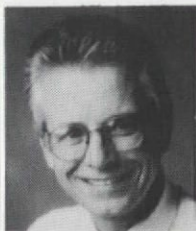

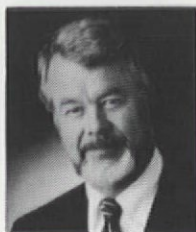

VIRGINIA PINNELL

Virginia Pinnell, former AIA Detroit Chapter president, passed away in April in Ft. Myers, Florida. Ginny was most recently a resident of Atlanta, Georgia and Ft. Myers.

WILLIAM GARDNER

An architect who left his mark across America, William Gardner passed away in late March at age 72. Gardner helped design attractions such as Sea World's Shamu Stadium in Orlando and buildings such as the TWA terminal at Kennedy International Airport in New York.

Gardner, who retired nine years ago and moved to the Traverse City area, worked with Eero Saarinen & Associates in the 1950s and 1960s. In the 1970s and 1980s he taught architecture at the University of Michigan and established a firm in Detroit. He was the principal architect for the Burroughs World Headquarters and Wayne State University's Shapiro Hall in Detroit. Gardner is survived by his wife, Jo Ann, and two daughters.
