## President's Report

## **Shape Future Architects**

In the pre-computer days, the month of June was the time of the annual pilgrimage to Ann Arbor. For one week, offices were understaffed while the exam-takers endured three days of multiple-choice questions, followed by the dreaded twelve-hour design problem. At the end of the week, the drafters returned bleary eyed, drained and exhausted.

Now that the exam is computerized there is no event to remind us of the plight of those pursuing a license. They are still with us, though, and they still need coaching and instruction.

We have been distracted by the various tasks of protecting the profession. We have engaged the interior designer in the discussions to set their legislation; we have resisted the spread of unlicensed practice, and we support nominees for the state boards. We worked through the MAF to promote the awareness of architecture and its role in society. We've held our honor awards and conducted seminars to maintain our own education.

The profession, however, has to extend into the future. Unless we pass on to the next generation of architects the knowledge and traditions we value, we have failed the profession. In part, architecture is a profession – not just a job – because we are one moment in a long line. What we know and use on a daily basis was taught to us by the previous generation. It is our responsibility to add to this knowledge and pass it on to the next generation.

Long before the current fad of

mentoring, we were all shepherded through our internships by someone who cared. In time, the Intern Development Program (IDP) formalized these relationships and set standards to meet NCARB requirements. The key is still an architect taking the time to work with an aspiring architect, sharing knowledge and experience, and guiding the candidate toward a license.

Time flows only in one direction and there is no way to go back to repay our mentors. We honor them by taking on their role and passing on their knowledge to those who follow.

Whether you are an IDP advisor or not, take the time to teach the young people in your office. Share your experience with them – and learn from them as well. Youth is the source of energy and new ideas that keep the profession strong and vibrant. Time spent with interns will bring the most lasting results. To shape the future of architecture, shape the architects of the future.

## **Californians Defeat Competition Killer**

The 3 million people who voted against the measure (62 percent of the turnout) voiced their preference to have local governments, schools, hospitals, prisons and other public clients hire the most qualified design and engineering professionals.

The proposal put forward by the employees union of the California Department of Transportation would have required cost competition between public and private design professionals and gave an unfair competitive advantage to the public-sector providers.

AIAM contributed \$1,000 to help fight the proposal. In all the California design professionals raised \$1.2 million in PAC monies to fight the proposition.

## Masonry Board Addresses Critical Issues

The Masonry Advisory Board, formed in Spring 1997, opens lines of communication between design professionals and masonry contractors. The Board identifies areas of concern and works to achieve resolution.

Currently two architects sit on the Board – Glen Reimer of URS Greiner and Jim Velthoven of Giffels. Additional architect members are needed. Others represent consulting engineers, masonry suppliers, masonry contractors, the Masonry Institute of Michigan and the International Masonry Institute.

The Board was initiated because of concerns about the quality of installed product, specifically reinforced masonry. As a result of the Board's cooperative approach, a formal 8-hour training program was developed on reinforcing and grouting

The Masonry Advisory Board has also undertaken a research program. It will focus on the various effects of grout consolidation methods, the relationship of consolidation methods to rebar pull-out strengths and the uniformity of grout relative to consolidation method. Results are not yet available.

Recommended language to be included as part of the specification for reinforced masonry, in either Section 04810 or 04820.

#### Part 1 - General

Article "Quality Assurance" Contractor's Qualifications Firms shall have a minimum of 5 years experience in placing of reinforced masonry.

Foremen responsible for the placement of reinforced masonry shall be qualified on the basis of having passed the Masonry Institute of Michigan (MIM) training program, "Reinforcing Walls and Grouting of Hollow Unit Masonry."

## **Latest CES Statistics**

More than 35 percent of AIA Michigan members have completed the 1998 CES requirement as of June 2, 1998, according to a report by the Council of Architectural Component Executives. The figures do not include credits earned at the 1998 AIA Convention in San Francisco or the AIAM Spring Convention in Battle Creek.

Of the 50 states, Alabama AIA members showed the highest rate with 59 percent having already completed the 1998 requirement. New York had the lowest percentage of completion at almost 22 percent.

The report also shows that nearly 64 percent have completed the 1997 requirement, and 91 percent have completed at least some of the 1997 requirement.

## AIA Officers Elected at Convention

At the 130th national convention of the American Institute of Architects, delegates elected Ronald Skaggs, FAIA, of Dallas, as the 1999 first vice president/president-elect. Skaggs will assume his new office in December 1998 and become president of the AIA in 2000. Michael Stanton, FAIA, of San Francisco, will succeed Ronald Altoon, FAIA, as president in 1999.

John Anderson, FAIA (Colorado); Ronald Bertone, FAIA (New Jersey); and Jonathon Woodman, AIA (Massachusetts) were elected vice presidents. AIA delegates elected David Collins, FAIA, (Ohio) as Institute secretary for the 1999-2000 term.

## Members Vote for 3-Year Ad Campaign

Delegates at the annual business meeting voted almost unanimously in favor of a bylaws change that will delegate to the Board of Directors the authority to levy an annual assessment of \$50 per member in the years 1999, 2000 and 2001 to support a national television advertisement campaign. The money collected through this assessment is to be used exclusively for the campaign.

## Ambassador Bridge/ Gateway Project Pedestrian Bridge Design Competition

The Michigan Department of Transportation, in association with SEMCOG, the Southeast Michigan Council of Governments, the Federal Highway Administration and AIA-Detroit, is sponsoring a competition for the design of a pedestrian bridge to be construction over I-75/I-96 near Bagley Ave. in southwest Detroit.

The competition is part of a larger project that will impove access to the Ambassador Bridge which serves traffic to Canada. That project is called the Ambassador Bridge/Gateway Project.

An information packet is being prepared for mailing to potential competition entrants. Five finalists will be determined by a jury of architects, engineers and artists selected for the project. Each finalist will receive \$5,000 for their work. The Federal Highway Administration and the Detroit International Bridge Company are providing the award money. A Project Steering Committee representing stakeholders will rank the five finalists. The topranked entrant will be included on the design team for the project.

Individual competitors must be a registered professional engineer or architect to qualify. Team competitors must include such an individual. Only one entry is allowed per individual or team and individual entrants may not participate on a team; nor may anyone participate on more than one team.

## NCARB Briefs

## Q&A: Intern Development Program

This is the second article in a series addressing the most frequently asked questions about four NCARB services, compiling a Council Record, completing IDP, becoming NCARBcertified and transmitting your record for reciprocal registration.

## Q. What is the Intern Development Program?

A. The Intern Development Program (IDP) is a set of resources that, when used in a systematic manner throughout the internship period, contributes to the development of competent architects. Those resources include the NCARB Council Record, which can serve as a record-keeping tool throughout the architect's career: mentorship provided by practicing architects and information about issues that affect the intern and the practice of architecture as a whole. IDP is not a series of registration requirements and conditions, nor is it a study program for passing the Architect Registration Examination. The program's major objectives are described in Section I of the publication IDP Guidelines (available directly from NCARB or through its Web site at www.ncarb.org.

#### Q. How do I enroll in the program? What does it cost to participate?

A. Interns begin their participation in IDP by taking the following steps: (1) Request an IDP Information Package from NCARB. (2) Identify an IDP sponsor and select an IDP advisor. General selection criteria are found in Section IV of IDP Guidelines. (3) Establish an NCARB Council Record and document all previous acceptable training. The cost to initiate a Council Record is \$265, which covers all services associated with the record for the first three years.

## Q. Do I need an accredited degree in architecture to participate?

A. The level of post-secondary education required to begin IDP varies from state to state. Michigan applicants must possess an NAABaccredited professional degree. Applicants who do not possess an accredited degree should contact the Michigan Board of Architects at 517-241-9253.

#### Q. Why should I begin documenting my training when my internship starts? Why not wait until I've completed the IDP Training Requirement?

A. To derive the maximum benefits from IDP, interns should begin documenting their training and supporting education at the beginning of their first acceptable employment. Retroactive documentation is discouraged for several reasons including: (A) Previous employers often cannot verify training units earned, resulting in a loss of training credit toward admission to the examination. (B) Retroactive record-keeping usually delays the examination application process, resulting in postponement of examination and registration. (C) Several registration boards place limits on the amount of experience that can be retroactively documented.

#### Q. I'm having trouble getting the minimum training units required in several areas. Can I use supplementary education to satisfy these requirements?

A. No. Supplementary education can be used to supplement minimum levels of required training, but cannot serve as a substitute for such experience. More specifically, supplementary education cannot be used to satisfy the minimum training units required in IDP Training Areas 1-16. The AIA has developed many excellent educational resources. Interns should be encouraged to use them for augmenting required training and exploring the broader aspects of architectural practice.

## Free ARE Practice Software Available

The NCARB has added the practice software for the Architect Registration Examination (ARE) to its Web site. Exam candidates can now download the software directly onto their computers by signing on to the site at www.ncarb.org and following the links to the examination information.

The software includes tutorials to teach candidates how to use the various testing tools found in the three graphic divisions of ARE. (There are no practice programs for the six multiple-choice divisions.) Following the tutorials are 15 representative vignettes, one for each of the 15 vignettes that make up the graphic divisions.

Previously, candidates had to request the ARE software after reaching eligibility from their state registration boards. Now the software is being sent to all candidates on diskette, but with the addition of an online version, architectural interns can begin to familiarize themselves with the ARE software even before they become eligible candidates.

#### HERMAN J. PRATT, AIA

Herman J. Pratt, a founder of the Kalamazoo-based Stapert, Pratt & Sprau architectural firm that designed church, school, hospital, government and other buildings for more than 25 years, died May 18 in Texas. He was 84.

Projects in which Pratt was involved included the Miller Road Post Office, St. Monica Catholic Church and Winchell Elementary School. He also designed additions to Bronson Methodist Hospital, the police-courts building and alterations to the City Hall.

Pratt grew up in Kalamazoo and went to Chicago Technical College. He worked most of his life in Kalamazoo, but also did work in Phoenix and had become an architectural consultant in Texas from his retirement until his death. He is survived by his wife, Orma; two daughters; one son; six grandchildren and three great-grandchildren.

AIA Michigan was recently informed of the death of David Pyle, AIA, of Kalamazoo in early 1997. Pyle was an active member of the Western Michigan Chapter of AIAM and was also involved in community affairs.
